#### Public Hearing

SB 102

Exempts from state and local transient lodging taxes military lodging used for temporary overnight human occupancy by active or retired members or service veterans of Armed Forces of the United States or National Guard or by employees or agents of Oregon Military Department.

SB 104

Authorizes Office of Emergency Management to establish programs, or authorize certain private entities to establish programs, to credential individuals as critical service providers.

SB 105

Transfers responsibility for Oregon Emergency Response System from Department of State Police to Office of Emergency Management.

SB 150 \*\*

\*\*Subsequent Referral(s) to Tax Expenditures

Extends sunset for tax credit for provision of medical care to residents of Oregon Veterans' Home.
