SB 306 ** **Subsequent Referral(s) to Finance and Revenue
Directs Department of Veterans' Affairs to study and make recommendations for policy proposals for tax treatment of military pensions.

Public Hearing

SB 441
Modifies criteria for erecting roadside memorial signs for deceased veterans who were formerly prisoners of war or unaccounted for.

SB 534
Grants fee waiver to certain family members of persons who were killed in action during armed conflict while serving in Armed Forces of United States.

Work Session

SB 150 ** **Subsequent Referral(s) to Tax Expenditures
Extends sunset for tax credit for provision of medical care to residents of Oregon Veterans' Home.

SB 184
Modifies laws relating to preference given to veterans in public employment.
