# Interfering with a Peace Officer Data

Arrests and Convictions for ORS 162.247

- Prior to 2020, arrests for IPO increased by 140%, while convictions increased by over 50%.
- Similar to most other crimes, in 2020 both arrests and convictions fell for IPO due to the COVID-19 pandemic.
- It is also notable that the overall upward trend between 2010 and 2019 was not impacted by the *Oregon v. McNally* ruling in 2017, which narrowed the applicability of 162.247.

<sup>†</sup> Jails reporting housing information included Clackamas, Columbia, Coos, Cottage Grove, Deschutes, Douglas, Florence, Jackson, Josephine, Lane, Marion, NORCOR, Sweet Home, Tillamook, Union, and Washington.

- The CJC collected jail data pursuant to HB 3194 (2019). This data collection included a request for housing information for all booked individuals.
- In non-IPO cases, defendants were houseless 14% of the time.
- In IPO cases, defendants were houseless almost 19.5% of the time.
- It is important to note that the estimate of houseless individuals is conservative, as our data only includes defendants who were *confirmed* as houseless.

Racial Breakdown of Arrests and Convictions

† Approximately 0.1% of arrests and 3-4% of convictions are for individuals of "unknown" race.

- Comparing the racial breakdown in arrests and convictions to Census population breakdowns:
  - Most concerning is the frequency of arrests and convictions for IPO for Black individuals
  - While arrests for Latinx individuals are lower than their population share, convictions are slightly higher
