Thank you for taking the time to accept this letter of support for my accomplished and respected colleague, Sophorn Cheang, as she presents herself for confirmation before your august committee. Please understand that everything that follows will be my absolute and untrammeled position of support for your wisdom in her selection, and my urging for your speedy confirmation of this most excellent candidate.

I did not come to this perspective lightly. I have worked with Ms. Cheang in many of her various roles over time:

- In her role at IRCO (Immigrant & Refugee Community Organization) as Director of the Asian Family Center, I have seen her work tirelessly for the Asian and Pacific islander community in our region, from program development to strategy to collaborative projects to delivery of services and implementation. She also contributed to CCC by participating in collective advocacy, programs and services efforts;

I have found her, in all of these many and varied settings, to exhibit the reliable through lines of honest advice and dialogue, a passion for the Oregon community, and attention to detail without sacrificing the big picture strategic view essential for any organizational leader, while simultaneously being the consummate advocate for her staff and collaborators as she seeks the best solutions for the work at hand.

She also brings a perspective and sensitivity unique to any of her predecessors in this role: she arrives as an immigrant, a mother, a leader graduating from no less than three bastions of higher education in our state, and a professional uniquely qualified to imbue Business Oregon with the necessary focus on equity embraced by the Governor and many other leaders in the state. Such a vision will be important to enticing business to Oregon's ever changing demographics, and expanding the innovation needed to keep our current businesses competitive.

Sophorn is a kind, attentive, and compassionate leader, who will make Business Oregon stronger, and reflect the interests for all of Oregon.
