# WHAT THE MEASURE DOES:

Modifies period in which certain tax refund interest begins accruing, effective for refunds owing as of January 1, 2018.

## **ISSUES DISCUSSED:**

- Example of inconsistency in interest accrual
- Background on when and how the interest inconsistency became part of statute.

# **EFFECT OF AMENDMENT:**

No amendment.

## **BACKGROUND:**

Statutory changes made in SB 33 (2017) modified interest rate computation from monthly computation to daily computation for purposes of tax deficiency or tax refunds owed by the Department of Revenue (DOR). This change aligned DOR interest computation practices with generally accepted accounting practices in other industries. Statutory language in 2017 did however create inconsistency in interest accrual in certain instances. Such inconsistency was not included in 2017 measure description and is likely an inadvertent consequence of the 2017 legislation. Measure eliminates potential interest inconsistency as of January 1, 2018, in alignment with originally enacted changes made by SB 33 (2017).
