# **STATE AVIATION BOARD**

The Governor has appointed the following individual to the State Aviation Board subject to Senate confirmation.<sup>1</sup>

## Appointee

Thomas Krueger of Keizer; New appointment

#### Term

Krueger: March 15, 2021 – June 30, 2022

#### **Appointment/Confirmation Authority**

ORS 835.102 (2019)

#### Statement of Economic Interest<sup>2</sup>

Not required.

### **Statutory Requirements<sup>3</sup>**

The board consists of seven members appointed by the Governor and subject to confirmation by the Senate. Members serve four-year terms.<sup>4</sup>

- members must be appointed with consideration of the different geographic regions of the state, with one member being a resident of the area east of the Cascade Range (FERGUSON (R));
- not more than four members may belong to the same political party (BARSALOU (R), GRANATO (D), KRUEGER (R), MEEKER (R), PEREYO (N/A), PETERS (D)); and
- membership must represent diverse aviation interests from both private and public sectors.

The Governor must appoint one member as chairperson and another as vice chairperson, to serve such terms, duties and powers as the board determines are necessary.<sup>5</sup> A majority of

members constitutes a quorum for the transaction of business. The board must meet at least once quarterly.

### **Duties and Authority**

The board provides policy oversight for the Oregon Department of Aviation.

The board must:6

- with the advice of the department, incorporate as part of its program a definite plan for the development of airports, state airways, airplane industries and aviation generally;
- through the department, cooperate with and assist the federal government, the municipalities of the state, and other persons in the development of aviation activities;
- oversee the administration of the department, including authorizing contracts, the receipt and use of federal funds, and use of moneys in the State Aviation Account;
- exercise and perform its statutory authority, power, and duty commensurate with and for the purpose of protecting and insuring the general public interest and safety, the safety of persons receiving instruction concerning, or operating, or using or traveling in aircraft, and of persons or property on land or water, and to develop and promote aviation in this state; and
- in consultation with the State Marine Board and the State Parks and Recreation Department, adopt rules governing seaplane safety and operations in state waters.

The board may:<sup>7</sup>

- perform such acts, adopt or amend and issue such orders, rules and regulations, and make, promulgate and amend such minimum standards as it considers necessary to perform its statutory duties; and
- fix the compensation of the director of the department.
