#### ENERGY EFFICIENCY STANDARDS (APPLIANCE STANDARDS)

Establish energy efficiency requirements for common products in order to be sold, offered for sale, or installed in Oregon

Contribute toward consumer energy efficiency, cost savings, and greenhouse gas reductions

Are complementary to building energy codes to address energy consumption on the built environment



Include a role for both State and Federal governments

# HOW ODOE ESTABLISHES STANDARDS

- ORS 469.261 provides ODOE with the authority to review standards and administratively adopt new or updated efficiency standards
- If the director adopts rules to update the minimum energy efficiency standards specified in ORS <u>469.233 (Energy efficiency standards</u>) or to establish new minimum energy efficiency standards:

(A) The rules may not take effect until one year following their adoption by the director; and

(B) The Governor shall cause to be **introduced at the next Legislative Assembly a bill** to conform the statutory minimum energy efficiency standards to the minimum energy efficiency standards adopted by the director by rule.





What does the bill do?

• Establishes energy efficiency standards (conforming to rule)

• Cleans up statute

• Streamlines the process for updating an existing standard to maintain alignment with other states



## HB 2062 A

#### Items addressed in House -3 Amendment, 2062 A Engrossed

- Better aligns and relates the process for updating standards to the process for building code updates
- Requires consultation with appropriate building code Advisory Boards for updates to existing standards and definitions
- Clarifies language for ODOE administrative updates to a more recent version of a standard to maintain or improve consistency with other states
