## SUMMARY

Delays implementation requirements for paid family and medical leave program.

Takes effect on 91st day following adjournment sine die.

## A BILL FOR AN ACT

Relating to family medical leave benefits; amending ORS 657B.340 and sections 50, 51, 60, 62 and 63, chapter 700, Oregon Laws 2019; and prescribing an effective date.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1.** ORS 657B.340 is amended to read:

657B.340. (1) The Director of the Employment Department shall establish a family and medical leave insurance program to provide family and medical leave insurance benefits to a covered individual as specified in this chapter.

(2) Not later than [*September 1, 2021*] **September 1, 2022**, the director shall adopt rules that are necessary to establish the program under subsection (1) of this section, including but not limited to rules that:

(a) Establish an outreach plan for the program to receive input from, and disseminate information to, employers and eligible employees.

(b) Establish a process by which employers may apply for approval of an employer-offered benefit plan under ORS 657B.210.

(c) Establish alternatives by which an employer may determine a benefit year period, including on a calendar year and noncalendar year basis.

(3) The director may enter into interagency agreements to perform the duties and functions necessary to implement and administer this chapter.

1 (4) Whenever possible, the director shall use existing employer and public  
2 infrastructure to maintain records, conduct outreach and facilitate contri-  
3 butions made to the program.

4 (5) All agencies of state government, as defined in ORS 174.111, shall,  
5 upon request of the director, assist in the performance of the director's du-  
6 ties under this chapter, including but not limited to outreach, technical as-  
7 sistance and training.

8 **SECTION 2.** Section 50, chapter 700, Oregon Laws 2019, is amended to  
9 read:

10 **Sec. 50.** Beginning [*January 1, 2023*] **January 1, 2024**, and not more than  
11 once each year for three consecutive calendar years thereafter, the Director  
12 of the Employment Department shall conduct a review of the expenses in-  
13 curred by the Employment Department in reviewing plans for approval under  
14 [*section 43 of this 2019 Act*] **ORS 657B.210**, including an analysis of adequacy  
15 of the application fee determined by the department and administrative ex-  
16 penses related to request for review of determinations regarding approval or  
17 denial of applications as provided under [*section 31 of this 2019 Act*] **ORS**  
18 **657B.410**.

19 **SECTION 3.** Section 51, chapter 700, Oregon Laws 2019, is amended to  
20 read:

21 **Sec. 51.** (1)(a) The Director of the Employment Department shall submit  
22 to the interim committees of the Legislative Assembly related to workforce  
23 or business and labor, in the manner provided in ORS 192.245, reports sum-  
24 marizing the Employment Department's progress toward implementing the  
25 family and medical leave insurance program described in [*sections 1 to 51 of*  
26 *this 2019 Act*] **ORS chapter 657B**.

27 (b) The director shall submit the first report not later than February 15,  
28 2020, and a second report not later than [*September 1, 2021*] **September 1,**  
29 **2022**.

30 (2) Beginning on [*July 1, 2023*] **July 1, 2024**, and once during each of the  
31 following three consecutive biennia, the director shall, to the extent that the

1 director has acquired the information, submit to the interim committees of  
2 the Legislative Assembly related to workforce or business and labor, in the  
3 manner provided in ORS 192.245, a report that includes:

4 (a) The total number of claims submitted under [*section 12 of this 2019*  
5 *Act*] **ORS 657B.090**.

6 (b) The number of claims allowed under [*section 13 of this 2019 Act*] **ORS**  
7 **657B.100** and the number of claims denied under [*section 13 of this 2019*  
8 *Act*] **ORS 657B.100**.

9 (c) The total amount of benefits paid out of the Paid Family and Medical  
10 Leave Insurance Fund established under [*section 39 of this 2019 Act*] **ORS**  
11 **657B.430**.

12 (d) Data regarding the use of moneys in the fund, the solvency of the fund  
13 and the balance of the fund.

14 (e) The amount of contributions collected under [*section 16 of this 2019*  
15 *Act*] **ORS 657B.150**.

16 (f) The number of applications for plan approval submitted under [*section*  
17 *43 of this 2019 Act*] **ORS 657B.210**, including the number of plans approved  
18 and the costs the department incurred in reviewing such applications.

19 (g) The number of applications received by the department for employer  
20 assistance and the total amounts awarded in grants [*under section 42 of this*  
21 *2019 Act*] **ORS 657B.200**.

22 (h) The director shall include in the reports described in this subsection  
23 any recommendations made by the advisory committee under [*section 36 of*  
24 *this 2019 Act*] **ORS 657B.380**.

25 **SECTION 4.** Section 60, chapter 700, Oregon Laws 2019, is amended to  
26 read:

27 **Sec. 60.** When the Employment Department determines that moneys in  
28 sufficient amount are available in the Paid Family and Medical Leave In-  
29 surance Fund established under [*section 39 of this 2019 Act*] **ORS 657B.430**,  
30 but in no event later than [*January 1, 2023*] **June 30, 2023**, the department  
31 shall reimburse the General Fund, without interest, in an amount equal to

1 the amount from the General Fund appropriated as provided in section 59,  
2 **chapter 700, Oregon Laws 2019** [*of this 2019 Act*], **as modified by section**  
3 **62, chapter 9, Oregon Laws 2020 (second special session).**

4 **SECTION 5.** Section 62, chapter 700, Oregon Laws 2019, is amended to  
5 read:

6 **Sec. 62.** The Director of the Employment Department shall establish the  
7 family and medical leave insurance program under [*section 33 of this 2019*  
8 *Act*] **ORS 657B.340** such that eligible employees as defined in [*section 2 of*  
9 *this 2019 Act*] **ORS 657B.010** and employers may begin making contributions  
10 to the program no later than [*January 1, 2022*] **January 1, 2023.**

11 **SECTION 6.** Section 63, chapter 700, Oregon Laws 2019, is amended to  
12 read:

13 **Sec. 63.** (1)(a) [*Sections 8, 11, 14, 16 to 31, 37, 41, 43 to 48, 49a and 61 of*  
14 *this 2019 Act*] **ORS 657B.070, 657B.080, 657B.110, 657B.130, 657B.150,**  
15 **657B.175, 657B.180, 657B.190, 657B.210, 657B.220, 657B.230, 657B.240,**  
16 **657B.250, 657B.260, 657B.280, 657B.290, 657B.300, 657B.310, 657B.320,**  
17 **657B.330, 657B.370, 657B.390, 657B.410, 657B.440, 657B.460, 657B.470,**  
18 **657B.900, 657B.910 and 657B.920** and section 50, chapter 700, Oregon

26 (c) **ORS 657B.040 becomes operative on August 3, 2023.**

27 (d) **The amendments to ORS 410.619 by sections 52 and 53, chapter**  
28 **700, Oregon Laws 2019, and the amendments to ORS 657.100[,] and 657.471**  
29 [*and 659A.162*] by sections [*54, 55 and 56 of this 2019 Act*] **54 and 55, chapter**  
30 **700, Oregon Laws 2019,** become operative on January 1, 2023.

5 (2) The Employment Department and the Department of Revenue may take  
6 any action before the operative dates specified in subsection (1) of this sec-  
7 tion that is necessary to enable the departments to exercise, on and after the  
8 operative dates specified in subsection (1) of this section, the duties, func-  
9 tions and powers conferred on the departments by [*sections 1 to 51 of this*  
10 *2019 Act*] **ORS chapter 657B.**

11 **SECTION 7. This 2021 Act takes effect on the 91st day after the date**  
12 **on which the 2021 regular session of the Eighty-first Legislative As-**  
13 **sembly adjourns sine die.**
