# HB 2528 A -A10, -A11, -A12, -A16, -A17 STAFF MEASURE SUMMARY

## **Senate Committee On Health Care**

#### WHAT THE MEASURE DOES:

Directs Oregon Board of Dentistry (Board) to issue dental therapist license to qualified applicant. Limits dental therapy licensure to graduates of dental pilot project education programs until January 1, 2025. Specifies examination requirements to dental therapy license applicants. Prohibits unlicensed use of title "dental therapist" and practice of dental therapy and specifies exceptions. Allows Board to charge fees related to dental therapist licensure. Specifies elements of required collaborative agreement between dental therapist and supervising dentist. Specifies dental therapist scope of practice. Specifies permitted supervision ratios for dentists to dental therapists and dental therapists to dental assistants and expanded function dental assistants. Authorizes dental therapists to dispense and orally administer specified drugs. Requires dental therapists to purchase and maintain liability insurance. Requires dental therapists to dedicate at least 51 percent of practice to patients who represent underserved populations or practice in dental health professional shortage areas. Takes effect on 91st day following adjournment sine die.

## **ISSUES DISCUSSED:**

## **EFFECT OF AMENDMENT:**

- -A10 **Replaces measure**. Clarifies licensure qualification requirements. Removes January 1, 2025 limitation on dental therapy licensure for graduates of dental pilot project education programs. (**Section 3**) Clarifies dental therapist practice area requirements (**Section 10**).
- -A11 Removes requirement that prior to January 1, 2025 dental therapist applicants complete education program through a dental pilot project. Removes direct pulp capping of permanent teeth from dental therapist scope of practice.
- -A12 Clarifies dental therapist scope of practice for simple extractions of teeth.
- -A16 Requires that prior to January 1, 2025 dental therapist applicants complete education program through a dental pilot project. Clarifies that beginning January 1, 2025, completion of a dental therapy education program that was part of a dental pilot project or is accredited by the Commission on Dental Accreditation (CODA) is required for licensure as dental therapist. Requires collaborative agreement to include provision that requires dental therapist to consult with dentist if dental therapist intends to perform an irreversible surgical procedure under general supervision on a patient who has a severe systemic disease. Clarifies scope of practice for direct pulp capping of permanent teeth. Requires supervising dentist to review procedures and patient charts for procedures performed by dental therapist requiring indirect supervision.

-A17 Requires that prior to January 1, 2025 dental therapist applicants complete education program. Clarifies that beginning January 1, 2025, completion of a dental therapy education program that was part of a dental pilot project or is accredited by the Commission on Dental Accreditation (CODA) or participation in a dental pilot project is required for licensure as dental therapist. Requires collaborative agreement to include provision that requires dental therapist to consult with dentist if dental therapist intends to perform an irreversible surgical procedure under general supervision on a patient who has a severe systemic disease. Clarifies scope of practice for direct pulp capping of permanent teeth. Requires supervising dentist to review procedures and patient charts for procedures performed by dental therapist requiring indirect supervision.

#### **BACKGROUND:**

Senate Bill 738 (2011) authorized the Oregon Health Authority (OHA) to approve pilot projects encouraging the development of innovative practices in oral health delivery focusing on populations that have the highest disease rates and least access to dental care. In February 2016, OHA approved Pilot Project #100 ("Oregon Tribes Dental Health Aide Therapist Pilot Project") to develop a new category of dental personnel in Oregon and teach new oral health care roles to previously untrained individuals. The Pilot Project authorized the Northwest Portland Area Indian Health Board to utilize the Alaska Dental Health Aide Therapist (DHAT) program that has been providing services in Alaska for 11 years. The Alaska DHAT program is modeled off the international model of dental nurses who have been providing oral health services in nearly 100 countries around the world.

Several states have passed legislation authorizing the practice of dental therapy, including Maine, Vermont, Connecticut, Minnesota, Michigan, New Mexico, Arizona, and Nevada. In August 2020, the Commission on Dental Accreditation (CODA) accredited Ilisagvik College in Alaska to become the first dental therapy training program in the United States.

House Bill 2528 A creates dental therapy licensure in Oregon through the Oregon Board of Dentistry.
