Summary of Revenue Changes

HB 2345 makes a one-time General Fund appropriation of \$500,000 to Oregon Business Development Department (OBDD) to establish the Oregon Rural Capacity Fund.

Summary of Natural Resources Subcommittee Action

HB 2345 establishes the Oregon Rural Capacity Fund for the Department to provide resources to Oregon’s Economic Development Districts to assist rural jurisdictions to learn about, apply for, and administer grants from public and private sources. The bill appropriates \$500,000 into the newly established fund. The bill requires rural jurisdictions to use resources solely for staffing and building capacity necessary for workforce, infrastructure, economic, and community development. The bill also requires districts to file quarterly reports with OBDD about assistance given to rural jurisdictions.

OBDD must make the program operational by January 1, 2022. By September 15 of each year, OBDD is required to submit an annual report about the assistance program, to an interim committee of the legislative assembly related to economic development.
