House Bill 2222

Sponsored by Representative WILDE (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Modifies definition of "meeting" for purposes of public meetings law to state that meeting may occur without regard to location or stated purpose for which members of governing body convene.

Excludes one-on-one meetings of two members of governing body from definition of "meeting," even if serial one-on-one meetings take place between members of governing body. Establishes affirmative duty of chief administrative officer of public body or employee of public body who routinely and customarily advises governing body on public meetings law requirements to advise governing body on whether meeting content qualifies for executive session. Establishes joint and several liability for specified public body officers and employees who, with willful misconduct, fail or incorrectly advise governing body of meeting content's eligibility for executive session. Authorizes Oregon Government Ethics Commission to adopt rules establishing criteria for when

official or employee of public body has affirmative duty to advise on meeting content qualification for executive session. Authorizes commission to impose civil penalties on members of governing body or specified officers or employees of public body for conducting executive sessions in which meeting content does not meet executive session requirements.

4	SECTION 1. ORS 192.610 is amended to read:
5	192.610. As used in ORS 192.610 to 192.690:
6	(1) "Decision" means any determination, action, vote or final disposition upon a motion, pro-
7	posal, resolution, order, ordinance or measure on which a vote of a governing body is required, at
8	any meeting at which a quorum is present.
9	(2) "Executive session" means any meeting or part of a meeting of a governing body which is
10	closed to certain persons for deliberation on certain matters.
11	(3) "Governing body" means the members of any public body which consists of two or more
12	members, with the authority to make decisions for or recommendations to a public body on policy
13	or administration.
14	(4) "Public body" means the state, any regional council, county, city or district, or any municipal
15	or public corporation, or any board, department, commission, council, bureau, committee or sub-
16	committee or advisory group or any other agency thereof.
17	(5) "Meeting" :
18	(a) Means the convening of a governing body of a public body for which a quorum is required
19	in order to make a decision or to deliberate toward a decision on any matter, without regard to
20	the location at which, or the stated purpose for which, the governing body convenes. ["Meet-
21	ing"]
22	(b) Does not include:
23	(A) Any on-site inspection of any project or program[.];
24	(B) ["Meeting" also does not include] The attendance of members of a governing body at any

1 national, regional or state association to which the public body or the members belong[.]; or

2 (C) One-on-one meetings between two members of a governing body, even if two members 3 of a governing body constitute a quorum of the governing body or if serial one-on-one 4 meetings take place between members of the governing body, during which discussions about 5 one or more pending decisions of the governing body occur.

SECTION 2. ORS 192.660 is amended to read:

192.660. (1) ORS 192.610 to 192.690 do not prevent the governing body of a public body from
holding executive session during a regular, special or emergency meeting, after the presiding officer
has identified the authorization under ORS 192.610 to 192.690 for holding the executive session.

10 (2) The governing body of a public body may hold an executive session:

11 (a) To consider the employment of a public officer, employee, staff member or individual agent.

12 (b) To consider the dismissal or disciplining of, or to hear complaints or charges brought 13 against, a public officer, employee, staff member or individual agent who does not request an open 14 hearing.

(c) To consider matters pertaining to the function of the medical staff of a public hospital licensed pursuant to ORS 441.015 to 441.087 including, but not limited to, all clinical committees, executive, credentials, utilization review, peer review committees and all other matters relating to medical competency in the hospital.

(d) To conduct deliberations with persons designated by the governing body to carry on labornegotiations.

(e) To conduct deliberations with persons designated by the governing body to negotiate real
 property transactions.

23 (f) To consider information or records that are exempt by law from public inspection.

(g) To consider preliminary negotiations involving matters of trade or commerce in which the governing body is in competition with governing bodies in other states or nations.

(h) To consult with counsel concerning the legal rights and duties of a public body with regard
to current litigation or litigation likely to be filed.

(i) To review and evaluate the employment-related performance of the chief executive officer of
any public body, a public officer, employee or staff member who does not request an open hearing.

(j) To carry on negotiations under ORS chapter 293 with private persons or businesses regarding
 proposed acquisition, exchange or liquidation of public investments.

(k) To consider matters relating to school safety or a plan that responds to safety threats made
 toward a school.

34 (L) If the governing body is a health professional regulatory board, to consider information ob-35 tained as part of an investigation of licensee or applicant conduct.

36 (m) If the governing body is the State Landscape Architect Board, or an advisory committee to 37 the board, to consider information obtained as part of an investigation of registrant or applicant 38 conduct.

(n) To discuss information about review or approval of programs relating to the security of anyof the following:

1 (10) Notwithstanding ORS 244.290, the Oregon Government Ethics Commission may not adopt 2 rules that establish what entities are considered representatives of the news media that are entitled 3 to attend executive sessions under subsection (4) of this section.

4 (11) The chief administrative officer of a public body or any other employee of a public 5 body who routinely and customarily advises the governing body on the requirements of ORS 6 192.610 to 192.690 has an affirmative duty to advise a governing body on whether meeting 7 content qualifies for an executive session under this section.

SECTION 3. ORS 192.680 is amended to read:

9 192.680. (1) A decision made by a governing body of a public body in violation of ORS 192.610 10 to 192.690 shall be voidable. The decision shall not be voided if the governing body of the public 11 body reinstates the decision while in compliance with ORS 192.610 to 192.690. A decision that is 12 reinstated is effective from the date of its initial adoption.

(2) Any person affected by a decision of a governing body of a public body may commence a suit in the circuit court for the county in which the governing body ordinarily meets, for the purpose of requiring compliance with, or the prevention of violations of ORS 192.610 to 192.690, by members of the governing body, or to determine the applicability of ORS 192.610 to 192.690 to matters or decisions of the governing body.

18 (3) Notwithstanding subsection (1) of this section, if the court finds that the public body made 19 a decision while in violation of ORS 192.610 to 192.690, the court shall void the decision of the governing body if the court finds that the violation was the result of intentional disregard of the law 20or willful misconduct by a quorum of the members of the governing body, unless other equitable 2122relief is available. The court may order such equitable relief as it deems appropriate in the cir-23cumstances. The court may order payment to a successful plaintiff in a suit brought under this section of reasonable attorney fees at trial and on appeal, by the governing body, or public body of 2425which it is a part or to which it reports.

(4)(a) If the court makes a finding that a violation of ORS 192.610 to 192.690 has occurred under subsection (2) of this section and that the violation is the result of willful misconduct by any member or members of the governing body, that member or members shall be jointly and severally liable to the governing body or the public body of which it is a part for the amount paid by the body under subsection (3) of this section.

(b) If the court makes a finding that a violation of ORS 192.660 has occurred under subsection (2) of this section and that the violation is the result of willful misconduct of an officer or employee of the public body who had a duty to advise the governing body of the public body under ORS 192.660 (11), that officer or employee shall be jointly and severally liable to the governing body or the public body of which it is a part for the amount paid by the body under subsection (3) of this section.

(5) Any suit brought under subsection (2) of this section must be commenced within 60 days
 following the date that the decision becomes public record.

(6) The provisions of this section shall be the exclusive remedy for an alleged violation of ORS192.610 to 192.690.

24 244.350. (1) The Oregon Government Ethics Commission may impose civil penalties not to ex-25 ceed:

(a) Except as provided in paragraphs (b), (c) and (d) of this subsection, \$5,000 for violation of
 any provision of this chapter or any resolution adopted under ORS 244.160.

28 (b) \$25,000 for violation of ORS 244.045.

29 (c) \$10,000 for willfully violating ORS 244.040.

30 (d) Two times the amount of the penalty provision for violating a nondisclosure agreement that 31 is contained within each nondisclosure agreement entered into in violation of ORS 244.049.

(2)(a) Except as provided in paragraph (b) of this subsection, the commission may impose civil
 penalties not to exceed \$1,000 for violation of any provision of ORS 192.660.

(b) A civil penalty may not be imposed under this subsection if the violation occurred as a result
 of the governing body of the public body acting upon the advice of the public body's counsel.

(c) A civil penalty under this section may be imposed on one or more members of the
 governing body of the public body or on an officer or employee of the public body described
 in ORS 192.660 (11) for conducting an executive session in which meeting content does not
 meet executive session requirements.

(3) The commission may impose civil penalties not to exceed \$250 for violation of ORS 293.708.
A civil penalty imposed under this subsection is in addition to and not in lieu of a civil penalty that
may be imposed under subsection (1) of this section.

(4)(a) The commission may impose civil penalties on a person who fails to file the statement
required under ORS 244.050 or 244.217. In enforcing this subsection, the commission is not required
to follow the procedures in ORS 244.260 before finding that a violation of ORS 244.050 or 244.217

1 has occurred.

(b) Failure to file the required statement in timely fashion is prima facie evidence of a violation
of ORS 244.050 or 244.217.

4 (c) The commission may impose a civil penalty of \$10 for each of the first 14 days the statement 5 is late beyond the date set by law, or by the commission under ORS 244.050, and \$50 for each day 6 thereafter. The maximum penalty that may be imposed under this subsection is \$5,000.

7 (5) In lieu of or in conjunction with finding a violation of law or any resolution or imposing a 8 civil penalty under this section, the commission may issue a written letter of reprimand, explanation 9 or education.
