

HOUSE AMENDMENTS TO HOUSE BILL 2316

By COMMITTEE ON BEHAVIORAL HEALTH

1 On page 1 of the printed bill, line 2, after the semicolon delete the rest of the line and insert
2 “creating new provisions; amending ORS 458.380 and 458.385; repealing ORS 458.380; and declaring
3 an emergency.”.

4 Delete lines 4 through 11 and insert:

5 **“SECTION 1. (1) The Behavioral Health Housing Incentive Fund is established in the**
6 **State Treasury, separate and distinct from the General Fund. The Behavioral Health Housing**
7 **Incentive Fund consists of moneys deposited or transferred to the fund by the Legislative**
8 **Assembly and moneys appropriated to the fund by the Legislative Assembly. Interest earned**
9 **on the fund shall be credited to the fund.**

10 **“(2) Moneys in the Behavioral Health Housing Incentive Fund are continuously appro-**
11 **priated to the Oregon Health Authority to carry out the provisions of ORS 458.385.**

12 **“SECTION 2. On the effective date of this 2021 Act, interest earned on the Housing for**
13 **Mental Health Fund established in ORS 458.380 shall be transferred to the Behavioral Health**
14 **Housing Incentive Fund established in section 1 of this 2021 Act.**

15 **“SECTION 3. Any unobligated funds remaining in the Housing for Mental Health Fund**
16 **established in ORS 458.380 on June 30, 2022, shall be transferred to and deposited in the Be-**
17 **havioral Health Housing Incentive Fund established in section 1 of this 2021 Act.**

18 **“SECTION 4. ORS 458.380 is amended to read:**

19 **“458.380. [(1)] The Housing for Mental Health Fund is established in the State Treasury, sepa-**
20 **rate and distinct from the General Fund. The Housing for Mental Health Fund consists of moneys**
21 **deposited in the fund under section 8, chapter 812, Oregon Laws 2015, and may include moneys ap-**
22 **propriated, allocated, deposited or transferred to the fund by the Legislative Assembly or otherwise**
23 **and interest earned on moneys in the fund.**

24 **“[(2) Moneys in the fund are continuously appropriated to the Housing and Community Services**
25 **Department for disbursement for the purposes set forth in ORS 458.385.]”.**

26 In line 12, delete “2” and insert “5”.

27 In line 14, delete “Housing for Mental Health Fund” and insert “Behavioral Health Housing
28 Incentive Fund established in section 1 of this 2021 Act”.

29 On page 2, after line 20, insert:

30 **“SECTION 6. ORS 458.380 is repealed on June 30, 2022.**

31 **“SECTION 7. This 2021 Act being necessary for the immediate preservation of the public**
32 **peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect**
33 **on its passage.”.**
