House Bill 2606

Sponsored by Representative GOMBERG (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Includes identification card issued by province or territory of Canada as acceptable form of identification for purchase of alcoholic beverages.

A BILL FOR AN ACT

2	Relating to identification required for purchase of alcoholic beverages; amending ORS 471.130.
3	Be It Enacted by the People of the State of Oregon:
4	SECTION 1. ORS 471.130 is amended to read:
5	471.130. (1) [All licensees and permittees of the Oregon Liquor Control Commission,] Before selling
6	or serving an alcoholic [liquor] beverage to any person about whom there is any reasonable doubt
7	of the person's having reached 21 years of age, a licensee or permittee shall require [such] the
8	person to produce one of the following pieces of identification:
9	(a) The person's passport issued by the United States or a foreign government.
10	(b) The person's motor vehicle operator's license issued by this state or another state of the
11	United States or a province or territory of Canada.
12	(c) An identification card issued under ORS 807.400.
13	(d) A United States military identification card.
14	(e) An identification card issued by a federally recognized Indian tribe.
15	(f) Any other identification card issued by a state or territory of the United States or province
16	or territory of Canada that bears a picture of the person, the name of the person, the person's date
17	of birth and a physical description of the person.
18	(g) Proof of the person's participation in the Secure Electronic Network for Travelers Rapid
19	Inspection program operated by United States Customs and Border Protection, the NEXUS program
20	jointly operated by that agency and the Canada Border Services Agency, or a successor to either
21	of those programs that is recognized by the Oregon Liquor Control Commission.
22	(2) If a person does not have identification as described in subsection (1) of this section, the
23	permittee or licensee shall require [such] the person to make a written statement of age and furnish
24	evidence of the person's true age and identity. The written statement of age shall be on a form
25	furnished or approved by the commission, including but not limited to the following information:

29	I am 21 years of age or over.
