

HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2927

1 On page 84 of the printed A-engrossed bill, after line 42, insert:

3 **“FISCAL PROVISIONS**

5 **“SECTION 156. Notwithstanding any other provision of law, the General Fund appropri-**
6 **ation made to the Oregon Military Department by section 1 (3), chapter __, Oregon Laws**
7 **2021 (Enrolled Senate Bill 5535), for the biennium beginning July 1, 2021, for emergency**
8 **management, is increased by \$3,431,834 for preparing the Office of Emergency Management**
9 **as a separate state agency.**

10 **“SECTION 157. Notwithstanding any other provision of law, the General Fund appropri-**
11 **ation made to the Oregon Military Department by section 1 (1), chapter __, Oregon Laws**
12 **2021 (Enrolled Senate Bill 5535), for the biennium beginning July 1, 2021, for administration,**
13 **is increased by \$1,006,057 for preparing the Office of Emergency Management as a separate**
14 **state agency.**

15 **“SECTION 158. Notwithstanding any other law limiting expenditures, the limitation on**
16 **expenditures established by section 2 (4), chapter __, Oregon Laws 2021 (Enrolled Senate**
17 **Bill 5535), for the biennium beginning July 1, 2021, as the maximum limit for payment of ex-**
18 **penditures from fees, moneys or other revenues, including Miscellaneous Receipts and re-**
19 **imbursements from federal service agreements, but excluding lottery funds and federal funds**
20 **not described in section 2 (4), chapter __, Oregon Laws 2021 (Enrolled Senate Bill 5535),**
21 **collected or received by the Oregon Military Department, for community support, is in-**
22 **creased by \$5,000,000 for state active duty costs.**

23 **“SECTION 159. In addition to and not in lieu of any other appropriation, there is appro-**
24 **priated to the Emergency Board, for the biennium beginning July 1, 2021, out of the General**
25 **Fund, the amount of \$1,807,561, to be allocated to the Department of State Police for pre-**
26 **paring the office of the State Fire Marshal as a separate state agency.**

27 **“SECTION 160. In addition to and not in lieu of any other appropriation, there is appro-**
28 **priated to the Office of the Governor, for the biennium beginning July 1, 2021, out of the**
29 **General Fund, the amount of \$237,161 to support the work of the Oregon Homeland Security**
30 **Council.”.**
