

House Bill 2927

Sponsored by Representatives EVANS, GOMBERG; Representatives LEWIS, MEEK, NOBLE, POST, RAYFIELD, WILLIAMS (at the request of former Representative Carla Piluso) (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Renames Office of Emergency Management as Oregon Department of Emergency Management. Establishes department as independent state agency. Vests in department emergency authority regarding public health emergencies, emergency quarantines and conflagrations. Transfers rulemaking authority regarding nuclear emergencies from State Department of Energy to Oregon Department of Emergency Management. Directs department to carry out certain functions related to regional and statewide emergency preparedness.

Transfers Oregon Emergency Response System from Department of State Police to Oregon Department of Emergency Management.

Renames office of State Fire Marshal as Department of the State Fire Marshal and establishes department as independent state agency. Transfers search and rescue functions from Office of Emergency Management to department. Requires State Fire Marshal to establish guidelines for wildfire buffer zones that produce defensible spaces around lands in forestland-urban interface.

Transfers Oregon Homeland Security Council to Office of Governor and renames as Oregon Homeland Security Commission. Adds members to and modifies duties of commission.

Establishes Emergency Preparedness Advisory Council to advise and make policy recommendations to Oregon Homeland Security Commission regarding federal emergency support functions.

Establishes Local Government Emergency Management Advisory Council to provide advice and recommendations to Oregon Department of Emergency Management regarding department's emergency preparedness and response functions.

Becomes operative on July 1, 2023.

Be It Enacted by the People of the State of Oregon:

RENAMING AND REORGANIZATION OF THE OFFICE OF EMERGENCY MANAGEMENT

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 **SECTION 1.** (1) The amendments to ORS 401.052, 401.054, 401.062, 401.072, 401.076, 401.082,
 2 401.088 and 401.092 by sections 2 to 9 of this 2021 Act are intended to change the name of the
 3 “Office of Emergency Management” to the “Oregon Department of Emergency
 4 Management” and to establish that entity as a state agency independent from the Oregon
 5 Military Department.

6 (2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel
 7 may substitute for words designating the “Office of Emergency Management,” wherever they
 8 occur in statutory law, other words designating the “Oregon Department of Emergency
 9 Management.”

10 **SECTION 2.** ORS 401.052 is amended to read:

11 401.052. (1) The [*Office*] **Oregon Department** of Emergency Management is established [*in the*
 12 *Oregon Military Department*].

13 (2) The [*office*] **department** shall be responsible for:

14 (a) Coordinating and facilitating private sector and governmental efforts to prevent, prepare for,
 15 respond to and recover from emergencies; and

16 (b) Coordinating exercises and training, planning, preparedness, response, mitigation and recov-
 17 ery activities with state and local emergency services agencies and organizations.

18 (3) The [*office*] **department** shall prepare a statewide emergency management plan and update
 19 the plan from time to time as necessary.

20 **SECTION 3.** ORS 401.054 is amended to read:

21 401.054. (1) Each of the following agencies, entities and officials shall designate an individual to
 22 act as a liaison with the [*Office*] **Oregon Department** of Emergency Management:

- 23 (a) The Department of Consumer and Business Services;
- 24 (b) The Department of Corrections;
- 25 (c) The Department of Education;
- 26 (d) The Department of Environmental Quality;
- 27 (e) The Department of Human Services;

11 (2) Each agency, entity and official required to designate a liaison under this section shall des-
 12 ignate an individual who has authority during an emergency to allocate resources and assets of the
 13 agency, entity or official.

14 (3) Each individual designated as a liaison under subsection (1) of this section shall assist in the
 15 coordination of the functions of the agency, entity or official that designated the individual that
 16 relate to emergency preparedness and response with similar functions of the [Office] **Oregon De-**
 17 **partment** of Emergency Management.

18 **SECTION 4.** ORS 401.062 is amended to read:

19 401.062. (1) The [Office] **Oregon Department** of Emergency Management is under the super-
 20 vision and control of a director, who is responsible for the performance of the duties, functions and
 21 powers of the [office] **department**.

22 (2) [The Adjutant General, with the approval of] The Governor[,] shall appoint the Director of the
 23 [Office] **Oregon Department** of Emergency Management, who holds office at the pleasure of the
 24 [Adjutant General.] **Governor. The appointment of the director is subject to confirmation by**
 25 **the Senate in the manner prescribed by ORS 171.562 and 171.565.**

26 (3) The director shall be paid a salary as provided by law or, if not so provided, as prescribed
 27 by [the Adjutant General, with the approval of] the Governor.

28 (4) For purposes of administration, subject to the approval of the [Adjutant General] **Governor,**
 29 the director may organize and reorganize the [office] **department** as the director considers neces-
 30 sary to properly conduct the work of the [office] **department**.

31 (5) The director may divide the functions of the [office] **department** into administrative divi-
 32 sions. Subject to the approval of the [Adjutant General] **Governor,** the director may appoint an in-
 33 dividual to administer each division. The administrator of each division serves at the pleasure of the
 34 director and is not subject to the provisions of ORS chapter 240. Each individual appointed under
 35 this subsection must be well qualified by technical training and experience in the functions to be
 36 performed by the individual.

37 **SECTION 5.** ORS 401.072 is amended to read:

38 401.072. (1) The Director of the [Office] **Oregon Department** of Emergency Management may,
 39 by written order filed with the Secretary of State, appoint a deputy director. The deputy director
 40 serves at the pleasure of the director, has authority to act for the director in the absence of the
 41 director and is subject to the control of the director at all times.

42 (2) Subject to any applicable provisions of ORS chapter 240, the director shall appoint all sub-
 43 ordinate officers and employees of the [Office of Emergency Management] **department,** prescribe
 44 their duties and fix their compensation.

45 **SECTION 6.** ORS 401.076 is amended to read:

1 401.076. In accordance with applicable provisions of ORS chapter 183, the Director of the
2 [Office] **Oregon Department** of Emergency Management may adopt rules necessary for the admin-
3 istration of the laws that the [Office of Emergency Management] **department** is charged with ad-
4 ministering.

5 **SECTION 7.** ORS 401.092 is amended to read:

6 401.092. (1) The Director of the [Office] **Oregon Department** of Emergency Management is re-
7 sponsible for coordinating and facilitating exercises and training, emergency planning, preparedness,
8 response, mitigation and recovery activities with the state and local emergency services agencies
9 and organizations, and shall[, *with the approval of the Adjutant General or as directed by the Gover-*
10 *nor*]:

11 (a) Make rules that are necessary and proper for the administration and implementation of this
12 chapter;

13 (b) Coordinate the activities of all public and private organizations specifically related to pro-
14 viding emergency services within this state;

15 (c) Maintain a cooperative liaison with emergency management agencies and organizations of
16 local governments, other states and the federal government;

41 401.082. (1) To aid and advise the Director of the [Office] **Oregon Department** of Emergency
42 Management in the performance of the functions of the [Office] **Oregon Department** of Emergency
43 Management, the director may establish such advisory and technical committees as the director
44 considers necessary. The committees may be continuing or temporary. The director shall determine
45 the representation, membership, terms and organization of the committees and shall appoint their

1 members. The director is an ex officio member of each committee.

2 (2) Members of the committees are not entitled to compensation, but in the discretion of the
 3 director may be reimbursed from funds available to the [office] **department** for actual and necessary
 4 travel and other expenses incurred by them in the performance of their official duties in the manner
 5 and amount provided in ORS 292.495.

6 **SECTION 9.** ORS 401.088 is amended to read:

7 401.088. The Director of the [Office] **Oregon Department** of Emergency Management may enter
 8 into interagency agreements with other state agencies that the director determines are necessary
 9 to carry out the duties of the [Office] **Oregon Department** of Emergency Management.

13 **SECTION 10.** (1) **The unexpended balances of amounts authorized to be expended by the**
 14 **Oregon Military Department for purposes of the Office of Emergency Management for the**
 15 **biennium beginning July 1, 2023, from revenues dedicated, continuously appropriated, appro-**
 16 **propriated or otherwise made available to the department, are transferred to and are available**
 17 **for expenditure by the Oregon Department of Emergency Management for the biennium be-**
 18 **ginning July 1, 2023.**

19 (2) **The expenditure classifications, if any, established by Acts authorizing or limiting**
 20 **expenditures by the Office of Emergency Management remain applicable to expenditures by**
 21 **the Oregon Department of Emergency Management under this section.**

25 **SECTION 11.** **The amendments to ORS 401.052, 401.054, 401.062, 401.072, 401.076, 401.082,**
 26 **401.088 and 401.092 by sections 2 to 9 of this 2021 Act do not affect any action, proceeding or**
 27 **prosecution involving or with respect to any duties, functions and powers of the Office of**
 28 **Emergency Management begun before and pending as of the operative date specified in sec-**
 29 **tion 155 of this 2021 Act, except that the Oregon Department of Emergency Management is**
 30 **substituted for the Office of Emergency Management in any such action, proceeding or**
 31 **prosecution.**

35 **SECTION 12.** (1) **Nothing in the amendments to ORS 401.052, 401.054, 401.062, 401.072,**
 36 **401.076, 401.082, 401.088 and 401.092 by sections 2 to 9 of this 2021 Act relieves a person of a**
 37 **liability, duty or obligation accruing under or with respect to the duties, functions and pow-**
 38 **ers conferred by those statutes prior to the operative date specified in section 155 of this 2021**
 39 **Act. The Oregon Department of Emergency Management may undertake the collection or**
 40 **enforcement of any such liability, duty or obligation.**

41 (2) **The rights and obligations of the Office of Emergency Management legally incurred**
 42 **under contracts, leases and business transactions executed, entered into or begun before the**
 43 **operative date specified in section 155 of this 2021 Act are transferred to the Oregon De-**
 44 **partment of Emergency Management. For the purpose of succession to these rights and ob-**
 45 **ligations, the Oregon Department of Emergency Management is a continuation of the Office**

5 **SECTION 13.** The rules of the Office of Emergency Management in effect on the opera-
6 tive date specified in section 155 of this 2021 Act continue in effect until superseded or re-
7 pealed by rules of the Oregon Department of Emergency Management. References in rules
8 of the Office of Emergency Management to the Office of Emergency Management or an of-
9 ficer or employee of the Office of Emergency Management are considered to be references
10 to the Oregon Department of Emergency Management or an officer or employee of the
11 Oregon Department of Emergency Management.

12 **SECTION 14.** Whenever, in any statutory law or resolution of the Legislative Assembly
13 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-
14 erence is made to the Office of Emergency Management or an officer or employee of the
15 Office of Emergency Management, the reference is considered to be a reference to the
16 Oregon Department of Emergency Management or an officer or employee of the Oregon
17 Department of Emergency Management.

21 **SECTION 15.** The Director of the Office of Emergency Management on the operative date
22 specified in section 155 of this 2021 Act shall serve as the initial Director of the Oregon De-
23 partment of Emergency Management at the pleasure of the Governor and without the need
24 for confirmation by the Senate.

29 **SECTION 16.** ORS 401.094 is amended to read:

30 401.094. (1)(a) The **Oregon** Department of [*State Police*] **Emergency Management** shall main-
31 tain a system for the notification and interagency coordination of state resources in response to
32 emergencies involving multijurisdictional cooperation between the various levels of government and
33 private business entities.

34 [*(b) The department shall provide the Office of Emergency Management with a service level*
35 *agreement that describes the continued daily operations and maintenance of the system, the services and*
36 *supplies needed to maintain the system 24 hours a day, every day of the year, and the policies and*
37 *procedures that support the overall notification system.*]

38 (2) The [*notification*] system shall be managed by the [*Office of Emergency Management*] **de-**
39 **partment** as a continuously available communications network and a component of the [*state's*]
40 **State Emergency Operations Center.**

41 (3) The [*notification*] system shall be the primary point of contact by which any public agency
42 provides the state notification of an emergency or disaster, or requests access to state and federal
43 resources.

44 (4) Each department of state government, and those agencies of state government identified in
45 the statewide emergency management plan prepared under ORS 401.052 as having emergency service

1 or administrative responsibilities, shall appoint an emergency management coordinator as their
 2 representative to work with the [*Office of Emergency Management*] **department** on the development
 3 and implementation of emergency plans and procedures.

4 (5) The [*Office of Emergency Management*] **department** shall adopt rules relating to the plan-
 5 ning, administration and operation of the [*notification*] system maintained under this section.

6 **SECTION 17.** ORS 433.441 is amended to read:

7 433.441. (1) Upon the occurrence of a public health emergency, the Governor may declare a state
 8 of public health emergency as authorized by ORS 433.441 to 433.452 to protect the public health.

9 (2) A [*proclamation*] **declaration** of a state of public health emergency must specify:

- 10 (a) The nature of the public health emergency;
- 11 (b) The political subdivision or geographic area subject to the [*proclamation*] **declaration**;
- 12 (c) The conditions that have brought about the public health emergency; and
- 13 (d) The duration of the state of public health emergency, if the duration is less than 14 days.

14 (3) During a **declared** public health emergency, the Governor **or the Director of the Oregon**
 15 **Department of Emergency Management** may:

16 (a) Close, order the evacuation of or **order** the decontamination of any facility the Governor
 17 **or the director** has reasonable cause to believe may endanger the public health.

18 (b) Regulate or restrict by any means necessary the use, sale or distribution of food, fuel, med-
 19 ical supplies, medicines or other goods and services.

20 (c) Prescribe modes of transportation, routes and destinations required for the evacuation of
 21 individuals or the provision of emergency services.

22 (d) Control or limit entry into, exit from, movement within and the occupancy of premises in any
 23 public area subject to or threatened by a public health emergency if such actions are reasonable
 24 and necessary to respond to the public health emergency.

25 (e) Authorize pharmacists licensed under ORS chapter 689 to administer vaccines to persons
 26 who are three years of age or older.

27 (f) Take any other action that may be necessary for the management of resources, or to protect
 28 the public during a public health emergency, including any actions [*authorized*] **the Governor may**
 29 **take** under ORS 401.168, 401.185, 401.188 and 401.192.

30 (4) Nothing in ORS 433.441 to 433.452 limits the authority of the Governor to declare a state
 31 of emergency under ORS 401.165. If a state of emergency is declared as authorized under ORS
 32 401.165, the Governor **or the director** may implement any action authorized by ORS 433.441 to
 33 433.452.

34 (5) A [*proclamation*] **declaration** of a state of public health emergency expires when terminated
 35 by a declaration of the Governor or no more than 14 days after the date the public health emergency
 36 is [*proclaimed*] **declared** unless the Governor expressly extends the [*proclamation*] **declaration** for
 37 an additional 14-day period.

38 (6) When real or personal property is taken under power granted by this section, the owner of
 39 the property shall be entitled to reasonable compensation from the state.

1 (c) “Individual” means a natural person.

2 (d) “Individually identifiable health information” means any oral or written health information
3 in any form or medium that is:

4 (A) Created or received by a covered entity, an employer or a health care provider that is not
5 a covered entity; and

6 (B) Identifiable to an individual, including demographic information that identifies the individual,
7 or for which there is a reasonable basis to believe the information can be used to identify an indi-
8 vidual, and that relates to:

9 (i) The past, present or future physical or mental health or condition of an individual;

10 (ii) The provision of health care to an individual; or

11 (iii) The past, present or future payment for the provision of health care to an individual.

12 (e) “Legal representative” means attorney at law, person holding a general power of attorney,
13 guardian, conservator or any person appointed by a court to manage the personal or financial affairs
14 of a person, or agency legally responsible for the welfare or support of a person.

15 (2)(a) During a **state of** public health emergency declared under ORS 433.441, the Public Health
16 Director, **after consultation with the Director of the Oregon Department of Emergency**
17 **Management**, may, as necessary to appropriately respond to the public health emergency:

18 (A) Adopt reporting requirements for and provide notice of those requirements to health care
19 providers, institutions and facilities for the purpose of obtaining information directly related to the
20 public health emergency;

21 (B) After consultation with appropriate medical experts, create and require the use of diagnostic
22 and treatment protocols to respond to the public health emergency and provide notice of those
23 protocols to health care providers, institutions and facilities;

24 (C) Order, or authorize local public health administrators to order, public health measures ap-
25 propriate to the public health threat presented;

27 who are three years of age or older;

30 notice of those actions to health care providers, institutions and facilities, including public health
31 actions authorized by ORS 431A.015;

32 (F) Take any enforcement action authorized by ORS 431A.010, including the imposition of civil
33 penalties of up to \$500 per day against individuals, institutions or facilities that knowingly fail to
34 comply with requirements resulting from actions taken in accordance with the powers granted to
35 the Public Health Director under subparagraphs (A), (B) and (E) of this paragraph; and

36 (G) The authority granted to the Public Health Director under this section:

37 (i) Supersedes any authority granted to a local public health authority if the local public health
38 authority acts in a manner inconsistent with guidelines established or rules adopted by the **Public**
39 **Health** Director under this section; and

40 (ii) Does not supersede the general authority granted to a local public health authority or a
41 local public health administrator except as authorized by law or necessary to respond to a public
42 health emergency.

43 (b) The authority of the Public Health Director to take administrative action, and the effec-

16 (4) The State Chief Information Officer shall contract with qualified, independent consultants for
17 the purpose of conducting vulnerability assessments under subsection (3) of this section.

18 (5) In collaboration with appropriate agencies, the State Chief Information Officer shall develop
19 and implement policies for responding to events that damage or threaten the availability, integrity
20 or confidentiality of information systems or the information stored in information systems, whether
21 those systems are within, interoperable with or outside the state's shared computing and network
22 infrastructure. In the policies, the State Chief Information Officer shall prescribe actions reasonably
23 necessary to:

24 (a) Promptly assemble and deploy in a coordinated manner the expertise, tools and methodol-
25 ogies required to prevent or mitigate the damage caused or threatened by an event;

26 (b) Promptly alert other persons of the event and of the actions reasonably necessary to prevent
27 or mitigate the damage caused or threatened by the event;

28 (c) Implement forensic techniques and controls developed under subsection (6) of this section;

29 (d) Evaluate the event for the purpose of possible improvements to the security of information
30 systems; and

31 (e) Communicate and share information with appropriate agencies, using preexisting incident
32 response capabilities.

33 (6) After consultation and collaborative development with appropriate agencies and the Oregon
34 Department of Administrative Services, the State Chief Information Officer shall implement forensic
35 techniques and controls for the security of information systems, whether those systems are within,

2 (8)(a) State agencies are responsible for securing computers, hardware, software, storage media,

7 (f) The [office] **department** shall conduct periodic inspections of preparedness equipment dis-

11 preparedness equipment or require the recipient to reimburse the [office] **department** for the cost

5 the extent necessary for the proper presentation of an unemployment insurance claim.

6 (b) Upon request to the United States Secretary of Labor. The Employment Department shall
7 disclose the information in a form and containing the information that the United States Secretary
8 of Labor may require. The information disclosed is confidential and may not be used for any other
9 purpose.

10 (c) Pursuant to section 303(a)(7) of the Social Security Act, upon request to any agency of the
11 United States charged with the administration of public works or assistance through public em-
12 ployment. Under this paragraph, the Employment Department shall disclose the name, address, or-

 16 cancellation, waiver, reduction or compromise of fees, penalties or interest, subpoenaing and exam-
 17 ining witnesses and books and papers, and the issuance of warrants and the procedures relating
 18 thereto, shall apply to the collection of fees, penalties and interest by the Department of Revenue
 19 under this section, except where the context requires otherwise.

20 (7) All moneys received by the Department of Revenue under this section shall be deposited in
 21 the State Treasury and credited to a suspense account established under ORS 293.445. After pay-
 22 ment of administration expenses incurred by the department in the administration of this section and
 23 of refunds or credits arising from erroneous overpayments, the balance of the money shall be
 24 transferred to the High Hazard Train Route Oil Spill Preparedness Fund established under [section
 25 14 of this 2019 Act] **ORS 468B.435** and to the Oil and Hazardous Material Transportation by Rail
 26 Action Fund established under ORS 453.394, in the proportionate amounts that each agency found
 27 and determined to be necessary under subsection (2) of this section.

 31 **SECTION 147.** ORS 401.109 is amended to read:

32 401.109. (1) The Oregon Homeland Security [Council] **Commission** is created within the Office
 33 of [Emergency Management] **the Governor**. The [council] **commission** shall:

34 [(a) Receive briefings on security matters:]

35 [(A) For which the office is responsible at least annually from state agencies and organizations as
 36 determined by the council; and]

37 [(B) Relating to catastrophic disasters declared by the Governor pursuant to Article X-A, section
 38 1, of the Oregon Constitution, or states of emergency declared by the Governor pursuant to ORS
 39 401.165.]

40 (a) **Develop strategies for the effective coordination of the emergency planning,**
 41 **preparedness and response, mitigation and recovery activities of state agencies.**

42 (b) **Receive briefings from state agencies on security matters, as determined by the**
 43 **commission, including but not limited to security matters relating to:**

44 (A) **Catastrophic disasters declared by the Governor pursuant to Article X-A, section 1,**
 45 **of the Oregon Constitution;**

- 1 **(B) States of emergency declared by the Governor pursuant to ORS 401.165;**
- 2 **(C) Public health emergencies declared by the Governor pursuant to ORS 433.441;**
- 3 **(D) The exercise of the Governor’s authority under ORS 476.520; and**
- 4 **(E) Emergency quarantines ordered by the Director of the Oregon Department of**
- 5 **Emergency Management pursuant to ORS 561.560.**

6 *[(b)]* **(c) Advise state agencies with responsibility for security matters [on the future direction of**
 7 *the office’s planning, preparedness, response and recovery activities]* **to facilitate the coordination**
 8 **of the agencies’ emergency preparedness and response functions.**

9 (2) The membership of the *[council]* **commission** consists of:

10 (a) Four members from the Legislative Assembly appointed as follows:

11 (A) Two members from the Senate appointed by the President of the Senate; and

12 (B) Two members from the House of Representatives appointed by the Speaker of the House of
 13 Representatives;

14 (b) The Governor;

15 (c) The Adjutant General;

16 (d) The Superintendent of State Police;

17 (e) The Director of the *[Office]* **Oregon Department** of Emergency Management; and

18 (f) A representative of the Department of Justice appointed by the Attorney General.

19 **(g) The State Resilience Officer;**

20 **(h) The State Fire Marshal;**

21 **(i) The Director of the Department of Public Safety Standards and Training;**

22 **(j) The Director of the Oregon Health Authority;**

23 **(k) The Director of Transportation;**

24 **(L) The State Forester;**

25 **(m) The Director of the Department of Corrections;**

26 **(n) The Superintendent of State Police; and**

27 **(o) One member appointed by the Governor to act as a senior policy advisor for emer-**
 28 **gency operations.**

29 (3) Each member appointed to the *[council]* **commission** under subsection *[(2)]* **(2)(a), (f) and**
 30 **(m)** of this section serves at the pleasure of the appointing authority. The membership of a public
 31 official ceases upon termination of the office held by the official at the time of appointment to the
 32 *[council]* **commission.**

33 (4) The Governor is the chairperson of the *[council]* **commission.**

34 (5) The *[Adjutant General]* **Director of the Oregon Department of Emergency Management**
 35 is the vice chairperson of the *[council]* **commission** and serves as the chairperson in the absence
 36 of the Governor.

37 (6) Members of the *[council]* **commission** are not entitled to compensation under ORS 292.495.
 38 The *[director]* **Governor**, in the *[director’s]* **Governor’s** discretion, may reimburse members of the
 39 *[council]* **commission** as provided in ORS 292.495 for actual and necessary travel or other expenses
 40 incurred in the performance of their duties as members of the *[council]* **commission.**

41 **(7) A majority of the members of the commission constitutes a quorum for the trans-**
 42 **action of business.**

43 **(8) Official action by the commission requires the approval of a majority of the members**
 44 **of the commission.**

45 **(9) If there is a vacancy for any cause, the appointing authority shall make an appoint-**

1 ment to become immediately effective.

2 (10) The commission shall meet at least once per month at places specified by the call
3 of the chairperson or of a majority of the members of the commission.

4 (11) The commission may adopt rules necessary for the operation of the commission.

5 (12) The commission may employ and fix the compensation of such professional assist-
6 ants and clerical and other employees as the commission deems necessary for the effective
7 conduct of its work.

8 (13) All agencies of state government, as defined in ORS 174.111, are directed to assist
9 the commission in the performance of the duties of the commission and, to the extent per-
10 mitted by laws relating to confidentiality, to furnish information and advice the members of
11 the commission consider necessary to perform their duties.

15 **SECTION 148.** (1) The unexpended balances of amounts authorized to be expended by the
16 Office of Emergency Management for purposes of the Oregon Homeland Security Council for
17 the biennium beginning July 1, 2023, from revenues dedicated, continuously appropriated,
18 appropriated or otherwise made available to the office, are transferred to and are available
19 for expenditure by the Office of the Governor for purposes of the Oregon Homeland Security
20 Commission for the biennium beginning July 1, 2023.

21 (2) The expenditure classifications, if any, established by Acts authorizing or limiting
22 expenditures by the Office of Emergency Management remain applicable to expenditures by
23 the Office of the Governor under this section.

25 (Action, Proceeding, Prosecution)

27 **SECTION 149.** The amendments to ORS 401.109 by section 147 of this 2021 Act do not af-
28 fect any action, proceeding or prosecution involving or with respect to any duties, functions
29 and powers of the Oregon Homeland Security Council begun before and pending as of the
30 operative date specified in section 155 of this 2021 Act, except that the Oregon Homeland
31 Security Commission is substituted for the Oregon Homeland Security Council in any such
32 action, proceeding or prosecution.

34 (Liability, Duty, Obligation)

36 **SECTION 150.** (1) Nothing in the amendments to ORS 401.109 by section 147 of this 2021
37 Act relieves a person of a liability, duty or obligation accruing under or with respect to the
38 duties, functions and powers conferred by that statute prior to the operative date specified
39 in section 155 of this 2021 Act. The Oregon Homeland Security Commission may undertake
40 the collection or enforcement of any such liability, duty or obligation.

41 (2) The rights and obligations of the Oregon Homeland Security Council legally incurred
42 under contracts, leases and business transactions executed, entered into or begun before the
43 operative date specified in section 155 of this 2021 Act are transferred to the Oregon Home-
44 land Security Commission. For the purpose of succession to these rights and obligations, the
45 Oregon Homeland Security Commission is a continuation of the Oregon Homeland Security

5 **SECTION 150a.** (1) The amendments to ORS 401.109 by section 147 of this 2021 Act are
6 intended to change the name of the “Oregon Homeland Security Council” to the “Oregon

8 (2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel

26 **EMERGENCY PREPAREDNESS ADVISORY COUNCIL**

28 **SECTION 151.** (1) The Emergency Preparedness Advisory Council is established.

29 (2) The council consists of 13 members appointed as follows:

30 (a) One member appointed by the Adjutant General to represent the Oregon Military
31 Department;

32 (b) One member appointed by the Director of the Oregon Department of Emergency
33 Management to represent the Oregon Department of Emergency Management;

34 (c) One member appointed by the State Fire Marshal to represent the Department of the
35 State Fire Marshal;

36 (d) One member appointed by the Superintendent of State Police to represent the De-
37 partment of State Police;

38 (e) One member appointed by the Director of the Department of Public Safety Standards
39 and Training to represent the Department of Public Safety Standards and Training;

40 (f) One member appointed by the Director of the Oregon Health Authority to represent
41 the Oregon Health Authority;

42 (g) One member appointed by the Director of Transportation to represent the Depart-
43 ment of Transportation;

44 (h) One member appointed by the Attorney General to represent the Department of
45 Justice;

1 (i) One member appointed by the State Forester to represent the State Forestry De-
2 partment; and

3 (j) Four members appointed by the Governor as follows:

4 (A) One member to represent counties;

5 (B) One member to represent cities;

6 (C) One member with experience in emergency preparedness to represent regional or-
7 ganizations; and

8 (D) One member with experience in emergency preparedness to represent local organ-
9 izations.

10 (3) The council shall advise and make policy recommendations to the Oregon Homeland
11 Security Commission regarding federal emergency support functions.

12 (4) A majority of the members of the Emergency Preparedness Advisory Council consti-
13 tutes a quorum for the transaction of business.

14 (5) Official action by the council requires the approval of a majority of the members of
15 the council.

16 (6) The council shall elect one of its members to serve as chairperson.

17 (7) If there is a vacancy for any cause, the appointing authority shall make an appoint-
18 ment to become immediately effective.

19 (8) The council shall meet at least once quarterly at the place specified by the call of the
20 chairperson or of a majority of the members of the council.

21 (9) The council may adopt rules necessary for the operation of the council.

22 (10) The Oregon Department of Emergency Management shall provide staff support to
23 the council.

24 (11) Members of the council are not entitled to compensation or reimbursement for ex-
25 penses and serve as volunteers on the council.

26 (12) All agencies of state government, as defined in ORS 174.111, are directed to assist
27 the council in the performance of the duties of the council and, to the extent permitted by
28 laws relating to confidentiality, to furnish information and advice the members of the council
29 consider necessary to perform their duties.

30
31 **LOCAL GOVERNMENT EMERGENCY MANAGEMENT ADVISORY COUNCIL**

32
33 **SECTION 152.** (1) The Local Government Emergency Management Advisory Council is
34 established.

35 (2) The council consists of 10 members appointed by the Governor as follows:

36 (a) One member to represent an organization representing Oregon counties;

37 (b) One member to represent an organization representing Oregon cities;

38 (c) One member to represent emergency medical service providers;

39 (d) One member to represent fire departments;

40 (e) One member to represent a statewide association of emergency managers, emergency
41 responders, government agencies and elected officials committed to minimizing the impact
42 of disasters in Oregon;

43 (f) One member to represent county sheriffs;

44 (g) One member to represent volunteer emergency medical service providers; and

45 (h) Three members with experience relating to emergency preparedness or management

1 to represent the public.

2 (3) The council shall provide advice and recommendations to the Oregon Department of
3 Emergency Management regarding its emergency preparedness and response functions.

4 (4) A majority of the members of the council constitutes a quorum for the transaction
5 of business.

6 (5) Official action by the council requires the approval of a majority of the members of
7 the council.

8 (6) The council shall elect one of its members to serve as chairperson.

9 (7) If there is a vacancy for any cause, the Governor shall make an appointment to be-
10 come immediately effective.

11 (8) The council shall meet at times and places specified by the call of the chairperson or
12 of a majority of the members of the council.

13 (9) The council may adopt rules necessary for the operation of the council.

14 (10) The department shall provide staff support to the council.

15 (11) Members of the council are not entitled to compensation or reimbursement for ex-
16 penses and serve as volunteers on the council.

17 (12) All agencies of state government, as defined in ORS 174.111, are directed to assist
18 the council in the performance of the duties of the council and, to the extent permitted by
19 laws relating to confidentiality, to furnish information and advice the members of the council
20 consider necessary to perform their duties.

21 **SECTION 153.** The Governor or the following agencies may take any action before the
22 operative date specified in section 155 of this 2021 Act that is necessary for the Governor or
23 agency to exercise, on or after the operative date specified in section 155 of this 2021 Act,
24 all of the duties, functions and powers conferred on the Governor or the agency by sections
25 1, 10 to 15, 25a, 91 to 97, 104 to 107a and 148 to 152 of this 2021 Act and the amendments to
26 statutes and session law by sections 2 to 9, 16 to 25, 26 to 88, 90, 98 to 103 and 108 to 147 of
27 this 2021 Act:

- 28 (1) The Office of Emergency Management;
- 29 (2) The Oregon Military Department;
- 30 (3) The State Fire Marshal;
- 31 (4) The Department of State Police; or
- 32 (5) The Oregon Homeland Security Council.

33 **SECTION 154.** The Governor and the following agencies shall report to the appropriate
34 interim committees of the Legislative Assembly no later than September 15 of each year
35 before the operative date specified in section 155 of this 2021 Act on the actions taken that
36 are necessary for the Governor or agency to exercise, on or after the operative date specified
37 in section 155 of this 2021 Act, all of the duties, functions and powers conferred on the
38 Governor or the agency by sections 1, 10 to 15, 25a, 91 to 97, 104 to 107a and 148 to 152 of this
39 2021 Act and the amendments to statutes and session law by sections 2 to 9, 16 to 25, 26 to
40 88, 90, 98 to 103 and 108 to 147 of this 2021 Act:

- 41 (1) The Office of Emergency Management;
- 42 (2) The Oregon Military Department;
- 43 (3) The State Fire Marshal;
- 44 (4) The Department of State Police; and
- 45 (5) The Oregon Homeland Security Council.

OPERATIVE DATE
