SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

[Requires Department of Public Safety Standards and Training to investigate person's character before accepting person for training and certification as police officer or reserve officer.]

[Directs department to adopt rules prohibiting officers from racist behaviors.]

[Requires law enforcement agency that obtains evidence that law enforcement officer has engaged in racist behavior to provide evidence to district attorney within 14 days.]

[Directs Governor to convene task force to develop plan for removing peace officers who have discriminatory sentiments that would violate the rights of protected classes.] [Directs Bureau of Labor and Industries to establish and maintain hotline for reports of officer

misconduct.]

States legislative findings about racism and public safety. Requires Department of Public Safety Standards and Training to create uniform back-ground checklist and standardized personal history questionnaire for use by law enforcement units in hiring public safety officers.

Directs law enforcement units to adopt policies that set standards for speech and expression by police officers and reserve officers.

Requires employers to provide employment information to law enforcement units for purpose of hiring public safety officers.

Exempts law enforcement units from prohibition on employer access to personal social media accounts.

A BILL FOR AN ACT

Relating to law enforcement officers; creating new provisions; and amending ORS 659A.330. $\mathbf{2}$

Be It Enacted by the People of the State of Oregon: 3

SECTION 1. Sections 2 to 4 of this 2021 Act are added to and made a part of ORS 181A.355 4

to 181A.670. 5

SECTION 2. The Legislative Assembly finds that: 6

7 (1) Racism has no place in public safety.

(2) Law enforcement officers hold a unique position in our community and must demon-8

strate principles of equity, transparency, honesty and trust with all members of society. 9

(3) Membership or participation in hate groups, racial supremacist organizations or mil-10 itant groups erodes public trust in law enforcement officers and community safety.

(4) Participation in racist organizations and displays of symbols of racism or racial su-

premacy are at odds with the position of trust and authority law enforcement officers occupy 1314 in our community.

SECTION 3. The Department of Public Safety Standards and Training shall create a 15uniform background checklist and a standardized personal history questionnaire for use by 16 law enforcement units in hiring applicants to be public safety officers. The checklist must 17 18 include a description of the law enforcement unit's investigation of the applicant, including

but not limited to: 1

2 (1) Information about a psychiatric or psychological evaluation of the applicant, including the evaluator's name and license number and an assessment of the applicant's tendencies, 3 feelings and opinions toward diverse cultures, races and ethnicities and differing social, pol-4 itical, economic and life statuses; 5

(2) Investigation of the applicant's finances; and

(3) Identification of at least three references provided by the applicant that are inter-7 viewed by the law enforcement unit. 8

9 SECTION 4. A law enforcement unit that employs police officers or reserve officers shall adopt policies that set standards for speech and expression by officers in and outside the 10 course and scope of employment. The policies must apply to all forms of speech and ex-11 12 pression, including but not limited to film, video, print media, public and private speech and use of Internet services including but not limited to electronic mail, file transfer, remote 13 computer access, news services, social networking, social media, instant messaging, blogs, 14 15 forums and video and other file-sharing sites. The policies may not violate the constitutional 16 rights to free speech and expression.

SECTION 5. (1) As used in this section:

18 (a) "Employment information" means written information in connection with job appli-19 cations, performance evaluations, attendance records, disciplinary actions, eligibility for re-20hire and other information relevant to the performance of a public safety officer.

21(b) "Law enforcement unit" has the meaning given that term in ORS 181A.355.

22(c) "Public safety officer" has the meaning given that term in ORS 181A.355.

23(2) When an employer receives a request for employment information from a law enforcement unit for the purpose of hiring an applicant to be a public safety officer, the 2425employer shall provide the employment information to the law enforcement unit if:

(a) The request is made in writing; and

27(b) The request is accompanied by a notarized authorization by the applicant releasing the employer of liability. 28

(3) An employer may charge reasonable fees to cover actual costs incurred in disclosing 2930 employment information under this section.

31 (4) An employer is not subject to civil liability arising out of the disclosure of employment information under this section. 32

(5) A law enforcement unit may bring an action for an injunction in circuit court to 33 34 compel an employer to disclose employment information under this section.

35 (6) Employment information disclosed to a law enforcement unit under this section is confidential as provided in ORS 192.355 (4) and may not be further disclosed by the law 36 37 enforcement unit, except to another law enforcement unit conducting a background check 38 for the purpose of hiring the applicant. A law enforcement unit that receives employment information from another law enforcement unit under this subsection may use the informa-39 40 tion only for investigative leads and shall independently verify the information.

SECTION 6. ORS 659A.330 is amended to read:

42659A.330. (1) It is an unlawful employment practice for an employer to:

(a) Require or request an employee or an applicant for employment to establish or maintain a 43 personal social media account, or to disclose or to provide access through the employee's or 44 applicant's user name and password, password or other means of authentication that provides access 45

to a personal social media account; 1 2 (b) Require an employee or an applicant for employment to authorize the employer to advertise on the personal social media account of the employee or applicant; 3 (c) Compel an employee or applicant for employment to add the employer or an employment 4 agency to the employee's or applicant's list of contacts associated with a social media website; $\mathbf{5}$ (d) Except as provided in subsection (4)(b) of this section, compel an employee or applicant for 6 employment to access a personal social media account in the presence of the employer and in a 7 manner that enables the employer to view the contents of the personal social media account that 8 9 are visible only when the personal social media account is accessed by the account holder's user 10 name and password, password or other means of authentication; (e) Take, or threaten to take, any action to discharge, discipline or otherwise penalize an em-11 12 ployee for the employee's refusal to: 13 (A) Establish or maintain a personal social media account; (B) Disclose, or provide access through, the employee's user name and password, password or 14 15 other means of authentication that is associated with a personal social media account; (C) Add the employer to the employee's list of contacts associated with a social media website; 16 17 or 18 (D) Access a personal social media account as described in paragraph (d) of this subsection; or 19 (f) Fail or refuse to hire an applicant for employment because the applicant refused to: (A) Establish or maintain a personal social media account; 20(B) Disclose, or provide access through, the applicant's user name and password, password or 2122other means of authentication that is associated with a personal social media account; 23(C) Add the employer to the applicant's list of contacts associated with a social media website; 24or 25(D) Access a personal social media account as described in paragraph (d) of this subsection. 26(2) An employer may require an employee to disclose any user name and password, password 27or other means for accessing an account provided by, or on behalf of, the employer or to be used on behalf of the employer. 28(3) An employer may not be held liable for the failure to request or require an employee or ap-2930 plicant to disclose the information specified in subsection (1)(a) of this section. 31 (4) Nothing in this section prevents an employer from: 32(a) Conducting an investigation, without requiring an employee to provide a user name and password, password or other means of authentication that provides access to a personal social media 33 34 account of the employee, for the purpose of ensuring compliance with applicable laws, regulatory 35 requirements or prohibitions against work-related employee misconduct based on receipt by the employer of specific information about activity of the employee on a personal online account or 36 37 service. 38 (b) Conducting an investigation permitted under this subsection that requires an employee, without providing a user name and password, password or other means of authentication that pro-39 vides access to a personal social media account of the employee, to share content that has been 40 reported to the employer that is necessary for the employer to make a factual determination about 41 the matter. 42

43 (c) Complying with state and federal laws, rules and regulations and the rules of self-regulatory44 organizations.

(5) Nothing in this section prohibits an employer from accessing information available to the

1 public about the employee or applicant that is accessible through an online account.

2 (6) If an employer inadvertently receives the user name and password, password or other means 3 of authentication that provides access to a personal social media account of an employee through 4 the use of an electronic device or program that monitors usage of the employer's network or 5 employer-provided devices, the employer is not liable for having the information but may not use the 6 information to access the personal social media account of the employee.

7 (7) This section does not apply to an employer that is a law enforcement unit as defined
8 in ORS 181A.355.

9 [(7)] (8) As used in this section:

(a) "Personal social media account" means a social media account that is used by an employee
 or applicant for employment exclusively for personal purposes unrelated to any business purpose of
 the employer or prospective employer and that is not provided by or paid for by the employer or
 prospective employer.

(b) "Social media" means an electronic medium that allows users to create, share and view user-generated content, including, but not limited to, uploading or downloading videos, still photographs, blogs, video blogs, podcasts, instant messages, electronic mail or Internet website profiles or locations.
