

HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2949

By JOINT COMMITTEE ON WAYS AND MEANS

1 On page 3 of the printed A-engrossed bill, line 7, delete “only”.

2 In line 14, delete “or”.

3 In line 15, delete the period and insert “; or

4 “(g) Another type of behavioral health care provider as prescribed by the authority by rule.”.

5 Delete lines 17 through 28 and insert:

6 **“SECTION 3. Notwithstanding any other law limiting expenditures, the amount of**
7 **\$60,000,000 is established for the biennium beginning July 1, 2021, as the maximum limit for**
8 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**
9 **but excluding lottery funds and federal funds, collected or received by the Oregon Health**
10 **Authority, for the expenditure of American Rescue Plan Act State Fiscal Recovery Funds**
11 **received by the Oregon Department of Administrative Services and transferred to the au-**
12 **thority for deposit into the Behavioral Health Incentive Subaccount created in section 1 of**
13 **this 2021 Act, to carry out section 2 of this 2021 Act.”.**

14 In line 29, delete “6” and insert “4”.

15 In line 36, delete “or”.

16 In line 37, delete the period and insert “; or

17 “(e) Another behavioral health care discipline as prescribed by the authority by rule.”.

18 Delete lines 39 through 42 and insert:

19 **“SECTION 5. Notwithstanding any other law limiting expenditures, the amount of \$20,000,000**
20 **is established for the biennium beginning July 1, 2021, as the maximum limit for payment of expenses**
21 **from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds**
22 **and federal funds, collected or received by the Oregon Health Authority, for the expenditure of**
23 **American Rescue Plan Act State Fiscal Recovery Funds received by the Oregon Department of Ad-**
24 **ministrative Services and transferred to the authority, to be expended to carry out section 4 of this**
25 **2021 Act and distributed as follows:”.**

26 On page 4, line 1, delete “6” and insert “4”.

27 In line 2, delete “8” and insert “6”.

28 Delete lines 12 through 28 and insert:

29 **“SECTION 7. (1) The Oregon Health Authority shall coordinate with systems of higher**
30 **education and with the Higher Education Coordinating Commission in considering workforce**
31 **investments under sections 2 and 4 of this 2021 Act.**

32 **“(2) The authority shall ensure that investments made in accordance with sections 2 and**
33 **4 of this 2021 Act are aligned and coordinated with other state investments that are intended**
34 **to improve behavioral health outcomes for residents of this state, including but not limited**
35 **to investments made from moneys in the Drug Treatment and Recovery Services Fund es-**

2 In line 29, delete “11” and insert “8”.

3 On page 5, line 37, delete “12” and insert “9”.

4 On page 6, line 15, delete “13” and insert “10”.

6 On page 8, line 36, delete “15” and insert “12”.

7 On page 9, line 33, delete “16” and insert “13”.

8 On page 11, line 2, delete “17” and insert “14”.
