SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Defines "adult use cannabis item," "artificially derived cannabinoid," *[and "tetrahydrocannabinol"]* "**delta-9-tetrahydrocannabinol**" and "**total delta-9-tetrahydrocannabinol**" for statutes related to marijuana and industrial hemp. Authorizes Oregon Liquor Control Commission to regulate artificially derived cannabinoids. Requires industrial hemp commodities or products intended for human consumption to be processed by licensed marijuana processor. Prohibits person other than licensed marijuana retailer from selling specified industrial hemp commodity or product to consumer. Requires commission to adopt rules establishing maximum concentration of *[tetrahydrocannabinol]* **total delta-9-tetrahydrocannabinol** and other cannabinoids, including artificially derived cannabinoids, in single serving of cannabinoid product.

Allows Oregon Health Authority to disclose location of specified registered entities to person designated by State Department of Agriculture.

Directs *[State Department of Agriculture]* **department** to administer Oregon Hemp State Program for production, processing and sale of industrial hemp. Requires department to conduct criminal records check on applicant for industrial hemp grower license. **Allows person licensed by department to transport within this state specified hemp and hemp commodities.** Directs commission, in consultation with department, to adopt by rule maximum concentration of tetrahydrocannabinol, other cannabinoids and artificially derived cannabinoids in single servings of industrial hemp product. **Requires department to establish by rule requirements for tracking transfer of specified industrial hemp commodities and products. Directs department to adopt rules to require industrial hemp grower to report to department loss of or intention to not plant crop. Requires grower ordered to destroy or remediate industrial hemp crop to provide to department documentation of destruction or remediation. Directs department to refuse to issue registration or take other specified action if person plants industrial hemp crop or commits specified violation prior to applying for grower registration.** Allows marijuana processor to transfer, sell or transport industrial hemp commodity or product to person that is not marijuana processor, retailer or wholesaler if commodity or product meets specified requirements. Prohibits sale of industrial hemp commodity or product intended for human consumption to consumer unless commodity or product meets specified requirements. **Establishes civil penalty not to exceed \$10,000 applicable to certain persons growing industrial hemp crop that contains specified tetrahydrocannabinol concentration.**

Establishes Task Force on Cannabis-Derived Intoxicants. Requires task force to submit interim report not later than December 31, 2021, and final report not later than December 31, 2022, to interim committee of Legislative Assembly related to economic development.

Increases distribution of moneys from Oregon Marijuana Account to Illegal Marijuana Market Enforcement Grant Program Fund.

Directs commission to map locations of registered or licensed industrial hemp operations and licensed marijuana production premises and make map available to law enforcement and other specified parties. Directs commission to develop methodology to distinguish whether cannabis plant is industrial hemp or marijuana. Allows department to enter into interagency agreement with commission for purposes of enforcement. Requires department to adopt rules regarding law enforcement accompaniment of department representatives for purposes of protection. Allows Governor to order Oregon National Guard to assist department with enforcement. Creates crime of unlawful production of marijuana. Punishes by maximum of 364 days' imprisonment, \$6,250 fine, or both. Sunsets January 1, 2024.

Declares emergency, effective on passage.

8 **STATUTES RELATED TO MARIJUANA**

10 **SECTION 1.** ORS 475B.015 is amended to read:

11 475B.015. As used in ORS 475B.010 to 475B.545:

12 (1) **“Adult use cannabinoid” includes, but is not limited to, tetrahydrocannabinols,**
13 **tetrahydrocannabinolic acids that are artificially or naturally derived,**
14 **delta-8-tetrahydrocannabinol, delta-9-tetrahydrocannabinol, the optical isomers of**
15 **delta-8-tetrahydrocannabinol or delta-9-tetrahydrocannabinol and any artificially derived**
16 **cannabinoid that is reasonably determined to have an intoxicating effect.**

17 (2) **“Adult use cannabis item” means:**

18 (a) **A marijuana item; or**

19 (b) **An industrial hemp commodity or product that exceeds:**

20 (A) **The concentration of adult use cannabinoids established by the Oregon Liquor Con-**
21 **trol Commission, in consultation with the Oregon Health Authority and the State Depart-**
22 **ment of Agriculture, by rule; or**

23 (B) **The greater of:**

24 (i) **A concentration of more than 0.3 percent total delta-9-tetrahydrocannabinol; or**

25 (ii) **The concentration of total delta-9-tetrahydrocannabinol allowed under federal law.**

26 (3)(a) **“Artificially derived cannabinoid” means a chemical substance that is created by a**
27 **chemical reaction that changes the molecular structure of any chemical substance derived**
28 **from the plant Cannabis family Cannabaceae.**

29 (b) **“Artificially derived cannabinoid” does not include:**

30 (A) **A naturally occurring chemical substance that is separated from the plant Cannabis**
31 **family Cannabaceae by a chemical or mechanical extraction process;**

32 (B) **Cannabinoids that are produced by decarboxylation from a naturally occurring**
33 **cannabinoid acid without the use of a chemical catalyst; or**

34 (C) **Any other chemical substance identified by the commission, in consultation with the**
35 **authority and the department, by rule.**

36 [(1)] (4) **“Cannabinoid” means any of the chemical compounds that are the active constituents**
37 **derived from marijuana.**

38 [(2)] (5) **“Cannabinoid concentrate” means a substance obtained by separating cannabinoids from**
39 **marijuana by:**

40 (a) **A mechanical extraction process;**

41 (b) **A chemical extraction process using a nonhydrocarbon-based solvent, such as water, vege-**
42 **table glycerin, vegetable oils, animal fats, isopropyl alcohol or ethanol;**

43 (c) **A chemical extraction process using carbon dioxide, provided that the process does not in-**
44 **volve the use of high heat or pressure; or**

45 (d) **Any other process identified by the [Oregon Liquor Control] commission, in consultation with**

1 the [Oregon Health] authority, by rule.

2 [(3)] (6) “Cannabinoid edible” means food or potable liquid into which a cannabinoid concen-
3 trate, cannabinoid extract or dried marijuana leaves or flowers have been incorporated.

4 [(4)] (7) “Cannabinoid extract” means a substance obtained by separating cannabinoids from
5 marijuana by:

6 (a) A chemical extraction process using a hydrocarbon-based solvent, such as butane, hexane
7 or propane;

8 (b) A chemical extraction process using carbon dioxide, if the process uses high heat or pres-
9 sure; or

10 (c) Any other process identified by the commission, in consultation with the authority, by rule.

11 [(5)(a)] (8)(a) “Cannabinoid product” means a cannabinoid edible and any other product intended
12 for human consumption or use, including a product intended to be applied to the skin or hair, that
13 contains cannabinoids or dried marijuana leaves or flowers.

14 (b) “Cannabinoid product” does not include:

15 (A) Usable marijuana by itself;

16 (B) A cannabinoid concentrate by itself;

17 (C) A cannabinoid extract by itself; or

18 (D) Industrial hemp[, *as defined in ORS 571.269*].

19 [(6)] (9) “Consumer” means a person who purchases, acquires, owns, holds or uses marijuana
20 items other than for the purpose of resale.

21 [(7)] (10) “Deliver” means the actual, constructive or attempted transfer from one person to
22 another of a marijuana item, whether or not there is an agency relationship.

23 (11) **“Delta-9-tetrahydrocannabinol” or “delta-9-THC” means**
24 **(6aR,10aR)-6,6,9-trimethyl-3-pentyl-6a,7,8,10a-tetrahydro-6H- benzo[c]chromen-1-ol.**

25 (12) **“Delta-9-tetrahydrocannabinolic acid” or “delta-9-THCA” means**
26 **(6aR,10aR)-1-hydroxy-6,6,9-trimethyl-3-pentyl-6a,7,8,10a-tetrahydro-6H-benzo[c]chromene-2-**
27 **carboxylic acid.**

28 [(8)] (13) “Designated primary caregiver” has the meaning given that term in ORS 475B.791.

29 [(9)(a)] (14)(a) “Financial consideration” means value that is given or received either directly
30 or indirectly through sales, barter, trade, fees, charges, dues, contributions or donations.

31 (b) “Financial consideration” does not include marijuana, cannabinoid products or cannabinoid
32 concentrates that are delivered within the scope of and in compliance with ORS 475B.301.

33 [(10)] (15) “Homegrown” means grown by a person 21 years of age or older for noncommercial
34 purposes.

35 [(11)] (16) “Household” means a housing unit and any place in or around a housing unit at which
36 the occupants of the housing unit are producing, processing, possessing or storing homegrown
37 marijuana, cannabinoid products, cannabinoid concentrates or cannabinoid extracts.

38 [(12)] (17) “Housing unit” means a house, an apartment or a mobile home, or a group of rooms
39 or a single room that is occupied as separate living quarters, in which the occupants live and eat
40 separately from any other persons in the building and that has direct access from the outside of the
41 building or through a common hall.

42 [(13)] (18) “Immature marijuana plant” means a marijuana plant that is not flowering.

43 (19) **“Industrial hemp” has the meaning given that term in ORS 571.269.**

44 [(14)] (20) “Licensee” means a person that holds a license issued under ORS 475B.070, 475B.090,
45 475B.100 or 475B.105.

1 [(15)] (21) “Licensee representative” means an owner, director, officer, manager, employee, agent
2 or other representative of a licensee, to the extent that the person acts in a representative capacity.

3 [(16)(a)] (22)(a) “Manufacture” means producing, propagating, preparing, compounding, convert-
4 ing or processing a marijuana item, either directly or indirectly, by extracting from substances of
5 natural origin.

6 (b) “Manufacture” includes any packaging or repackaging of a marijuana item or the labeling
7 or relabeling of a container containing a marijuana item.

8 [(17)(a)] (23)(a) “Marijuana” means the plant Cannabis family Cannabaceae, any part of the
9 plant Cannabis family Cannabaceae and marijuana seeds.

10 (b) “Marijuana” does not include:

11 (A) Industrial hemp[, *as defined in ORS 571.269*]; or

12 (B) Prescription drugs, as that term is defined in ORS 689.005, including those containing one
13 or more cannabinoids, that are approved by the United States Food and Drug Administration and
14 dispensed by a pharmacy, as defined in ORS 689.005.

15 [(18)] (24) “Marijuana flowers” means the flowers of the plant genus Cannabis within the plant
16 family Cannabaceae.

17 [(19)] (25) “Marijuana items” means marijuana, cannabinoid products, cannabinoid concentrates
18 and cannabinoid extracts.

19 [(20)] (26) “Marijuana leaves” means the leaves of the plant genus Cannabis within the plant
20 family Cannabaceae.

21 [(21)] (27) “Marijuana processor” means:

22 (a) A person that processes marijuana items in this state[.]; or

23 (b) **A person that holds a license issued under ORS 475B.090 and processes industrial
24 hemp commodities or products pursuant to ORS 571.336.**

25 [(22)] (28) “Marijuana producer” means a person that produces marijuana in this state.

26 [(23)] (29) “Marijuana retailer” means a person that sells marijuana items to a consumer in this
27 state.

28 [(24)(a)] (30)(a) “Marijuana seeds” means the seeds of the plant Cannabis family Cannabaceae.

29 (b) “Marijuana seeds” does not include the seeds of industrial hemp[, *as defined in ORS
30 571.269*].

31 [(25)] (31) “Marijuana wholesaler” means a person that purchases marijuana items in this state
32 for resale to a person other than a consumer.

33 [(26)] (32) “Mature marijuana plant” means a marijuana plant that is not an immature marijuana
34 plant.

35 [(27)] (33) “Medical grade cannabinoid product, cannabinoid concentrate or cannabinoid
36 extract” means a cannabinoid product, cannabinoid concentrate or cannabinoid extract that has a
37 concentration of [*tetrahydrocannabinol*] **adult use cannabinoids** that is permitted under ORS
38 475B.625 in a single serving of the cannabinoid product, cannabinoid concentrate or cannabinoid
39 extract for consumers who hold a valid registry identification card issued under ORS 475B.797.

40 [(28)] (34) “Medical purpose” means a purpose related to using usable marijuana, cannabinoid
41 products, cannabinoid concentrates or cannabinoid extracts to mitigate the symptoms or effects of
42 a debilitating medical condition, as defined in ORS 475B.791.

43 [(29)] (35) “Noncommercial” means not dependent or conditioned upon the provision or receipt
44 of financial consideration.

45 [(30)(a)] (36)(a) “Premises” includes the following areas of a location licensed under ORS

1 475B.010 to 475B.545:

2 (A) All public and private enclosed areas at the location that are used in the business operated
3 at the location, including offices, kitchens, rest rooms and storerooms;

4 (B) All areas outside a building that the commission has specifically licensed for the processing,
5 wholesale sale or retail sale of marijuana items; and

6 (C) For a location that the commission has specifically licensed for the production of marijuana
7 outside a building, that portion of the location used to produce marijuana.

8 (b) "Premises" does not include a primary residence.

9 [(31)(a)] (37)(a) "Processes" means the processing, compounding or conversion of:

10 (A) Marijuana into cannabinoid products, cannabinoid concentrates or cannabinoid extracts[.];

11 or

12 (B) Pursuant to ORS 571.336, industrial hemp or industrial hemp commodities or products
13 into industrial hemp commodities or products that contain cannabinoids and are intended for
14 human consumption or use.

15 (b) "Processes" does not include packaging or labeling.

16 [(32)(a)] (38)(a) "Produces" means the manufacture, planting, cultivation, growing or harvesting
17 of marijuana.

18 (b) "Produces" does not include:

19 (A) The drying of marijuana by a marijuana processor, if the marijuana processor is not other-
20 wise producing marijuana; or

21 (B) The cultivation and growing of an immature marijuana plant by a marijuana processor,
22 marijuana wholesaler or marijuana retailer if the marijuana processor, marijuana wholesaler or
23 marijuana retailer purchased or otherwise received the plant from a licensed marijuana producer.

24 [(33)] (39) "Propagate" means to grow immature marijuana plants or to breed or produce
25 marijuana seeds.

26 [(34)] (40) "Public place" means a place to which the general public has access and includes,
27 but is not limited to, hallways, lobbies and other parts of apartment houses and hotels not consti-
28 tuting rooms or apartments designed for actual residence, and highways, streets, schools, places of
29 amusement, parks, playgrounds and areas used in connection with public passenger transportation.

30 [(35)] (41) "Registry identification cardholder" has the meaning given that term in ORS 475B.791.

31 (42) "Total delta-9-tetrahydrocannabinol" or "total delta-9-THC" means the sum of the
32 concentration or mass of delta-9-THCA multiplied by 0.877 plus the concentration or mass
33 of delta-9-THC.

34 [(36)(a)] (43)(a) "Usable marijuana" means the dried leaves and flowers of marijuana.

35 (b) "Usable marijuana" does not include:

36 (A) Marijuana seeds;

37 (B) The stalks and roots of marijuana; or

38 (C) Waste material that is a by-product of producing or processing marijuana.

39 **SECTION 2.** ORS 475B.025 is amended to read:

40 475B.025. (1) The Oregon Liquor Control Commission has the duties, functions and powers
41 specified in ORS 475B.010 to 475B.545 and the powers necessary or proper to enable the commission
42 to carry out the commission's duties, functions and powers under ORS 475B.010 to 475B.545. The
43 jurisdiction, supervision, duties, functions and powers of the commission extend to any person that
44 produces, processes, transports, delivers, sells or purchases a marijuana item in this state. The
45 commission may sue and be sued.

1 (2) The duties, functions and powers of the commission specified in ORS 475B.010 to 475B.545
2 include the following:

3 (a) To regulate the production, processing, transportation, delivery, sale and purchase of
4 marijuana items in accordance with the provisions of ORS 475B.010 to 475B.545.

5 (b) To issue, renew, suspend, revoke or refuse to issue or renew licenses for the production,
6 processing or sale of marijuana items, or other licenses related to the consumption of marijuana
7 items, and to permit, in the commission's discretion, the transfer of a license between persons.

8 (c) To adopt, amend or repeal rules as necessary to carry out the intent and provisions of ORS
9 475B.010 to 475B.545, including rules that the commission considers necessary to protect the public
10 health and safety.

11 (d) To exercise all powers incidental, convenient or necessary to enable the commission to ad-
12 minister or carry out the provisions of ORS 475B.010 to 475B.545 or any other law of this state that
13 charges the commission with a duty, function or power related to marijuana. Powers described in
14 this paragraph include, but are not limited to:

15 (A) Issuing subpoenas;

16 (B) Compelling the attendance of witnesses;

17 (C) Administering oaths;

18 (D) Certifying official acts;

19 (E) Taking depositions as provided by law;

20 (F) Compelling the production of books, payrolls, accounts, papers, records, documents and tes-
21 timony; and

22 (G) Establishing fees in addition to the application, licensing and renewal fees described in ORS
23 475B.070, 475B.090, 475B.100 and 475B.105, provided that any fee established by the commission is
24 reasonably calculated not to exceed the cost of the activity for which the fee is charged.

25 (e) To adopt rules regulating and prohibiting advertising marijuana items in a manner:

26 (A) That is appealing to minors;

27 (B) That promotes excessive use;

28 (C) That promotes illegal activity; or

29 (D) That otherwise presents a significant risk to public health and safety.

30 (f) To regulate the use of marijuana items for other purposes as deemed necessary or appropri-
31 ate by the commission.

32 (g) To establish pilot programs, of not more than three years in duration, to expand access to
33 marijuana for medical use for registry identification cardholders and designated primary caregivers,
34 as defined in ORS 475B.791.

35 **(h) To regulate the processing, transportation, delivery, sale and purchase of artificially**
36 **derived cannabinoids in accordance with the provisions of ORS 475B.010 to 475B.545.**

37 (3) Fees collected pursuant to subsection (2)(d)(G) of this section shall be deposited in the
38 Marijuana Control and Regulation Fund established under ORS 475B.296.

39 **SECTION 3.** ORS 475B.090 is amended to read:

40 475B.090. (1) The processing of marijuana items is subject to regulation by the Oregon Liquor
41 Control Commission.

42 (2) A marijuana processor must have a processor license issued by the commission for the
43 premises at which marijuana items are processed. To hold a processor license under this section, a
44 marijuana processor:

45 (a) Must apply for a license in the manner described in ORS 475B.040;

1 (b) Must provide proof that the applicant is 21 years of age or older;

2 (c) If the marijuana processor processes marijuana extracts[,] **or industrial hemp extracts, as**
3 **defined in ORS 571.269**, may not be located in an area zoned exclusively for residential use; and

4 (d) Must meet the requirements of any rule adopted by the commission under subsection (3) of
5 this section.

6 (3) The commission shall adopt rules that:

7 (a) Require a marijuana processor to annually renew a license issued under this section;

8 (b) Establish application, licensure and renewal of licensure fees for marijuana processors;

9 (c) Require marijuana processed by a marijuana processor to be tested in accordance with ORS
10 475B.555;

11 **(d) Require industrial hemp commodities and products processed by a marijuana**
12 **processor to meet any requirements for industrial hemp commodities or products established**
13 **under ORS 571.260 to 571.348 or rules adopted under ORS 571.260 to 571.348;**

14 [(d)] (e) Allow a marijuana processor registered under ORS 475B.139 to process marijuana and
15 usable marijuana into medical grade cannabinoid products, cannabinoid concentrates and
16 cannabinoid extracts in the same manner that rules adopted under ORS 475B.010 to 475B.545 allow
17 a marijuana processor to process marijuana and usable marijuana into general use cannabinoid
18 products, cannabinoid concentrates and cannabinoid extracts, excepting those circumstances where
19 differentiating between the processing of medical grade cannabinoid products, cannabinoid concen-
20 trates and cannabinoid extracts and the processing of general use cannabinoid products, cannabinoid
21 concentrates and cannabinoid extracts is necessary to protect the public health and safety; and

22 [(e)] (f) Require a marijuana processor to meet any public health and safety standards and in-
23 dustry best practices established by the commission by rule related to:

24 (A) Cannabinoid edibles;

25 (B) Cannabinoid concentrates;

26 (C) Cannabinoid extracts; and

27 (D) Any other type of cannabinoid product **or industrial hemp commodity or product** identi-
28 fied by the commission by rule.

29 (4) Fees adopted under subsection (3)(b) of this section:

30 (a) May not exceed, together with other fees collected under ORS 475B.010 to 475B.545, the cost
31 of administering ORS 475B.010 to 475B.545; and

32 (b) Shall be deposited in the Marijuana Control and Regulation Fund established under ORS
33 475B.296.

34 **SECTION 4.** ORS 475B.211 is amended to read:

35 475B.211. Except for a marijuana retailer registered under ORS 475B.146 to sell or deliver
36 marijuana items to a registry identification cardholder who is 18 years of age or older **or as allowed**
37 **pursuant to ORS 475B.785 to 475B.949**, a [*licensee or licensee representative*] **person** may not sell
38 or deliver [*a marijuana item*] **an adult use cannabis item** to a person under 21 years of age.

39 **SECTION 5.** ORS 475B.227 is amended to read:

40 475B.227. (1) For purposes of this section:

41 (a) "Export" includes placing a marijuana item in any mode of transportation for hire, such as
42 luggage, mail or parcel delivery, even if the transportation of the marijuana item is intercepted prior
43 to the marijuana item leaving this state.

44 (b) "Marijuana item" includes **an industrial hemp** [*products and commodities*] **commodity or**
45 **product** that [*contain more than 0.3 percent tetrahydrocannabinol.*] **exceeds the greater of:**

1 (A) A concentration of 0.3 percent total delta-9-tetrahydrocannabinol; or

2 (B) The concentration of total delta-9-tetrahydrocannabinol allowed under federal law.

3 (2) A person may not import marijuana items into this state or export marijuana items from this
4 state.

5 (3) [Except as provided in subsection (4) of this section,] A violation of this section is a Class B
6 violation[.], **except:**

7 (a) As provided in subsection (4) of this section; or

8 (b) If the item is industrial hemp and does not exceed a total
9 delta-9-tetrahydrocannabinol concentration of one percent.

10 (4) A violation of this section is a:

11 (a) Class A misdemeanor, if the importation or exportation:

12 (A) Is not for consideration and the person holds a license issued under ORS 475B.070, 475B.090,

20 amount specified in ORS 475B.337 (1)(a) to (f); or

21 (C) Concerns a cannabinoid extract that was not purchased from a marijuana retailer that holds
22 a license issued under ORS 475B.105.

23 **SECTION 5a.** ORS 475B.253 is amended to read:

24 475B.253. [(1) As used in this section, "industrial hemp" has the meaning given that term in ORS
25 571.269.]

26 [(2)] (1) An industrial hemp product or commodity offered for sale by a marijuana retailer that
27 holds a license issued under ORS 475B.105 must carry a label that clearly identifies whether the
28 product or commodity is derived from hemp or marijuana.

29 [(3)] (2) The Oregon Liquor Control Commission may inspect the premises of a marijuana
30 retailer that holds a license issued under ORS 475B.105 to ensure compliance with this section.

31 **SECTION 6.** ORS 475B.254 is amended to read:

32 475B.254. (1) As used in this section:

33 (a) "Consumer" means a person who purchases, acquires, owns, holds or uses marijuana items
34 other than for the purpose of resale.

30 partment may require fingerprints of any individual listed on an application submitted under
31 ORS 571.260 to 571.348, including:

- 32 (a) If the applicant is a limited partnership, each partner of the limited partnership;
33 (b) If the applicant is a limited liability company, each member of the limited liability
34 company;
35 (c) If the applicant is a corporation, each director and officer of the corporation;
36 (d) Any individual who is a partner, member, director or officer of an entity with a fi-
37 nancial interest in the applicant; and
38 (e) Other key participants with the applicant, as identified by the department by rule.

8 **(1) For purposes of this section, “consumer” means a person that purchases, acquires,**
9 **owns, holds or uses an industrial hemp commodity or product other than for the purpose of**
10 **resale.**

11 **(2) A person may not sell, transfer or deliver to a consumer an industrial hemp com-**
12 **modity or product that contains cannabinoids and is intended for human consumption unless:**

13 **(a) The industrial hemp commodity or product has been tested in accordance with ORS**
14 **571.330 and any rules adopted pursuant to ORS 571.330;**

15 **(b) If the hemp commodity or product is intended for human consumption by ingestion,**
16 **the hemp commodity or product was processed in a facility licensed by the State Department**
17 **of Agriculture under ORS 616.695 to 616.755 or in a facility in another state or jurisdiction**
18 **that meets requirements substantially similar to requirements established under ORS 616.695**
19 **to 616.755;**

20 **(c) The person obtains and maintains documentation of the results of the testing;**

21 **(d) If the industrial hemp commodity or product is sold to a person under 21 years of age**
22 **or any representations are made to the consumer about the concentration of**
23 **delta-8-tetrahydrocannabinol, the results of the testing required under this subsection dem-**
24 **onstrate the concentration of delta-8-tetrahydrocannabinol;**

25 **(e) The industrial hemp commodity or product does not contain more than 0.3 percent**
26 **tetrahydrocannabinol or the concentration of tetrahydrocannabinol allowed under federal**
27 **law, whichever is greater; and**

28 **(f) The industrial hemp commodity or product does not exceed the concentration of adult**
29 **use cannabinoids established by the Oregon Liquor Control Commission, in conjunction with**
30 **the Oregon Health Authority and State Department of Agriculture, by rule.**

31 **(3) The testing required under subsection (2) of this section may be conducted only by:**

32 **(a) A laboratory licensed by the commission under ORS 475B.560 and accredited by the**
33 **authority under ORS 475B.565; or**

34 **(b) If the industrial hemp commodity or product was processed outside of this state, a**
35 **laboratory accredited to the same or more stringent standards as a laboratory described in**
36 **paragraph (a) of this subsection.**

37 **(4) A person may not sell or deliver an adult use cannabis item to a person under 21**
38 **years of age.**

39 **(5) This section does not apply to the retail sale of industrial hemp commodities or products by**
40 **a marijuana retailer, as defined in ORS 475B.015, that holds a license issued under ORS 475B.105.**

41 **SECTION 33.** ORS 571.345 is amended to read:

42 571.345. The State Department of Agriculture may by rule or order establish a process providing
43 for the remediation of a violation of ORS 571.330 or 571.333 that is committed by a grower or han-
44 dler [registered] licensed under ORS 571.281 and is not committed intentionally.

45 **SECTION 33a.** ORS 571.348 is amended to read:

1 571.348. (1) Subject to the provisions of ORS chapter 183, the State Department of Agriculture
2 may impose a civil penalty not to exceed \$2,500 on a person for violating:

3 (a) A provision of ORS 571.260 to 571.348;

4 (b) A rule adopted under a provision of ORS 571.260 to 571.348; or

5 (c) An order issued by the department pursuant to a provision of ORS 571.260 to 571.348 or a

11 **TASK FORCE ON CANNABIS-DERIVED INTOXICANTS**

12
13 **SECTION 37.** (1) The Task Force on Cannabis-Derived Intoxicants is established.

14 (2) The task force consists of 15 members appointed as follows:

15 (a) The President of the Senate shall appoint one member from among the members of
16 the Senate;

17 (b) The Senate Minority Leader shall appoint one member from among the members of
18 the Senate;

19 (c) The Speaker of the House of Representatives shall appoint one member from among
20 the members of the House of Representatives;

21 (d) The House Minority Leader shall appoint one member from among the members of
22 the House of Representatives; and

23 (e) The Governor shall appoint 11 members as follows:

24 (A) One member who represents counties in this state;

25 (B) One member who represents cities in this state;

26 (C) One member who represents law enforcement agencies;

27 (D) One member who represents industrial hemp growers registered or licensed under
28 ORS 571.281;

29 (E) One member who represents industrial hemp handlers registered or licensed under
30 ORS 571.281;

31 (F) The director of the Oregon State University Global Hemp Innovation Center, or a
32 designee of the director;

33 (G) Two members who represent licensees, as defined in ORS 475B.015;

34 (H) The Director of Agriculture, or a designee of the director;

35 (I) The director of the Oregon Health Authority Public Health Division, or a designee of
36 the director; and

37 (J) The administrator of the Oregon Liquor Control Commission, or a designee of the
38 administrator.

39 (3) The task force shall consider:

40 (a) Changes to state law to support the regulation of intoxicating cannabis-derived pro-
41 ducts and artificially derived cannabinoids;

42 (b) The consolidation of administrative functions related to the regulation of cannabis;

43 (c) Methods to prevent sales to minors of industrial hemp commodities or products that
44 contain intoxicating cannabinoids;

45 (d) Regulation to address genetic engineering of cannabis;

1 (e) Testing requirements and methods of enforcement of testing requirements for
2 cannabinoids, including artificially derived cannabinoids, to protect the public health and
3 safety;

4 (f) Policy changes related to interstate commerce and transportation of cannabis;

5 (g) Changes to state regulation of cannabis as a result of federal laws; and

6 (h) Input from marijuana and industrial hemp industry members.

7 (4) A majority of the members of the task force constitutes a quorum for the transaction
8 of business.

9 (5) Official action by the task force requires the approval of a majority of the members
10 of the task force.

11 (6) The task force shall elect one of its members to serve as chairperson.

12 (7) If there is a vacancy for any cause, the appointing authority shall make an appoint-
13 ment to become immediately effective.

14 (8) The task force shall meet at times and places specified by the call of the chairperson
15 or of a majority of the members of the task force.

16 (9) The task force may adopt rules necessary for the operation of the task force.

17 (10) Not later than June 30, 2022, the State Department of Agriculture shall report to the
18 task force on the implementation of section 18 of this 2021 Act.

19 (11)(a) The task force shall submit a report in the manner provided by ORS 192.245, and
20 shall include initial findings and recommendations for legislation, to the interim committee
21 of the Legislative Assembly related to economic development no later than December 31,
22 2021.

23 (b) The task force shall submit a report in the manner provided by ORS 192.245, and shall
24 include final findings and recommendations for legislation, to the interim committee of the
25 Legislative Assembly related to economic development no later than December 31, 2022. The
26 report submitted under this paragraph must include a summary of the information submit-
27 ted to the task force by the department under subsection (10) of this section.

28 (12) The Oregon Liquor Control Commission and the State Department of Agriculture,
29 in consultation with the Oregon Health Authority and the Department of Revenue, shall
30 provide staff support to the task force.

31 (13) Members of the task force who are not members of the Legislative Assembly are not
32 entitled to compensation or reimbursement for expenses and serve as volunteers on the task
33 force.

34 (14) All agencies of state government, as defined in ORS 174.111, are directed to assist
35 the task force in the performance of the duties of the task force and, to the extent permitted
36 by laws relating to confidentiality, to furnish information and advice the members of the task
37 force consider necessary to perform their duties.

38 **SECTION 38.** Section 37 of this 2021 Act is repealed on January 2, 2023.

43 **SECTION 39.** Section 16, chapter 103, Oregon Laws 2018, is amended to read:

44 **Sec. 16.** (1) Notwithstanding ORS 475B.759, before making any other distribution from the
45 Oregon Marijuana Account established under ORS 475B.759, the Department of Revenue shall first

1 distribute quarterly from the account the following:

2 (a) \$875,000 to the Oregon Liquor Control Commission for deposit in the Marijuana Control and
3 Regulation Fund established under ORS 475B.296; and

4 (b) [~~\$375,000~~] **\$750,000** to the Oregon Criminal Justice Commission for deposit into the Illegal
5 Marijuana Market Enforcement Grant Program Fund established under section 15 [*of this 2018*
6 *Act*], **chapter 103, Oregon Laws 2018**, for the purposes of paying the costs incurred by the com-
7 mission in carrying out the provisions of section 13 [*of this 2018 Act*], **chapter 103, Oregon Laws**
8 **2018**.

9 (2) The final distribution made under subsection (1) of this section shall be made in the fiscal
10 quarter beginning on October 1, 2023.

12 **ENFORCEMENT**

13
14 **SECTION 40.** (1) **The Oregon Liquor Control Commission shall, with the assistance of the**
15 **State Department of Agriculture, create and continually update a map of the locations of**
16 **industrial hemp operations registered or licensed under ORS 571.281 and premises for which**
17 **a license has been issued under ORS 475B.070.**

18 (2) **The commission shall make the map described in subsection (1) of this section avail-**
19 **able to law enforcement agencies in this state and public employees and officials who are**
20 **responsible for the enforcement of state and local laws regulating industrial hemp or**
21 **marijuana.**

22 **SECTION 41.** (1) **A person commits the crime of unlawful production of marijuana if the**
23 **person produces marijuana or industrial hemp:**

24 (a) **At a location that is not confirmed by the Oregon Health Authority, the Oregon Li-**
25 **quor Control Commission or the State Department of Agriculture to be the location of an**
26 **industrial hemp operation registered or licensed under ORS 571.281, a premises for which a**
27 **license was issued under ORS 475B.090 or a marijuana grow site registered under ORS**
28 **475B.810; and**

29 (b) **In an amount that is not allowed by state law.**

30 (2) **Unlawful production of marijuana is a Class A misdemeanor.**

31 (3) **Marijuana or industrial hemp that is unlawfully produced, as described in subsection**
32 **(1) of this section, is considered contraband and may be destroyed by a law enforcement**
33 **agency.**

34 **SECTION 41a.** (1) **The Oregon Liquor Control Commission, in consultation with the State**
35 **Department of Agriculture, shall develop by rule a methodology to distinguish whether a**
36 **cannabis plant is marijuana or industrial hemp for purposes of sections 40 to 44 of this 2021**
37 **Act. The methodology must include testing criteria and cannabinoid concentrations above**
38 **which immature or mature cannabis plants are presumptively considered to be marijuana.**

39 (2) **The department may order a person registered or licensed under ORS 571.281 to de-**
40 **stroy any cannabis plants located at an industrial hemp operation for which the person de-**
41 **scribed in this subsection is responsible if the cannabis plants are presumptively considered**
42 **to be marijuana under the methodology adopted pursuant to subsection (1) of this section.**

44 **agreement with the Oregon Liquor Control Commission to allow representatives of the**
45 **commission to carry out inspections of industrial hemp crops under ORS 571.281 (7).**

1 (2) The department and the commission may adopt rules to carry out this section.

2 **SECTION 43.** (1) Pursuant to rules adopted by the State Department of Agriculture under
3 subsection (2) of this section:

4 (a) Law enforcement officers may accompany the department to an industrial hemp op-
5 eration for the purposes of providing protection for the department's representatives; and

6 (b) Public employees and officials who are responsible for the enforcement of state and
7 local laws may accompany the department to an industrial hemp operation in order to carry
8 out inspections that the public employees or officials are authorized to perform.

9 (2) The department shall adopt rules to carry out this section.

10 **SECTION 44.** The Governor may order that the Oregon National Guard provide assist-
11 ance and support to the State Department of Agriculture and law enforcement in carrying
12 out inspections of industrial hemp crops under ORS 571.281 (7) and other duties of the de-
13 partment related to the enforcement of ORS 571.260 to 571.348.
