

HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 3000

2 475B.529, 475B.550, 475B.555, 475B.600, 475B.625, 475B.876, 571.260, 571.263, 571.269, 571.272,”.

3 In line 4, delete “51.288” and insert “571.288” and after “571.339,” delete the rest of the line and
4 delete line 5 and insert “571.345 and 571.348 and section 16, chapter 103, Oregon Laws 2018, and
5 section 8, chapter ___, Oregon Laws 2021 (Enrolled House Bill 2519); repealing ORS 571.341; and
6 declaring an emergency.”.

7 Delete lines 7 through 14 and delete pages 2 through 22 and insert:

9 “STATUTES RELATED TO MARIJUANA

10
11 “**SECTION 1.** ORS 475B.015 is amended to read:

12 “475B.015. As used in ORS 475B.010 to 475B.545:

13 “(1) ‘**Adult use cannabinoid**’ includes, but is not limited to, tetrahydrocannabinols,
14 tetrahydrocannabinolic acids that are artificially or naturally derived,
15 delta-8-tetrahydrocannabinol, delta-9-tetrahydrocannabinol, the optical isomers of
16 delta-8-tetrahydrocannabinol or delta-9-tetrahydrocannabinol and any artificially derived
17 cannabinoid that is reasonably determined to have an intoxicating effect.

18 “(2) ‘**Adult use cannabis item**’ means:

19 “(a) A marijuana item; or

20 “(b) An industrial hemp commodity or product that exceeds:

21 “(A) The concentration of adult use cannabinoids established by the Oregon Liquor Con-
22 trol Commission, in consultation with the Oregon Health Authority and the State Depart-
23 ment of Agriculture, by rule; or

24 “(B) The greater of:

25 “(i) A concentration of more than 0.3 percent total delta-9-tetrahydrocannabinol; or

26 “(ii) The concentration of total delta-9-tetrahydrocannabinol allowed under federal law.

27 “(3)(a) ‘**Artificially derived cannabinoid**’ means a chemical substance that is created by
28 a chemical reaction that changes the molecular structure of any chemical substance derived
29 from the plant Cannabis family Cannabaceae.

30 “(b) ‘**Artificially derived cannabinoid**’ does not include:

31 “(A) A naturally occurring chemical substance that is separated from the plant Cannabis
32 family Cannabaceae by a chemical or mechanical extraction process;

33 “(B) Cannabinoids that are produced by decarboxylation from a naturally occurring
34 cannabinoid acid without the use of a chemical catalyst; or

35 “(C) Any other chemical substance identified by the commission, in consultation with the

1 **authority and the department, by rule.**

2 “[1] (4) ‘Cannabinoid’ means any of the chemical compounds that are the active constituents
3 derived from marijuana.

4 “[2] (5) ‘Cannabinoid concentrate’ means a substance obtained by separating cannabinoids from
5 marijuana by:

6 “(a) A mechanical extraction process;

7 “(b) A chemical extraction process using a nonhydrocarbon-based solvent, such as water, vege-
8 table glycerin, vegetable oils, animal fats, isopropyl alcohol or ethanol;

9 “(c) A chemical extraction process using carbon dioxide, provided that the process does not in-
10 volve the use of high heat or pressure; or

11 “(d) Any other process identified by the [*Oregon Liquor Control*] commission, in consultation
12 with the [*Oregon Health*] authority, by rule.

13 “[3] (6) ‘Cannabinoid edible’ means food or potable liquid into which a cannabinoid concen-
14 trate, cannabinoid extract or dried marijuana leaves or flowers have been incorporated.

15 “[4] (7) ‘Cannabinoid extract’ means a substance obtained by separating cannabinoids from
16 marijuana by:

17 “(a) A chemical extraction process using a hydrocarbon-based solvent, such as butane, hexane
18 or propane;

19 “(b) A chemical extraction process using carbon dioxide, if the process uses high heat or pres-
20 sure; or

21 “(c) Any other process identified by the commission, in consultation with the authority, by rule.

22 “[5](a) (8)(a) ‘Cannabinoid product’ means a cannabinoid edible and any other product intended
23 for human consumption or use, including a product intended to be applied to the skin or hair, that
24 contains cannabinoids or dried marijuana leaves or flowers.

25 “(b) ‘Cannabinoid product’ does not include:

26 “(A) Usable marijuana by itself;

27 “(B) A cannabinoid concentrate by itself;

28 “(C) A cannabinoid extract by itself; or

29 “(D) Industrial hemp[, *as defined in ORS 571.269*].

30 “[6] (9) ‘Consumer’ means a person who purchases, acquires, owns, holds or uses marijuana
31 items other than for the purpose of resale.

32 “[7] (10) ‘Deliver’ means the actual, constructive or attempted transfer from one person to
33 another of a marijuana item, whether or not there is an agency relationship.

34 “(11) **‘Delta-9-tetrahydrocannabinol’ or ‘delta-9-THC’ means**
35 **(6aR,10aR)-6,6,9-trimethyl-3-pentyl-6a,7,8,10a-tetrahydro-6H- benzo[c]chromen-1-ol.**

36 “(12) **‘Delta-9-tetrahydrocannabinolic acid’ or ‘delta-9-THCA’ means**
37 **(6aR,10aR)-1-hydroxy-6,6,9-trimethyl-3-pentyl-6a,7,8,10a-tetrahydro-6H-benzo[c]chromene-2-**
38 **carboxylic acid.**

39 “[8] (13) ‘Designated primary caregiver’ has the meaning given that term in ORS 475B.791.

40 “[9](a) (14)(a) ‘Financial consideration’ means value that is given or received either directly
41 or indirectly through sales, barter, trade, fees, charges, dues, contributions or donations.

42 “(b) ‘Financial consideration’ does not include marijuana, cannabinoid products or cannabinoid
43 concentrates that are delivered within the scope of and in compliance with ORS 475B.301.

44 “[10] (15) ‘Homegrown’ means grown by a person 21 years of age or older for noncommercial
45 purposes.

1 “[(11)] (16) ‘Household’ means a housing unit and any place in or around a housing unit at which
2 the occupants of the housing unit are producing, processing, possessing or storing homegrown
3 marijuana, cannabinoid products, cannabinoid concentrates or cannabinoid extracts.

4 “[(12)] (17) ‘Housing unit’ means a house, an apartment or a mobile home, or a group of rooms
5 or a single room that is occupied as separate living quarters, in which the occupants live and eat
6 separately from any other persons in the building and that has direct access from the outside of the
7 building or through a common hall.

8 “[(13)] (18) ‘Immature marijuana plant’ means a marijuana plant that is not flowering.

9 “(19) ‘Industrial hemp’ has the meaning given that term in ORS 571.269.

10 “[(14)] (20) ‘Licensee’ means a person that holds a license issued under ORS 475B.070, 475B.090,
11 475B.100 or 475B.105.

12 “[(15)] (21) ‘Licensee representative’ means an owner, director, officer, manager, employee, agent
13 or other representative of a licensee, to the extent that the person acts in a representative capacity.

14 “[(16)(a)] (22)(a) ‘Manufacture’ means producing, propagating, preparing, compounding, convert-
15 ing or processing a marijuana item, either directly or indirectly, by extracting from substances of
16 natural origin.

17 “(b) ‘Manufacture’ includes any packaging or repackaging of a marijuana item or the labeling
18 or relabeling of a container containing a marijuana item.

19 “[(17)(a)] (23)(a) ‘Marijuana’ means the plant Cannabis family Cannabaceae, any part of the
20 plant Cannabis family Cannabaceae and marijuana seeds.

21 “(b) ‘Marijuana’ does not include:

22 “(A) Industrial hemp[, *as defined in ORS 571.269*]; or

23 “(B) Prescription drugs, as that term is defined in ORS 689.005, including those containing one
24 or more cannabinoids, that are approved by the United States Food and Drug Administration and
25 dispensed by a pharmacy, as defined in ORS 689.005.

26 “[(18)] (24) ‘Marijuana flowers’ means the flowers of the plant genus Cannabis within the plant
27 family Cannabaceae.

28 “[(19)] (25) ‘Marijuana items’ means marijuana, cannabinoid products, cannabinoid concentrates
29 and cannabinoid extracts.

30 “[(20)] (26) ‘Marijuana leaves’ means the leaves of the plant genus Cannabis within the plant
31 family Cannabaceae.

32 “[(21)] (27) ‘Marijuana processor’ means:

33 “(a) A person that processes marijuana items in this state[.]; or

34 “(b) **A person that holds a license issued under ORS 475B.090 and processes industrial
35 hemp commodities or products pursuant to ORS 571.336.**

36 “[(22)] (28) ‘Marijuana producer’ means a person that produces marijuana in this state.

37 “[(23)] (29) ‘Marijuana retailer’ means a person that sells marijuana items to a consumer in this
38 state.

39 “[(24)(a)] (30)(a) ‘Marijuana seeds’ means the seeds of the plant Cannabis family Cannabaceae.

40 “(b) ‘Marijuana seeds’ does not include the seeds of industrial hemp[, *as defined in ORS
41 571.269*].

42 “[(25)] (31) ‘Marijuana wholesaler’ means a person that purchases marijuana items in this state
43 for resale to a person other than a consumer.

44 “[(26)] (32) ‘Mature marijuana plant’ means a marijuana plant that is not an immature marijuana
45 plant.

1 “[27] (33) ‘Medical grade cannabinoid product, cannabinoid concentrate or cannabinoid
2 extract’ means a cannabinoid product, cannabinoid concentrate or cannabinoid extract that has a
3 concentration of [tetrahydrocannabinol] **adult use cannabinoids** that is permitted under ORS
4 475B.625 in a single serving of the cannabinoid product, cannabinoid concentrate or cannabinoid
5 extract for consumers who hold a valid registry identification card issued under ORS 475B.797.

6 “[28] (34) ‘Medical purpose’ means a purpose related to using usable marijuana, cannabinoid
7 products, cannabinoid concentrates or cannabinoid extracts to mitigate the symptoms or effects of
8 a debilitating medical condition, as defined in ORS 475B.791.

9 “[29] (35) ‘Noncommercial’ means not dependent or conditioned upon the provision or receipt
10 of financial consideration.

11 “[30)(a)] (36)(a) ‘Premises’ includes the following areas of a location licensed under ORS
12 475B.010 to 475B.545:

13 “(A) All public and private enclosed areas at the location that are used in the business operated
14 at the location, including offices, kitchens, rest rooms and storerooms;

15 “(B) All areas outside a building that the commission has specifically licensed for the processing,
16 wholesale sale or retail sale of marijuana items; and

17 “(C) For a location that the commission has specifically licensed for the production of marijuana
18 outside a building, that portion of the location used to produce marijuana.

19 “(b) ‘Premises’ does not include a primary residence.

20 “[31)(a)] (37)(a) ‘Processes’ means the processing, compounding or conversion of:

21 “(A) Marijuana into cannabinoid products, cannabinoid concentrates or cannabinoid
22 extracts[.]; or

23 “(B) Pursuant to ORS 571.336, industrial hemp or industrial hemp commodities or pro-
24 ducts into industrial hemp commodities or products that contain cannabinoids and are in-
25 tended for human consumption or use.

26 “(b) ‘Processes’ does not include packaging or labeling.

27 “[32)(a)] (38)(a) ‘Produces’ means the manufacture, planting, cultivation, growing or harvesting
28 of marijuana.

29 “(b) ‘Produces’ does not include:

30 “(A) The drying of marijuana by a marijuana processor, if the marijuana processor is not oth-
31 erwise producing marijuana; or

32 “(B) The cultivation and growing of an immature marijuana plant by a marijuana processor,
33 marijuana wholesaler or marijuana retailer if the marijuana processor, marijuana wholesaler or
34 marijuana retailer purchased or otherwise received the plant from a licensed marijuana producer.

35 “[33] (39) ‘Propagate’ means to grow immature marijuana plants or to breed or produce
36 marijuana seeds.

37 “[34] (40) ‘Public place’ means a place to which the general public has access and includes,
38 but is not limited to, hallways, lobbies and other parts of apartment houses and hotels not consti-
39 tuting rooms or apartments designed for actual residence, and highways, streets, schools, places of
40 amusement, parks, playgrounds and areas used in connection with public passenger transportation.

41 “[35] (41) ‘Registry identification cardholder’ has the meaning given that term in ORS 475B.791.

42 “(42) **‘Total delta-9-tetrahydrocannabinol’ or ‘total delta-9-THC’ means the sum of the**
43 **concentration or mass of delta-9-THCA multiplied by 0.877 plus the concentration or mass**
44 **of delta-9-THC.**

45 “[36)(a)] (43)(a) ‘Usable marijuana’ means the dried leaves and flowers of marijuana.

1 “(b) ‘Usable marijuana’ does not include:

2 “(A) Marijuana seeds;

3 “(B) The stalks and roots of marijuana; or

4 “(C) Waste material that is a by-product of producing or processing marijuana.

5 “**SECTION 2.** ORS 475B.025 is amended to read:

6 “475B.025. (1) The Oregon Liquor Control Commission has the duties, functions and powers
7 specified in ORS 475B.010 to 475B.545 and the powers necessary or proper to enable the commission
8 to carry out the commission’s duties, functions and powers under ORS 475B.010 to 475B.545. The
9 jurisdiction, supervision, duties, functions and powers of the commission extend to any person that
10 produces, processes, transports, delivers, sells or purchases a marijuana item in this state. The
11 commission may sue and be sued.

12 “(2) The duties, functions and powers of the commission specified in ORS 475B.010 to 475B.545
13 include the following:

14 “(a) To regulate the production, processing, transportation, delivery, sale and purchase of
15 marijuana items in accordance with the provisions of ORS 475B.010 to 475B.545.

16 “(b) To issue, renew, suspend, revoke or refuse to issue or renew licenses for the production,
17 processing or sale of marijuana items, or other licenses related to the consumption of marijuana
18 items, and to permit, in the commission’s discretion, the transfer of a license between persons.

19 “(c) To adopt, amend or repeal rules as necessary to carry out the intent and provisions of ORS
20 475B.010 to 475B.545, including rules that the commission considers necessary to protect the public
21 health and safety.

22 “(d) To exercise all powers incidental, convenient or necessary to enable the commission to ad-
23 minister or carry out the provisions of ORS 475B.010 to 475B.545 or any other law of this state that
24 charges the commission with a duty, function or power related to marijuana. Powers described in
25 this paragraph include, but are not limited to:

26 “(A) Issuing subpoenas;

27 “(B) Compelling the attendance of witnesses;

28 “(C) Administering oaths;

29 “(D) Certifying official acts;

30 “(E) Taking depositions as provided by law;

31 “(F) Compelling the production of books, payrolls, accounts, papers, records, documents and
32 testimony; and

33 “(G) Establishing fees in addition to the application, licensing and renewal fees described in ORS
34 475B.070, 475B.090, 475B.100 and 475B.105, provided that any fee established by the commission is
35 reasonably calculated not to exceed the cost of the activity for which the fee is charged.

36 “(e) To adopt rules regulating and prohibiting advertising marijuana items in a manner:

37 “(A) That is appealing to minors;

38 “(B) That promotes excessive use;

39 “(C) That promotes illegal activity; or

40 “(D) That otherwise presents a significant risk to public health and safety.

41 “(f) To regulate the use of marijuana items for other purposes as deemed necessary or appro-
42 priate by the commission.

43 “(g) To establish pilot programs, of not more than three years in duration, to expand access to
44 marijuana for medical use for registry identification cardholders and designated primary caregivers,
45 as defined in ORS 475B.791.

1 **“(h) To regulate the processing, transportation, delivery, sale and purchase of artificially**
2 **derived cannabinoids in accordance with the provisions of ORS 475B.010 to 475B.545.**

3 “(3) Fees collected pursuant to subsection (2)(d)(G) of this section shall be deposited in the
4 Marijuana Control and Regulation Fund established under ORS 475B.296.

5 **“SECTION 3.** ORS 475B.090 is amended to read:

6 “475B.090. (1) The processing of marijuana items is subject to regulation by the Oregon Liquor
7 Control Commission.

8 “(2) A marijuana processor must have a processor license issued by the commission for the
9 premises at which marijuana items are processed. To hold a processor license under this section, a
10 marijuana processor:

11 “(a) Must apply for a license in the manner described in ORS 475B.040;

12 “(b) Must provide proof that the applicant is 21 years of age or older;

13 “(c) If the marijuana processor processes marijuana extracts[,] **or industrial hemp extracts,**
14 **as defined in ORS 571.269,** may not be located in an area zoned exclusively for residential use; and

15 “(d) Must meet the requirements of any rule adopted by the commission under subsection (3) of
16 this section.

17 “(3) The commission shall adopt rules that:

18 “(a) Require a marijuana processor to annually renew a license issued under this section;

19 “(b) Establish application, licensure and renewal of licensure fees for marijuana processors;

20 “(c) Require marijuana processed by a marijuana processor to be tested in accordance with ORS
21 475B.555;

22 **“(d) Require industrial hemp commodities and products processed by a marijuana**
23 **processor to meet any requirements for industrial hemp commodities or products established**
24 **under ORS 571.260 to 571.348 or rules adopted under ORS 571.260 to 571.348;**

25 “[(d)] (e) Allow a marijuana processor registered under ORS 475B.139 to process marijuana and
26 usable marijuana into medical grade cannabinoid products, cannabinoid concentrates and
27 cannabinoid extracts in the same manner that rules adopted under ORS 475B.010 to 475B.545 allow
28 a marijuana processor to process marijuana and usable marijuana into general use cannabinoid
29 products, cannabinoid concentrates and cannabinoid extracts, excepting those circumstances where
30 differentiating between the processing of medical grade cannabinoid products, cannabinoid concen-
31 trates and cannabinoid extracts and the processing of general use cannabinoid products, cannabinoid
32 concentrates and cannabinoid extracts is necessary to protect the public health and safety; and

33 “[(e)] (f) Require a marijuana processor to meet any public health and safety standards and in-
34 dustry best practices established by the commission by rule related to:

35 “(A) Cannabinoid edibles;

36 “(B) Cannabinoid concentrates;

37 “(C) Cannabinoid extracts; and

38 “(D) Any other type of cannabinoid product **or industrial hemp commodity or product** iden-
39 tified by the commission by rule.

40 “(4) Fees adopted under subsection (3)(b) of this section:

41 “(a) May not exceed, together with other fees collected under ORS 475B.010 to 475B.545, the
42 cost of administering ORS 475B.010 to 475B.545; and

43 “(b) Shall be deposited in the Marijuana Control and Regulation Fund established under ORS
44 475B.296.

45 **“SECTION 4.** ORS 475B.211 is amended to read:

1 “475B.211. Except for a marijuana retailer registered under ORS 475B.146 to sell or deliver
2 marijuana items to a registry identification cardholder who is 18 years of age or older **or as allowed**
3 **pursuant to ORS 475B.785 to 475B.949**, a [*licensee or licensee representative*] **person** may not sell
4 or deliver [*a marijuana item*] **an adult use cannabis item** to a person under 21 years of age.

5 “**SECTION 5.** ORS 475B.227 is amended to read:

6 “475B.227. (1) For purposes of this section:

7 “(a) ‘Export’ includes placing a marijuana item in any mode of transportation for hire, such as
8 luggage, mail or parcel delivery, even if the transportation of the marijuana item is intercepted prior
9 to the marijuana item leaving this state.

10 “(b) ‘Marijuana item’ includes **an industrial hemp** [*products and commodities*] **commodity or**
11 **product** that [*contain more than 0.3 percent tetrahydrocannabinol.*] **exceeds the greater of:**

12 “(A) **A concentration of 0.3 percent total delta-9-tetrahydrocannabinol; or**

13 “(B) **The concentration of total delta-9-tetrahydrocannabinol allowed under federal law.**

14 “(2) A person may not import marijuana items into this state or export marijuana items from
15 this state.

16 “(3) [*Except as provided in subsection (4) of this section,*] A violation of this section is a Class
17 B violation[.], **except:**

18 “(a) **As provided in subsection (4) of this section; or**

19 “(b) **If the item is industrial hemp and does not exceed a total**
20 **delta-9-tetrahydrocannabinol concentration of one percent.**

21 “(4) A violation of this section is a:

22 “(a) Class A misdemeanor, if the importation or exportation:

23 “(A) Is not for consideration and the person holds a license issued under ORS 475B.070,
24 475B.090, 475B.100 or 475B.105; or

25 “(B) Concerns an amount of marijuana items that exceeds the applicable maximum amount
26 specified in ORS 475B.337 (1)(a) to (f).

27 “(b) Class C felony, if the importation or exportation:

28 “(A) Is for consideration and the person holds a license issued under ORS 475B.070, 475B.090,
29 475B.100 or 475B.105;

30 “(B) Concerns an amount of marijuana items that exceeds 16 times the applicable maximum
31 amount specified in ORS 475B.337 (1)(a) to (f); or

32 “(C) Concerns a cannabinoid extract that was not purchased from a marijuana retailer that
33 holds a license issued under ORS 475B.105.

34 “**SECTION 5a.** ORS 475B.253 is amended to read:

35 “475B.253. [*(1) As used in this section, ‘industrial hemp’ has the meaning given that term in ORS*
36 *571.269.*]

37 “[*(2)*] (1) An industrial hemp product or commodity offered for sale by a marijuana retailer that
38 holds a license issued under ORS 475B.105 must carry a label that clearly identifies whether the
39 product or commodity is derived from hemp or marijuana.

40 “[*(3)*] (2) The Oregon Liquor Control Commission may inspect the premises of a marijuana
41 retailer that holds a license issued under ORS 475B.105 to ensure compliance with this section.

42 “**SECTION 6.** ORS 475B.254 is amended to read:

43 “475B.254. (1) As used in this section:

44 “(a) ‘Consumer’ means a person who purchases, acquires, owns, holds or uses marijuana items
45 other than for the purpose of resale.

1 “(b) ‘Marijuana item’ includes [*industrial hemp products and commodities*] **an industrial hemp**
2 **commodity or product** that [*contain more than 0.3 percent tetrahydrocannabinol.*] **exceeds:**

3 “(A) **The concentration of adult use cannabinoids established by the Oregon Liquor Con-**
4 **trol Commission, in consultation with the Oregon Health Authority and the State Depart-**
5 **ment of Agriculture, by rule; or**

6 “(B) **The greater of:**

7 “(i) **A concentration of 0.3 percent total delta-9-tetrahydrocannabinol; or**

8 “(ii) **The concentration of total delta-9-tetrahydrocannabinol allowed under federal law.**

9 “(2) A person other than a marijuana retailer that holds a license issued under ORS 475B.105
10 may not sell marijuana items to a consumer.

11 “**SECTION 7.** ORS 475B.529 is amended to read:

12 “475B.529. (1) Notwithstanding the authority granted to the State Department of Agriculture
13 under ORS chapters 571, 618 and 633 and ORS 632.275 to 632.290, 632.450 to 632.490, 632.516 to
14 632.625, 632.705 to 632.815, 632.835 to 632.850 and 632.900 to 632.985, the department may not exer-
15 cise authority over marijuana items or a licensee, except that ORS 618.121 to 618.161, 618.991,
16 618.995, 633.311 to 633.479, 633.992 and 633.994 apply to marijuana items or to a licensee.

17 “(2) In exercising its authority under ORS chapter 616, the department may not:

18 “(a) Establish standards for marijuana as a food additive, as defined in ORS 616.205;

19 “(b) Consider marijuana to be an adulterant, unless the concentration of a cannabinoid in a
20 cannabinoid product, cannabinoid concentrate or cannabinoid extract exceeds acceptable levels es-
21 tablished by the Oregon Health Authority by rule; or

22 “(c) Apply ORS 616.256, 616.265, 616.270 or 616.275 to cannabinoid edibles or enforce ORS
23 616.256, 616.265, 616.270 or 616.275 with respect to cannabinoid edibles.

24 “(3) **Subsection (2)(b) of this section does not prohibit the department from considering**
25 **artificially derived cannabinoids to be adulterants.**

26 “**SECTION 8.** ORS 475B.550 is amended to read:

27 “475B.550. As used in ORS 475B.550 to 475B.590:

28 “(1) **‘Adult use cannabinoid’ includes, but is not limited to, tetrahydrocannabinols,**
29 **tetrahydrocannabinolic acids that are artificially or naturally derived,**
30 **delta-8-tetrahydrocannabinol, delta-9-tetrahydrocannabinol, the optical isomers of**
31 **delta-8-tetrahydrocannabinol or delta-9-tetrahydrocannabinol and any artificially derived**
32 **cannabinoid that is reasonably determined to have an intoxicating effect.**

2 authority under ORS 475B.565; or

3 “(b) If the industrial hemp commodity or product was processed outside of this state, a
4 laboratory accredited to the same or more stringent standards as a laboratory described in
5 paragraph (a) of this subsection.

6 “(4) A person may not sell or deliver an adult use cannabis item to a person under 21
7 years of age.

8 “(5) This section does not apply to the retail sale of industrial hemp commodities or products
9 by a marijuana retailer, as defined in ORS 475B.015, that holds a license issued under ORS 475B.105.

10 “**SECTION 33.** ORS 571.345 is amended to read:

11 “571.345. The State Department of Agriculture may by rule or order establish a process provid-
12 ing for the remediation of a violation of ORS 571.330 or 571.333 that is committed by a grower or
13 handler [*registered*] **licensed** under ORS 571.281 and is not committed intentionally.

14 “**SECTION 33a.** ORS 571.348 is amended to read:

15 “571.348. (1) Subject to the provisions of ORS chapter 183, the State Department of Agriculture
16 may impose a civil penalty not to exceed \$2,500 on a person for violating:

17 “(a) A provision of ORS 571.260 to 571.348;

18 “(b) A rule adopted under a provision of ORS 571.260 to 571.348; or

19 “(c) An order issued by the department pursuant to a provision of ORS 571.260 to 571.348 or a
20 rule adopted under a provision of ORS 571.260 to 571.348.

21 “(2) **In addition to the penalty described in subsection (1) of this section, subject to the**
22 **provisions of ORS chapter 183, the department may impose a civil penalty not to exceed**
23 **\$10,000 on a person if the person is a grower registered under ORS 571.281 and the depart-**
24 **ment determines that the person’s industrial hemp crop contains an average**
25 **tetrahydrocannabinol concentration of at least 10 percent on a dry weight basis.**

26 “[(2)] (3) The department may not discipline a person under this section on the basis that pos-
27 sessed, delivering and manufacturing industrial hemp are prohibited by federal law.

28 “[(3)] (4) All moneys collected by the department under this section shall be deposited in the
29 General Fund in the State Treasury to the credit of the Industrial Hemp Fund established under
30 ORS 571.278.

31 “**SECTION 33b.** ORS 571.348, as amended by section 33a of this 2021 Act, is amended to read:

32 “571.348. (1) Subject to the provisions of ORS chapter 183, the State Department of Agriculture
33 may impose a civil penalty not to exceed \$2,500 on a person for violating:

34 “(a) A provision of ORS 571.260 to 571.348;

35 “(b) A rule adopted under a provision of ORS 571.260 to 571.348; or

36 “(c) An order issued by the department pursuant to a provision of ORS 571.260 to 571.348 or a
37 rule adopted under a provision of ORS 571.260 to 571.348.

38 “(2) **In addition to the penalty described in subsection (1) of this section, subject to the pro-**

3 **“SECTION 35. The State Department of Agriculture shall issue a license to grow or**
4 **handle hemp under ORS 571.281 on the date the previous registration is due for renewal to**
5 **a grower or handler who:**

6 **“(1) Registered under ORS 571.281 on or before the operative date specified in section 36**
7 **of this 2021 Act; and**

8 **“(2) Meets the requirements for registration renewal.**

9 **“SECTION 36. (1) Sections 14 to 17 of this 2021 Act, the amendments to ORS 571.260,**
10 **571.263, 571.281, 571.285, 571.288, 571.294, 571.302, 571.327, 571.330, 571.336, 571.337, 571.339,**
11 **571.345 and 571.348 by sections 19, 20, 23 to 33 and 33b of this 2021 Act, the amendments to**
12 **sections 18 to 18c of this 2021 Act by sections 18d to 18g of this 2021 Act and the repeal of**
13 **ORS 571.341 by section 34 of this 2021 Act become operative on January 1, 2022.**

14 **“(2) The Oregon Health Authority, the Oregon Liquor Control Commission and the State**
15 **Department of Agriculture may take any action before the operative date specified in sub-**
16 **section (1) of this section that is necessary to enable the authority, the commission and the**
17 **department to exercise, on and after the operative date specified in subsection (1) of this**
18 **section, all of the duties, functions and powers conferred on the authority, the commission**
19 **and the department by sections 14 to 17 of this 2021 Act, the amendments to ORS 571.260,**
20 **571.263, 571.281, 571.285, 571.288, 571.294, 571.302, 571.327, 571.330, 571.336, 571.337, 571.339,**
21 **571.345 and 571.348 by sections 19, 20, 23 to 33 and 33b of this 2021 Act, the amendments to**
22 **sections 18 to 18c of this 2021 Act by sections 18d to 18g of this 2021 Act and the repeal of**
23 **ORS 571.341 by section 34 of this 2021 Act.**

25 **“TASK FORCE ON CANNABIS-DERIVED INTOXICANTS**

26
27 **“SECTION 37. (1) The Task Force on Cannabis-Derived Intoxicants is established.**

28 **“(2) The task force consists of 15 members appointed as follows:**

29 **“(a) The President of the Senate shall appoint one member from among the members of**
30 **the Senate;**

31 **“(b) The Senate Minority Leader shall appoint one member from among the members of**
32 **the Senate;**

33 **“(c) The Speaker of the House of Representatives shall appoint one member from among**
34 **the members of the House of Representatives;**

35 **“(d) The House Minority Leader shall appoint one member from among the members of**
36 **the House of Representatives; and**

37 **“(e) The Governor shall appoint 11 members as follows:**

38 **“(A) One member who represents counties in this state;**

39 **“(B) One member who represents cities in this state;**

40 **“(C) One member who represents law enforcement agencies;**

41 **“(D) One member who represents industrial hemp growers registered or licensed under**
42 **ORS 571.281;**

43 **“(E) One member who represents industrial hemp handlers registered or licensed under**
44 **ORS 571.281;**

45 **“(F) The director of the Oregon State University Global Hemp Innovation Center, or a**

1 designee of the director;

2 “(G) Two members who represent licensees, as defined in ORS 475B.015;

3 “(H) The Director of Agriculture, or a designee of the director;

4 “(I) The director of the Oregon Health Authority Public Health Division, or a designee
5 of the director; and

6 “(J) The administrator of the Oregon Liquor Control Commission, or a designee of the
7 administrator.

8 “(3) The task force shall consider:

9 “(a) Changes to state law to support the regulation of intoxicating cannabis-derived pro-
10 ducts and artificially derived cannabinoids;

11 “(b) The consolidation of administrative functions related to the regulation of cannabis;

12 “(c) Methods to prevent sales to minors of industrial hemp commodities or products that
13 contain intoxicating cannabinoids;

14 “(d) Regulation to address genetic engineering of cannabis;

15 “(e) Testing requirements and methods of enforcement of testing requirements for
16 cannabinoids, including artificially derived cannabinoids, to protect the public health and
17 safety;

18 “(f) Policy changes related to interstate commerce and transportation of cannabis;

19 “(g) Changes to state regulation of cannabis as a result of federal laws; and

20 “(h) Input from marijuana and industrial hemp industry members.

21 “(4) A majority of the members of the task force constitutes a quorum for the trans-
22 action of business.

23 “(5) Official action by the task force requires the approval of a majority of the members
24 of the task force.

25 “(6) The task force shall elect one of its members to serve as chairperson.

26 “(7) If there is a vacancy for any cause, the appointing authority shall make an appoint-
27 ment to become immediately effective.

28 “(8) The task force shall meet at times and places specified by the call of the chairperson
29 or of a majority of the members of the task force.

30 “(9) The task force may adopt rules necessary for the operation of the task force.

31 “(10) Not later than June 30, 2022, the State Department of Agriculture shall report to
32 the task force on the implementation of section 18 of this 2021 Act.

33 “(11)(a) The task force shall submit a report in the manner provided by ORS 192.245, and
34 shall include initial findings and recommendations for legislation, to the interim committee
35 of the Legislative Assembly related to economic development no later than December 31,
36 2021.

37 “(b) The task force shall submit a report in the manner provided by ORS 192.245, and
38 shall include final findings and recommendations for legislation, to the interim committee
39 of the Legislative Assembly related to economic development no later than December 31,
40 2022. The report submitted under this paragraph must include a summary of the information
41 submitted to the task force by the department under subsection (10) of this section.

42 “(12) The Oregon Liquor Control Commission and the State Department of Agriculture,
43 in consultation with the Oregon Health Authority and the Department of Revenue, shall
44 provide staff support to the task force.

45 “(13) Members of the task force who are not members of the Legislative Assembly are

1 not entitled to compensation or reimbursement for expenses and serve as volunteers on the
2 task force.

3 “(14) All agencies of state government, as defined in ORS 174.111, are directed to assist
4 the task force in the performance of the duties of the task force and, to the extent permitted
5 by laws relating to confidentiality, to furnish information and advice the members of the task
6 force consider necessary to perform their duties.

7 “SECTION 38. Section 37 of this 2021 Act is repealed on January 2, 2023.

9 “**ILLEGAL MARIJUANA MARKET ENFORCEMENT**
10 **GRANT PROGRAM FUNDING**

11
12 “SECTION 39. Section 16, chapter 103, Oregon Laws 2018, is amended to read:

13 “**Sec. 16.** (1) Notwithstanding ORS 475B.759, before making any other distribution from the
14 Oregon Marijuana Account established under ORS 475B.759, the Department of Revenue shall first
15 distribute quarterly from the account the following:

16 “(a) \$875,000 to the Oregon Liquor Control Commission for deposit in the Marijuana Control and
17 Regulation Fund established under ORS 475B.296; and

18 “(b) [~~\$375,000~~] **\$750,000** to the Oregon Criminal Justice Commission for deposit into the Illegal
19 Marijuana Market Enforcement Grant Program Fund established under section 15 [*of this 2018*
20 *Act*], **chapter 103, Oregon Laws 2018**, for the purposes of paying the costs incurred by the com-
21 mission in carrying out the provisions of section 13 [*of this 2018 Act*], **chapter 103, Oregon Laws**
22 **2018**.

23 “(2) The final distribution made under subsection (1) of this section shall be made in the fiscal
24 quarter beginning on October 1, 2023.

25
26 “**ENFORCEMENT**

27
28 “SECTION 40. (1) The Oregon Liquor Control Commission shall, with the assistance of
29 the State Department of Agriculture, create and continually update a map of the locations
30 of industrial hemp operations registered or licensed under ORS 571.281 and premises for
31 which a license has been issued under ORS 475B.070.

32 “(2) The commission shall make the map described in subsection (1) of this section
33 available to law enforcement agencies in this state and public employees and officials who
34 are responsible for the enforcement of state and local laws regulating industrial hemp or
35 marijuana.

36 “SECTION 41. (1) A person commits the crime of unlawful production of marijuana if the
37 person produces marijuana or industrial hemp:

38 “(a) At a location that is not confirmed by the Oregon Health Authority, the Oregon Li-
39 quor Control Commission or the State Department of Agriculture to be the location of an
40 industrial hemp operation registered or licensed under ORS 571.281, a premises for which a
41 license was issued under ORS 475B.090 or a marijuana grow site registered under ORS
42 475B.810; and

43 “(b) In an amount that is not allowed by state law.

44 “(2) Unlawful production of marijuana is a Class A misdemeanor.

45 “(3) Marijuana or industrial hemp that is unlawfully produced, as described in subsection

1 (1) of this section, is considered contraband and may be destroyed by a law enforcement
2 agency.

3 “**SECTION 41a.** (1) The Oregon Liquor Control Commission, in consultation with the
4 State Department of Agriculture, shall develop by rule a methodology to distinguish whether
5 a cannabis plant is marijuana or industrial hemp for purposes of sections 40 to 44 of this 2021
6 Act. The methodology must include testing criteria and cannabinoid concentrations above
7 which immature or mature cannabis plants are presumptively considered to be marijuana.

8 “(2) The department may order a person registered or licensed under ORS 571.281 to de-
9 stroy any cannabis plants located at an industrial hemp operation for which the person de-
10 scribed in this subsection is responsible if the cannabis plants are presumptively considered
11 to be marijuana under the methodology adopted pursuant to subsection (1) of this section.

12 “**SECTION 42.** (1) The State Department of Agriculture may enter into an interagency
13 agreement with the Oregon Liquor Control Commission to allow representatives of the
14 commission to carry out inspections of industrial hemp crops under ORS 571.281 (7).

15 “(2) The department and the commission may adopt rules to carry out this section.

16 “**SECTION 43.** (1) Pursuant to rules adopted by the State Department of Agriculture
17 under subsection (2) of this section:

18 “(a) Law enforcement officers may accompany the department to an industrial hemp
19 operation for the purposes of providing protection for the department’s representatives; and

20 “(b) Public employees and officials who are responsible for the enforcement of state and
21 local laws may accompany the department to an industrial hemp operation in order to carry
22 out inspections that the public employees or officials are authorized to perform.

23 “(2) The department shall adopt rules to carry out this section.

24 “**SECTION 44.** The Governor may order that the Oregon National Guard provide assist-
25 ance and support to the State Department of Agriculture and law enforcement in carrying
26 out inspections of industrial hemp crops under ORS 571.281 (7) and other duties of the de-
27 partment related to the enforcement of ORS 571.260 to 571.348.

28 “**SECTION 45.** Sections 40 to 44 of this 2021 Act are repealed on January 1, 2024.

29

37 “(2) The Oregon Liquor Control Commission may take any action before the operative date
38 specified in subsection (1) of this section that is necessary to enable the commission to exercise, on
39 or after the operative date specified in subsection (1) of this section, all of the duties, functions and
40 powers conferred on the commission by sections 2 and 3 [of this 2021 Act], **chapter __, Oregon**
41 **Laws 2021**, and the amendments to ORS 475B.206, 475B.220, 475B.261 and 475B.301 by sections 4 to
42 7 [of this 2021 Act], **chapter __, Oregon Laws 2021**.
