14 "SECTION 1. ORS 801.026 is amended to read:

15 "801.026. (1) Persons, motor vehicles and equipment employed or used by a public or telecom-16 munications utility, electric cooperative or by the United States, this state or any political subdivi-17 sion of this state are exempt from the provisions of the vehicle code specified in subsection (3) of 18 this section while on a highway and working or being used to service, construct, maintain or repair 19 the facilities of a utility.

"(2) Persons, motor vehicles and equipment employed or being used in the construction or reconstruction of a street or highway are exempt from the provisions of the vehicle code specified in subsection (3) of this section if:

23 "(a) They are within the immediate construction project as described in the governmental 24 agency contract, if there is a contract; and

25 "(b) The work is being done in an area that is signed in accordance with the manual adopted 26 under ORS 810.200.

"(3) Persons, motor vehicles and equipment described in subsections (1) and (2) of this section are exempt from provisions of the vehicle code relating to rules of the road as described in ORS chapter 811, except that this subsection does not apply to:

30 "(a) Reckless driving, as defined in ORS 811.140.

31 "(b) Driving while under the influence of intoxicants, as defined in ORS 813.010.

"(c) Failure to perform the duties of a driver involved in a [collision] crash, as described in ORS
811.700 or 811.705.

34 "(d) Criminal driving while suspended or revoked, as defined in ORS 811.182.

35 "(e) Fleeing or attempting to elude a police officer, as defined in ORS 811.540.

1 "(f) The provisions of ORS 811.145, 811.155, 811.170 and 811.175.

2 "(4) Motor vehicles and equipment being used in the area and in the manner described in sub-3 section (2) of this section are also exempt from the provisions of the vehicle code relating to vehicle 4 size and weight to the extent set out in the governmental agency contract.

5

"(5) Devices moved exclusively on stationary rail tracks are exempt from the vehicle code.

6 "(6) Devices that are powered exclusively by human power are not subject to those provisions 7 of the vehicle code that relate to vehicles. Notwithstanding this subsection, bicycles are generally 8 subject to the vehicle code as provided under ORS 814.400.

9 "(7) The exemptions in subsection (3) of this section do not apply to the persons and vehicles 10 when traveling to or from the facilities or construction project.

11

"SECTION 2. ORS 801.040 is amended to read:

12 "801.040. This section describes circumstances where special provisions are made concerning the 13 authority of cities, counties or other political subdivisions in relation to some portion of the vehicle 14 code. This section is not the only section of the vehicle code that applies to such authority and 15 [*shall*] **may** not be interpreted to affect the vehicle code except as specifically provided in this sec-16 tion. The following limits are partial or complete as described:

"(1) [No] A county, municipal or other local body with authority to adopt and administer local police regulations under the Constitution and laws of this state [shall] may not enact or enforce any rule or regulation in conflict with the provisions of the vehicle code described in this subsection except as specifically authorized in the vehicle code. This subsection applies to the provisions of the vehicle code relating to abandoned vehicles, vehicle equipment, regulation of vehicle size, weight and load, the manner of operation of vehicles and use of roads by persons, animals and vehicles.

"(2) Except as provided in ORS 822.230 and this subsection, [no] a city, county or other political [subdivisions shall] subdivision may not regulate or require or issue any registration, licenses, permits or surety bonds or charge any fee for the regulatory or surety registration of any person required to obtain a certificate from the Department of Transportation under ORS 822.205. This subsection does not:

28 "(a) Limit any authority of a city or county to license and collect a general and 29 nondiscriminatory license fee levied upon all businesses or to levy a tax based upon business con-30 ducted by any person within the city or county.

31 "(b) Limit the authority of any city or county to impose any requirements or conditions as part 32 of any contract to perform towing or recovering services for the city or county.

33 "(c) Limit the authority of any city or county to impose requirements and conditions that govern 34 the towing of a vehicle by a towing business under ORS 98.812 so long as those requirements and 35 conditions are consistent with the provisions of ORS 822.230.

36 "(3) [No] A city, county or other political subdivision of this state, [nor] or any state agency, 37 may **not** adopt a regulation or ordinance that imposes a special fee for the use of public lands or 38 waters by snowmobiles or Class I all-terrain vehicles, or for the use of any access thereto that is 39 owned by or under the jurisdiction of either the United States, this state or any such city, county 40 or other political subdivision. The registration fees provided by ORS 821.320 are in lieu of any per-41 sonal property or excise tax imposed on snowmobiles by this state or any political subdivision. 42[No] A city, county or other municipality, [and no] or a state agency [shall] may not impose any 43 other registration or license fee on any snowmobile in this state. This subsection does not prohibit 44 any city, county or other political subdivision, or any state agency from regulating the operation 45 of snowmobiles or Class I all-terrain vehicles on public lands, waters and other properties under its

1 jurisdiction and on streets or highways within its boundaries by adopting regulations or ordinances 2 of its governing body if such regulations are not inconsistent with ORS 821.150 to 821.292.

3 "(4) The provisions of ORS 819.110 to 819.215 relating to towing of vehicles that are abandoned 4 establish minimum requirements subject to the following:

"(a) Notwithstanding paragraph (b) of this subsection, a county or incorporated city may su-5 persede such provisions by ordinance or charter provision. 6

7 (b) Any road authority described under ORS 810.010 may adopt rules or procedures that do not 8 conflict with such provisions to provide for additional protection for the owner or person with an interest in a vehicle subject to such provisions or that more quickly accomplish the procedures es-9 10 tablished under such provisions.

11 (5) Any incorporated city may by ordinance require that the driver of a vehicle involved in 12[an accident] a crash file with a designated city department a copy of any report required to be filed 13under ORS 811.725. All such reports shall be for the confidential use of the city department but subject to the same requirements for release of such reports as provided for the release of such re-14 15ports by the department under ORS 802.220 and 802.240.

16 "(6) Except as otherwise specifically provided in this section, in accordance with the provisions of ORS 801.041, the governing body of a county may establish by ordinance registration fees for 1718 vehicles registered at a residence or business address within the county.

19 "(7) Except as otherwise specifically provided in this section, in accordance with the provisions 20of ORS 801.042, the governing body of a district may establish by ordinance registration fees for 21vehicles registered at a residence or business address within the district.

22"SECTION 3. ORS 801.280 is amended to read:

23"801.280. 'Financial responsibility requirements' means the ability to respond in damages for liability, on account of [accidents] crashes arising out of the ownership, operation, maintenance or 2425use of a motor vehicle in a manner provided under ORS 806.060.

"SECTION 4. ORS 801.440 is amended to read:

27"801.440. 'Right of way' means the right of one vehicle or pedestrian to proceed in a lawful manner in preference to another vehicle or pedestrian approaching under such circumstances of di-28rection, speed and proximity as to give rise to danger of [collision] crashing unless one grants pre-2930 cedence to the other.

"SECTION 5. ORS 802.040 is amended to read:

"802.040. (1) The Department of Transportation shall specify the minimum contents of a report 3233 about, and the means for reporting, [accidents] crashes that are required to be reported under ORS 34810.460, 811.725, 811.730 and 811.735. The department shall consult with the state police and city and 35 county law enforcement officials before approving means for [accident] crash reports required under 36 ORS 810.460. Any means of reporting specified under this subsection shall require sufficiently de-37 tailed information to disclose, with reference to a [traffic accident] crash, the cause, conditions then 38 existing and the persons and vehicles involved. Upon request, if the department adopts forms as one 39 means of reporting [accidents] crashes, the department shall make the forms available through po-40 lice departments, sheriffs' offices and other suitable agencies or individuals.

41 "(2) The department shall assure that any means specified under subsection (1) of this section for use in [accident] crash reports required under ORS 811.725, 811.730 and 811.735 include a way 42of making owners aware of the definition of a totaled vehicle and of the owner's duty under ORS 43 44 819.012.

45 "(3) The department shall prescribe and provide suitable forms for the administration and enforcement of the financial responsibility requirements under the vehicle code or shall prescribe
any other means of accomplishing the same end that the department finds convenient.

"SECTION 6. ORS 802.050 is amended to read:

4 "802.050. (1) The Department of Transportation may compile, publish and distribute a vehicle 5 code book containing statutes administered by the department concerning vehicles and drivers, 6 along with other related laws. The department may establish and collect a reasonable fee for books 7 issued to groups or persons who are not employees of the department. Any fee established under this 8 section shall not exceed the costs of the compilation, publication and distribution of the books.

9 "(2) The department shall publish statistical information based on the analysis and tabulation 10 of [accident] **crash** reports under ORS 802.220. Publication under this subsection shall be annual or 11 at more frequent intervals.

"(3) The department shall make rules it adopts concerning aiming of headlights, auxiliary lights and passing lights available to the public in an appropriate publication.

14 "SECTION 7. ORS 802.060 is amended to read:

15

"802.060. The Department of Transportation may:

"(1) Apply for, accept and receive such grants, contributions or other moneys as may be available to this state or any of its agencies for research and other programs concerning the safe operation of motor vehicles upon the highways, including research or educational programs for the improvement of drivers, the reduction of [*traffic accidents*] **crashes** and the reduction of violations of traffic laws and ordinances.

"(2) Enter into such contracts or agreements, employ such personnel, and do all things necessary to receive available moneys and carry on any research or program mentioned in subsection (1) of this section, provided that the authority herein granted and the contracts, agreements and other acts authorized to be entered into or performed, shall be subject to and not in conflict with the provisions of any other applicable state statutes.

"SECTION 8. ORS 802.070 is amended to read:

27 "802.070. The Department of Transportation shall assist accredited schools and educational in-28 stitutions of this state in the promotion of highway safety and shall carry on with other activities 29 under the laws providing for the registration of motor vehicles and motor vehicle operators and 30 chauffeurs, other projects having for their purpose the prevention of motor vehicle [accidents] 31 crashes.

32 "

"SECTION 9. ORS 802.075 is amended to read:

33 "802.075. The Department of Transportation shall adopt rules for approval of a motor vehicle 34 [accident] crash prevention course that will qualify a person for the reduction in premium provided 35 by ORS 742.490 to 742.494. The rules may include requirements for the contents of a course and 36 qualifications of an organization offering a course.

37 "SECTION 10. ORS 802.091 is amended to read:

38 "802.091. (1) The Department of Transportation shall pay reasonable costs for the removal of
 39 any vehicle, cargo or debris resulting from a motor vehicle [accident] crash if:

40 "(a) The motor vehicle [*accident*] **crash** resulted in the death of a person 18 years of age or 41 younger;

42 "(b) The [accident] crash occurred on a state highway;

43 "(c) The surviving family members would otherwise be responsible for the cost of the cleanup;44 and

45 "(d) There is no insurance available.

1 "(2) Subsection (1) of this section does not apply if:

2 "(a) It is established by a preponderance of the evidence that the deceased was engaged in 3 conduct that would constitute a crime; or

- 4 "(b) The vehicle of the deceased was not insured under a motor vehicle liability insurance policy
 5 that complied with financial responsibility requirements under ORS 806.060.
- 6 "<u>SECTION 11.</u> ORS 802.200, as amended by section 16, chapter 701, Oregon Laws 2019, is 7 amended to read:
- 8 "802.200. In addition to any other records the Department of Transportation may establish, the 9 department is subject to the following provisions concerning records:
- "(1) The department shall maintain records concerning the titling of vehicles in this state. The records under this subsection shall include the following:
- "(a) For vehicles issued a title by this state, the records shall identify the vehicle and contain the following:
- 14 "(A) The name of the vehicle owner and any security interest holders in order of priority, except 15 that a security interest holder need not be identified if the debtor who granted the interest is in the 16 business of selling vehicles and the vehicles constitute inventory held for sale;
- 17 "(B) The name of any lessor of the vehicle;
- 18 "(C) The vehicle description; and
- 19 "(D) Whether a certificate of title was issued for the vehicle.
- 20 "(b) If the vehicle is an antique vehicle that is reconstructed, the records shall indicate that the 21 vehicle is reconstructed.
- 22 "(c) If the vehicle is a replica, the records shall indicate that the vehicle is a replica.
- 23 "(d) Any other information concerning the titling of vehicles that the department considers 24 convenient or appropriate.
- 25 "(e) All odometer disclosures and readings for a vehicle that are reported to the department 26 under provisions of the vehicle code. The department shall keep the most recent version of records 27 required under this paragraph in electronic form.
- "(f) If the vehicle has been reported to the department as a totaled vehicle under the provisions of ORS 819.012 or 819.014, the records shall indicate that the vehicle is a totaled vehicle unless the reason for the report was theft and the vehicle has been recovered.
- 31 "(2) If a vehicle that has been registered or titled in another jurisdiction is registered or titled 32 in this state, the department shall retain a record of any odometer readings shown on the title or 33 registration documents submitted to the department at the time of registration or title.
- 34 "(3) Except as otherwise provided in ORS 826.003, the department shall maintain records con-35 cerning the registration of vehicles required to be registered by the department. The records con-36 cerning the registration of vehicles may be stored along with records concerning the titling of 37 vehicles. The records under this subsection shall include the following:
- "(a) For vehicles registered by the department, the records shall identify the vehicle and containthe following:
- 40 "(A) The registration plate number assigned by the department to the vehicle;
- 41 "(B) The name of the vehicle owner;
- 42 "(C) The vehicle description and vehicle identification number; and
- "(D) An indication that the vehicle is a totaled vehicle if it has been reported to the department
 as a totaled vehicle under the provisions of ORS 819.012 or 819.014, unless the reason for the report
 was theft and the vehicle has been recovered.

1 "(b) Any other information concerning the registration of vehicles that the department considers 2 convenient or appropriate.

"(4) The department shall maintain separate records for the regulation of vehicle dealers. The
records required under this subsection shall include the following information about persons issued
dealer certificates:

"(a) The person's application for a vehicle dealer certificate.

7 "(b) An alphabetical index of the name of each person applying for a vehicle dealer certificate.

8 "(c) A numerical index according to the distinctive number assigned to each vehicle dealer.

9 "(5) The department shall maintain a file on vehicles for which the title record is canceled under 10 ORS 819.030. The records required under this subsection shall disclose the last registered owner of 11 each vehicle, any security interest holder or holders and lessors of each vehicle as shown by the 12 canceled title record for each vehicle and the make and year model for each vehicle.

"(6) The department shall maintain a record of each agreement or declaration under ORS
 802.500 and 802.520.

"(7) The department shall maintain separate and comprehensive records of all transactions affecting the Revolving Account for Emergency Cash Advances described under ORS 802.100.

17 "(8) The department shall maintain suitable records of driver licenses, driver permits and iden-18 tification cards. The records required under this subsection shall include all of the following:

19 "(a) An index by name and number.

20 "(b) Supporting documentation of all driver licenses, driver permits or identification cards is-21 sued.

22 "(c) Every application for a driver license, driver permit or identification card.

23 "(d) All driver licenses or driver permits that have been suspended, revoked or canceled.

24 "(e)(A) For each driver license, driver permit or identification card, the Social Security number 25 of the person to whom the driver license, driver permit or identification card is issued or the written 26 statement that the person has not been assigned a Social Security number.

"(B) As used in this paragraph, a 'driver license,' 'driver permit' or 'identification card' means
a driver license, driver permit or identification card that is not a:

29 "(i) Real ID;

30 "(ii) Commercial driver license; or

31 "(iii) Commercial learner driver permit.

32 "(f) For each commercial driver license and commercial learner driver permit, the Social Secu-33 rity number of the person to whom the license or permit is issued, or any other number or identi-34 fying information that the Secretary of the United States Department of Transportation determines 35 appropriate to identify the person.

36 "(g) For each Real ID, the Social Security number of the person to whom the Real ID is issued, 37 or proof that the person is not eligible for a Social Security number.

38 "(9) The Department of Transportation shall maintain a two-part driving record consisting of 39 an employment driving record and a nonemployment driving record for each person as required un-40 der this subsection. All of the following apply to the records required under this subsection:

41 "(a) The department shall maintain driving records on each person the department determines
42 requires an Oregon driving record to comply with federal regulations or provisions of the vehicle
43 code. The department shall establish rules for maintaining driving records under this subsection.

44 "(b) In addition to other information required by this paragraph, the employment driving record 45 shall include all reports of drug test results that are made to the department under ORS 825.410 or

1 825.415. Notwithstanding any other provision of law, release of the portion of the employment driv-2 ing record that shows drug test results reported under ORS 825.410 or 825.415 is permitted only in accordance with ORS 802.202. The employment driving record shall also include all motor vehicle 3 4 [accidents] crashes that the person is required to report under ORS 811.720, all suspensions of driving privileges required to be placed on the record under ORS 809.280, all suspensions of the 5 person's commercial driving privileges that result from operation or use of a commercial motor ve-6 7 hicle and all convictions, as determined by the department by rule, of the person for violation of 8 motor vehicle laws except convictions for offenses requiring mandatory revocation or suspension of driving privileges under ORS 809.409, 809.411, 809.510 to 809.545 and 813.400, but shall include only 9 such [accidents] crashes, suspensions and convictions that occur while the person is driving a motor 10 11 vehicle:

"(A) In the course of the person's employment when the person is employed by another for theprincipal purpose of driving a motor vehicle;

"(B) Carrying persons or property for compensation;

"(C) In the course of the person's employment in the collection, transportation or delivery of mail if the vehicle is government owned or marked for the collection, transportation or delivery of mail in accordance with government rules;

18 "(D) That is an authorized emergency vehicle;

19 "(E) That is a commercial motor vehicle; or

20 "(F) In the course of the person's employment with a federal, state or local government in a 21 public works project involving repair or maintenance of water, sewer or road systems.

22 "(c) The nonemployment driving record shall include the person's:

"(A) Motor vehicle [accidents] crashes that the person is required to report under ORS 811.720,
other than the motor vehicle [accidents] crashes that are included on the person's employment
driving record;

"(B) Suspensions, cancellations and revocations of licenses, permits and driving privileges;

"(C) Judgments and convictions, as determined by the department by rule, for violation of the motor vehicle laws including, for each violation of ORS 811.100 or 811.111, the speed at which the person was convicted of traveling and the posted speed, the speed limit or the speed that constitutes prima facie evidence of violation of the basic speed rule, as appropriate; and

"(D) Diversion agreements entered into under ORS 813.220 within the preceding 15 years.

32 "(d) The department may record other entries to indicate correspondence, interviews, partic-33 ipation in driver improvement programs or other matters concerning the status of the driving priv-34 ileges of the person.

35 "(e) When a person is issued a driver license or driver permit by this state, the department may 36 request a copy of driving records that exist for the person in any other jurisdiction. The department 37 shall adopt rules specifying when the department may request driving records from other jurisdic-38 tions and may apply entries from out-of-state records for use in Oregon.

39 "(f) When a suspension of a driver permit, driver license or other driving privilege is placed on 40 the driving record under ORS 809.280 for failure to appear in court on a traffic crime, the depart-41 ment shall note on the record that the suspension was for failure to appear in court and shall also 42 note the offense charged against the person on which the person failed to appear.

43 "(g) The Department of Transportation, in consultation with the Department of State Police, 44 shall devise and implement a method of noting suspensions and revocations of driving privileges on 45 the record in such a way that police agencies can determine directly from the record what class of offense, as provided by law, is committed by a person who drives in violation of the suspension or revocation. If the Department of Transportation and the Department of State Police devise a mutually agreeable alternative method of informing police agencies of the nature of a suspension or revocation and the consequences of its violation, the implementation of that method shall satisfy the duty of the Department of Transportation under this paragraph.

6 "(10) The department shall maintain [accident] **crash** reports filed with the department under 7 ORS 810.460 and 811.725 to 811.735.

8 "(11) The department shall maintain records of bank checks or money orders returned under9 ORS 802.110.

"(12) The department shall maintain records of trip permits issued by the department under ORS
803.600, as provided under this subsection. The records required by this subsection shall include the
following:

13 "(a) A description of the vehicle sufficient to identify the vehicle.

14 "(b) The person to whom the permit was issued.

15 "(c) When the permit was issued.

16 "(d) The type of permit issued.

"(e) For registration weight trip permits, the maximum allowable registration weight permitted for operation under the permit.

"(f) Any other information the department determines appropriate or convenient.

"<u>SECTION 12.</u> ORS 802.220 is amended to read:

21 "802.220. (1) Except as otherwise provided in this subsection and ORS 802.177, the records the 22 Department of Transportation maintains under ORS 802.200 on vehicles are public records. The re-23 cords of vehicles registered under ORS 805.060 are not public records and are exempt from public 24 inspection as provided under ORS 181A.220 and are for the confidential use of criminal justice 25 agencies described under ORS 181A.010. The department may charge the fee established under ORS 26 802.230 for furnishing information under this section concerning a vehicle or its owner.

"(2) The department may charge the fee established under ORS 802.230 for furnishing to the public information from the records the department maintains under ORS 802.200 concerning driver licenses or driver permits.

"(3) The records the department keeps under ORS 802.200 on judgments or convictions under
 ORS 810.375 shall be open to the inspection of any person during reasonable business hours. Nothing
 in this subsection authorizes the release of personal information as defined in ORS 802.175.

33 "(4) The department shall upon request furnish any person certified abstracts of the employment driving record and the nonemployment driving record of any person whose driving records are 3435 maintained under ORS 802.200. If an abstract of the employment driving record is not specifically 36 requested, the department shall only furnish an abstract of the nonemployment driving record. 37 Nothing in this subsection authorizes the release of personal information as defined in ORS 802.175. 38 The department shall collect the fee established for abstracts of driving records under ORS 802.230. A certified abstract issued under this section shall not contain any of the following, unless the ab-39 40 stract is being requested under ORS 746.265 (3):

41 "(a) Any [accident] crash or conviction for violation of motor vehicles laws that occurred more
42 than three years immediately preceding a request for abstract.

"(b) Any suspension ordered under ORS 809.220 after the department has received notice to
 reinstate a person's suspended driving privileges under ORS 809.220.

45 "(c) Any diversion agreement under ORS 813.220 entered into more than three years imme-

1 diately preceding a request for the abstract.

"(5) Except as otherwise provided in this subsection, [accident] crash reports filed with the department under ORS 811.725, 811.730 or 811.735 shall be without prejudice to the individual filing the report and shall be for the confidential use of state administrative and enforcement agencies. The department may use the confidential [accident] crash reports to provide the following information to the persons described:

"(a) Upon request, the department shall disclose the following information to any party involved
in the [accident] crash or to their personal representative or any member of the family of a party
involved in the [accident] crash:

"(A) The identity of the owner, driver, occupants and the registration number of a vehicle involved in the [accident] crash;

"(B) The names of any companies insuring the owner or driver of a vehicle involved in the [accident] crash; and

14 "(C) The names of any witnesses to the [accident] crash.

(1) A person commits the offense of failure of a garage to report [an accident] **a crash** ³⁶ or bullet contact if the person is in charge of any garage or repair shop to which is brought any ³⁷ motor vehicle that shows evidence of having been involved in a serious [accident] **crash** or struck ³⁸ by any bullet and the person does not report to the nearest police station or sheriff's office within ³⁹ 24 hours after such motor vehicle is received giving the registration number and the name and ad-⁴⁰ dress of the owner or operator of such vehicle.

"(2) An additional report need not be made under this section when the owner of the vehicle is
also the owner of the garage or repair shop and the person has made a report under ORS 811.725

(1) The Department of Transportation shall adopt regulations prescribing specifications 3 for the construction and maintenance of railroad-highway crossings, both at grade level and at sep-4 arated grades. 30 "D(6)(b)(i) <u>Content of electronic transmissions.</u> If the court allows service by a specific elec-31 tronic method, the case name, case number, and name of the court in which the action is pending 32 must be prominently positioned where it is most likely to be read first. For e-mail service, those 33 details must appear in the subject line. For text message service, they must appear in the first line 34 of the first text. For facsimile service, they must appear at the top of the first page. For posting to 35 a social media account, they must appear in the top lines of the posting.

³⁶ "D(6)(b)(ii) <u>Format of electronic transmissions.</u> If the court allows alternative service by an ³⁷ electronic method, the summons, complaint, and any other documents must be attached in a file ³⁸ format that is capable of showing a true copy of the original document. When an electronic method ³⁹ is incapable of transferring transmissions that exceed a certain size, the plaintiff must not exceed ⁴⁰ those express size limitations. If the size of the attachments exceeds the limitations of any electronic ⁴¹ method allowed, then multiple sequential transmissions may be sent immediately after the initial ⁴² transmission to complete service.

However, nothing contained in this section requires the insurer to reproduce in the policy the particular language of 5 any of the following provisions: 6

7 "(1)(a) Notwithstanding ORS 30.260 to 30.300, the insurer will pay all sums that the insured or 8 the heirs or legal representative of the insured is legally entitled to recover as damages from the owner or operator of an uninsured vehicle because of bodily injury sustained by the insured caused 9 10 by accident and arising out of the ownership, maintenance or use of the uninsured vehicle. 15(b) No judgment against any person or organization alleged to be legally responsible for bodily 16 injury, except for proceedings instituted against the insurer as provided in this policy, shall be 17conclusive, as between the insured and the insurer, on the issues of liability of the person or or-18 ganization or of the amount of damages to which the insured is legally entitled.

19 "(2) As used in this policy:

"(a) 'Bodily injury' means bodily injury, sickness or disease, including death resulting therefrom.

21(b) 'Hit-and-run vehicle' means a vehicle that causes bodily injury to an insured arising out of 22physical contact of the vehicle with the insured or with a vehicle the insured is occupying at the 23time of the [accident] **crash**, provided:

24"(A) The identity of either the operator or the owner of the hit-and-run vehicle cannot be as-25certained;

"(B) The insured or someone on behalf of the insured reported the [accident] crash within 72 2627hours to a police, peace or judicial officer, to the Department of Transportation or to the equivalent department in the state where the [accident] crash occurred, and filed with the insurer within 30 28 29days thereafter a statement under oath that the insured or the legal representative of the insured 30 has a cause or causes of action arising out of the [accident] crash for damages against a person or persons whose identities are unascertainable, and setting forth the facts in support thereof; and 31

32"(C) At the insurer's request, the insured or the legal representative of the insured makes 33 available for inspection the vehicle the insured was occupying at the time of the [accident] crash. 34

"(c) 'Insured,' when unqualified and when applied to uninsured motorist coverage, means:

35 "(A) The named insured as stated in the policy and any person designated as named insured in 36 the schedule and, while residents of the same household, the spouse of any named insured and rel-37 atives of either, provided that neither the relative nor the spouse is the owner of a vehicle not de-38 scribed in the policy and that, if the named insured as stated in the policy is other than an 39 individual or spouses in a marriage who are residents of the same household, the named insured 40 shall be only a person so designated in the schedule;

41 "(B) Any child residing in the household of the named insured if the insured has performed the 42duties of a parent to the child by rearing the child as the insured's own although the child is not related to the insured by blood, marriage or adoption; and 43

44 "(C) Any other person while occupying an insured vehicle, provided the actual use thereof is 45 with the permission of the named insured.

1 "(d) 'Insured vehicle,' except as provided in paragraph (e) of this provision, means:

2 "(A) The vehicle described in the policy or a newly acquired or substitute vehicle, as each of 3 those terms is defined in the public liability coverage of the policy, insured under the public liability 4 provisions of the policy; or

"(g) 'Phantom vehicle' means a vehicle that causes bodily injury to an insured arising out of a motor vehicle [accident] crash that is caused by a vehicle that has no physical contact with the insured or the vehicle the insured is occupying at the time of the [accident] crash, provided:

15 "(A) The identity of either the operator or the owner of the phantom vehicle cannot be ascer-16 tained;

"(B) The facts of the [accident] crash can be corroborated by competent evidence other than the testimony of the insured or any person having an uninsured motorist claim resulting from the [accident] crash; and

"(C) The insured or someone on behalf of the insured reported the [accident] **crash** within 72 hours to a police, peace or judicial officer, to the Department of Transportation or to the equivalent department in the state where the [accident] **crash** occurred, and filed with the insurer within 30 days thereafter a statement under oath that the insured or the legal representative of the insured has a cause or causes of action arising out of the [accident] **crash** for damages against a person or persons whose identities are unascertainable, and setting forth the facts in support thereof.

"(h) 'State' includes the District of Columbia, a territory or possession of the United States anda province of Canada.

"(i) 'Stolen vehicle' means an insured vehicle that causes bodily injury to the insured arising
out of a motor vehicle [accident] crash if:

"(A) The vehicle is operated without the consent of the insured;

31 "(B) The operator of the vehicle does not have collectible motor vehicle bodily injury liability 32 insurance;

"(C) The insured or someone on behalf of the insured reported the [accident] crash within 72
 hours to a police, peace or judicial officer or to the equivalent department in the state where the
 [accident] crash occurred; and

36 "(D) The insured or someone on behalf of the insured cooperates with the appropriate law 37 enforcement agency in the prosecution of the theft of the vehicle.

38 "(j) 'Sums that the insured or the heirs or legal representative of the insured is legally entitled 39 to recover as damages' means the amount of damages that:

"(A) A claimant could have recovered in a civil action from the owner or operator at the time
of the injury after determination of fault or comparative fault and resolution of any applicable defenses;

43 "(B) Are calculated without regard to the tort claims limitations of ORS 30.260 to 30.300; and

44 "(C) Are no larger than benefits payable under the terms of the policy as provided in subsection45 (7) of this section.

1 "(k) 'Uninsured vehicle,' except as provided in paragraph (L) of this provision, means:

2 "(A) A vehicle with respect to the ownership, maintenance or use of which there is no collectible motor vehicle bodily injury liability insurance, in at least the amounts or limits prescribed for 3 4 bodily injury or death under ORS 806.070 applicable at the time of the [accident] crash with respect 5 to any person or organization legally responsible for the use of the vehicle, or with respect to which there is collectible bodily injury liability insurance applicable at the time of the [accident] crash but 6 7 the insurance company writing the insurance denies coverage or the company writing the insurance 8 becomes voluntarily or involuntarily declared bankrupt or for which a receiver is appointed or be-9 comes insolvent. Proof of claim shall be made upon forms furnished by the insurer unless the insurer fails to furnish the forms within 15 days after receiving notice of claim.
