SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Requires Department of Transportation to study development of uniform standards for speed bump height and markings.]

[Sunsets January 2, 2023.]

Prohibits sale of gasoline by dealer unless it contains at least 10 percent denatured fuel ethanol by volume or concentrations of at least 9.2 percent anhydrous ethanol by volume.

A BILL FOR AN ACT

2 Relating to transportation; amending ORS 646.913.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 646.913 is amended to read:

5 646.913. (1) Except as provided in subsection (4) of this section, a wholesale dealer, retail dealer
6 or nonretail dealer may not sell gasoline or offer gasoline for sale unless the gasoline contains **at**
7 **least** 10 percent denatured fuel ethanol by volume. Gasoline that contains anhydrous ethanol in
8 concentrations *[between 9.2 percent and 10 percent]* **of at least 9.2 percent** by volume complies with
9 the requirement set forth in this subsection.

10 (2) The State Department of Agriculture shall adopt standards for gasoline blended with ethanol
11 that is sold in this state. The standards that the department adopts shall require that the gasoline
12 blended with ethanol:

13 (a) Contains ethanol that is derived from agricultural or woody waste or residue;

14 (b) Complies with the volatility requirements specified in 40 C.F.R. part 80;

15 (c) Complies with ASTM International specification D 4814, Standard Specification for Autom-
16 tive Spark-Ignition Engine Fuel;

17 (d) Is not blended with casinghead gasoline, absorption gasoline, drip gasoline or natural gaso-
18 line after the gasoline has been sold, transferred or otherwise removed from a refinery or terminal;
19 and

20 (e) Contains denatured fuel ethanol that complies with ASTM International specification D 4806,
21 Standard Specification for Denatured Fuel Ethanol for Blending with Gasolines for Use as Autom-
22 tive Spark-Ignition Engine Fuel.

23 (3) The department may review specifications adopted by ASTM International, or equivalent
24 organizations, and federal regulations and revise the standards adopted under this section as nec-
25 essary.

26 (4) A wholesale dealer, retail dealer or nonretail dealer may sell or offer for sale gasoline that

1 is not blended with ethanol if the gasoline has an octane rating, as defined in ORS 646.945, of 91
2 or above or if the gasoline is for use in:

3 (a) An aircraft:

4 (A) With a supplemental type certificate approved by the Federal Aviation Administration that
5 allows the aircraft to use gasoline that is intended for use in motor vehicles; or

6 (B) Issued a type certificate by an aircraft engine manufacturer that allows the aircraft to use
7 gasoline that is intended for use in motor vehicles;

8 (b) An aircraft that has been issued an experimental certificate, as described in 14 C.F.R. 21.191,
9 by the Federal Aviation Administration and for which the manufacturer's specifications require the
10 use of gasoline that is intended for use in motor vehicles;

11 (c) A light-sport aircraft, as defined in 14 C.F.R. 1.1, for which the manufacturer's specifications
12 require the use of gasoline that is intended for use in motor vehicles;

13 (d) A vintage aircraft, as defined by the Oregon Department of Aviation by rule, for which the
14 manufacturer's specifications require the use of gasoline that is intended for use in motor vehicles;

15 (e) An antique vehicle, as defined in ORS 801.125;

16 (f) A Class I all-terrain vehicle, as defined in ORS 801.190;

17 (g) A Class III all-terrain vehicle, as defined in ORS 801.194;

18 (h) A Class IV all-terrain vehicle, as defined in ORS 801.194 (2);

19 (i) A racing activity vehicle, as defined in ORS 801.404;

20 (j) A snowmobile, as defined in ORS 801.490;

21 (k) Tools, including but not limited to lawn mowers, leaf blowers and chain saws; or

22 (L) A watercraft.
