SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies, adds and repeals laws relating to transportation.
Takes effect on 91st day following adjournment sine die.

16 **Be It Enacted by the People of the State of Oregon:**

18 **IN GENERAL**

19
20 **SECTION 1.** ORS 811.602, as amended by section 2, chapter 413, Oregon Laws 2019, is amended
21 to read:

22 811.602. (1) A disabled person parking permit is a means of identifying vehicles being used to
23 exercise the parking privileges described in ORS 811.635. The following are disabled person parking
24 permits:

25 (a) A special decal described in ORS 811.605 issued by the Department of Transportation to be
26 affixed to a golf cart or substantially similar vehicle;

27 (b) An individual placard described in ORS 811.605;

28 (c) A program placard issued by the department under ORS 811.607;

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted.
New sections are in **boldfaced** type.

1 (d) A family placard issued by the department under ORS 811.609;

2 (e) A foreign visitor placard issued by the department under ORS 811.611;

3 (f) A “Wheelchair User” placard or decal issued by the department under ORS 811.613; and

4 (g) An “Oregon Wounded Warrior” placard or decal issued by the department under ORS
5 811.616.

6 (2) The department shall issue a disabled person parking permit in the form of a decal or indi-
7 vidual placard to any person who submits an application that complies with ORS 811.604. Nothing
8 in this section prohibits the department from issuing a decal or individual placard to a person who
9 has disabled veteran registration plates issued under ORS 805.100 and who qualifies for the decal
10 or placard.

11 (3) Except as otherwise provided in this subsection, the department may not issue more than one
12 individual placard to an applicant. The department may issue a replacement placard upon receipt
13 of proof satisfactory to the department that the original placard has been lost, mutilated or de-
14 stroyed. The department may issue a temporary duplicate permit to a person who needs a duplicate
15 permit for travel purposes. A temporary duplicate permit shall be valid for **up to** 120 days. The de-
16 partment shall adopt rules governing application for and issuance of temporary duplicate permits.
17 Nothing in this subsection prohibits issuance of an individual placard to a person who has been is-
18 sued a decal.

19 *[(4) Permits issued under this section may be renewed by mail.]*

20 *[(5)]* (4) Permits for use on vehicles that are regularly used as part of a program for the trans-
21 portation of persons with disabilities are issued as provided in ORS 811.607.

22 *[(6)]* (5) Except as provided in subsection *[(7)]* (6) of this section, the department shall determine
23 the form, size and content of any decal or placard issued under this section and shall adopt rules
24 governing their issuance, display and use as necessary to carry out this section.

25 *[(7)(a)]* (6)(a) Except as provided in paragraph (b) of this subsection, the department may not
26 require a decal or placard issued under this section to an individual or a family to contain any
27 identifying information about the person to whom the decal or placard is issued, including any of
28 the following:

29 (A) Name;

30 (B) Address;

31 (C) Telephone number;

32 (D) Social Security number;

33 (E) Driver license number;

34 (F) Golf cart driver permit number;

35 (G) Identification card number;

36 (H) Passport or visa number; or

37 (I) Photograph.

38 (b) The department may require a decal or placard issued under this section to an individual
39 or a family to contain not more than four digits of the driver license or identification card number
40 of the person to whom the decal or placard is issued.

41 **SECTION 2. Section 3 of this 2021 Act is added to and made a part of the Oregon Vehicle**
42 **Code.**

43 **SECTION 3. The Department of Transportation shall invalidate a disabled parking permit**
44 **issued under ORS 811.602 if any of the following occurs:**

45 (1) **The department receives information that the person issued an individual or**

1 **“Wheelchair User” placard or permit has since obtained a driver license or driver permit**
2 **issued by another jurisdiction or has since obtained an identification card in another juris-**
3 **isdiction that is similar to the person’s identification card issued by this state.**

4 (2) **The department receives notice that the person issued a disabled parking permit is**
5 **deceased.**

6 (3) **The department determines that the disabled parking permit was issued under**
7 **fraudulent circumstances.**

8 (4) **The department determines that the person, program or family for which the permit**
9 **was issued no longer qualifies for the permit.**

10 **SECTION 4.** ORS 811.604 is amended to read:

11 811.604. Application for issuance or renewal of a disabled person parking permit in the form of
12 an individual placard or decal issued under ORS 811.602 shall include:

13 (1) A certificate, signed and dated within six months preceding the date of application, by a li-
14 censed physician, a licensed nurse practitioner or a licensed physician assistant to the Department
15 of Transportation that the applicant is a person with a disability or a certificate, signed and dated
16 within six months preceding the date of application, by a licensed optometrist that the applicant is
17 a person with a disability because of loss of vision or substantial loss of visual acuity or visual field
18 beyond correction;

19 (2) The state-issued licensing number of the licensed physician, certified nurse practitioner, li-
20 censed physician assistant or licensed optometrist who signed the certificate described in subsection
21 (1) of this section; and

22 (3) The number of a [*current, valid*] driver license, [*golf cart*] driver permit, identification card
23 or parking identification card issued to the applicant by the department.

24 **SECTION 5.** ORS 811.605 is amended to read:

25 811.605. (1) An applicant for an individual placard or decal issued by the Department of Trans-
26 portation under ORS 811.602 must have a driver license, a [*disability golf cart*] driver permit, an
27 identification card or a parking identification card issued by the department. [*The placard or decal*
28 *shall be valid so long as the license, permit, identification card or parking identification card is valid*
29 *and may be renewed when the license, permit or card is renewed.*]

30 (2) An individual placard or decal shall contain an expiration date that is visible from outside
31 the vehicle when the placard or decal is displayed on or in the vehicle. [*The expiration date shall*
32 *be the same as the expiration date of the driver license, golf cart driver permit, identification card or*
33 *parking identification card of the holder of the placard.*]

34 (3) **A placard or decal issued under this section shall be valid for a period of eight years**
35 **from the date of issue. A placard or decal may be renewed in a manner determined by the**
36 **department by rule.**

37 **SECTION 6.** ORS 811.613 is amended to read:

38 811.613. (1) The Department of Transportation shall issue a “Wheelchair User” disabled person
39 parking permit in the form of a “Wheelchair User” placard or decal for use by a person who uses
40 a wheelchair or similar low-powered motorized or mechanically propelled vehicle designed specif-
41 ically for use by a person with a physical disability.

42 (2) The department shall determine the form, size and content of the placards or decals, except
43 that the department shall require that the placards or decals:

44 (a) Include the words “Wheelchair User.”

45 (b) Have an expiration date that is visible from outside the vehicle when the placard or decal

1 is displayed on or in the vehicle.

2 (3) The department shall by rule determine how a person may qualify for a “Wheelchair User”
3 placard or decal under this section.

4 (4) An applicant for a “Wheelchair User” placard or decal issued by the department under this
5 section must have a driver license, a [*disability golf cart*] driver permit or an identification card is-
6 sued by the department. [*The placard or decal shall be valid as long as the license, permit or iden-*
7 *tification card is valid and may be renewed when the license, permit or identification card is*
8 *renewed.*]

9 [*(5) The expiration date shall be the same as the expiration date of the driver license, disability*
10 *golf cart driver permit or identification card of the holder of the placard or decal.*]

11 **(5) A placard or decal issued under this section shall be valid for a period of eight years**
12 **from the date of issue. A placard or decal may be renewed in a manner determined by the**
13 **department by rule.**

14 **SECTION 7.** ORS 811.616 is amended to read:

15 811.616. (1) The Department of Transportation shall issue an “Oregon Wounded Warrior” disa-
16 bled person parking permit in the form of an “Oregon Wounded Warrior” placard or decal for use
17 by a wounded warrior.

18 (2) A person is a wounded warrior who qualifies for an “Oregon Wounded Warrior” parking
19 permit if the person:

20 (a) Submits written proof to the Department of Transportation of having a United States De-
21 partment of Veterans Affairs total disability rating of at least 50 percent as a result of an injury
22 or illness that the veteran incurred, or that was aggravated, during active military service; and

23 (b) Received a discharge or release under other than dishonorable conditions.

24 (3) The Department of Transportation shall determine the form, size and content of the placards
25 or decals, except that the department shall require that the placards or decals:

26 (a) Include the words “Oregon Wounded Warrior.”

27 (b) Have an expiration date that is visible from outside the vehicle when the placard or decal
28 is displayed on or in the vehicle.

29 (4) The Department of Transportation shall by rule determine how a person may apply for an
30 “Oregon Wounded Warrior” placard or decal under this section.

31 (5) An applicant for an “Oregon Wounded Warrior” placard or decal issued by the Department
32 of Transportation under this section must have a driver license, a [*disability golf cart*] driver permit
33 or an identification card issued by the department. [*The placard or decal shall be valid as long as*
34 *the license, permit or identification card is valid and may be renewed when the license, permit or*
35 *identification card is renewed.*]

36 [*(6) The expiration date shall be the same as the expiration date of the driver license, disability*
37 *golf cart driver permit or identification card of the holder of the placard or decal.*]

38 **(6) A placard or decal issued under this section shall be valid for a period of eight years**
39 **from the date of issue. A placard or decal may be renewed in a manner determined by the**
40 **department by rule.**

41 **SECTION 8.** ORS 819.016 is amended to read:

42 819.016. (1) Except as provided in subsection (2) of this section, when the provisions of ORS
43 819.010, 819.012 or 819.014 require a person to surrender to the Department of Transportation a
44 certificate of title for a vehicle, or when a person acquires a vehicle under the provisions of ORS
45 819.215, the person shall apply to the department for a salvage title for the vehicle. The application

1 shall comply with the requirements of ORS 803.140.

2 (2) When the person is not required to surrender a certificate of title because title for the ve-
3 hicle was issued in some other form, the person shall follow procedures adopted by the department
4 by rule.

5 *[(3) Subsections (1) and (2) of this section do not apply if the person does not intend to rebuild or*
6 *repair the vehicle, to transfer the vehicle or to use the frame or unibody of the vehicle for repairing or*
7 *constructing another vehicle.]*

8 **(3) Subsections (1) and (2) of this section do not apply if the person:**

9 **(a) Does not intend to rebuild or repair the vehicle, to transfer the vehicle or to use**
10 **frame or unibody of the vehicle for repairing or constructing another vehicle; or**

11 **(b) Rebuilds or repairs the vehicle and applies to title the vehicle with the designation**
12 **of assembled, reconstructed or replica.**

13 **SECTION 9.** ORS 824.068 is amended to read:

14 824.068. (1) The Department of Transportation shall prescribe standards for water quality [*and*
15 *sanitation facilities*] on railroad locomotives [*and cabooses*] in this state.

16 (2) The department may for good cause shown permit variances from the standards so pre-
17 scribed.

18 **SECTION 10.** ORS 319.665 is amended to read:

19 319.665. (1) The seller of fuel for use in a motor vehicle shall collect the tax provided by ORS
20 319.530 at the time the fuel is sold, unless one of the following situations applies:

21 *[(a) The Department of Transportation has issued a weight identifier under ORS 825.450 for the*
22 *vehicle into which the seller delivers or places the fuel.]*

23 **(a) The Department of Transportation has issued for the vehicle into which the seller**
24 **delivers or places the fuel a weight identifier under ORS 825.450 or a valid user's emblem**
25 **under ORS 319.600.**

26 (b) The fuel is dispensed at a nonretail facility, in which case the seller shall collect any tax
27 owed at the same time the seller collects the purchase price from the person to whom the fuel was
28 dispensed at the nonretail facility. A seller is not required to collect the tax under this paragraph
29 from a person who certifies to the seller that the use of the fuel is exempt from the tax imposed
30 under ORS 319.530.

31 (c) A cardlock card is used for purchase of the fuel at an attended portion of a retail facility
32 equipped with a cardlock card reader, in which case the cardlock card issuer licensed in this state
33 is responsible for collecting and remitting the tax unless the person making the purchase certifies
34 to the seller that the use of the fuel is exempt from the tax imposed under ORS 319.530.

35 (2) If a cardlock card is used for purchase of fuel at an attended portion of a retail facility
36 equipped with a cardlock card reader, the seller at the retail facility may deduct fuel purchases
37 made with a cardlock card from the seller's retail transactions if the seller provides the department
38 with the following information:

39 (a) A monthly statement from a cardlock card issuer that details the cardlock card purchases
40 at the retail facility; and

41 (b) A listing of cardlock card issuers and gallons of fuel purchased at the retail facility by the
42 issuers' customers.

43 (3) The department shall supply each seller of fuel for use in a motor vehicle with a chart which
44 sets forth the tax imposed on given quantities of fuel.

45 **SECTION 11.** ORS 319.671 is amended to read:

1 319.671. (1) The seller of fuel for any purpose shall make a duplicate invoice for every sale of
2 fuel for any purpose and shall retain one copy and give the other copy to the user. The Department
3 of Transportation may prescribe the form of the invoice. The invoice shall show:

- 4 (a) The seller's name and address;
- 5 (b) The date;
- 6 (c) The amount of the sale in gallons; and
- 7 (d) The name and address of the user.

8 (2) In addition to the invoice entries listed in subsection (1) of this section, the seller of fuel for
9 use in a motor vehicle shall indicate on the invoice the amount of the tax collected, if any, and:

10 (a) The license plate number, if the vehicle bears a license plate issued by the department or
11 another jurisdiction;

12 (b) The emblem number, if the vehicle bears a user's emblem; *[or]*

13 (c) The temporary pass number, if the vehicle bears no valid user's emblem *[or license plate is-*
14 *sued by the department.]*; **or**

15 **(d) The license plate number, if the vehicle bears no valid user's emblem or temporary**
16 **pass number issued by the department.**

17 (3) Notwithstanding subsection (1) of this section, this section does not require any invoice to
18 be prepared for any sale where fuel is delivered into the fuel tank of a vehicle described in this
19 subsection unless the operator of the vehicle requests an invoice. If an invoice is prepared under
20 this subsection, the name and address of a user is not required to be shown on the invoice for sales
21 where the fuel is delivered into the fuel tanks of vehicles described in this subsection. This sub-
22 section applies to vehicles:

23 (a) That have a combined weight of 26,000 pounds or less; and

24 (b)(A) For which the tax under ORS 319.530 must be paid at the time of sale under ORS 319.665;

25 or

26 (B) For which an emblem has been issued under ORS 319.535.

27 **SECTION 12.** ORS 819.010 is amended to read:

28 819.010. (1) A person commits the offense of failure to comply with requirements for destruction
29 of a vehicle if the person wrecks, dismantles[,] **or** disassembles *[or substantially alters]* the form of
30 any vehicle that is or is required to be registered or titled under the vehicle code or under ORS
31 chapter 826 and the person does not comply with all of the following:

32 (a) The person must give notice to the Department of Transportation, in a form specified by the
33 department, of the person's intention to dismantle, disassemble[,] **or** wreck *[or substantially alter]* the
34 form of the vehicle at least seven days prior to commencement thereof.

35 (b) If the vehicle is visible from a public right of way, the person must complete the wrecking,
36 dismantling[,] **or** disassembling *[or substantial alteration]* of **the form of the vehicle** within 30 days
37 from the commencement thereof.

38 (c) If the vehicle is registered by this state, the person must deliver or mail to the department
39 the registration card, certificate of title, if one has been issued, and registration plates of the vehicle
40 within 30 days after the person wrecks, dismantles[,] **or** disassembles *[or substantially alters]* the
41 form of the vehicle.

42 (d) If no certificate of title has been issued for the vehicle, the person must notify the depart-
43 ment in a manner determined by the department by rule within 30 days after the person wrecks,
44 dismantles[,] **or** disassembles *[or substantially alters]* the form of the vehicle.

45 (e) If required to do so under ORS 819.016, the person shall apply for a salvage title for the

1 vehicle.

2 (2) This section does not apply to persons who are acting within the scope of a dismantler cer-
3 tificate issued under ORS 822.110.

4 (3) The offense described in this section, failure to comply with requirements for destruction of
5 vehicle, is a Class A misdemeanor.

6 **SECTION 13.** ORS 319.950 is amended to read:

7 319.950. (1) **The governing body of** a city, county or other local government may enact or
8 amend any charter provision, ordinance, resolution or other provision taxing fuel for motor vehicles
9 after submitting the proposed tax to the electors of the local government for their approval.

10 (2) **The governing body of a local government that imposes a tax on fuel for motor vehi-**
11 **cles pursuant to this section may enter into an intergovernmental agreement under ORS**
12 **190.010 with the Department of Transportation pursuant to which the department shall col-**
13 **lect and distribute the revenues from the tax.**

14 **SECTION 14.** The amendments to ORS 319.950 by section 13 of this 2021 Act apply to
15 intergovernmental agreements entered into on or after January 1, 1977, by the governing
16 body of a city, county or other local government with the Department of Transportation for
17 purposes of the collection and distribution of revenues from taxes on fuel for motor vehicles
18 by the department.

19 **SECTION 15.** ORS 346.510 is amended to read:

20 346.510. As used in ORS 346.510 to 346.570:

21 (1) "Cafeteria" means a food-dispensing facility:

22 (a) That can provide a variety of prepared foods and beverages;

23 (b) Where a patron may move through a self-service line;

24 (c) That may employ some servers to wait on patrons; and

25 (d) That provides seating suitable for patrons to consume meals.

26 (2) "Healthy vending item" and "local vending item" have the meanings given those terms by
27 rules adopted by the Commission for the Blind in consultation with the Public Health Director and
28 the business enterprise consumer committee.

29 (3) "Person who is blind" means a person who has not more than 20/200 visual acuity in the
30 better eye with best correction or whose visual acuity, if better than 20/200, is accompanied by a
31 limit to the field of vision to such a degree that its widest diameter subtends an angle of no greater
32 than 20 degrees and whose blindness is certified by a licensed physician who specializes in diseases
33 of the eye.

34 (4) "Political subdivision" means a local government as defined in ORS 174.116, a municipality,
35 town or village of this state.

36 (5) "Public building" or "property" means a building, land or other real property, or a portion
37 of a building, land or other real property, that is occupied by a department or an agency of the State
38 of Oregon or by a political subdivision, except for a public elementary school, a secondary school,
39 a public university listed in ORS 352.002 or a public corporation created pursuant to ORS 353.020.

40 (6) "Vending facility" means:

41 (a) Shelters, counters, shelving, display and wall cases, refrigerating apparatus and other ap-
42 propriate auxiliary equipment that are necessary or customarily used for the vending of articles,
43 including an established mix of healthy vending items approved by the Commission for the Blind and
44 the agency, department or political subdivision charged with maintaining the public building or
45 property where the vending facility is located;

1 (b) Vending machines; or

2 (c) Cafeterias or snack bars for the dispensing of foodstuffs and beverages.

3 (7) "Vending facility manager" means a person who is:

4 (a) Blind;

5 (b) Responsible for the day-to-day conduct of the vending facility operation; and

6 (c) Licensed under ORS 346.510 to 346.570.

7 (8) "Vending machine" means a manual or coin-operated machine or a similar device used for
8 vending articles, including machines or devices that accept electronic payment.

9 (9) "Visitor venue" means a public building or property that is operated by a political subdivi-
10 sion of this state and that is:

11 (a) A convention, event or exposition center;

12 (b) A zoo;

13 (c) A performing arts center;

14 (d) A museum;

15 (e) A golf course;

16 (f) A facility primarily used for sporting events; or

17 (g) A commercial airport owned and operated by a city, **a county** or a port district organized
18 under ORS chapter 778.

19 **SECTION 16.** ORS 811.260 is amended to read:

20 811.260. Except as provided in ORS 811.265 (2), a driver is in violation of ORS 811.265 if the
21 driver makes a response to traffic control devices that is not permitted under the following:

22 (1) Green signal. A driver facing a green light may proceed straight through or turn right or left
23 unless a sign at that place prohibits either turn. A driver shall yield the right of way to other ve-
24 hicles within the intersection at the time the green light is shown.

25 (2) Green arrow. A driver facing a green arrow signal light, shown alone or in combination with
26 another signal, may cautiously enter the intersection only to make the movement indicated by such
27 arrow or such other movement as is permitted by other signals shown at the same time.

28 (3) Green bicycle signal. A bicyclist facing a green bicycle signal may proceed straight through
29 or turn right or left unless a sign at that place prohibits either turn. The bicyclist shall yield the
30 right of way to other vehicles within the intersection at the time the green bicycle signal is shown.

31 (4) Steady circular yellow signal. A driver facing a steady circular yellow signal light is thereby
32 warned that the related right of way is being terminated and that a red or flashing red light will
33 be shown immediately. A driver facing the light shall stop at a clearly marked stop line, but if none,
34 shall stop before entering the marked crosswalk on the near side of the intersection, or if there is
35 no marked crosswalk, then before entering the intersection. If a driver cannot stop in safety, the
36 driver may drive cautiously through the intersection.

37 (5) Steady yellow arrow signal. A driver facing a steady yellow arrow signal, alone or in com-
38 bination with other signal indications, is thereby warned that the related right of way is being ter-
39 minated. Unless entering the intersection to make a movement permitted by another signal, a driver
40 facing a steady yellow arrow signal shall stop at a clearly marked stop line, but if none, shall stop
41 before entering the marked crosswalk on the near side of the intersection, or if there is no marked
42 crosswalk, then before entering the intersection. If a driver cannot stop in safety, the driver may
43 drive cautiously through the intersection.

44 (6) Steady yellow bicycle signal. A bicyclist facing a steady yellow bicycle signal is thereby
45 warned that the related right of way is being terminated and that a red bicycle signal will be shown

1 immediately. A bicyclist facing a steady yellow bicycle signal shall stop at a clearly marked stop
 2 line, but if none, shall stop before entering the marked crosswalk on the near side of the inter-
 3 section, or if there is no marked crosswalk, then before entering the intersection. If a bicyclist
 4 cannot stop in safety, the bicyclist may proceed cautiously through the intersection.

5 (7) Steady circular red signal. A driver facing a steady circular red signal light alone shall stop
 6 at a clearly marked stop line, but if none, before entering the marked crosswalk on the near side
 7 of the intersection, or if there is no marked crosswalk, then before entering the intersection. The
 8 driver shall remain stopped until a green light is shown except when the driver is permitted to
 9 proceed under ORS 811.360.

10 (8) Steady red arrow signal. A driver facing a steady red arrow signal, alone or in combination
 11 with other signal indications, may not enter the intersection to make the movement indicated by the
 12 red arrow signal. Unless entering the intersection to make some other movement which is permitted
 13 by another signal, a driver facing a steady red arrow signal shall stop at a clearly marked stop line,
 14 but if none, before entering the marked crosswalk on the near side of the intersection, or if there
 15 is no marked crosswalk, then before entering the intersection. The vehicle shall remain stopped until
 16 a green light is shown except when the driver is permitted to proceed under ORS 811.360.

17 (9) Steady red bicycle signal. A bicyclist facing a steady red bicycle signal shall stop at a clearly
 18 marked stop line, but if none, before entering the marked crosswalk on the near side of the inter-
 19 section, or if there is no marked crosswalk, then before entering the intersection. The bicyclist shall
 20 remain stopped until a green bicycle signal is shown except when the bicyclist is permitted to pro-
 21 ceed under ORS 811.360.

22 (10) Traffic control devices at places other than intersections. If a traffic control device that is
 23 a signal is erected and maintained at a place other than an intersection, the provisions of this sec-
 24 tion relating to signals shall be applicable. A required stop shall be made at a sign or marking on
 25 the roadway indicating where the stop shall be made, but in the absence of such sign or marking
 26 the stop shall be made at the signal.

27 (11) Flashing red signal. When a driver approaches a flashing red light used in a traffic control
 28 device or with a traffic sign, the driver shall stop at a clearly marked stop line, but if none, before
 29 entering the marked crosswalk on the near side of the intersection, or if there is no marked cross-
 30 walk, then at the point nearest the intersecting roadway where the driver has a view of approaching
 31 traffic on the intersecting roadway before entering it. The right to proceed shall be subject to the
 32 rules applicable after making a stop at a stop sign. This subsection does not apply to:

33 (a) A person operating a bicycle; or

34 (b) Drivers at railroad grade crossings. Conduct of a driver approaching a railroad grade
 35 crossing is governed by ORS 811.455.

36 (12) Flashing circular yellow signal. *[When a driver approaches a flashing circular yellow light*
 37 *used as a signal in a traffic control device or with a traffic sign, the driver may proceed through the*
 38 *intersection or past the signal only with caution.]* **When a driver facing a flashing circular yellow**
 39 **signal approaches an intersection, the driver may cautiously enter the intersection to pro-**
 40 **ceed straight through, turn right or turn left except as such movement is modified by lane**
 41 **use signs, turn prohibition signs, lane markings, roadway design, separate turn signal indi-**
 42 **cations or other traffic control devices.** This subsection does not apply at railroad grade
 43 crossings. Conduct of a driver approaching a railroad grade crossing is governed by ORS 811.455.

44 (13) Flashing yellow arrow signal. A driver facing a flashing yellow arrow signal, alone or in
 45 combination with other signal indications, may cautiously enter the intersection only to make the

1 movement indicated by the flashing yellow arrow signal or the movement permitted by other signals
2 shown at the same time. A driver shall yield the right of way to other vehicles within the inter-
3 section at the time the flashing yellow arrow signal is shown. In addition, a driver turning left shall
4 yield the right of way to other vehicles approaching from the opposite direction so closely as to
5 constitute an immediate hazard during the time when the turning vehicle is moving across or within
6 the intersection.

7 (14) Lane direction control signals. When lane direction control signals are placed over the in-
8 dividual lanes of a highway, a person may drive a vehicle in any lane over which a green signal
9 light is shown, but may not enter or travel in any lane over which a red signal light is shown.

10 (15) Stop signs. A driver approaching a stop sign shall stop at a clearly marked stop line, but
11 if none, before entering the marked crosswalk on the near side of the intersection or, if there is no
12 marked crosswalk, then at the point nearest the intersecting roadway where the driver has a view
13 of approaching traffic on the intersecting roadway before entering it. After stopping, the driver shall
14 yield the right of way to any vehicle in the intersection or approaching so close as to constitute an
15 immediate hazard during the time when the driver is moving across or within the intersection. This
16 subsection does not apply to a person operating a bicycle.

17 (16) Yield signs. A driver approaching a yield sign shall slow the driver's vehicle to a speed
18 reasonable for the existing conditions and if necessary for safety, shall stop at a line as required for
19 stop signs under this section, and shall yield the right of way to any vehicles in the intersection or
20 approaching so closely as to constitute an immediate hazard.

21 **(17) Flashing yellow beacon. When a flashing yellow beacon is used to supplement another**
22 **traffic control device, a driver shall pay extra attention to the message provided by the**
23 **beacon and follow the requirements of the other traffic control device, which might not be**
24 **otherwise applicable at all times.**

40 [*c*] **(e) “Vehicle” means a vehicle, vessel, train, boat or any other equipment that is mobile.**

41 (2) The Legislative Assembly finds and declares that:

42 (a) Transportation electrification is necessary to reduce petroleum use, achieve optimum levels
43 of energy efficiency and carbon reduction, meet federal and state air quality standards, meet this
44 state’s greenhouse gas emissions reduction goals described in ORS 468A.205 and improve the public
45 health and safety;

1 (b) Widespread transportation electrification requires that electric companies increase access to
2 the use of electricity as a transportation fuel;

3 (c) Widespread transportation electrification requires that electric companies increase access to
4 the use of electricity as a transportation fuel in low and moderate income communities;

45 (11) Violation of ORS 824.306 by any railroad company or officer or agent thereof, or any other

4 (a) "Transferee" means any person to whom ownership of a motor vehicle is transferred by
5 purchase, gift or any other means other than by creation of a security interest and any person who,
6 as an agent, signs an odometer disclosure statement for the transferee.

7 (b) "Transferor" means any person who transfers ownership of a motor vehicle by sale, gift or
8 any means other than by creation of a security interest and any person who, as an agent, signs an
9 odometer disclosure statement for the transferor.

10 (2) Except as otherwise provided in this section, upon transfer of any interest in a motor vehicle,
11 an odometer disclosure statement shall be made by the transferor to the transferee. The disclosure
12 shall be in a form that complies with the provisions of ORS 803.120 and shall contain the information

14 (3) If a transfer requiring a disclosure statement involves a leased vehicle, the lessor shall notify

12 279A.142. A contracting agency may, by appropriate ordinance, resolution, [or] rule **or other**
13 **appropriate legislative action**, limit competition for a public contract to emerging small businesses
14 certified under ORS 200.055 if the contract price is estimated at [~~\$100,000~~] **\$250,000** or less and is
15 funded by the Emerging Small Business Account established under ORS 200.180.

17 **SECTION 48.** ORS 279C.307 is amended to read:

18 279C.307. (1) Except as provided in [*subsection (2)*] **subsections (2) and (3)** of this section, a
19 contracting agency that procures personal services for the purpose of administering, managing,
20 monitoring, inspecting, evaluating compliance with or otherwise overseeing a public contract that
21 is subject to this chapter may not:

22 (a) Procure the personal services from a contractor or an affiliate of a contractor who is a party
23 to the public contract that is subject to administration, management, monitoring, inspection, evalu-
24 ation or oversight by means of the personal services; or

25 (b) Procure the personal services through the public contract that is subject to administration,
26 management, monitoring, inspection, evaluation or oversight by means of the personal services.

27 (2) Subsection (1) of this section does not apply to a **combination of preconstruction services**
28 **and construction services in a** procurement for construction manager/general contractor services
29 or to a **combination of design services and construction services in** a design-build procurement,
30 as defined in rules the Attorney General or a contracting agency adopts under ORS 279A.065.

31 (3)(a) **If a contracting agency anticipates that the contracting agency must procure per-**
32 **sonal services of the type described in subsection (1) of this section and the contracting**
33 **agency intends to accept a bid or proposal from a contractor that would be subject to the**
34 **prohibition set forth in subsection (1) of this section, the contracting agency shall apply to**
35 **an appropriate authority for an exception to the prohibition before awarding a public con-**
36 **tract for the personal services or amending an existing public contract to include the per-**
37 **sonal services.**

38 (b) **For a state contracting agency, the appropriate authority is the Director of the**
39 **Oregon Department of Administrative Services. For a local contracting agency, the appro-**
40 **priate authority is the local contracting agency's local contract review board. For the De-**
41 **partment of Transportation, with respect to a procurement described in ORS 279A.050 (3)(b),**
42 **the appropriate authority is the Director of Transportation.**

43 (c) **In preparing an application under paragraph (a) of this subsection, a contracting**
44 **agency shall consult with legal counsel to ensure compliance with the provisions of this**
45 **section and this chapter. The requirements of this paragraph are in addition to any re-**

2 **(d) An application under paragraph (a) of this subsection must include findings and jus-**

11 **(i) Is unlikely to encourage favoritism in awarding public contracts or to substantially**
12 **diminish competition for public contracts; and**

13 **(ii)(I) Is reasonably expected to result in substantial cost savings to the contracting**

15 **(II) Otherwise substantially promotes the public interest in a manner that could not be**
16 **practicably realized by complying with the prohibition described in subsection (1) of this**
17 **section.**

18 **(e)(A) If the appropriate authority approves the contracting agency's application under**
19 **paragraph (a) of this subsection, the appropriate authority shall prepare written findings and**
20 **justifications for the approval. The contracting agency's findings, justifications and facts and**
21 **the appropriate authority's findings, justifications and approval are public records that are**
22 **subject to disclosure as provided in ORS 192.311 to 192.478.**

23 **(B) If the appropriate authority disapproves the contracting agency's application, the**
24 **appropriate authority shall state the reasons for the disapproval in a written notice to the**
25 **contracting agency and shall indicate whether the disapproval extends only to the contract-**
26 **ing agency's acceptance of a bid or proposal from a contractor that would be subject to the**
27 **prohibition described in subsection (1) of this section or whether the appropriate authority**
28 **also disagrees with the contracting agency's stated need for the personal services.**

29 **(C) The appropriate authority's approval or disapproval is final.**

30 **(f) In approving an exception under this subsection, the appropriate authority may direct**
31 **a contracting agency to consult with legal counsel to ensure compliance with applicable law**
32 **in conducting a procurement for personal services of the type described in subsection (1) of**
33 **this section.**

35 **279C.335. (1) All public improvement contracts [shall] must be based upon competitive bids ex-**

37 **(a) A public improvement contract with a qualified nonprofit agency that provides employment**
38 **opportunities for individuals with disabilities under ORS 279.835 to 279.855.**

39 **(b) A public improvement contract that is exempt under subsection (2) of this section.**

40 **(c) A public improvement contract with a value of less than \$5,000.**

41 **(d) A public improvement contract with a contract price that does not exceed \$100,000 made**
42 **under procedures for competitive quotes in ORS 279C.412 and 279C.414.**

43 **(e) A contract to repair, maintain, improve or protect property the Department of Veterans'**
44 **Affairs obtains under ORS 407.135 and 407.145 (1).**

45 **(f) An energy savings performance contract that a contracting agency enters into in accordance**

1 with rules of procedure adopted under ORS 279A.065.

2 **(g) A public improvement contract with an estimated contract price of \$250,000 or less**
3 **that a contracting agency awards to an emerging small business certified under ORS 200.055**
4 **and funds with moneys from the Emerging Small Business Account established under ORS**
5 **200.180. A contracting agency that awards a public contract exempted from competitive bid-**
6 **ding under this paragraph shall solicit competitive quotes as provided in ORS 279C.414 before**
7 **making the award.**

8 (2) Subject to subsection (4)(b) and (c) of this section, the Director of the Oregon Department
9 of Administrative Services, a local contract review board or, for contracts described in ORS
10 279A.050 (3)(b), the Director of Transportation may exempt a public improvement contract or a class
11 of public improvement contracts from the competitive bidding requirement of subsection (1) of this
12 section after the Director of the Oregon Department of Administrative Services, the Director of
13 Transportation or the local contract review board approves the following findings that the con-
14 tracting agency submits or, if a state agency is not the contracting agency, that the state agency
15 that is seeking the exemption submits:

16 (a) The exemption is unlikely to encourage favoritism in awarding public improvement contracts
17 or substantially diminish competition for public improvement contracts.

18 (b) Awarding a public improvement contract under the exemption will likely result in substantial
19 cost savings and other substantial benefits to the contracting agency or the state agency that seeks
20 the exemption or, if the contract is for a public improvement described in ORS 279A.050 (3)(b), to
21 the contracting agency or the public. In approving a finding under this paragraph, the Director of
22 the Oregon Department of Administrative Services, the Director of Transportation or the local
23 contract review board shall consider the type, cost and amount of the contract and, to the extent
24 applicable to the particular public improvement contract or class of public improvement contracts,
25 the following:

26 (A) How many persons are available to bid;

27 (B) The construction budget and the projected operating costs for the completed public im-
28 provement;

29 (C) Public benefits that may result from granting the exemption;

30 (D) Whether value engineering techniques may decrease the cost of the public improvement;

31 (E) The cost and availability of specialized expertise that is necessary for the public improve-
32 ment;

33 (F) Any likely increases in public safety;

34 (G) Whether granting the exemption may reduce risks to the contracting agency, the state
35 agency or the public that are related to the public improvement;

36 (H) Whether granting the exemption will affect the sources of funding for the public improve-
37 ment;

38 (I) Whether granting the exemption will better enable the contracting agency to control the
39 impact that market conditions may have on the cost of and time necessary to complete the public
40 improvement;

41 (J) Whether granting the exemption will better enable the contracting agency to address the size
42 and technical complexity of the public improvement;

43 (K) Whether the public improvement involves new construction or renovates or remodels an
44 existing structure;

45 (L) Whether the public improvement will be occupied or unoccupied during construction;

1 (M) Whether the public improvement will require a single phase of construction work or multi-
2 ple phases of construction work to address specific project conditions; and

3 (N) Whether the contracting agency or state agency has, or has retained under contract, and
4 will use contracting agency or state agency personnel, consultants and legal counsel that have
5 necessary expertise and substantial experience in alternative contracting methods to assist in de-
6 veloping the alternative contracting method that the contracting agency or state agency will use to
7 award the public improvement contract and to help negotiate, administer and enforce the terms of
8 the public improvement contract.

9 (c) As an alternative to the finding described in paragraph (b) of this subsection, if a contracting
10 agency or state agency seeks an exemption that would allow the contracting agency or state agency
11 to use an alternative contracting method that the contracting agency or state agency has not pre-
12 viously used, the contracting agency or state agency may make a finding that identifies the project
13 as a pilot project for which the contracting agency or state agency intends to determine whether
14 using the alternative contracting method actually results in substantial cost savings to the con-
15 tracting agency, to the state agency or, if the contract is for a public improvement described in ORS
16 279A.050 (3)(b), to the contracting agency or the public. The contracting agency or state agency
17 shall include an analysis and conclusion regarding actual cost savings, if any, in the evaluation re-
18 quired under ORS 279C.355.

19 (3) In making findings to support an exemption for a class of public improvement contracts, the
20 contracting agency or state agency shall clearly identify the class using the class's defining char-
21 acteristics. The characteristics must include a combination of project descriptions or locations, time
22 periods, contract values, methods of procurement or other factors that distinguish the limited and
23 related class of public improvement contracts from the agency's overall construction program. The
24 agency may not identify a class solely by funding source, such as a particular bond fund, or by the
25 method of procurement, but shall identify the class using characteristics that reasonably relate to
26 the exemption criteria set forth in subsection (2) of this section.

27 (4) In granting exemptions under subsection (2) of this section, the Director of the Oregon De-
28 partment of Administrative Services, the Director of Transportation or the local contract review
29 board shall:

30 (a) If appropriate, direct the use of alternative contracting methods that take account of market
31 realities and modern practices and are consistent with the public policy of encouraging competition.

32 (b) Require and approve or disapprove written findings by the contracting agency or state
33 agency that support awarding a particular public improvement contract or a class of public im-
34 provement contracts, without the competitive bidding requirement of subsection (1) of this section.
35 The findings must show that the exemption of a contract or class of contracts complies with the
36 requirements of subsection (2) of this section.

37 (c) Require a contracting agency or state agency that procures construction manager/general
38 contractor services to conduct the procurement in accordance with model rules the Attorney Gen-
39 eral adopts under ORS 279A.065 (3).

40 (5)(a) A contracting agency or state agency *[shall]* **may** hold a public hearing before approving
41 the findings required by subsection (2) of this section and before the Director of the Oregon De-
42 partment of Administrative Services, the Director of Transportation or the local contract review
43 board grants an exemption from the competitive bidding requirement for a public improvement con-
44 tract or a class of public improvement contracts.

45 (b) Notification of *[the public hearing]* **a proposed exemption under subsection (2) of this**

1 **section** must be published in at least one trade newspaper of general statewide circulation a mini-
2 mum of 14 days before the *[hearing]* **date on which the contracting agency intends to take**
3 **action to approve or disapprove the exemption.**

4 (c) The notice must state that **in response to a written request**, the **contracting agency or**
5 **state agency will hold a** public hearing *[is]* for the purpose of taking comments on the draft
6 findings for an exemption from the competitive bidding requirement. *[At the time of the notice, copies*
7 *of the draft findings must be made available to the public. At the option of the contracting agency or*
8 *state agency, the notice may describe the process by which the findings are finally adopted and may*
9 *indicate the opportunity for further public comment.]*

10 (d) *[At the]* **If the contracting agency or state agency conducts a** public hearing, the con-
11 tracting agency or state agency shall offer an opportunity for any interested party to appear and
12 comment.

13 (e) If a contracting agency or state agency must act promptly because of circumstances beyond
14 the agency's control that do not constitute an emergency, notification of the *[public hearing]* **pro-**
15 **posed exemption** may be published simultaneously with the agency's solicitation of contractors for
16 the alternative public contracting method, as long as responses to the solicitation are due at least
17 five days after the *[hearing and approval of the findings]* **agency intends to take action to approve**
18 **or disapprove the proposed exemption.**

19 (6) The purpose of an exemption is to exempt one or more public improvement contracts from
20 competitive bidding requirements. The representations in and the accuracy of the findings, including
21 any general description of the resulting public improvement contract, are the bases for approving
22 the findings and granting the exemption. The findings may describe anticipated features of the re-
23 sulting public improvement contract, but the final parameters of the contract are those character-
24 istics or specifics announced in the solicitation document.

25 (7) A public improvement contract awarded under the competitive bidding requirement of sub-
26 section (1) of this section may be amended only in accordance with rules adopted under ORS
27 279A.065.

28 (8) A public improvement contract that is excepted from the competitive bidding requirement
29 under subsection (1)(a), (c), (d), (e), *[or]* (f) **or (g)** of this section is not subject to the exemption re-
30 quirements of subsection (2) of this section.

38 HIGHWAY SPEEDS

39
40 **SECTION 81.** ORS 810.180 is amended to read:

41 810.180. (1) As used in this section:

42 (a) "Designated speed" means the speed that is designated by a road authority as the maximum
43 permissible speed for a highway and that may be different from the statutory speed for the highway.

44 (b) "Statutory speed" means the speed that is established as a speed limit under ORS 811.111,
45 or is established as the speed the exceeding of which is prima facie evidence of violation of the basic

1 speed rule under ORS 811.105.

2 (2)(a) A designated speed established under this section is a speed limit if the highway for which
3 the speed is designated is subject to a statutory speed limit under ORS 811.111 that is in addition
4 to the speed limit established under ORS 811.111 (1)(b).

5 (b) A speed greater than a designated speed established under this section is prima facie evi-
6 dence of violation of the basic speed rule if the designated speed is established for a highway on
7 which there is no speed limit other than the limit established under ORS 811.111 (1)(b).

8 (3) The Department of Transportation may establish by rule designated speeds on any specified
9 section of interstate highway if the department determines that speed limits established under ORS
10 811.111 (1) are greater or less than is reasonable or safe under the conditions that exist with respect
11 to that section of the interstate highway. Designated speeds established under this subsection are
12 subject to all of the following:

13 (a) The department may not establish a designated speed under this subsection of more than:

14 (A) Sixty-five miles per hour for vehicles described in ORS 811.111 (1)(b); and

15 (B) Seventy miles per hour for all other vehicles.

16 (b) If the department establishes designated speeds under this subsection that are greater than
17 65 miles per hour, the designated speed for vehicles described in ORS 811.111 (1)(b) must be at least
18 five miles per hour lower than the designated speed for all other vehicles on the specified section
19 of interstate highway.

20 (c) The department may establish a designated speed under this subsection only if an engineer-
21 ing and traffic investigation indicates that the statutory speed for the interstate highway is greater
22 or less than is reasonable or safe under conditions the department finds to exist.

23 (d) A designated speed established under this subsection is effective when appropriate signs
24 giving notice of the designated speed are posted on the section of interstate highway where the
25 designated speed is imposed.

26 (4)(a) The department may establish, pursuant to a process established by rule, a designated
27 speed on a state highway outside of a city. The authority granted under this subsection includes,
28 but is not limited to, the authority to establish different designated speeds for different kinds or
29 classes of vehicles as the department determines reasonable and safe. A designated speed established
30 under this subsection for any kind or class of vehicles may not exceed the speed limit for the high-
31 way for that kind or class of vehicles as established in ORS 811.111 or, if there is no speed limit for
32 the highway other than the limit established in ORS 811.111 (1)(b), may not exceed 55 miles per hour.

33 (b) The department may establish a designated speed under this subsection only if an engineer-
34 ing and traffic investigation indicates that the statutory speed for the highway is greater or less
35 than is reasonable or safe under conditions the department finds to exist.

36 (c) A designated speed established under this subsection is effective when appropriate signs
37 giving notice of the designated speed are posted on the portion of highway where the designated
38 speed is imposed.

39 (5) After a written request is received from a road authority for a highway other than a highway
40 described in subsection (3) or (4) of this section, the department, pursuant to a process established
41 by rule, may establish a designated speed for the highway. The authority granted under this sub-
42 section includes, but is not limited to, the authority to establish different designated speeds for dif-
43 ferent kinds or classes of vehicles as the department determines reasonable and safe. The authority
44 granted under this subsection is subject to all of the following:

45 (a) The written request from the road authority must state a recommended designated speed.

1 (b) The department may establish a designated speed under this subsection only if an engineer-
2 ing and traffic investigation indicates that the statutory speed for the highway is greater or less
3 than is reasonable or safe under conditions the department finds to exist.

4 (c) The department may not make a final decision to establish a designated speed under this
5 subsection without providing the affected road authorities with notice and opportunity for a hearing.

6 (d) A road authority may file a written objection to a designated speed that is proposed by the
7 department under this subsection and that affects the road authority.

8 (e) A designated speed established under this subsection is effective when appropriate signs
9 giving notice of the designated speed are posted on the portion of the highway where the designated
10 speed is imposed. The expense of erecting any sign under this subsection shall be borne by the road
11 authority having jurisdiction over the portion of the highway where the designated speed is imposed.

12 (f) The department, pursuant to a process established by rule, may delegate its authority under
13 this subsection with respect to highways that are low volume or unpaved to a city or county with
14 jurisdiction over the highway. The department shall delegate authority under this paragraph only
15 if it determines that the city or county will exercise the authority according to criteria adopted by
16 the department.

17 **(g) The department, pursuant to a process established by rule, may delegate its authority**
18 **under this subsection to Clackamas County, Multnomah County or a city with jurisdiction**
19 **over the highway. The department shall delegate authority under this paragraph only if it**
20 **determines that Clackamas County, Multnomah County or the city will exercise the author-**
21 **ity according to criteria adopted by the department. When Clackamas County, Multnomah**
22 **County or a city establishes a designated speed under this paragraph, the county or city shall**
23 **provide written notice to the department. The designated speed established under this para-**
24 **graph is effective 30 days after the department receives the notice.**

25 (6) The department may override the speed limit established for ocean shores under ORS 811.111
26 (1)(c) and establish a designated speed of less than 25 miles per hour on any specified section of
27 ocean shore if the department determines that the speed limit established under ORS 811.111 (1)(c)
28 is greater than is reasonable or safe under the conditions that exist with respect to that part of the
29 ocean shore. The authority granted under this subsection is subject to all of the following:

30 (a) The department may make the determination required under this subsection only on the basis
31 of an investigation.

32 (b) A designated speed established under this subsection is effective when posted upon appro-
33 priate fixed or variable signs on the portion of ocean shore where the designated speed is imposed.

34 (7) A road authority may adopt a designated speed to regulate the speed of vehicles in parks
35 under the jurisdiction of the road authority. A road authority regulating the speed of vehicles under
36 this subsection shall post and maintain signs at all park entrances to give notice of any designated
37 speed.

38 (8) A road authority may establish by ordinance or order a temporary designated speed for
39 highways in its jurisdiction that is lower than the statutory speed. A temporary designated speed
40 may be established under this subsection if, in the judgment of the road authority, the temporary
41 designated speed is necessary to protect any portion of the highway from being unduly damaged, or
42 to protect the safety of the public and workers when temporary conditions such as construction or
43 maintenance activities constitute a danger. The following apply to the authority granted under this
44 subsection:

45 (a) Statutory speeds may be overridden by a temporary designated speed only:

1 (A) For a specific period of time for all vehicles; or

2 (B) For a specified period of time for a specific kind or class of vehicle that is causing identified
3 damage to highways.

4 (b) This subsection may not be used to establish a permanent designated speed.

5 (c) The authority granted by this subsection may be exercised only if the ordinance or order that
6 imposes the temporary designated speed:

7 (A) Specifies the hazard, damage or other condition requiring the temporary designated speed;
8 and

9 (B) Is effective only for a specified time that corresponds to the hazard, damage or other con-
10 dition specified.

11 (d) A temporary designated speed imposed under this subsection must be imposed by a proper
12 written ordinance or order. A sign giving notice of the temporary designated speed must be posted
13 at each end of the portion of highway where the temporary designated speed is imposed and at such
14 other places on the highway as may be necessary to inform the public. The temporary designated
15 speed shall be effective when signs giving notice of the temporary designated speed are posted.

16 (9) A road authority may establish an emergency speed on any highway under the jurisdiction
17 of the road authority that is different from the existing speed on the highway. The authority granted
18 under this subsection is subject to all of the following:

19 (a) A speed established under this subsection is effective when appropriate signs giving notice
20 thereof are posted upon the highway or portion of highway where the emergency speed is imposed.
21 All signs posted under this subsection must comply with ORS 810.200.

22 (b) The expense of posting any sign under this subsection shall be borne by the road authority
23 having jurisdiction over the highway or portion of highway where the emergency speed is imposed.

24 (c) A speed established under this subsection may be effective for not more than 120 days.

25 (10) A road authority may establish by ordinance a designated speed for a highway under the
26 jurisdiction of the road authority that is five miles per hour lower than the statutory speed. The
27 following apply to the authority granted under this subsection:

28 (a) The highway is located in a residence district.

29 (b) The statutory speed may be overridden by a designated speed only if:

30 (A) The road authority determines that the highway has an average volume of fewer than 2,000
31 motor vehicles per day, more than 85 percent of which are traveling less than 30 miles per hour;
32 and

33 (B) There is a traffic control device on the highway that indicates the presence of pedestrians
34 or bicyclists.

35 (c) The road authority shall post a sign giving notice of the designated speed at each end of the
36 portion of highway where the designated speed is imposed and at such other places on the highway
37 as may be necessary to inform the public. The designated speed shall be effective when signs giving
38 notice of the designated speed are posted.

39 (11) A city may establish by ordinance a designated speed for a highway under the jurisdiction
40 of the city that is five miles per hour lower than the statutory speed. The following apply to the
41 authority granted under this subsection:

42 (a) The highway is located in a residence district.

43 (b) The highway is not an arterial highway.

44 (c) The city shall post a sign giving notice of the designated speed at each end of the portion
45 of highway where the designated speed is imposed and at such other places on the highway as may

1 be necessary to inform the public. The designated speed shall be effective when signs giving notice
2 of the designated speed are posted.

27 (3) This section does not apply to vehicles exempted from this section under ORS 815.145.

28 (4) This section applies only to sections of highway on which a road authority requires
29 a person to carry traction tires or chains within the vehicle and on which signs requiring the
30 carrying of traction tires or chains have been posted as provided in ORS 815.045.

31 (5) A court may not find a person to be in violation of the offense described under this
32 section if the court determines that the conditions of the highway at the time the person
33 was cited did not require posting under rules adopted under ORS 815.045. The defense under
34 this subsection may be affirmatively asserted by any person cited for violation of the offense

7 [(iv)] (v) The person previously has been convicted of any degree of murder, manslaughter or
8 criminally negligent homicide resulting from the operation of a commercial motor vehicle or assault
9 in the first degree resulting from the operation of a commercial motor vehicle;

7 **SECTION 132. ORS 383.001 is added to and made a part of ORS 383.003 to 383.075.**

8 **SECTION 133.** ORS 383.001 is amended to read:

9 383.001. The Legislative Assembly finds that:

10 (1) The development, improvement, expansion and maintenance of an efficient, safe and well-
11 maintained system of roads, highways and other transportation facilities is essential to the economic
12 well-being and high quality of life of the people of this state.

13 (2) Public sources of revenues, including federal funding, to provide an efficient transportation
14 system have not kept pace with the state's growing population and growing transportation needs,
15 and all available alternative sources of funding should be utilized to supplement available public
16 sources of revenues.

17 (3) Because public funding sources are not providing the state with sufficient funds to meet all
18 of its transportation needs, private funding should be encouraged as an additional source of funding
19 for transportation projects and facilities.

20 (4) Various alternatives for utilizing the funds of private entities in the acquisition, design,
21 construction, reconstruction, operation and maintenance of transportation facilities exist, including
22 arrangements whereby private entities obtain exclusive agreements to design, build, own, lease or
23 operate with private funds all or a portion of transportation projects and facilities in exchange for
24 the right to receive certain revenues generated from the operation and utilization of such trans-
25 portation projects and facilities.

26 (5) Another important alternative for the funding of transportation facilities is the use of federal
27 funds pursuant to 23 U.S.C. 129(a), as amended by section 112 of the Intermodal Surface Transpor-
28 tation Efficiency Act of 1991, which established a program authorizing federal participation in con-
29 struction of publicly or privately owned toll highways, bridges and tunnels.

30 (6) The federal legislation allows for a mix of federal funding and private funding of transpor-
31 tation facilities, allowing the states to leverage available federal funds as a means for attracting
32 private capital.

33 (7) Legislation for the utilization of private funding of transportation facilities should be flexible
34 enough to permit the Department of Transportation to obtain the advantages of any available al-
35 ternative under which the acquisition, design, construction, reconstruction, operation, maintenance
36 and repair of transportation facilities can be financed in whole or in part or in combination by any
37 available sources of private or public funding.

38 (8) The funding of transportation facilities through the imposition of tolls on those who use such
39 facilities is a fair and impartial means of assessing the costs of improvements against those who
40 most benefit from such improvements, and is consistent with public policy.

41 (9) Joint endeavors of public and private entities do the following:

42 (a) Take advantage of private sector efficiencies in designing, constructing and operating
43 transportation projects.

44 (b) Allow for the rapid formation of capital necessary for funding transportation projects.

45 *shall be deposited into the Congestion Relief Fund established under ORS 383.155 for the implemen-*

1 *tation and administration of the congestion relief program established pursuant to this section, includ-*
2 *ing but not limited to the Value Pricing Set-Up Project.]*

3 *[(6) Subject to any restrictions in an agreement with the Federal Highway Administration or other*
4 *federal law, in addition to the amounts received from value pricing under this section, the moneys in*
5 *the Congestion Relief Fund shall be used to implement and administer the traffic congestion relief*
6 *program.]*

7 **(4) To the extent necessary and permitted by state and federal law and Article IX, section**
8 **3a, of the Oregon Constitution, the commission shall ensure tolls assessed pursuant to sub-**
9 **section (3) of this section or tolls assessed as part of the Interstate 5 Boone Bridge and**
10 **Seismic Improvement Project:**

11 **(a) Reduce traffic congestion by managing demand on the tollway and by improving op-**
12 **erations on the tollway;**

13 **(b) Reduce traffic congestion as a result of the tollway, not only on the tollway but also**
14 **on adjacent, connected or parallel highways to the tollways, regardless of ownership;**

15 **(c) Improve safety not only on the tollway but also on adjacent, connected or parallel**
16 **highways to the tollways, regardless of ownership; and**

17 **(d) Minimize and mitigate impacts to historically and currently underrepresented and**
18 **disadvantaged communities.**

19 **(5) Any unit of government assessing tolls on highways for which the unit of government**
20 **is the road authority, pursuant to ORS 810.010, shall collaborate with other units of govern-**
21 **ment to:**

22 **(a) Determine whether assessing tolls may result in traffic, equity, safety or climate**
23 **impacts as a result of assessing tolls;**

24 **(b) Determine appropriate investments or efforts that may minimize or reduce any po-**
25 **tential impacts; and**

26 **(c) Periodically review any investments or efforts identified and implemented under this**
27 **subsection.**

28 *[(7)]* **(6) Before [imposing value pricing] assessing tolls in the locations described under**
29 **subsection (3) of this section, the commission shall report to the Joint Committee on Transporta-**
30 **tion established under ORS 171.858.**

31 *[(8)]* **(7) The commission may enter into agreements with the State of Washington, or the State**
32 **of Washington's tollway operator or other** designee, relating to establishing, reviewing, adjusting
33 and collecting tolls for the program described in this section.

34 **(8) As used in this section, "highway" has the meaning given that term in ORS 366.005.**

35 **SECTION 147. Revenue bonds for tollway projects. (1) In accordance with the applicable**
36 **provisions of ORS chapter 286A, the State Treasurer, at the request of the Department of**
37 **Transportation, may issue and sell revenue bonds known as tollway project revenue bonds**
38 **for the purpose of financing tollway projects, provided that such bonds do not constitute a**
39 **debt or general obligation of the department or of this state or any of its political subdivi-**
40 **sions, but shall be payable solely from the revenues, amounts, funds and accounts de-**
41 **scribed in ORS 383.009 and sections 148 and 151 of this 2021 Act.**

42 **(2) The proceeds of bonds issued under this section may be used by the department or**
43 **loaned or granted to a private entity or a local government, as defined in ORS 174.116, for**
44 **the purposes of:**

45 **(a) Financing any portion of the costs related to the purposes described in ORS 383.009**

1 (2);

2 (b) Funding any required reserves; and

3 (c) Paying costs of issuing the bonds.

4 (3) The bonds authorized by this section may be issued as taxable bonds or as tax-exempt
5 bonds under the income tax laws of the United States.

6 (4) Notwithstanding the status of the bonds for federal income tax purposes, interest paid
7 to the owners of the bonds shall be exempt from personal income taxes imposed by this
8 state.

9 (5) Subject to the limitations under ORS 383.004 and 383.009, when issuing bonds under
10 this section, the department and the State Treasurer may make covenants with bondholders
11 regarding the imposition and regulation of tolls to meet the department's obligations under
12 the terms of any indenture prepared under section 150 of this 2021 Act, any loan agreement
13 and any grant agreement, including without limitation:

14 (a) Financial covenants, debt service requirements, reserve requirements and any other
15 funding requirements;

16 (b) The use of the amounts required to be deposited in the Toll Program Fund; and

17 (c) The issuance of additional bonds.

18 (6) The state may not in any way impair obligations of any agreement between the state
19 and holders of tollway project revenue bonds issued under this section.

20 (7) The department, with the approval of the State Treasurer, may designate the extent
21 to which a series of tollway project revenue bonds authorized under this section is secured
22 and payable:

23 (a) On a parity of lien or on a subordinate basis to existing or future Highway User Tax
24 Bonds issued under ORS 367.615, but only if sufficient moneys described under ORS 367.605
25 may be pledged to:

26 (A) First, pay the annual bond debt service of all Highway User Tax Bonds issued pur-
27 suant to ORS 367.615 and 367.620; and

28 (B) Second, pay the annual bond debt service for all tollway project revenue bonds issued
29 under this subsection; or

30 (b) From additional revenue sources as permitted under section 148 of this 2021 Act.

31 (8) A holder of tollway project revenue bonds issued under this section may not compel
32 the payment of federal transportation funds to the department.

33 (9) This section is supplemental and in addition to any other authority in ORS chapters
34 286A, 366 and 367 for the issuance of bonds by the State Treasurer at the request of the de-
35 partment.

36 SECTION 148. Sources of funds to secure revenue bonds for tollway projects. (1) Moneys
37 deposited in the Toll Program Fund established under ORS 383.009 are pledged to the pay-
38 ment of tollway project revenue bonds issued under section 147 of this 2021 Act.

39 (2) The Department of Transportation, with the approval of the State Treasurer, may
40 designate in any revenue declaration or indenture prepared under section 150 of this 2021
41 Act additional revenues as security for the payment of tollway project revenue bonds. The
42 department shall set the order of priority for the additional revenues used. Additional re-

44 (a) Moneys under ORS 367.605, which are pledged to payment of Highway User Tax Bonds

2 (c) Any other moneys legally available to the department.

3 (3) The lien or charge of any pledge of moneys in the Toll Program Fund to secure bonds
4 designated as tollway project revenue bonds under section 147 of this 2021 Act is superior
5 or prior to any other lien or charge and to any law of the state requiring the department to
6 spend moneys for tollway project revenue projects. As long as any tollway project revenue
7 bonds issued under section 147 of this 2021 Act are outstanding, moneys deposited to the Toll
8 Program Fund shall be applied first to the payment of principal of, and interest on, any bonds
9 designated as tollway project revenue bonds under section 147 of this 2021 Act and then to
10 any other purposes described under ORS 383.009.

11 SECTION 149. Collection and use of federal transportation funds. (1) If allowed by federal
12 law, the Department of Transportation may use federal transportation funds for the follow-
13 ing purposes:

14 (a) For deposit into one or more special funds or accounts that may be pledged to secure
15 payment of the tollway project revenue bonds issued under section 147 of this 2021 Act.

16 (b) For payment of the costs of tollway projects.

23 Transportation must prepare a revenue declaration or indenture authorizing issuance of the
24 bonds. The revenue declaration or indenture must be signed by the Director of Transporta-
25 tion or a person designated by the director and must be approved by the State Treasurer or
26 a person designated by the State Treasurer.

27 (2) A revenue declaration or indenture prepared under this section may do any of the

29 (a) Pledge any part or all of moneys described under section 148 of this 2021 Act for

37 (e) Provide for procedures, if any, by which the terms of contracts with bondholders may
38 be amended or rescinded, for the percentage of the bondholders that must consent to
39 amendment or rescission of the contract and for the manner of bondholder consent to any
40 amendment or rescission of the contract.

41 (f) Establish a trustee and vest the trustee with property, rights, powers and duties in
42 trust, as the State Treasurer determines appropriate.

43 (g) Provide for other matters affecting the issuance of bonds.

44 (h) Provide for a debt service reserve pursuant to ORS 286A.025 (6).

45 (i) Provide for certain covenants pursuant to ORS 286A.025 (4)(c) and ORS 286A.102 (10).

1 to 367.665 that are issued to fund infrastructure loans and the proceeds of which are deposited in
2 the infrastructure fund.

3 (8) "Infrastructure fund" means the Oregon Transportation Infrastructure Fund.

4 (9) "Infrastructure loan" means a loan of moneys in the infrastructure fund to finance a trans-
5 portation project.

6 (10) "Municipality" means a city, county, road district, school district, special district, metro-
7 politan service district, the Port of Portland or an intergovernmental entity organized under ORS
8 190.010.

9 (11) "Transportation project" means any project or undertaking that facilitates any mode of
10 transportation within this state. The term includes, but is not limited to, a project for highway,
11 transit, rail and aviation capital infrastructure, bicycle and pedestrian paths, bridges and ways, and
12 other projects that facilitate the transportation of materials, animals or people.

13 **SECTION 155.** ORS 367.555 is amended to read:

14 367.555. (1) The Department of Transportation may request the State Treasurer to issue general
15 obligation bonds of the State of Oregon used to provide funds to defray the costs of building and
16 maintaining permanent roads, including the costs of location, relocation, improvement, construction
17 and reconstruction of state highways and bridges[, *in an outstanding principal amount that is subject*
18 *to the provisions of ORS 286A.035.*] **and those portions of a tollway project, as defined in ORS**
19 **383.003, that constitute building or maintaining permanent roads.**

20 **(2) The principal amount of any bonds issued under this section is subject to the pro-**
21 **visions of ORS 286A.035.**

22 **SECTION 156.** ORS 367.560 is amended to read:

23 367.560. All moneys obtained from the sale of general obligation bonds under ORS 367.555 to
24 367.600 must be paid over to the State Treasurer and credited by the State Treasurer to **either** the
25 State Highway Fund **or the Toll Program Fund**. Such moneys may be used only for the purposes
26 [*stated in ORS 367.555 to 367.600 and, pending the use of such moneys for highway purposes*] **for**
27 **which the bonds were authorized to be sold and, pending the use of the moneys,** may be in-
28 vested as provided by law.

29 **SECTION 157.** ORS 367.615 is amended to read:

30 367.615. (1) The Department of Transportation may request the State Treasurer to issue and sell
31 revenue bonds known as Highway User Tax Bonds as provided in this section.

32 (2) Bonds issued under this section do not constitute a debt or general obligation of this state
33 or any political subdivision of this state but are secured and payable from moneys described under

36 (3) This state shall provide for the continued assessment, levy, collection and deposit into the
37 highway fund of moneys described under ORS 367.605 in amounts sufficient to pay, when due, the
38 annual bond debt service and other amounts necessary to meet requirements established by

40 (4) This state may not in any way impair obligations of any agreement between this state and
41 the holders of bonds issued under this section.

42 (5) The authority granted by this section is continuing and the department reserves the right
43 to request the State Treasurer to issue additional bonds under this section subject to the following:

44 (a) Additional bonds must be secured equally and ratably by the pledge and appropriation of
45 moneys described under ORS 367.605 unless the State Treasurer, as permitted by law and the con-

1 tracts with owners of outstanding Highway User Tax Bonds, issues additional bonds in different
2 series and secures each series by a lien on and pledge of moneys described under ORS 367.605 that
3 is superior to or subordinate to the lien of the pledge securing any other series of Highway User
4 Tax Bonds.

5 (b) The State Treasurer may only issue additional bonds **under this section** if sufficient moneys
6 described under ORS 367.605 may be pledged to pay the annual bond debt service for all outstanding

31 367.806. (1) As part of the Oregon Innovative Partnerships Program established under ORS
32 367.804, the Department of Transportation may:

33 (a) Enter into any agreement or any configuration of agreements relating to transportation
34 projects with any private entity or unit of government or any configuration of private entities and
35 units of government. The subject of agreements entered into under this section may include, but
36 need not be limited to, planning, acquisition, financing, development, design, construction, recon-
37 struction, replacement, improvement, maintenance, management, repair, leasing and operation of
38 transportation projects.

39 (b) Include in any agreement entered into under this section any financing mechanisms, includ-
40 ing but not limited to the imposition and collection of franchise fees or user fees and the develop-
41 ment or use of other revenue sources.

42 (2) As part of the Oregon Innovative Partnerships Program established under ORS 367.804, the
43 department shall enter into agreements to undertake transportation projects the subjects of which
44 include the application of technology standards to determine whether to certify technology, the
45 collection of metered use data, tax processing and account management, as these subjects relate to

1 the operation of a road usage charge system pursuant to ORS 319.883 to 319.946.

2 (3) The agreements among the public and private sector partners entered into under this section
3 must specify at least the following:

4 (a) At what point in the transportation project public and private sector partners will enter the
5 project and which partners will assume responsibility for specific project elements;

6 (b) How the partners will share management of the risks of the project;

7 (c) How the partners will share the costs of development of the project;

8 (d) How the partners will allocate financial responsibility for cost overruns;

9 (e) The penalties for nonperformance;

10 (f) The incentives for performance;

11 (g) The accounting and auditing standards to be used to evaluate work on the project; and

12 (h) Whether the project is consistent with the plan developed by the Oregon Transportation
13 Commission under ORS 184.617 and any applicable regional transportation plans or local transpor-
14 tation system programs and, if not consistent, how and when the project will become consistent with
15 applicable plans and programs.

16 (4) The department may, either separately or in combination with any other unit of government,
17 enter into working agreements, coordination agreements or similar implementation agreements to
18 carry out the joint implementation of any transportation project selected under ORS 367.804.

19 (5) Except for ORS 383.015[383.017 (1), (2), (3) and (5)] and 383.019, the provisions of ORS
20 383.003 to 383.075 apply to any tollway project entered into under ORS 367.800 to 367.824.

21 (6) The provisions of ORS 279.835 to 279.855 and ORS chapters 279A, 279B and 279C do not
22 apply to concepts or proposals submitted under ORS 367.804, or to agreements entered into under
23 this section, except that if public moneys are used to pay any costs of construction of public works
24 that is part of a project, the provisions of ORS 279C.800 to 279C.870 apply to the public works. In
25 addition, if public moneys are used to pay any costs of construction of public works that is part of
26 a project, the construction contract for the public works must contain provisions that require the
27 payment of workers under the contract in accordance with ORS 279C.540 and 279C.800 to 279C.870.

28 (7)(a) The department may not enter into an agreement under this section until the agreement
29 is reviewed and approved by the Oregon Transportation Commission.

30 (b) The department may not enter into, and the commission may not approve, an agreement
31 under this section for the construction of a public improvement as part of a transportation project
32 unless the agreement provides for bonding, financial guarantees, deposits or the posting of other
33 security to secure the payment of laborers, subcontractors and suppliers who perform work or pro-
34 vide materials as part of the project.

35 (c) Before presenting an agreement to the commission for approval under this subsection, the
36 department must consider whether to implement procedures to promote competition among subcon-
37 tractors for any subcontracts to be let in connection with the transportation project. As part of its

45 formation are submitted to the commission in connection with its review and approval of a trans-

1 portation project under subsection (7) of this section.

2 (9) The terms of a final agreement entered into under this section and the terms of a proposed
3 agreement presented to the commission for review and approval under subsection (7) of this section
4 are subject to disclosure under ORS 192.311 to 192.478.

5 (10) As used in this section:

6 (a) "Public improvement" has the meaning given that term in ORS 279A.010.

7 (b) "Public works" has the meaning given that term in ORS 279C.800.

8 **SECTION 159.** ORS 367.816 is amended to read:

9 367.816. (1) Notwithstanding ORS 367.020, the Department of Transportation may use moneys in
10 the Oregon Transportation Infrastructure Fund established by ORS 367.015 to ensure the repayment
11 of loan guarantees or extensions of credit made to or on behalf of private entities engaged in the
12 planning, acquisition, financing, development, design, construction, reconstruction, replacement, im-
13 provement, maintenance, management, repair, leasing or operation of any transportation project that
14 is part of the program established under ORS 367.804.

15 (2) The lien of a pledge made under this section is subordinate to the lien of a pledge securing
16 bonds payable from moneys in the State Highway Fund described in ORS 366.505, the [*State Tollway*
17 *Account*] **Toll Program Fund** established by ORS 383.009 or the State Transportation Enterprise
18 Fund established by ORS 367.810.

19 **SECTION 160.** ORS 381.312 is amended to read:

20 381.312. (1) The Port of Hood River, or any private entity or unit of government that the port
21 designates to operate a bridge in an agreement the port enters into under ORS 381.205 to 381.314,
22 may establish, collect or alter a reasonable toll, administrative fee or civil penalty in connection
23 with the bridge.

24 (2) The port or the private entity or unit of government that the port designates shall deposit
25 any proceeds from a toll, administrative fee or civil penalty into an account established under an
26 agreement described in ORS 381.310. The port or unit of government shall deposit the share of
27 proceeds that the port or unit of government receives with a depository that meets the requirements

22 (f) The effects of tollway implementation on community and local street traffic.

23 (3) Notwithstanding any other provision of ORS 383.001 to 383.075, no tollway project shall be
24 authorized unless the department finds that either:

25 (a) Based on the department's estimate of present and future traffic patterns, the revenues gen-
26 erated by the tollway project will be sufficient, after payment of all obligations incurred in con-
27 nection with the acquisition, construction and operation of such tollway project, to ensure the
28 continued maintenance, repair and reconstruction of the tollway project without the contribution
29 of additional public funds; or

30 (b) The revenues generated by the tollway project will be at least sufficient to pay its opera-
31 tional expenses and a portion of the costs of its construction, maintenance, repair and recon-
32 struction, and the importance of the tollway project to the welfare or economy of the state is great
33 enough to justify the use of public funding for a portion of its construction, maintenance, repair and
34 reconstruction.

35 (4) If the department finds that a proposed tollway project qualifies for authorization under this
36 section, the department may conduct or cause to be conducted any environmental, geological or
37 other studies required by law as a condition of construction of the tollway project. The costs of
38 completing the studies for any proposed tollway project may be paid from moneys in the [*State*
39 *Tollway Account*] **Toll Program Fund** that are reimbursed from the permanent financing for the

44 **SECTION 162.** (1) As used in this section, "toll" and "tollway" have the meanings given
45 those terms in ORS 383.003.

1 (2) Before the Department of Transportation assesses a toll, the department shall im-
2 plement a method for establishing equitable income-based toll rates to be paid by users of
3 tollways.

4 (3) At least 90 days before the date the Oregon Transportation Commission seeks ap-
5 proval from the Federal Highway Administration to use the income-based toll rates developed
6 under subsection (1) of this section, the department shall prepare and submit a report on the
7 method developed to the Joint Committee on Transportation and the Oregon Transportation
8 Commission. The department may also submit to the Joint Committee on Transportation any
9 recommended legislative changes. The report shall be provided to the Joint Committee on
10 Transportation, in the manner provided under ORS 192.245, on or before September 15, 2022.
