SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of Early Learning Division to Department of Early Learning and Care. Establishes Department of Early Learning and Care as state agency that is separate from Department of Education and that functions under, and is coordinated by, Early Learning Council.

Prescribes expanded duties, functions and powers of Department of Early Learning and Care, including administration of Employment Related Day Care. Modifies requirements of Employment Related Day Care.

Directs Early Learning Division, Department of Education and Department of Human Services to develop and implement plans for seamless transfer of relevant duties, functions and powers, and to report on plans to appropriate interim committees of Legislative Assembly.

Revises goals of statewide early learning system.

Modifies membership and duties of State Interagency Coordinating Council.

Declares emergency, effective on passage.

10 Whereas a child's brain makes one million new neural connections every second before the age
11 of five years, with early experiences shaping brain architecture; and

12 Whereas complex neural, social and emotional development occurs before the age of five years,
13 making early childhood a critical window in which to eliminate disparities; and

14 Whereas access to continuous, high-quality child care, early care and education and out-of-
15 school programs is critical to a child's success in school and life; and

16 Whereas both early care and education and out-of-school programs during elementary school
17 predict higher academic achievement at 15 years of age; and

18 Whereas all children are born full of potential, yet their family's zip code, income and race and
19 ethnicity are powerful predictors of a child's and family's access to high quality child care and early
20 education; and

1 Whereas child caring disproportionately impacts women, particularly women of color, through
2 child care shortages, lower wages as child care providers and staff and systemic discrimination; and

3 Whereas an affordable, accessible system of high quality child care is necessary for the health
4 of Oregon's economy because employers benefit when parents have safe, stable, culturally responsive
5 and developmentally appropriate care for their children that meets their needs; and

6 Whereas the Oregon Early Learning System should provide developmentally appropriate, cul-
7 turally responsive, relevant and inclusive child care and early care and education for children and
8 families across race, ethnicity, language, geography, ability and income levels, as recommended by
9 Raise Up Oregon; and

10 Whereas the health and stability of Oregon's child care and early care and education workforce
11 is pivotal to any expansion of child care in Oregon and this workforce, predominately composed of
12 women of color, is structurally afflicted by low wages, limited or no health care and a severe lack
13 of retirement benefits; and

14 Whereas Oregon must value the work of caregivers, especially Black and indigenous women,
15 women of color and immigrant women, and ensure that they receive the equitable pay and benefits
16 they deserve for their work, training and services that support workforce development and supports
17 offered to all provider types; and

18 Whereas Oregon's child care sector supports all providers, which are essential to offering a
19 mixed-delivery child care system and that include family, friend and neighbor child care, regulated
20 subsidy child care, registered family child care, certified family child care, certified child care cen-
21 ters, out-of-school programs, Oregon Prekindergarten, Head Start, Early Head Start, relief nurseries,
22 Healthy Families Oregon programs, privately subsidized child care programs and publicly funded
23 child care programs; and

24 Whereas the Oregon Early Learning System must be informed by and accountable to the parents
25 and providers who most need it and who know the most about the system; and

26 Whereas the partnership and collaboration between the Oregon Early Learning System, the
27 kindergarten through grade 12 system, the health system, the human services system and the hous-
28 ing system are critical to the success of every child; now, therefore,

29 **Be It Enacted by the People of the State of Oregon:**

30
31 **STATEWIDE EARLY LEARNING SYSTEM**

32
33 **SECTION 1.** ORS 417.728 is amended to read:

34 417.728. (1) The Early Learning Council [*shall lead a joint effort with other state and local early*
35 *childhood partners to establish the policies necessary for a voluntary*] **is responsible for leading**
36 **cross-sector strategic planning that establishes the goals, objectives and strategies necessary**
37 **for a statewide early learning system.**

38 [(2) *The voluntary statewide early learning system shall be designed to achieve:*]

39 [(a) *The appropriate outcomes identified by the Early Learning Council with input from early*
40 *childhood partners; and*]

41 [(b) *Any other early childhood benchmark or outcome that demonstrates progress toward meeting*
42 *a target and that is identified by the Early Learning Council with input from early childhood*
43 *partners.*]

44 **(2) The purpose of the statewide early learning system is to make progress toward en-**
45 **suring that:**

1 **(a) Children enter school ready to learn;**

2 **(b) Children are raised in families that are healthy, stable and attached; and**

3 **(c) Early learning is available and provided in a manner that is aligned, coordinated and**
4 **family centered.**

5 (3) The [voluntary] statewide early learning system shall include the following components:

6 (a) A process to identify as early as possible children and families who would benefit from early
7 learning services, including the required use of standardized screening and referral procedures used
8 throughout the [voluntary] statewide early learning system;

9 (b) A plan to support the identified needs of the child and family that coordinates case man-
10 agement personnel and the delivery of services to the child and family; and

11 (c) Services to support children who are zero through six years of age and their families who
12 give their express written consent, including:

13 (A) Screening, assessment and home visiting services pursuant to ORS 417.795;

14 (B) Specialized or targeted home visiting services;

15 (C) Community-based services such as relief nurseries, family support programs and parent ed-
16 ucation programs;

17 (D) Affordable, quality child care, as defined by the Early Learning Council;

18 (E) Preschool and other early education services;

19 (F) Health services for children and pregnant women;

20 (G) Mental health services;

21 (H) Alcohol and drug treatment programs that meet the standards promulgated by the Oregon
22 Health Authority pursuant to ORS 430.357;

23 (I) Developmental disability services; and

24 (J) Other state and local services.

25 (4) In establishing the definition of affordable, quality child care under subsection (3)(c)(D) of
26 this section, the Early Learning Council shall consult with child care providers and early childhood
27 educators. The definition established by the council shall support parental choice of child care pro-
28 vider and shall consider differences in settings and services, including but not limited to child care
29 for school-aged children, part-time care, odd-hour and respite care and factors of cultural appropri-
30 ateness and competence.

31 [(5) *No later than July 1, 2016, for the purpose of ensuring that affordable, quality home-based*
32 *child care is available through a subsidy program administered by the Department of Human Services,*
33 *the Early Learning Division, in consultation with the department, shall develop and implement a system*
34 *of quality supports for exempt family child care providers as defined in ORS 329A.430. The system*
35 *may use evidence-based practices or best practices that are consistent with state policies for child*
36 *well-being and development and that are subject to collective bargaining. The system must include*
37 *professional development opportunities for exempt family child care providers that are available for*
38 *attendance in person and through the Internet.*]

39 [(6)] (5) The Early Learning Council shall:

40 (a) Consolidate administrative functions relating to the [voluntary] statewide early learning
41 system, to the extent practicable, including but not limited to training and technical assistance,
42 planning and budgeting.

43 (b) Adopt policies to establish training and technical assistance programs to ensure that per-
44 sonnel have skills in appropriate areas, including screening, family assessment, competency-based
45 home visiting skills, cultural and gender differences and other areas as needed.

1 (c) Identify research-based age-appropriate and culturally and gender appropriate screening and
2 assessment tools that would be used as appropriate in programs and services of the [voluntary]
3 statewide early learning system.

4 (d) Develop a plan for the implementation of a common data system for voluntary early child-
5 hood programs.

6 (e) Coordinate existing and new early childhood programs to provide a range of community-
7 based supports.

8 (f) Establish a common set of quality assurance standards to guide local implementation of all
9 elements of the [voluntary] statewide early learning system, including voluntary universal screening
10 and assessment, home visiting, staffing, evaluation and community-based services.

11 (g) Ensure that all plans for voluntary early childhood services are coordinated and consistent
12 with federal and state law, including but not limited to plans for Oregon prekindergarten programs,
13 federal Head Start programs, early childhood special education services, early intervention services
14 and public health services.

15 (h) Identify how the [voluntary] statewide early learning system for children who are zero
16 through six years of age will link with systems of support for older children and their families.

17 (i) During January of each odd-numbered year, report to the Governor and the Legislative As-
18 sembly on the [voluntary] statewide early learning system.

19 [(7)] (6) The State Board of Education, the Employment Department, the Department of Human
20 Services and the Oregon Health Authority when adopting rules to administer voluntary early
21 childhood programs under their individual authority shall adopt rules:

22 (a) That are consistent with the requirements of the [voluntary] statewide early learning system
23 created under this section; and

24 (b) With the direction of the Early Learning Council.

25 [(8)] (7) Information gathered in conjunction with the voluntary comprehensive screening and
26 assessment of children and their families may be used only for the following purposes:

27 (a) Providing services to children and families who give their express written consent;

28 (b) Providing statistical data that are not personally identifiable;

29 (c) Accomplishing other purposes for which the family has given express written consent; and

30 (d) Meeting the requirements of mandatory state and federal disclosure laws.

31 **SECTION 2.** ORS 417.723 is amended to read:

32 417.723. The Oregon Health Authority and the Early Learning Council shall establish a grant
33 program to provide funding to support effective and scalable strategies that align [voluntary] state-
34 wide early learning systems and health systems for the purpose of improving the developmental
35 outcomes for children from zero through three years of age.

36 **SECTION 3.** ORS 417.727 is amended to read:

37 417.727. Based on the findings expressed in ORS 417.708, there is created the Oregon Early
38 Learning System. The goals of the system are to:

39 (1) Prevent child abuse and neglect;

40 (2) Improve the health and development of young children;

41 (3) Promote bonding and attachment in the early years of a child's life;

42 (4) Support parents in providing the optimum environment for their young children;

43 (5) Link and integrate services and supports in the [voluntary] statewide early learning system
44 pursuant to ORS 417.728;

45 (6) Ensure that children are entering school ready to learn; and

1 (7) Ensure that parents have access to affordable, quality child care.

2 **SECTION 4.** ORS 417.795 is amended to read:

3 417.795. (1) The Early Learning Division shall establish Healthy Families Oregon programs in
4 all counties of this state as funding becomes available.

5 (2) These programs shall be nonstigmatizing, voluntary and designed to achieve the appropriate
6 early childhood benchmarks and shall:

7 (a) Ensure that express written consent is obtained from the family prior to any release of in-
8 formation that is protected by federal or state law and before the family receives any services;

9 (b) Ensure that services are voluntary and that, if a family chooses not to accept services or
10 ends services, there are no adverse consequences for those decisions;

11 (c) Offer a voluntary comprehensive risk assessment of all children, from zero through three
12 years of age, and their families in coordination with [*voluntary*] statewide early learning system
13 screening and referral efforts;

14 (d) Ensure that the disclosure of information gathered in conjunction with the voluntary com-
15 prehensive risk assessment of children and their families is limited pursuant to ORS 417.728 [(8)] (7)
16 to the following purposes:

17 (A) Providing services under the programs to children and families who give their express
18 written consent;

19 (B) Providing statistical data that are not personally identifiable;

20 (C) Accomplishing other purposes for which the family has given express written consent; and

21 (D) Meeting the requirements of mandatory state and federal disclosure laws;

22 (e) Ensure that risk factors used in the risk screen are limited to those risk factors that have
23 been shown by research to be associated with poor outcomes for children and families;

24 (f) Identify, as early as possible, families that would benefit most from the programs;

25 (g) Provide parenting education and support services, including but not limited to community-
26 based home visiting services;

27 (h) Provide other supports, including but not limited to referral to and linking of community and
28 public services for children and families such as mental health services, alcohol and drug treatment
29 programs that meet the standards promulgated by the Oregon Health Authority under ORS 430.357,
30 child care, food, housing and transportation;

31 (i) Coordinate services for children consistent with other services provided through the Oregon
32 Early Learning System;

33 (j) Integrate data with any common data system for early childhood programs;

34 (k) Be included in a statewide independent evaluation to document:

35 (A) Level of screening and assessment;

36 (B) Incidence of child abuse and neglect;

37 (C) Change in parenting skills; and

38 (D) Rate of child development;

39 (L) Be included in a statewide training program in the dynamics of the skills needed to provide
40 early childhood services, such as assessment and home visiting; and

41 (m) Meet statewide quality assurance and quality improvement standards.

42 (3) The Healthy Families Oregon programs, in coordination with statewide home visiting part-
43 ners, shall:

44 (a) Identify existing services and describe and prioritize additional services necessary for a
45 voluntary home visit system;

1 (b) Build on existing programs;

2 (c) Maximize the use of volunteers and other community resources that support all families;

3 (d) Target, at a minimum, all prenatal families and families with children less than three months
4 of age and provide services through at least the child's third birthday; and

5 (e) Ensure that home visiting services provided by local home visiting partners for children and
6 pregnant women support and are coordinated with local Healthy Families Oregon programs.

7 (4) Through a Healthy Families Oregon program, a trained home visitor shall be assigned to
8 each family assessed as at risk that consents to receive services through the trained home visitor.
9 The trained home visitor shall conduct home visits and assist the family in gaining access to needed
10 services.

11 (5) The services required by this section shall be provided by hospitals, public or private entities
12 or organizations, or any combination thereof, capable of providing all or part of the family risk as-
13 sessment and the follow-up services. In granting a contract, collaborative contracting or requests for
14 proposals may be used and must include the most effective and consistent service delivery system.

15 (6) The family risk assessment and follow-up services for families at risk shall be provided by
16 trained home visitors organized in teams supervised by a manager.

17 (7) Each Healthy Families Oregon program shall adopt disciplinary procedures for trained home
18 visitors and other employees of the program. The procedures shall provide appropriate disciplinary
19 actions for trained home visitors and other employees who violate federal or state law or the poli-
20 cies of the program.

21 **SECTION 5.** ORS 417.788 is amended to read:

22 417.788. (1) The Early Learning Division shall support Relief Nursery programs statewide as
23 funding becomes available. Funding to support Relief Nursery programs may include, but is not
24 limited to:

25 (a) Administrative costs;

26 (b) Costs for direct service personnel, equipment, supplies and operating expenses;

27 (c) Start-up costs;

28 (d) Classroom furniture and materials;

29 (e) Playground equipment;

30 (f) Computers; and

31 (g) Transportation vehicles.

32 (2) The division may encourage communities to establish Relief Nursery programs for young
33 children who are at risk and their families. Communities may choose to establish regional Relief
34 Nursery programs. The Relief Nursery programs shall be consistent with the [*voluntary*] **statewide**
35 early learning system coordinated by the Early Learning Council.

36 (3) Relief Nursery programs shall participate in a statewide independent evaluation conducted
37 by the Oregon Association of Relief Nurseries to document improved child safety, reduction in foster
38 care placements, progress in healthy child development and improvement in family functioning and
39 support.

40 (4) Each Relief Nursery program that receives state funding shall have financial support from
41 the community that, excluding any amounts distributed to the Relief Nursery program pursuant to
42 ORS 131A.360 (4)(d) and 131A.365 (3)(d), is at least equal to 25 percent of any state allocation.

43 (5) The division shall adopt rules necessary for the administration of this section, including rules
44 requiring that any public funds received by Relief Nursery programs be used to achieve the out-
45 comes identified in subsection (3) of this section.

2 *[(p) At least one council member shall be from the Oregon Health Authority.]*

3 *[(q) The council may include other members appointed by the Governor, including but not limited*
4 *to one representative from the United States Bureau of Indian Affairs or, where there is no school*
5 *operated or funded by the bureau, from the Indian Health Service or the tribe or tribal council.]*

6 **(2) The membership of the council shall be composed as follows:**

7 **(a) At least 20 percent of the council members shall be parents of children with a disa-**
8 **bility who are 12 years of age or younger at the time the council member is appointed. When**
9 **appointing council members under this paragraph, the Governor shall ensure that:**

10 **(A) At least 50 percent of the council members are parents of a child with a disability**
11 **who is five years of age or younger at the time the council member is appointed;**

12 **(B) At least 20 percent of the council members:**

13 **(i) Are parents of a child with a disability who is three years of age or younger at the**
14 **time the council member is appointed; and**

15 **(ii) Have knowledge of, or experience with, programs or services for infants or toddlers**
16 **with a disability; and**

17 **(C) The council members represent the racial, ethnic and linguistic diversity of children**
18 **in this state who are five years of age or younger.**

19 **(b) At least 20 percent of the council members shall be public or private providers of**
20 **early intervention and early childhood special education services.**

21 **(c) At least one council member shall be from a program responsible for preparing early**
22 **intervention and early childhood special education educators.**

23 **(d) At least one council member shall be from a Head Start or Early Head Start program.**

24 **(e) At least one council member shall be from a home-based child care program.**

25 **(f) At least one council member shall be from a center-based child care program.**

26 **(g) At least one council member shall be from the committee that serves as the state**
27 **advisory council, as described in ORS 326.425 (3).**

28 **(h) At least one council member shall be a member of the State Advisory Council for**
29 **Special Education created under ORS 343.287.**

30 **(i) At least one council member shall be from each state agency involved in the provision**
31 **of, or payment for, early intervention and early childhood special education services to in-**
32 **ants and toddlers with a disability and their families.**

33 **(j) At least one council member shall be from each state agency responsible for providing**
34 **preschool services to children with a disability.**

35 **(k) At least one council member shall be from each state agency responsible for**
36 **children's mental health.**

37 **(L) At least two council members shall be from the Department of Human Services with**
38 **expertise in foster care or self-sufficiency programs.**

39 **(m) At least one council member shall be from the Office of Child Care with expertise in**
40 **the Child Care and Development Fund.**

41 **(n) At least one council member shall be a representative of the Department of Educa-**
42 **tion with expertise in the coordination of education of homeless children and youth.**

43 **(o) At least one council member shall be from the Department of Consumer and Business**
44 **Services with expertise in state regulation of private health insurance.**

45 **(p) At least one council member shall be from the Oregon Health Authority with exper-**

1 **tise in Medicaid and the Children's Health Insurance Program.**

2 **(q) At least one council member shall be a representative from a tribal agency responsi-**
3 **ble for supporting young children with developmental delays and disabilities, from a tribal**
4 **council or otherwise representing one or more tribes.**

5 (3) An individual appointed to represent a state agency *[that is involved in the provision of or*
6 *payment for services for preschool children with disabilities under subsection (2)(e) and (h) to (k) of this*
7 *section shall]* **under subsection (2) of this section must** have sufficient authority to engage in
8 making and implementing policy on behalf of the agency. **The Governor may appoint a council**
9 **member to represent more than one program or specialty listed in subsection (2) of this**
10 **section.**

11 **(4) In addition to the council members appointed under subsection (2) of this section:**

12 **(a) The Governor may appoint any other council members not listed in subsection (2) of**
13 **this section.**

14 **(b) The President of the Senate shall appoint one member from among members of the**
15 **Senate to serve as a nonvoting council member.**

16 **(c) The Speaker of the House of Representatives shall appoint one member from among**
17 **members of the House of Representatives to serve as a nonvoting council member.**

18 *[(4)]* **(5) The State Interagency Coordinating Council shall:**

19 **(a) Advise the Superintendent of Public Instruction, the State Board of Education, the Early**
20 **Learning System Director** and the Early Learning Council on unmet needs in the early childhood
21 special education and early intervention programs for *[preschool]* children with *[disabilities]* **a disa-**
22 **bility**, review and comment publicly on any rules proposed by the State Board of Education and the
23 distribution of funds for the programs and assist the state in developing and reporting data on and
24 evaluations of the programs and services.

25 **(b) Advise and assist the represented public agencies regarding the services and programs they**
26 **provide to [preschool] children with [disabilities] a disability** and their families, including public
27 comments on any proposed rules affecting the target population and the distribution of funds for
28 such services, and assist each agency in developing services that reflect the overall goals for the
29 target population as adopted by the council.

30 **(c) Advise [and assist] the Department of Education, the Early Learning Division** and other
31 state agencies *[in]* **on** the development and implementation of the policies that constitute the state-
32 wide system.

33 **(d) [Assist] Advise** all appropriate public agencies *[in]* **on** achieving the full participation, coor-
34 dination and cooperation for implementation of a statewide system that includes but is not limited
35 to:

36 **(A) Seeking information from service providers, service coordinators, parents and others about**
37 **any federal, state or local policies that impede timely service delivery; and**

38 **(B) Taking steps to ensure that any policy problems identified under subparagraph (A) of this**
39 **paragraph are resolved.**

40 **(e) Advise [and assist the Department of Education in] the Superintendent of Public Instruc-**
41 **tion and the Early Learning System Director on** identifying the sources of fiscal and other sup-
42 port for *[preschool]* **early intervention and early childhood special education** services, assigning
43 financial responsibility to the appropriate agencies and ensuring that the provisions of interagency
44 agreements under ORS 343.511 are carried out.

45 **(f) Review and comment on each agency's services and policies regarding services for infants,**

1 **toddlers and** preschool children with *[disabilities, or]* **a disability, or infants, toddlers and** pre-
2 school children who are at risk of developing disabling conditions, and their families to the maxi-
3 mum extent possible to assure cost-effective and efficient use of resources.

4 *[(g) To the extent appropriate, assist the Department of Education in the resolution of disputes.]*

5 *[(h) (g) Advise [and assist] the Department of Education **and the Early Learning Division on***
6 *[in] the preparation of applications and amendments thereto.*

7 *[(i) (h) Advise [and assist the Department of Education regarding the transition of preschool*
8 *children with disabilities] **the Superintendent of Public Instruction and the Early Learning***
9 ***System Director regarding transitions of children with a disability, including transitions to***
10 ***kindergarten.***

11 *[(j) (i) Prepare and submit an annual report to the Governor, **the Deputy Superintendent of***
12 ***Public Instruction,** the Early Learning System Director, the Early Learning Council, **the State***
13 ***Board of Education,** the Legislative Assembly and the United States Secretary of Education on the*
14 *status of early intervention *[programs operated]* **and early childhood special education services***
15 ***provided** within this state.*

16 *[(5) (6) The council may advise appropriate agencies about integration of services for preschool*
17 *children with *[disabilities]* **a disability** and at-risk preschool children.*

18 *[(6) (7) Terms of office for council members shall be three years, except that:*

19 (a) The representative from the State Advisory Council for Special Education shall serve a
20 one-year term; and

21 (b) The representatives from other state agencies and the *[representative]* **representatives** from
22 the Legislative Assembly shall serve indefinite terms.

23 *[(7) (8) Subject to approval by the Governor, the council may use federal funds appropriated for*
24 *this purpose and available to the council to:*

25 (a) Conduct hearings and forums;

26 (b) Reimburse nonagency council members under ORS 292.495 for attending council meetings, for
27 performing council duties, and for necessary expenses, including child care for parent members;

28 (c) Pay compensation to a council member if the member is not employed or if the member must
29 forfeit wages from other employment when performing official council business;

30 (d) Hire staff; and

31 (e) Obtain the services of such professional, technical and clerical personnel as may be neces-
32 sary to carry out its functions.

33 *[(8) (9) Except as provided in subsection *[(7) (8)]* of this section, council members shall serve*
34 *without compensation.*

35 *[(9) (10) The Department of Education shall provide clerical and administrative support, in-*
36 *cluding staff, to the council to carry out the performance of the council's function as described in*
37 *this section.*

SECTION 8. ORS 329A.500 is amended to read:

329A.500. [(1) *The Department of Human Services, in consultation with the Early Learning Division and the Office of Child Care, shall adopt rules for the operation of subsidy programs for employment-related child care administered by the department. At a minimum, and taking into account the availability of funds, the rules must provide the following:*]

[(a) *Subsidy recipients may be entitled to receive the subsidy for at least one year, regardless of changes in employment. Rules adopted by the department may provide for termination of subsidy eligibility for reasons other than changes in employment during the one-year period. Exit eligibility and copays must be structured to mitigate the financial impact of reduced subsidy support due to increased income.*]

[(b) *Subsidy recipients who are enrolled in coursework, as defined by the department by rule, may be entitled to receive the subsidy to enable the subsidy recipient to attend and participate in the coursework provided all other eligibility requirements are met.*]

[(c) *Persons who are self-employed may qualify for subsidy programs provided all other eligibility requirements are met.*]

[(d) *Subsidy recipients who voluntarily choose child care providers that meet minimum standards established under the tiered quality rating and improvement system implemented under ORS 329A.261 may qualify for lower copayments. A fair representation of the subsidy recipients who qualify for lower copayments must be persons with children who are from underserved racial, ethnic or minority populations. In addition, child care providers that meet specified minimum standards established under the tiered quality rating and improvement system may receive an enhanced reimbursement under the subsidy programs.*]

[(e) *Subsidy recipients must report a change of child care provider to the department during the period a subsidy is being received.*]

(1) As used in this section, “family” means any individual who is responsible for the care, control and supervision of a child.

(2) The Department of Human Services and the Early Learning Council shall adopt rules for the operation of the Employment Related Day Care subsidy program administered by the department.

(3) The rules adopted under this section must support equitable access to a supply of diverse child care providers that meet the needs of families, as those needs are defined by the department by rule, including:

- (a) Cultural diversity;**
- (b) Linguistic diversity;**
- (c) Racial and ethnic diversity; and**
- (d) Diversity of provider types.**

(4) The rules adopted under this section must provide that:

(a) A child’s eligibility to participate in the Employment Related Day Care subsidy program must be based on:

- (A) The household income of a child’s family; and**
- (B) Any other criteria established by the department.**
- (b) A child must be able to receive care that:**

(A) Meets the child’s developmental, disability and neurodiversity needs; and

(B) Enables the child’s family to complete activities that relate to family well-being, which may include the family’s work hours, education hours, commute time, study time and

1 **other activities that support family well-being.**

2 (c) **Payment to child care providers must be based on enrollment instead of attendance.**

3 (5) **Taking into account the availability of funds, the rules adopted under this section**
4 **must establish a sliding scale for copayment, with the requirement that a copayment may**
5 **not exceed seven percent of the household income of the child's family.**

6 (6) **In developing rules under this section, the department shall consider policies for in-**
7 **creasing the stability and continuity of a child's access to a family's preferred child care**

15 (i) The Department of Corrections, subject to any applicable provisions of ORS 279A.120,
16 279A.125, 279A.145 and 283.110 to 283.395, to procure or supervise the procurement of goods, ser-
17 vices and personal services under ORS 179.040 for its institutions;

18 (j) The Department of Veterans' Affairs to procure or supervise the procurement of real estate
19 broker and principal real estate broker services related to programs under the department's au-
20 thority;

21 (k) The Oregon Military Department to procure or supervise the procurement of construction
22 materials, equipment, supplies, services and personal services for public improvements, public works

39 an activity offered by the facility or in other nonwork activity.

40 (i) Facility operated as a school-age recorded program.

41 (6) "Family" has the meaning given that term in ORS [329.145] **329.155**.

42 (7) "Occasional" means that care is provided for no more than 70 days in any calendar year.

43 (8) "Parent cooperative" means a child care program in which:

44 (a) Care is provided by parents on a rotating basis;

45 (b) Membership in the cooperative includes parents;

1 (c) There are written policies and procedures; and

2 (d) A board of directors that includes parents of the children cared for by the cooperative con-
3 trols the policies and procedures of the program.

4 (9) "Preschool recorded program" means a facility providing care for preschool children that is
5 primarily educational for four hours or less per day and where no child is present at the facility for

5 (j) At least one council member shall be from each state agency responsible for providing pre-

7 (k) At least one council member shall be from each state agency responsible for children's
8 mental health.

9 (L) At least two council members shall be from the Department of Human Services with exper-
10 tise in foster care or self-sufficiency programs.

11 (m) At least one council member shall be from the [*Office of Child Care*] **Department of Early**
12 **Learning and Care** with expertise in the Child Care and Development Fund.

13 (n) At least one council member shall be a representative of the Department of Education with
14 expertise in the coordination of education of homeless children and youth.

15 (o) At least one council member shall be from the Department of Consumer and Business Ser-

41 (n) A naturopathic physician.

42 (o) A licensed professional counselor.

43 (p) A licensed marriage and family therapist.

44 (q) A firefighter or emergency medical services provider.

45 (r) A court appointed special advocate, as defined in ORS 419A.004.

1 (s) A child care provider registered or certified under ORS 329A.030 and 329A.250 to 329A.450.

2 (t) A member of the Legislative Assembly.

3 **SECTION 61.** ORS 805.205 is amended to read:

4 805.205. (1) Except as provided in subsection (7) of this section, the Department of Transporta-
5 tion shall provide for issuance of registration plates described in this section for nonprofit groups
6 meeting the qualifications for tax exempt status under section 501(c)(3) of the Internal Revenue Code
7 and for institutions of higher education. Plates issued under this section may be issued to owners
8 of motor vehicles registered under the provisions of ORS 803.420 (6)(a). Plates issued under this
9 section may not contain expressions of political opinion or religious belief. Rules adopted under this
10 section shall include, but need not be limited to, rules that:

11 (a) Specify circumstances under which the department may cease to issue plates for any partic-

27 **SECTION 73.** ORS 329A.500, as amended by section 8 of this 2021 Act, is amended to read:

28 329A.500. (1) As used in this section, “family” means any individual who is responsible for the
29 care, control and supervision of a child.

30 (2) The [*Department of Human Services and the*] Early Learning Council shall adopt rules for the
31 operation of the Employment Related Day Care subsidy program administered by the Department
32 of Early Learning and Care.

33 (3) The rules adopted under this section must support equitable access to a supply of diverse
34 child care providers that meet the needs of families, as those needs are defined by the [*department*]
35 council by rule, including:

- 36 (a) Cultural diversity;
- 37 (b) Linguistic diversity;
- 38 (c) Racial and ethnic diversity; and
- 39 (d) Diversity of provider types.

40 (4) The rules adopted under this section must provide that:

41 (a) A child’s eligibility to participate in the Employment Related Day Care subsidy program
42 must be based on:

- 43 (A) The household income of a child’s family; and
 - 44 (B) Any other criteria established by the [*department*] council.
- 45 (b) A child must be able to receive care that:

1 (A) Meets the child’s developmental, disability and neurodiversity needs; and

2 (B) Enables the child’s family to complete activities that relate to family well-being, which may
3 include the family’s work hours, education hours, commute time, study time and other activities that
4 support family well-being.

5 (c) Payment to child care providers must be based on enrollment instead of attendance.

6 **(d) A child care provider may be eligible to receive a higher rate of reimbursement or
7 other financial incentives for:**

8 **(A) Participating in quality improvement measures;**

9 **(B) Providing culturally or linguistically specific or appropriate care;**

10 **(C) Providing evening, overnight or weekend care;**

11 **(D) Providing care to children with a diagnosed disability;**

12 **(E) Providing infant or toddler care;**

13 **(F) Providing care to a population that has been identified as historically having an in-
14 adequate child care provider supply; or**

15 **(G) Providing any other specialized care that justifies a higher rate of reimbursement.**

16 (5) Taking into account the availability of funds, the rules adopted under this section [*must es-
17 tablish*]:

18 (a) **Must establish** a sliding scale for copayment, with the requirement that a copayment may
19 not exceed seven percent of the household income of the child’s family.

20 (b) **Must provide that eligibility to participate in the Employment Related Day Care sub-
21 sidy program:**

22 **(A) May not be based on the citizenship or legal status of a child or a child’s family; and**

23 **(B) Shall, for a child who met the initial eligibility requirements prescribed under sub-
24 section (4) of this section, continue for a minimum of 12 months from the date of initial el-
25 igibility unless the child’s family leaves this state or requests a termination of benefits or
26 for any other reason identified by the council. Rules adopted under this subparagraph shall
27 give priority to families receiving temporary assistance under the temporary assistance for
28 needy families program described in ORS 412.006.**

29 **(c) May provide that a determination of eligibility to participate in the Employment Re-
30 lated Day Care subsidy program consider the availability of family to attend to the child,
31 regardless of the family’s physical presence.**

32 (6) In developing rules under this section, the [*department*] **council** shall consider policies for
33 increasing the stability and continuity of a child’s access to a family’s preferred child care provider.

34 (7) Rules adopted by the [*department*] **council** under this section establish minimum requirements
35 pertaining to the Employment Related Day Care subsidy program and may not be construed to pre-
36 empt, limit or otherwise diminish the applicability of any policy, standard or collective bargaining
37 agreement that provides for an increased subsidy or a child care provider reimbursement amount
38 under state or federal law.

39 (8)(a) The [*department*] **council** shall work to meet federal recommendations for income eligibil-
40 ity and market access in regard to the Employment Related Day Care subsidy program administered
41 by the [*department*] **council**.

42 (b) Notwithstanding any provision of this section or any rule adopted by the [*department*]
43 **council** pursuant to this section, the laws and regulations applicable to the federal funds shall
44 govern when any aspect of child care is funded by federal funds.

45 **SECTION 74.** ORS 329A.505, as amended by section 8a of this 2021 Act, is amended to read:

1 329A.505. (1) At any reasonable time, an authorized representative of the Office of Child Care
2 may conduct an inspection or investigation of a regulated subsidy facility, as defined by the Early
3 Learning Council by rule.

4 (2) When conducting an investigation under this section, the Office of Child Care may:

5 (a) Take evidence;

6 (b) Take the depositions of witnesses, including the person under investigation, in the manner
7 prescribed by law for depositions in civil actions;

8 (c) Compel the appearance of witnesses, including the person under investigation, in the manner
9 prescribed by law for appearances in civil actions;

10 (d) Require answers to interrogatories;

11 (e) Compel the production of books, papers, accounts, documents or testimony that pertains to

18 (4) In addition to any rules adopted under ORS 329A.500, the Early Learning Council[, *in con-*
19 *sultation with the Department of Human Services,*] may adopt rules to establish minimum health and
20 safety standards for regulated subsidy facilities and for the administration of this section.

(3) The applicable percentage for a household in excess of eight members shall be calculated as if for a household size of eight members.

(4) The credit under this section is not allowed to a taxpayer with federal adjusted gross income or Oregon adjusted gross income, whichever is greater, in excess of 300 percent of the federal poverty level.

3 the amount of credit claimed by the taxpayer against any taxpayer who knowingly claims or at-
4 tempts to claim any amount of credit under this section for which the taxpayer is ineligible, or
5 against any individual who knowingly assists another individual in claiming any amount of credit
6 for which the individual is ineligible.

7 (7) The Department of Revenue may adopt rules for carrying out the provisions of this section
8 and prescribe the form used to claim a credit and the information required on the form.

9 (8) A nonresident individual shall be allowed the credit computed in the same manner and sub-
10 ject to the same limitations as the credit allowed a resident by subsection (1) of this section.
11 However, the credit shall be prorated using the proportion provided in ORS 316.117.

12 (9) If a change in the taxable year of a taxpayer occurs as described in ORS 314.085, or if the
13 Department of Revenue terminates the taxpayer's taxable year under ORS 314.440, the credit al-
14 lowed by this section shall be prorated or computed in a manner consistent with ORS 314.085.

15 (10) If a change in the status of a taxpayer from resident to nonresident or from nonresident to
16 resident occurs, the credit allowed by this section shall be determined in a manner consistent with
17 ORS 316.117.

18 (11) If the amount allowable as a credit under this section, when added to the sum of the
19 amounts allowable as payment of tax under ORS 316.187 or 316.583, other tax prepayment amounts
20 and other refundable credit amounts, exceeds the taxes imposed by ORS chapters 314 and 316 for
21 the tax year after application of any nonrefundable credits allowable for purposes of ORS chapter
22 316 for the tax year, the amount of the excess shall be refunded to the taxpayer as provided in ORS
23 316.502.

24 (12) Any amount that is refunded to the taxpayer under this section and that is in excess of the
25 tax liability of the taxpayer does not bear interest.

26 **SECTION 76.** ORS 406.072 is amended to read:

27 406.072. (1) As used in this section:

28 (a) "Uniformed service" means the Armed Forces of the United States, the Army National Guard
29 or the Air National Guard when the member is engaged in active duty for training, inactive duty
30 for training or full-time National Guard duty, the commissioned corps of the United States Public
31 Health Service and any other category of persons designated by the President of the United States
32 in time of war or national emergency.

33 (b) "Written information" means information that is in written form and includes but is not
34 limited to information obtained by electronic means, electronic mail, facsimile or other form of
35 electronic communication.

36 (2)(a) Subject to subsection (3) of this section and upon implementation or upgrade of an elec-
37 tronic delivery system that will enable the Department of Human Services to provide the notice
38 required by this subsection in a cost-effective and efficient manner, the Director of Human Services
39 shall notify the Director of Veterans' Affairs within 30 days of receipt of written information from
40 a member or veteran of a uniformed service who has applied for benefits or services under the fol-
41 lowing:

42 (A) Temporary assistance for needy families program under ORS 412.001 to 412.069;

43 (B) Assistance funded under Title IV-A of the Social Security Act as administered in this state
44 by the Department of Human Services;

45 (C) Supplemental Nutrition Assistance Program under ORS 411.806 to 411.845;

1 (D) Oregon Health Plan;

2 [(E) *Employment Related Day Care program administered by the Department of Human Services;*]

3 [(F)] (E) Programs and services for seniors and persons with disabilities administered by the
4 Department of Human Services; and

5 [(G)] (F) Vocational rehabilitation services and programs administered by the Department of
6 Human Services.

7 (b) **Subject to subsection (3) of this section, the Early Learning System Director shall**
8 **notify the Director of Veterans' Affairs within 30 days of receipt of written information from**
9 **a member or veteran of a uniformed service who has applied for benefits or services under**
10 **the Employment Related Day Care subsidy program administered by the Department of Early**
11 **Learning and Care.**

12 [(b)] (c) The notification required under this subsection is limited to notifying the Director of
13 Veterans' Affairs of the name and residence address or mailing address of the member or veteran.

14 [(c)] (d) The authorization of a member or veteran as required by subsection (3) of this section
15 may be contained in the written information at the time it is received by the Department of Human
16 Services **or the Department of Early Learning and Care** or separately at another time but the
17 authorization must specifically authorize the notification to be made under this subsection.

18 (3) The Director of Human Services **or the Early Learning System Director** shall notify the
19 Director of Veterans' Affairs as required by subsection (2) of this section only when authorized to
20 do so by the member or veteran of a uniformed service who submitted the written information.

21 (4) The Department of Human Services **and the Early Learning Council**, in consultation with
22 the Department of Veterans' Affairs, shall adopt rules to implement the provisions of this section,
23 including but not limited to the method of notification required under subsection (2) of this section.

24 **SECTION 77.** ORS 411.882 is amended to read:

25 411.882. In administering the JOBS Plus Program and to the extent permitted by federal law, the
26 Department of Human Services shall maximize the use of federal grants and apportionments of the
27 temporary assistance for needy families program[,] **and** the Supplemental Nutrition Assistance Pro-
28 gram [*and employment related child care*].

29 **SECTION 78.** (1) **The amendments to ORS 315.264, 329A.500, 329A.505, 406.072 and 411.882**
30 **by sections 73 to 77 of this 2021 Act become operative on July 1, 2023.**

31 (2) **Notwithstanding the operative date set forth in subsection (1) of this section, the**
32 **Early Learning Division and the Department of Human Services may take any action before**
33 **the operative date set forth in subsection (1) of this section that is necessary for the De-**
34 **partment of Early Learning and Care to exercise, on and after the operative date set forth**
35 **in subsection (1) of this section, all of the duties, functions and powers conferred on the**
36 **Department of Early Learning and Care by the amendments to ORS 315.264, 329A.500,**
37 **329A.505, 406.072 and 411.882 by sections 73 to 77 of this 2021 Act.**

38 (3) **For the purpose of ensuring that the Department of Early Learning and Care may**
39 **exercise, on and after the operative date set forth in subsection (1) of this section, all of the**
40 **duties, functions and powers conferred on the Department of Early Learning and Care by the**
41 **amendments to ORS 315.264, 329A.500, 329A.505, 406.072 and 411.882 by sections 73 to 77 of**
42 **this 2021 Act, the Early Learning Division and the Department of Human Services shall de-**
43 **velop and implement a plan that provides for a seamless transfer of duties, functions and**
44 **powers.**

45 (4) **The Governor shall resolve any disputes related to the plan developed and imple-**

1 mented under subsection (3) of this section, and the Governor's decision is final.

2 **SECTION 79.** (1) The amendments to ORS 329A.500 by section 73 of this 2021 Act are intended to transfer the Employment Related Day Care subsidy program from the Department
3 of Human Services to the Department of Early Learning and Care.

5 (2) For the purpose of the transfer described in subsection (1) of this section, the Director of Human Services shall:

7 (a) Deliver to the Department of Early Learning and Care all records and property within the jurisdiction of the director that relate to the duties, functions and powers transferred
8 by the amendments to ORS 329A.500 by section 73 of this 2021 Act; and

10 (b) Transfer to the Department of Early Learning and Care those employees engaged primarily in the exercise of the duties, functions and powers transferred by the amendments

21 **SECTION 80.** (1) The unexpended balances of amounts authorized to be expended by the Department of Human Services for the biennium beginning July 1, 2021, from revenues dedicated, continuously appropriated, appropriated or otherwise made available for the purpose
22 of administering and enforcing the duties, functions and powers of the Department of Human Services that are transferred by the amendments to ORS 329A.500 by section 73 of this 2021
23 Act are transferred to and are available for expenditure by the Department of Early Learning and Care for the biennium beginning July 1, 2021, for the purpose of administering and
24 enforcing the duties, functions and powers transferred to the Department of Early Learning and Care by the amendments to ORS 329A.500 by section 73 of this 2021 Act.

30 (2) The expenditure classifications, if any, established by Acts authorizing or limiting expenditures by the Department of Human Services remain applicable to expenditures by the
31 Department of Early Learning and Care under this section.

33 **SECTION 81.** The transfer of duties, functions and powers to the Department of Early Learning and Care by the amendments to ORS 329A.500 by section 73 of this 2021 Act does
34 not affect any action, proceeding or prosecution involving or with respect to such duties, functions and powers begun before and pending at the time of the transfer, except that the
35 Department of Early Learning and Care is substituted for the Department of Human Services in the action, proceeding or prosecution.

39 **SECTION 82.** (1) Nothing in the amendments to ORS 315.264, 329A.500, 329A.505, 406.072 and 411.882 by sections 73 to 77 of this 2021 Act relieves a person of a liability, duty or obligation accruing under or with respect to the duties, functions and powers transferred by the
40 amendments to ORS 329A.500 by section 73 of this 2021 Act. The Department of Early Learning and Care may undertake the collection or enforcement of any such liability, duty
41 or obligation.

45 (2) The rights and obligations of the Department of Human Services legally incurred un-

1 der contracts, leases and business transactions executed, entered into or begun before the
 2 operative date of the amendments to ORS 329A.500 by section 73 of this 2021 Act are trans-
 3 ferred to the Department of Early Learning and Care. For the purpose of succession to
 4 these rights and obligations, the Department of Early Learning and Care is a continuation
 5 of the Department of Human Services and not a new authority.

6 **SECTION 83.** Notwithstanding the transfer of duties, functions and powers by the
 7 amendments to ORS 329A.500 by section 73 of this 2021 Act, the rules of the Department of
 8 Human Services in effect on the operative date of the amendments to ORS 329A.500 by sec-
 9 tion 73 of this 2021 Act continue in effect until superseded or repealed by rules of the Early
 10 Learning Council. References in rules of the Department of Human Services to the Depart-
 11 ment of Human Services in relation to the Employment Related Day Care subsidy program

16 **SECTION 84.** Whenever, in any statutory law or resolution of the Legislative Assembly
 17 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-
 18 erence is made to the Department of Human Services or an officer or employee of the De-
 19 partment of Human Services in relation to the Employment Related Day Care subsidy
 20 program, the reference is considered to be a reference to the Department of Early Learning
 21 and Care or an officer or employee of the Department of Early Learning and Care.

 29 sections 64 and 78 of this 2021 Act, including:

30 (a) Progress on the transfer of child care assistance programs, including the Employment
 31 Related Day Care subsidy program, to the Early Learning Division.

32 (b) Progress on efforts to strengthen the alignment of the early childhood special edu-
 33 cation and early intervention services within the statewide early learning system.

34 (c) Progress on the adoption of rules related to school-age child care.

35 (2) No later than January 15, 2022, the Department of Human Services, in collaboration
 36 with the Early Learning Division, shall report to the appropriate interim committees of the
 37 Legislative Assembly. The report shall address the timelines and fiscal impact of the eligi-
 38 bility requirements as provided by the amendments to ORS 329A.500 by section 73 of this 2021
 39 Act.

40 (3) No later than January 15, 2022, the Early Learning Division, in collaboration with the
 41 Department of Education and the Department of Human Services, shall report to the ap-
 42 propriate interim committees of the Legislative Assembly. The report shall address the
 43 progress on the plans required to be developed and implemented as provided by sections 64
 44 and 78 of this 2021 Act, including:

45 (a) Progress on the transfer of background checks inspections for the Employment Re-

1 lated Day Care subsidy program to the Early Learning Division, including any recommen-
2 dations for legislation or other authority necessary for the collection of subsidy
3 overpayments made under the program.

4 (b) Progress on the transfer of child care assistance programs, including the Employment
5 Related Day Care subsidy program, to the Early Learning Division, and any recommended
6 changes related to the transfer.

7 (c) Recommendations to strengthen the alignment of the early childhood special educa-
8 tion and early intervention services within the statewide early learning system, including any
9 recommended changes to governance, policymaking or other oversight of the system.

10 (d) Progress on the adoption of rules related to school-age child care.

11 (e) Any fiscal impacts of the plan and any conflicts of the plan with federal statute that
12 must be resolved.

13 (f) Any budgetary impacts or recommendations for legislation related to the plan.

14 (4) No later than September 30, 2022, the Early Learning Division, in collaboration with
15 the Department of Education and the Department of Human Services, shall report to the
16 appropriate interim committees of the Legislative Assembly. The report shall include updates
17 on the implementation of the plan required to be developed and implemented as provided by
18 section 64 of this 2021 Act and the progress on the plan required to be developed and imple-
19 mented as provided by section 78 of this 2021 Act.
