SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of Early Learning Division to Department of Early Learning and Care. Establishes Department of Early Learning and Care as state agency that is separate from Department of Education and that functions under, and is coordinated by, Early Learning Council.

Prescribes expanded duties, functions and powers of Department of Early Learning and Care, including administration of Employment Related Day Care. Modifies requirements of Employment Related Day Care.

Directs Early Learning Division, Department of Education and Department of Human Services to develop and implement plans for seamless transfer of relevant duties, functions and powers, and to report on plans to appropriate interim committees of Legislative Assembly.

Revises goals of statewide early learning system.

Modifies membership and duties of State Interagency Coordinating Council.

Declares emergency, effective on passage.

10 Whereas a child's brain makes one million new neural connections every second before the age
11 of five years, with early experiences shaping brain architecture; and

12 Whereas complex neural, social and emotional development occurs before the age of five years,
13 making early childhood a critical window in which to eliminate disparities; and

14 Whereas access to continuous, high-quality child care, early care and education and out-of-
15 school programs is critical to a child's success in school and life; and

16 Whereas both early care and education and out-of-school programs during elementary school
17 predict higher academic achievement at 15 years of age; and

18 Whereas all children are born full of potential, yet their family's zip code, income and race and
19 ethnicity are powerful predictors of a child's and family's access to high quality child care and early

1 education; and

2 Whereas child caring disproportionately impacts women, particularly women of color, through
3 child care shortages, lower wages as child care providers and staff and systemic discrimination; and

4 Whereas an affordable, accessible system of high quality child care is necessary for the health
5 of Oregon's economy because employers benefit when parents have safe, stable, culturally responsive
6 and developmentally appropriate care for their children that meets their needs; and

7 Whereas the Oregon Early Learning System should provide developmentally appropriate, cul-
8 turally responsive, relevant and inclusive child care and early care and education for children and
9 families across race, ethnicity, language, geography, ability and income levels, as recommended by
10 Raise Up Oregon; and

11 Whereas the health and stability of Oregon's child care and early care and education workforce
12 is pivotal to any expansion of child care in Oregon and this workforce, predominately composed of
13 women of color, is structurally afflicted by low wages, limited or no health care and a severe lack
14 of retirement benefits; and

15 Whereas Oregon must value the work of caregivers, especially Black and indigenous women,
16 women of color and immigrant women, and ensure that they receive the equitable pay and benefits
17 they deserve for their work, training and services that support workforce development and supports
18 offered to all provider types; and

19 Whereas Oregon's child care sector supports all providers, which are essential to offering a
20 mixed-delivery child care system and that include family, friend and neighbor child care, regulated
21 subsidy child care, registered family child care, certified family child care, certified child care cen-
22 ters, out-of-school programs, Oregon Prekindergarten, Head Start, Early Head Start, relief nurseries,
23 Healthy Families Oregon programs, privately subsidized child care programs and publicly funded
24 child care programs; and

25 Whereas the Oregon Early Learning System must be informed by and accountable to the parents
26 and providers who most need it and who know the most about the system; and

27 Whereas the partnership and collaboration between the Oregon Early Learning System, the
28 kindergarten through grade 12 system, the health system, the human services system and the hous-
29 ing system are critical to the success of every child; now, therefore,

30 **Be It Enacted by the People of the State of Oregon:**

31
32 **STATEWIDE EARLY LEARNING SYSTEM**

33
34 **SECTION 1.** ORS 417.728 is amended to read:

35 417.728. (1) The Early Learning Council [*shall lead a joint effort with other state and local early*
36 *childhood partners to establish the policies necessary for a voluntary*] **is responsible for leading**
37 **cross-sector strategic planning that establishes the goals, objectives and strategies necessary**
38 **for a statewide early learning system.**

39 [(2) *The voluntary statewide early learning system shall be designed to achieve:*]

40 [(a) *The appropriate outcomes identified by the Early Learning Council with input from early*
41 *childhood partners; and*]

42 [(b) *Any other early childhood benchmark or outcome that demonstrates progress toward meeting*
43 *a target and that is identified by the Early Learning Council with input from early childhood*
44 *partners.*]

45 **(2) The purpose of the statewide early learning system is to make progress toward en-**

1 **uring that:**

2 (a) **Children enter school ready to learn;**

3 (b) **Children are raised in families that are healthy, stable and attached; and**

4 (c) **Early learning is available and provided in a manner that is aligned, coordinated and**
5 **family centered.**

6 (3) The [voluntary] statewide early learning system shall include the following components:

7 (a) A process to identify as early as possible children and families who would benefit from early
8 learning services, including the required use of standardized screening and referral procedures used
9 throughout the [voluntary] statewide early learning system;

10 (b) A plan to support the identified needs of the child and family that coordinates case man-
11 agement personnel and the delivery of services to the child and family; and

12 (c) Services to support children who are zero through six years of age and their families who
13 give their express written consent, including:

14 (A) Screening, assessment and home visiting services pursuant to ORS 417.795;

15 (B) Specialized or targeted home visiting services;

16 (C) Community-based services such as relief nurseries, family support programs and parent ed-
17 ucation programs;

18 (D) Affordable, quality child care, as defined by the Early Learning Council;

19 (E) Preschool and other early education services;

20 (F) Health services for children and pregnant women;

21 (G) Mental health services;

22 (H) Alcohol and drug treatment programs that meet the standards promulgated by the Oregon
23 Health Authority pursuant to ORS 430.357;

24 (I) Developmental disability services; and

25 (J) Other state and local services.

26 (4) In establishing the definition of affordable, quality child care under subsection (3)(c)(D) of
27 this section, the Early Learning Council shall consult with child care providers and early childhood
28 educators. The definition established by the council shall support parental choice of child care pro-
29 vider and shall consider differences in settings and services, including but not limited to child care
30 for school-aged children, part-time care, odd-hour and respite care and factors of cultural appropri-
31 ateness and competence.

32 [(5) No later than July 1, 2016, for the purpose of ensuring that affordable, quality home-based
33 child care is available through a subsidy program administered by the Department of Human Services,
34 the Early Learning Division, in consultation with the department, shall develop and implement a system
35 of quality supports for exempt family child care providers as defined in ORS 329A.430. The system
36 may use evidence-based practices or best practices that are consistent with state policies for child
37 well-being and development and that are subject to collective bargaining. The system must include
38 professional development opportunities for exempt family child care providers that are available for
39 attendance in person and through the Internet.]

40 [(6)] (5) The Early Learning Council shall:

41 (a) Consolidate administrative functions relating to the [voluntary] statewide early learning
42 system, to the extent practicable, including but not limited to training and technical assistance,
43 planning and budgeting.

44 (b) Adopt policies to establish training and technical assistance programs to ensure that per-
45 sonnel have skills in appropriate areas, including screening, family assessment, competency-based

1 home visiting skills, cultural and gender differences and other areas as needed.

2 (c) Identify research-based age-appropriate and culturally and gender appropriate screening and
3 assessment tools that would be used as appropriate in programs and services of the [voluntary]
4 statewide early learning system.

5 (d) Develop a plan for the implementation of a common data system for voluntary early child-
6 hood programs.

7 (e) Coordinate existing and new early childhood programs to provide a range of community-
8 based supports.

9 (f) Establish a common set of quality assurance standards to guide local implementation of all
10 elements of the [voluntary] statewide early learning system, including voluntary universal screening
11 and assessment, home visiting, staffing, evaluation and community-based services.

12 (g) Ensure that all plans for voluntary early childhood services are coordinated and consistent
13 with federal and state law, including but not limited to plans for Oregon prekindergarten programs,
14 federal Head Start programs, early childhood special education services, early intervention services
15 and public health services.

16 (h) Identify how the [voluntary] statewide early learning system for children who are zero
17 through six years of age will link with systems of support for older children and their families.

18 (i) During January of each odd-numbered year, report to the Governor and the Legislative As-
19 sembly on the [voluntary] statewide early learning system.

20 [(7)] (6) The State Board of Education, the Employment Department, the Department of Human
21 Services and the Oregon Health Authority when adopting rules to administer voluntary early
22 childhood programs under their individual authority shall adopt rules:

23 (a) That are consistent with the requirements of the [voluntary] statewide early learning system
24 created under this section; and

25 (b) With the direction of the Early Learning Council.

26 [(8)] (7) Information gathered in conjunction with the voluntary comprehensive screening and
27 assessment of children and their families may be used only for the following purposes:

28 (a) Providing services to children and families who give their express written consent;

29 (b) Providing statistical data that are not personally identifiable;

30 (c) Accomplishing other purposes for which the family has given express written consent; and

31 (d) Meeting the requirements of mandatory state and federal disclosure laws.

32 **SECTION 2.** ORS 417.723 is amended to read:

33 417.723. The Oregon Health Authority and the Early Learning Council shall establish a grant
34 program to provide funding to support effective and scalable strategies that align [voluntary] state-
35 wide early learning systems and health systems for the purpose of improving the developmental
36 outcomes for children from zero through three years of age.

37 **SECTION 3.** ORS 417.727 is amended to read:

38 417.727. Based on the findings expressed in ORS 417.708, there is created the Oregon Early
39 Learning System. The goals of the system are to:

40 (1) Prevent child abuse and neglect;

41 (2) Improve the health and development of young children;

42 (3) Promote bonding and attachment in the early years of a child's life;

43 (4) Support parents in providing the optimum environment for their young children;

44 (5) Link and integrate services and supports in the [voluntary] statewide early learning system
45 pursuant to ORS 417.728;

1 (6) Ensure that children are entering school ready to learn; and

2 (7) Ensure that parents have access to affordable, quality child care.

3 **SECTION 4.** ORS 417.795 is amended to read:

4 417.795. (1) The Early Learning Division shall establish Healthy Families Oregon programs in
5 all counties of this state as funding becomes available.

6 (2) These programs shall be nonstigmatizing, voluntary and designed to achieve the appropriate
7 early childhood benchmarks and shall:

8 (a) Ensure that express written consent is obtained from the family prior to any release of in-
9 formation that is protected by federal or state law and before the family receives any services;

10 (b) Ensure that services are voluntary and that, if a family chooses not to accept services or
11 ends services, there are no adverse consequences for those decisions;

12 (c) Offer a voluntary comprehensive risk assessment of all children, from zero through three
13 years of age, and their families in coordination with [voluntary] statewide early learning system
14 screening and referral efforts;

15 (d) Ensure that the disclosure of information gathered in conjunction with the voluntary com-
16 prehensive risk assessment of children and their families is limited pursuant to ORS 417.728 [(8)] (7)
17 to the following purposes:

18 (A) Providing services under the programs to children and families who give their express
19 written consent;

20 (B) Providing statistical data that are not personally identifiable;

21 (C) Accomplishing other purposes for which the family has given express written consent; and

22 (D) Meeting the requirements of mandatory state and federal disclosure laws;

23 (e) Ensure that risk factors used in the risk screen are limited to those risk factors that have
24 been shown by research to be associated with poor outcomes for children and families;

25 (f) Identify, as early as possible, families that would benefit most from the programs;

26 (g) Provide parenting education and support services, including but not limited to community-
27 based home visiting services;

28 (h) Provide other supports, including but not limited to referral to and linking of community and
29 public services for children and families such as mental health services, alcohol and drug treatment
30 programs that meet the standards promulgated by the Oregon Health Authority under ORS 430.357,
31 child care, food, housing and transportation;

32 (i) Coordinate services for children consistent with other services provided through the Oregon
33 Early Learning System;

34 (j) Integrate data with any common data system for early childhood programs;

35 (k) Be included in a statewide independent evaluation to document:

36 (A) Level of screening and assessment;

37 (B) Incidence of child abuse and neglect;

38 (C) Change in parenting skills; and

39 (D) Rate of child development;

40 (L) Be included in a statewide training program in the dynamics of the skills needed to provide
41 early childhood services, such as assessment and home visiting; and

42 (m) Meet statewide quality assurance and quality improvement standards.

43 (3) The Healthy Families Oregon programs, in coordination with statewide home visiting part-
44 ners, shall:

45 (a) Identify existing services and describe and prioritize additional services necessary for a

1 voluntary home visit system;

2 (b) Build on existing programs;

3 (c) Maximize the use of volunteers and other community resources that support all families;

4 (d) Target, at a minimum, all prenatal families and families with children less than three months
5 of age and provide services through at least the child's third birthday; and

6 (e) Ensure that home visiting services provided by local home visiting partners for children and
7 pregnant women support and are coordinated with local Healthy Families Oregon programs.

8 (4) Through a Healthy Families Oregon program, a trained home visitor shall be assigned to
9 each family assessed as at risk that consents to receive services through the trained home visitor.
10 The trained home visitor shall conduct home visits and assist the family in gaining access to needed
11 services.

12 (5) The services required by this section shall be provided by hospitals, public or private entities
13 or organizations, or any combination thereof, capable of providing all or part of the family risk as-
14 sessment and the follow-up services. In granting a contract, collaborative contracting or requests for
15 proposals may be used and must include the most effective and consistent service delivery system.

16 (6) The family risk assessment and follow-up services for families at risk shall be provided by
17 trained home visitors organized in teams supervised by a manager.

18 (7) Each Healthy Families Oregon program shall adopt disciplinary procedures for trained home
19 visitors and other employees of the program. The procedures shall provide appropriate disciplinary
20 actions for trained home visitors and other employees who violate federal or state law or the poli-
21 cies of the program.

22 **SECTION 5.** ORS 417.788 is amended to read:

23 417.788. (1) The Early Learning Division shall support Relief Nursery programs statewide as
24 funding becomes available. Funding to support Relief Nursery programs may include, but is not
25 limited to:

26 (a) Administrative costs;

27 (b) Costs for direct service personnel, equipment, supplies and operating expenses;

28 (c) Start-up costs;

29 (d) Classroom furniture and materials;

30 (e) Playground equipment;

31 (f) Computers; and

32 (g) Transportation vehicles.

33 (2) The division may encourage communities to establish Relief Nursery programs for young
34 children who are at risk and their families. Communities may choose to establish regional Relief
35 Nursery programs. The Relief Nursery programs shall be consistent with the *[voluntary]* **statewide**
36 early learning system coordinated by the Early Learning Council.

37 (3) Relief Nursery programs shall participate in a statewide independent evaluation conducted
38 by the Oregon Association of Relief Nurseries to document improved child safety, reduction in foster
39 care placements, progress in healthy child development and improvement in family functioning and
40 support.

41 (4) Each Relief Nursery program that receives state funding shall have financial support from
42 the community that, excluding any amounts distributed to the Relief Nursery program pursuant to
43 ORS 131A.360 (4)(d) and 131A.365 (3)(d), is at least equal to 25 percent of any state allocation.

44 (5) The division shall adopt rules necessary for the administration of this section, including rules
45 requiring that any public funds received by Relief Nursery programs be used to achieve the out-

1 comes identified in subsection (3) of this section.

2 **SECTION 6.** ORS 417.793 is amended to read:

3 417.793. The Early Learning Division shall support parents-as-teachers programs statewide as
4 funding becomes available. If a program is offered, the program shall be part of a comprehensive,
5 research-based approach to parent education and support. The program shall be consistent with the
6 [voluntary] **statewide** early learning system plan coordinated by the Early Learning Council.

10 **SECTION 7.** ORS 343.499 is amended to read:

11 343.499. (1)(a) There is created the State Interagency Coordinating Council.

12 (b) The Governor shall appoint members of the council from a list of eligible appointees **from**
13 **this state that is** provided by the council and agencies described in subsection (2) of this section
14 and shall ensure that the membership of the council reasonably represents the **racial, ethnic, lin-**
15 **guistic and geographic** population of this state.

16 (c) The Governor shall designate one member of the council to serve as the chairperson, or if
17 the Governor chooses not to name a chairperson, the council may elect one of its members to serve
18 as chairperson.

19 **(d) [However] Notwithstanding paragraph (c) of this subsection,** any member of the council
20 who represents the Department of Education may not serve as the chairperson of the council.

21 *[(2) The membership of the council shall be composed as follows:]*

22 *[(a) At least 20 percent of the council members shall be parents, including minority parents, of*
23 *preschool children with disabilities or of children with disabilities who are 12 years of age or younger*
24 *who have knowledge of or experience with programs for infants and toddlers with disabilities. At least*
25 *one council member shall be a parent of an infant or toddler with a disability or of a child with a*
26 *disability who is six years of age or younger.]*

27 *[(b) At least 20 percent of the council members shall be public or private providers of early inter-*
28 *vention and early childhood special education services.]*

29 *[(c) At least one council member shall be a member of the Legislative Assembly.]*

30 *[(d) At least one council member shall be involved in personnel preparation.]*

31 *[(e) At least one council member shall represent the Department of Human Services.]*

32 *[(f) At least one council member shall represent the federal Head Start program.]*

33 *[(g) At least one council member shall represent the Office of Child Care.]*

34 *[(h) At least one council member shall represent the Department of Education.]*

35 *[(i) At least one council member shall represent the Department of Consumer and Business Ser-*
36 *vices.]*

37 *[(j) At least one council member shall represent the Early Learning Division.]*

38 *[(k) At least one council member shall represent the Child Development and Rehabilitation Center*
39 *of the Oregon Health and Science University.]*

40 *[(L) At least one council member shall be a member of the State Advisory Council for Special Ed-*
41 *ucation created under ORS 343.287.]*

42 *[(m) At least one council member shall be a representative designated by the state coordinator for*
43 *homeless education.]*

44 *[(n) At least one council member shall represent the state child welfare agency responsible for foster*
45 *care.]*

1 *[(o) At least one council member shall represent the state agency responsible for children's mental*
2 *health.]*

3 *[(p) At least one council member shall be from the Oregon Health Authority.]*

4 *[(q) The council may include other members appointed by the Governor, including but not limited*
5 *to one representative from the United States Bureau of Indian Affairs or, where there is no school*
6 *operated or funded by the bureau, from the Indian Health Service or the tribe or tribal council.]*

7 **(2) The membership of the council shall be composed as follows:**

8 **(a) At least 20 percent of the council members shall be parents of children with a disa-**
9 **bility who are 12 years of age or younger at the time the council member is appointed. When**
10 **appointing council members under this paragraph, the Governor shall ensure that:**

11 **(A) At least 50 percent of the council members are parents of a child with a disability**
12 **who is five years of age or younger at the time the council member is appointed;**

13 **(B) At least 20 percent of the council members:**

14 **(i) Are parents of a child with a disability who is three years of age or younger at the**
15 **time the council member is appointed; and**

16 **(ii) Have knowledge of, or experience with, programs or services for infants or toddlers**
17 **with a disability; and**

18 **(C) The council members represent the racial, ethnic and linguistic diversity of children**
19 **in this state who are five years of age or younger.**

20 **(b) At least 20 percent of the council members shall be public or private providers of**
21 **early intervention and early childhood special education services.**

22 **(c) At least one council member shall be from a program responsible for preparing early**
23 **intervention and early childhood special education educators.**

24 **(d) At least one council member shall be from a Head Start or Early Head Start program.**

25 **(e) At least one council member shall be from a home-based child care program.**

26 **(f) At least one council member shall be from a center-based child care program.**

27 **(g) At least one council member shall be from the committee that serves as the state**
28 **advisory council, as described in ORS 326.425 (3).**

29 **(h) At least one council member shall be a member of the State Advisory Council for**
30 **Special Education created under ORS 343.287.**

31 **(i) At least one council member shall be from each state agency involved in the provision**
32 **of, or payment for, early intervention and early childhood special education services to in-**
33 **fant and toddlers with a disability and their families.**

34 **(j) At least one council member shall be from each state agency responsible for providing**
35 **preschool services to children with a disability.**

36 **(k) At least one council member shall be from each state agency responsible for**
37 **children's mental health.**

38 **(L) At least two council members shall be from the Department of Human Services with**
39 **expertise in foster care or self-sufficiency programs.**

40 **(m) At least one council member shall be from the Office of Child Care with expertise in**
41 **the Child Care and Development Fund.**

42 **(n) At least one council member shall be a representative of the Department of Educa-**
43 **tion with expertise in the coordination of education of homeless children and youth.**

44 **(o) At least one council member shall be from the Department of Consumer and Business**
45 **Services with expertise in state regulation of private health insurance.**

1 **(p) At least one council member shall be from the Oregon Health Authority with exper-**
2 **tise in Medicaid and the Children’s Health Insurance Program.**

3 **(q) At least one council member shall be a representative from a tribal agency responsi-**
4 **ble for supporting young children with developmental delays and disabilities, from a tribal**
5 **council or otherwise representing one or more tribes.**

6 (3) An individual appointed to represent a state agency *[that is involved in the provision of or*
7 *payment for services for preschool children with disabilities under subsection (2)(e) and (h) to (k) of this*
8 *section shall]* **under subsection (2) of this section must** have sufficient authority to engage in
9 making and implementing policy on behalf of the agency. **The Governor may appoint a council**
10 **member to represent more than one program or specialty listed in subsection (2) of this**
11 **section.**

12 **(4) In addition to the council members appointed under subsection (2) of this section:**

13 **(a) The Governor may appoint any other council members not listed in subsection (2) of**
14 **this section.**

15 **(b) The President of the Senate shall appoint one member from among members of the**
16 **Senate to serve as a nonvoting council member.**

17 **(c) The Speaker of the House of Representatives shall appoint one member from among**
18 **members of the House of Representatives to serve as a nonvoting council member.**

19 [(4)] **(5) The State Interagency Coordinating Council shall:**

20 (a) Advise the Superintendent of Public Instruction, the State Board of Education, **the Early**
21 **Learning System Director** and the Early Learning Council on unmet needs in the early childhood
22 special education and early intervention programs for *[preschool]* children with *[disabilities]* **a disa-**
23 **bility**, review and comment publicly on any rules proposed by the State Board of Education and the
24 distribution of funds for the programs and assist the state in developing and reporting data on and
25 evaluations of the programs and services.

26 (b) Advise and assist the represented public agencies regarding the services and programs they
27 provide to *[preschool]* children with *[disabilities]* **a disability** and their families, including public
28 comments on any proposed rules affecting the target population and the distribution of funds for
29 such services, and assist each agency in developing services that reflect the overall goals for the
30 target population as adopted by the council.

31 (c) Advise *[and assist]* the Department of Education, **the Early Learning Division** and other
32 state agencies *[in]* **on** the development and implementation of the policies that constitute the state-
33 wide system.

34 (d) *[Assist]* **Advise** all appropriate public agencies *[in]* **on** achieving the full participation, coordi-
35 nation and cooperation for implementation of a statewide system that includes but is not limited
36 to:

37 (A) Seeking information from service providers, service coordinators, parents and others about
38 any federal, state or local policies that impede timely service delivery; and

12 [(j) (i) Prepare and submit an annual report to the Governor, **the Deputy Superintendent of**
13 **Public Instruction,** the Early Learning System Director, the Early Learning Council, **the State**
14 **Board of Education,** the Legislative Assembly and the United States Secretary of Education on the
15 status of early intervention [*programs operated*] **and early childhood special education services**

18 **SECTION 11.** ORS 326.430 is amended to read:

19 326.430. (1) The **Department of Early Learning [Division] and Care** is established. [*in the De-*
20 *partment of Education. The purpose of the division is to ensure that children enter school ready to*
21 *succeed.*]

22 (2) The purposes of the department are to:

23 (a) Ensure that every child in this state is given the best opportunity to succeed in
24 school, work and life by providing:

25 (A) High-quality early childhood education programs for children from birth through five
26 years of age and child care for children from birth through 12 years of age; and

28 other specialized care from birth through 17 years of age;

32 considers the economic security and well-being of parents and providers.

33 [(2)] (3) The [division] **department** shall function under [*the direction and control of*] and be
34 coordinated by the Early Learning Council [*with*].

35 (4) The Early Learning System Director [*servicing*] **appointed under section 12 of this 2021 Act**
36 **shall serve** as the administrative officer of the department.

37 **SECTION 12.** (1) The Department of Early Learning and Care is under the supervision

24 balance of the funds.

45 (c) Deduct an amount equal to 20 percent of the forfeiture proceeds and deposit that amount in

1 the Oregon Criminal Justice Commission Account established under ORS 137.662 for support for
2 specialty courts as defined in ORS 137.680;

3 (d) Deduct an amount equal to 10 percent of the forfeiture proceeds and deposit that amount in
4 the **Department of Early Learning [Division] and Care** Fund established under ORS 326.435 for
5 disbursement to Relief Nursery programs as defined in ORS 417.786; and

6 (e) Deduct an amount equal to 10 percent of the forfeiture proceeds and deposit that amount in
7 an account established or designated by the State Treasurer in the higher education qualified tuition
8 savings program of the Oregon 529 Savings Network for disbursement to the scholarship program
9 for children of public safety officers established under ORS 348.270.

10 (5) If the forfeiting agency has entered into an agreement with a county under subsection (2)
11 of this section, after paying costs under subsection (3) of this section and making the deductions
12 required by subsection (4) of this section, the forfeiting agency shall pay the county the amounts
13 required by the agreement.

14 (6) After making all payments and deductions required by subsections (3), (4) and (5) of this
15 section, the forfeiting agency may use the remaining forfeiture proceeds, including amounts received
16 by a county under subsection (5) of this section or by any other public body under an intergovern-

18 (a) The purchase of equipment necessary for the enforcement of laws relating to the unlawful

26 agency shall pay an equitable portion of the forfeiture proceeds to each agency participating in the

2 Police under subsection (4) of this section, shall be divided between the State Police Account and

4 (A) One hundred percent of the first \$600,000 accumulated shall be deposited in the State Police

39 (G) Providing lead preschool teachers and teaching assistants with a salary that meets the
40 minimum salary requirements established by the Early Learning Council.

41 (H) Providing at least one teaching assistant in each classroom who provides support for aca-
42 demic instruction and who meets the state's personnel qualification requirements *[of one of the top*
43 *two tiers for the quality rating and improvement system for early childhood programs]* **as established**
44 **by rule by the Early Learning Council**.

45 (I) Providing children and families with additional health and child development supports, such

1 as screening, referrals and coordination with health care providers.

2 (g) Incorporates best practices in outreach, enrollment and programming for diverse cultural and
3 linguistic populations and children who have been historically underserved in preschool programs.

4 (h) Works in collaboration with community programs to ensure that families have knowledge of,
5 and are connected to, community resources and supports to meet the needs of children and families
6 served by the preschool program.

7 (i) Participates in an ongoing monitoring and program evaluation system that is used for con-
8 tinuous program improvement.

9 (6)(a) While any moneys received under a grant received or a contract entered into as provided
10 by this section must be used to serve children described in subsection (5)(c) of this section, nothing
11 in subsection (5)(c) of this section prevents a preschool provider from serving additional children,

36 (3) The [*division*] **department** shall monitor capacity needs and provide technical assistance to

36 (2) The [*Department of Human Services and the*] Early Learning Council shall adopt rules for the
37 operation of the Employment Related Day Care subsidy program administered by the Department
38 of Early Learning and Care.

39 (3) The rules adopted under this section must support equitable access to a supply of diverse
40 child care providers that meet the needs of families, as those needs are defined by the [*department*]
41 council by rule, including:

- 42 (a) Cultural diversity;
- 43 (b) Linguistic diversity;
- 44 (c) Racial and ethnic diversity; and
- 45 (d) Diversity of provider types.

1 (4) The rules adopted under this section must provide that:

2 (a) A child's eligibility to participate in the Employment Related Day Care subsidy program
3 must be based on:

4 (A) The household income of a child's family; and

5 (B) Any other criteria established by the [department] council.

6 (b) A child must be able to receive care that:

7 (A) Meets the child's developmental, disability and neurodiversity needs; and

8 (B) Enables the child's family to complete activities that relate to family well-being, which may
9 include the family's work hours, education hours, commute time, study time and other activities that

36 section (4) of this section, continue for a minimum of 12 months from the date of initial el-
37 igibility unless the child's family leaves this state or requests a termination of benefits or
38 for any other reason identified by the council. Rules adopted under this subparagraph shall
39 give priority to families receiving temporary assistance under the temporary assistance for
40 needy families program described in ORS 412.006.**

41 (c) **May provide that a determination of eligibility to participate in the Employment Re-
42 lated Day Care subsidy program consider the availability of family to attend to the child,
43 regardless of the family's physical presence.**

44 (6) In developing rules under this section, the [department] council shall consider policies for
45 increasing the stability and continuity of a child's access to a family's preferred child care provider.

1 (7) Rules adopted by the [department] **council** under this section establish minimum requirements
2 pertaining to the Employment Related Day Care subsidy program and may not be construed to pre-
3 empt, limit or otherwise diminish the applicability of any policy, standard or collective bargaining
4 agreement that provides for an increased subsidy or a child care provider reimbursement amount
5 under state or federal law.

6 (8)(a) The [department] **council** shall work to meet federal recommendations for income eligibil-
7 ity and market access in regard to the Employment Related Day Care subsidy program administered
8 by the [department] **council**.

9 (b) Notwithstanding any provision of this section or any rule adopted by the [department]
10 **council** pursuant to this section, the laws and regulations applicable to any federal funds shall
11 govern when any aspect of child care is funded by federal funds.

12 **SECTION 74.** ORS 329A.505, as amended by section 8a of this 2021 Act, is amended to read:

13 329A.505. (1) At any reasonable time, an authorized representative of the Office of Child Care
14 may conduct an inspection or investigation of a regulated subsidy facility, as defined by the Early
15 Learning Council by rule.

16 (2) When conducting an investigation under this section, the Office of Child Care may:

17 (a) Take evidence;

18 (b) Take the depositions of witnesses, including the person under investigation, in the manner
19 prescribed by law for depositions in civil actions;

20 (c) Compel the appearance of witnesses, including the person under investigation, in the manner
21 prescribed by law for appearances in civil actions;

22 (d) Require answers to interrogatories;

23 (e) Compel the production of books, papers, accounts, documents or testimony that pertains to
24 the matter under investigation;

25 (f) Issue subpoenas; and

26 (g) Inspect the premises of the facility under investigation.

27 (3) The Office of Child Care may, as a condition of finalizing an inspection, require improve-
28 ments, corrections or other measures to ensure that the regulated subsidy facility complies with the
29 requirements under the rules adopted under this section.

30 (4) In addition to any rules adopted under ORS 329A.500, the Early Learning Council[, *in con-*
31 *sultation with the Department of Human Services,*] may adopt rules to establish minimum health and
32 safety standards for regulated subsidy facilities and for the administration of this section.

33 **SECTION 75.** ORS 315.264 is amended to read:

34 315.264. (1)(a) A credit against the tax otherwise due under ORS chapter 316 shall be allowed
35 a taxpayer in an amount equal to a percentage of employment-related expenses of a type allowable

(3) The applicable percentage for a household in excess of eight members shall be calculated as if for a household size of eight members.

(4) The credit under this section is not allowed to a taxpayer with federal adjusted gross income or Oregon adjusted gross income, whichever is greater, in excess of 300 percent of the federal poverty level.

(5) In order to ensure compliance with the eligibility requirements of the credit allowed under this section, the Department of Revenue shall be afforded access to utilization data maintained by the Department of [Human Services] **Early Learning and Care** in its administration of the Employment Related Day Care **subsidy** program.

(6) The Department of Revenue may assess a penalty in an amount not to exceed 25 percent of the amount of credit claimed by the taxpayer against any taxpayer who knowingly claims or attempts to claim any amount of credit under this section for which the taxpayer is ineligible, or against any individual who knowingly assists another individual in claiming any amount of credit for which the individual is ineligible.

(7) The Department of Revenue may adopt rules for carrying out the provisions of this section and prescribe the form used to claim a credit and the information required on the form.

(9) If a change in the taxable year of a taxpayer occurs as described in ORS 314.085, or if the Department of Revenue terminates the taxpayer's taxable year under ORS 314.440, the credit allowed by this section shall be prorated or computed in a manner consistent with ORS 314.085.

(10) If a change in the status of a taxpayer from resident to nonresident or from nonresident to resident occurs, the credit allowed by this section shall be determined in a manner consistent with ORS 316.117.

(11) If the amount allowable as a credit under this section, when added to the sum of the amounts allowable as payment of tax under ORS 316.187 or 316.583, other tax prepayment amounts and other refundable credit amounts, exceeds the taxes imposed by ORS chapters 314 and 316 for the tax year after application of any nonrefundable credits allowable for purposes of ORS chapter 316 for the tax year, the amount of the excess shall be refunded to the taxpayer as provided in ORS 316.502.

(12) Any amount that is refunded to the taxpayer under this section and that is in excess of the tax liability of the taxpayer does not bear interest.

(b) "Written information" means information that is in written form and includes but is not

5 (3) For the purpose of ensuring that the Department of Early Learning and Care may

7 duties, functions and powers conferred on the Department of Early Learning and Care by the
8 amendments to ORS 315.264, 329A.500, 329A.505, 406.072 and 411.882 by sections 73 to 77 of
9 this 2021 Act, the Early Learning Division and the Department of Human Services shall de-
10 velop and implement a plan that provides for a seamless transfer of duties, functions and

12 (4) The Governor shall resolve any disputes related to the plan developed and imple-

5 bility requirements as provided by the amendments to ORS 329A.500 by section 73 of this 2021
6 Act.

7 (3) No later than January 15, 2022, the Early Learning Division, in collaboration with the
8 Department of Education and the Department of Human Services, shall report to the ap-
9 propriate interim committees of the Legislative Assembly. The report shall address the
10 progress on the plans required to be developed and implemented as provided by sections 64
11 and 78 of this 2021 Act, including:

12 (a) Progress on the transfer of background checks inspections for the Employment Re-
13 lated Day Care subsidy program to the Early Learning Division, including any recommen-
14 dations for legislation or other authority necessary for the collection of subsidy
15 overpayments made under the program.

16 (b) Progress on the transfer of child care assistance programs, including the Employment
17 Related Day Care subsidy program, to the Early Learning Division, and any recommended
18 changes related to the transfer.

19 (c) Recommendations to strengthen the alignment of the early childhood special educa-
20 tion and early intervention services within the statewide early learning system, including any
21 recommended changes to governance, policymaking or other oversight of the system.

22 (d) Progress on the adoption of rules related to school-age child care.

23 (e) Any fiscal impacts of the plan and any conflicts of the plan with federal statute that
24 must be resolved.

25 (f) Any budgetary impacts or recommendations for legislation related to the plan.

26 (4) No later than September 30, 2022, the Early Learning Division, in collaboration with
27 the Department of Education and the Department of Human Services, shall report to the
28 appropriate interim committees of the Legislative Assembly. The report shall include updates
29 on the implementation of the plan required to be developed and implemented as provided by
30 section 64 of this 2021 Act and the progress on the plan required to be developed and imple-
31 mented as provided by section 78 of this 2021 Act.
