**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Prohibits law enforcement agency or public body from denying services, benefits, privileges or opportunities to certain individuals on basis of federal civil immigration actions, inquiring about individual's citizenship status without connection to criminal investigation or providing information about individual in custody to federal immigration authority. Requires law enforcement agency to explain to individual committed or detained by law enforcement agency individual's right to refuse to disclose nationality, citizenship or immigration status and potential immigration consequences of refusal to disclose.

Prohibits use of public resources to assist federal immigration enforcement. Requires public body that receives communication or request for assistance from federal immigration authority to report request or communication to Oregon Criminal Justice Commission. Requires commission to continually publish reports of communications and requests received by public bodies. Requires Department of Justice to establish mechanism to receive reports of certain violations.

Prohibits public body, law enforcement agency or officer from entering into specified agreements related to federal immigration enforcement.

Allows any person to bring action to enjoin law enforcement agency or public body from providing certain information to federal immigration authority, using agency resources to enforce immigration laws or failing to comply with other requirements.

Declares emergency, effective on passage.

2 Relating to immigration; creating new provisions; amending ORS 180.805 and 181A.820; and declar-

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. As used in sections 1 to 6 of this 2021 Act:**

6 (1) **"Court facility" means a building or space occupied or used by a court of this state**  
7 **or local jurisdiction of this state, and any adjacent property including, but not limited to,**  
8 **sidewalks, parking area, grass or landscaped area, plazas, court-related offices, commercial**  
9 **and governmental spaces within the building or space and entrances to and exits from the**  
10 **building or space.**

11 (2) **"Federal immigration authority" means the United States Department of Homeland**  
12 **Security, the United States Immigration and Customs Enforcement, the United States Citi-**  
13 **zenship and Immigration Services, the United States Customs and Border Protection or a**  
14 **successor agency, any other federal immigration agency or official, or any other entity to**  
15 **which a federal immigration agency delegates or assigns the authority to detect, investigate**  
16 **or enforce violations of immigration law.**

17 (3) **"Immigration enforcement" means any activity that has as a purpose the apprehen-**

1 sion or identification of an individual in order to:

2 (a) Subject the individual to civil immigration arrest, civil immigration detention, re-  
3 moval or deportation proceedings or removal or deportation from the United States; or

4 (b) Criminally prosecute the individual for offenses related to federal laws regarding im-  
5 migration status.

6 (4) "Law enforcement agency" means:

7 (a) County sheriffs, municipal police departments, police departments established by a  
8 university under ORS 352.121 or 353.125;

9 (b) The Oregon State Police; and

10 (c) Corrections officers.

11 (5) "Officer" means an individual employed or contracted as an officer of a law enforce-  
12 ment agency whether or not the individual is on duty.

13 (6) "Public body" has the meaning given that term in ORS 174.109.

14 **SECTION 2.** (1) A law enforcement agency or public body may not:

15 (a) Except as required by state or federal law, deny services, benefits, privileges or op-  
16 portunities to an individual in custody, or on parole, probation or post-prison supervision,  
17 on the basis of known or suspected immigration status, the existence of an immigration  
18 detainer, hold, notification or other related federal immigration request or a civil immi-  
19 gration warrant;

20 (b) Inquire into or collect information about an individual's immigration or citizenship  
21 status or country of birth unless:

22 (A) The information is required to advance an investigation into a violation of state or  
23 local criminal law;

24 (B) The information is submitted to a court of this state, whether orally or in writing,  
25 in connection with a proceeding in that court; or

26 (C) As necessary to determine the individual's eligibility for a benefit that the individual  
27 is seeking; or

28 (c) Provide information about an individual in the custody of the public body or law  
29 enforcement agency to a federal immigration authority for the purpose of civil immigration  
30 enforcement, except:

31 (A) As may be required by a judicial subpoena issued as part of a court proceeding or by  
32 another compulsory court-issued legal process; or

33 (B) To the extent that the information is available to the general public and under the  
34 same terms and conditions as the information is available to the general public.

35 (2) For purposes of subsection (1)(c)(A) of this section, a judicial subpoena does not in-  
36 clude an administrative subpoena created and signed by a federal immigration authority.

37 (3) To ensure compliance with all treaty obligations, including consular notification, and  
38 state and federal laws, on the commitment or detainment of an individual, a law enforcement  
39 agency shall explain to the individual in writing, with interpretation into another language  
40 if requested:

41 (a) The individual's right to refuse to disclose the individual's nationality, citizenship or  
42 immigration status; and

43 (b) That disclosure of the individual's nationality, citizenship or immigration status may  
44 result in civil or criminal immigration enforcement, including removal from the United  
45 States.

1 (4) Any person may bring a civil action against a law enforcement agency or public body  
2 that violates subsections (1) to (3) of this section to enjoin the violation.

3 **SECTION 3.** (1) Public facilities, property, moneys, equipment, technology or personnel  
4 may not be used for the purpose of investigating, detecting, apprehending, arresting, de-  
5 taining or holding individuals for immigration enforcement.

6 (2) Actions with a purpose described in subsection (1) of this section include, but are not  
7 limited to, the following:

8 (a) Granting a federal immigration agency access to an area of a facility that is not  
9 normally open to the public.

10 (b) Supporting or assisting a federal agency in immigration enforcement, including but  
11 not limited to any of the following:

12 (A) Providing information, including but not limited to an individual's contact informa-  
13 tion, country of birth, custody status, release date, parole, probation or post-prison super-  
14 vision appointment dates or times, or home or work address, except as provided in section  
15 2 of this 2021 Act;

16 (B) Investigating or interrogating individuals for immigration enforcement; or

17 (C) Establishing traffic perimeters for the purpose of supporting or facilitating immi-  
18 gration enforcement.

19 (3)(a) If a public body receives a communication or request from a federal agency that  
20 relates to immigration enforcement, other than a judicial subpoena described in section 2  
21 (1)(c)(A) of this 2021 Act, the public body shall decline the request and document the com-  
22 munication or request. The documentation described in this subsection must be provided to  
23 the director or other similar management personnel of the public body.

24 (b) The public body shall submit the information documented under this subsection to the  
25 Oregon Criminal Justice Commission pursuant to procedures established by the commission.  
26 The commission shall require at least monthly submission of the information described in  
27 this subsection.

28 (c) A public body shall adopt internal procedures to carry out this subsection.

29 (4)(a) The commission shall publish and continually update, on a website operated by or  
30 on behalf of the commission, an entry for each communication or request described in sub-  
31 section (3) of this section, the public body that received the communication or request, the  
32 federal agency involved in the communication or that made the request and a summary of  
33 the public body's response to the communication or request.

34 (b) The information contained on the website described in this subsection may not con-  
35 tain any personally identifiable information of the individuals involved in the communication  
36 or request, including of an individual targeted by federal immigration authorities, an indi-  
37 vidual who reported the communication or request, an individual who witnessed the com-  
38 munication or request or report of the communication or request or the family members of  
39 an individual described in this paragraph.

40 (c)(A) Information obtained by the commission under this subsection may be used only  
41 for statistical purposes and coordination with the sanctuary violation reporting mechanism  
42 established under section 4 of this 2021 Act.

43 (B) Information described in this subsection that may reveal the identity of an individual  
44 described in paragraph (b) of this subsection is exempt from disclosure under ORS 192.311  
45 to 192.478.

1 (C) Pursuant to a request from the Department of Justice, the commission may release  
2 to the department information described in this subsection that is necessary to investigate  
3 a report made to the sanctuary violation reporting mechanism established under section 4  
4 of this 2021 Act if the information is used to support an individual described in paragraph (b)  
5 of this subsection.

6 (d) Not later than July 1, 2022, and at least annually thereafter, the commission shall  
7 issue a report that summarizes the information reported to the commission and published  
8 on the website described in this subsection. The commission shall provide the report to the  
9 Governor, the Legislative Assembly, the district attorneys of this state, the Department of  
10 State Police, each law enforcement agency in this state and the Department of Public Safety  
11 Standards and Training.

12 (5) Any person may bring a civil action against a law enforcement agency or public body  
13 that violates subsection (1) of this section to enjoin the violation.

14 **SECTION 4.** (1) The Department of Justice shall establish a sanctuary violation reporting  
15 mechanism to receive reports of alleged violations of sections 2 and 3 of this 2021 Act and  
16 ORS 180.805 and 181A.820. The sanctuary violation reporting mechanism must include a  
17 staffed telephone hotline and an online system that allows for electronic reporting.

18 (2) The sanctuary violation reporting mechanism must:

19 (a) Be coordinated with the Oregon Criminal Justice Commission to develop a standard-  
20 ized intake process for reports made through the hotline or online system;

21 (b) Collect all data possible regarding agencies, personnel, locations and individuals in-  
22 volved with violations reported through the hotline or online system;

23 (c) Provide culturally competent assistance, referrals and resources to an individual  
24 targeted by a violation reported through the hotline or online system, and ensure that the  
25 assistance, referrals and resources are designed to reduce the effects of trauma and prevent  
26 further trauma; and

27 (d) Coordinate with local organizations and service providers to assist individuals tar-  
28 geted by violations reported through the hotline or online system and families of those indi-  
29 viduals.

30 (3) The department, in coordination with the commission, shall publish and continually  
31 update, on a website operated by or on behalf of the department:

32 (a) The number of complaints received by the mechanism established under subsection  
33 (1) of this section; and

34 (b) An entry for each complaint, including the alleged violation, the federal agency im-  
35 plicated in the complaint and public bodies or agencies involved in the incident and the re-  
36 sponse of the public bodies and agencies.

37 (4) The information contained on the website described in subsection (3) of this section  
38 may not contain any personally identifiable information of the individuals involved in the  
39 incident on which the complaint is based.

40 (5) Information and data obtained under this section:

41 (a) May be used only for the purposes described in this section; and

42 (b) Is exempt from public disclosure under ORS 192.311 to 192.478 if the information may  
43 reveal the identity of an individual involved in an incident on which a complaint reported to  
44 the sanctuary violation reporting mechanism is based.

45 **SECTION 5.** (1) An individual may not be subject to civil arrest without a judicial warrant

1 or judicial order when the individual is in a court facility.

2 (2) An individual who, in good faith, is attending a court proceeding in which the indi-  
3 vidual is a party or potential witness, or family or household member of a party or potential  
4 witness, may not be subject to civil arrest while going to, remaining at or returning from  
5 the court proceeding, unless the civil arrest is supported by a judicial warrant or judicial  
6 order that authorizes the civil arrest.

7 (3) Any person may bring a civil action against a law enforcement agency or public body  
8 that violates this section to enjoin the violation.

9 **SECTION 6.** (1) A public body, law enforcement agency or an officer of a law enforcement  
10 agency may not enter into or renew an agreement, contract, memorandum of understanding  
11 or other arrangement that authorizes the public body, law enforcement agency or officer to  
12 exercise federal immigration enforcement powers, including those powers specified in 8  
13 U.S.C. 1357(g), or that otherwise permits the public body, law enforcement agency or officer  
14 to detain or house individuals for federal civil immigration violations.

15 (2) A public body or law enforcement agency may not enter into or renew an agreement,  
16 contract, memorandum of understanding or other arrangement under which the public body  
17 or law enforcement agency detains or houses individuals who are in the custody of a federal  
18 immigration authority for violations of federal immigration law.

19 (3) A person may not operate a private immigration detention facility within this state.

20 (4) Any person may bring a civil action against a law enforcement agency or public body  
21 that violates this section to enjoin the violation.

22 **SECTION 7.** Section 6 of this 2021 Act applies to agreements, contracts, memoranda of  
23 understanding or other arrangements entered into or renewed on or after the effective date  
24 of this 2021 Act.

25 **SECTION 8.** ORS 180.805 is amended to read:

26 180.805. (1) As used in this section:

27 (a) "Federal immigration authority" means the United States Department of Homeland  
28 Security, the United States Immigration and Customs Enforcement, the United States Citi-  
29 zenship and Immigration Services, the United States Customs and Border Protection or a  
30 successor agency, any other federal immigration agency or official, or any other entity to  
31 which a federal immigration agency delegates or assigns the authority to detect, investigate  
32 or enforce violations of immigration law.

33 (b) "Information concerning a person's citizenship or immigration status" means infor-  
34 mation about whether a person is a citizen of the United States or has lawful authority to  
35 be present in the United States, either through a visa, a green card or another official doc-  
36 umentation. The term does not include information consisting of a person's address, location,  
37 contact information, relatives, associates or other information that could lead to the de-  
38 tection or apprehension of the person.

39 (c) "Public body" has the meaning given that term in ORS 174.109.

40 (d) "Social media" has the meaning given that term in ORS 659A.330.

41 [(1)] (2) Except as required by state or federal law, a public body may not disclose, for the  
42 purpose of enforcement of federal immigration laws, the following information concerning any per-  
43 son, whether current or otherwise:

44 (a) The person's address;

45 (b) The person's workplace or hours of work;

1 (c) The person's school or school hours;

2 (d) The person's contact information, including telephone number, electronic mail address or  
3 social media account information;

4 (e) The identity of known associates or relatives of the person;

5 (f) The date, time or location of the person's hearings, proceedings or appointments with the  
6 public body that are not matters of public record; or

7 (g) Information described in paragraphs (a) through (f) of this subsection with respect to known  
8 relatives or associates of the person.

9 [(2)] (3) Except as required by state or federal law, or as necessary to determine eligibility for  
10 a benefit a person is seeking, a public body may not inquire about or request information concerning  
11 a person's citizenship or immigration status.

12 [(3)(a)] (4)(a) If a public body collects information concerning a person's citizenship or immi-  
13 gration status, the public body [may] **shall** decline to disclose the information unless disclosure is  
14 required by:

15 (A) State or federal law;

16 (B) A court order; or

17 (C) A warrant authorized by a court.

18 (b) Nothing in this subsection:

19 (A) Prevents a person from obtaining records about the person or the person's dependents from  
20 a public body; or

21 (B) Authorizes a public body to withhold aggregated information that is not personally identifi-  
22 able.

23 [(4)] (5) A public body shall, within six months of August 15, 2017, and every year thereafter,  
24 review the public body's confidentiality policies to ensure that the public body treats information  
25 concerning a person's citizenship or immigration status, and information described in subsection  
26 [(1)] (2) of this section, in a manner consistent with this section and ORS 180.810.

27 [(5) *Nothing in this section prohibits any public body from complying with a federal immigration  
28 authority as required by federal law.*]

29 [(6) *As used in this section:*]

30 [(a) *"Federal immigration authority" means the United States Department of Homeland Security,  
31 the United States Immigration and Customs Enforcement, the United States Citizenship and Immi-  
32 gration Services or a successor agency, any other federal immigration agency or official, or any other  
33 entity to which a federal immigration agency delegates or assigns the authority to detect, investigate  
34 or enforce violations of immigration law.*]

35 [(b) *"Information concerning a person's citizenship or immigration status" means information about  
36 whether a person is a citizen of the United States or has lawful authority to be present in the United  
37 States, either through a visa, a green card or another official documentation. The term does not include  
38 information consisting of a person's address, location, contact information, relatives, associates or other  
39 information that could lead to the detection or apprehension of the person.*]

40 [(c) *"Public body" has the meaning given that term in ORS 174.109.*]

41 [(d) *"Social media" has the meaning given that term in ORS 659A.330.*]

42 (6) **Any person may bring a civil action against a law enforcement agency or public body  
43 that violates subsection (2) or (3) of this section to enjoin the violation.**

44 **SECTION 9.** ORS 181A.820 is amended to read:

45 181A.820. (1) **As used in this section:**

1 (a) **“Federal immigration authority” has the meaning given that term in ORS 180.805.**

2 (b) **“Warrant of arrest” has the meaning given that term in ORS 131.005.**

3 [(1)] (2) [No] **A law enforcement agency [of the State of Oregon or of any political subdivision of**  
4 *the state shall] may not* use agency moneys, equipment or personnel for the purpose of detecting  
5 or apprehending persons [*whose only violation of law is that they are persons of foreign citizenship*  
6 *present in the United States in violation of]* **for the purpose of enforcing** federal immigration laws.

7 **(3) A law enforcement agency may not enter into a formal or informal agreement with**  
8 **a federal immigration authority relating to the detention of a person described in subsection**  
9 **(2) of this section.**

10 [(2)] (4) Notwithstanding subsection [(1)] (2) of this section, a law enforcement agency may ex-  
11 change information with [*United States Immigration and Customs Enforcement, United States Citi-*  
12 *zenship and Immigration Services and United States Customs and Border Protection]* **a federal**  
13 **immigration authority** in order to[:]

14 [(a) *Verify the immigration status of a person if the person is arrested for any criminal offense;*  
15 *or]*

16 [(b)] request criminal investigation information with reference to persons named in records of  
17 [*United States Immigration and Customs Enforcement, United States Citizenship and Immigration*  
18 *Services or United States Customs and Border Protection]* **the federal immigration authority.**

19 [(3)] (5) Notwithstanding subsection [(1)] (2) of this section, a law enforcement agency may ar-  
20 rest any person who:

21 (a) Is charged by the United States with a criminal violation of federal immigration laws under  
22 Title II of the Immigration and Nationality Act or 18 U.S.C. 1015, 1422 to 1429 or 1505; and

23 (b) Is subject to arrest for the crime pursuant to a warrant of arrest issued by a federal  
24 magistrate.

25 **(6) Any person may bring a civil action against a law enforcement agency that violates**  
26 **subsection (2) or (3) of this section to enjoin the violation.**

27 [(4)] (7) For purposes of subsection [(1)] (2) or (3) of this section, the Bureau of Labor and In-  
28 dustries is not a law enforcement agency.

29 [(5) *As used in this section, “warrant of arrest” has the meaning given that term in ORS*  
30 *131.005.*]

31 **SECTION 10. In addition to and not in lieu of any other appropriation, there is appro-**  
32 **priated to the Department of Justice, for the biennium beginning July 1, 2021, out of the**  
33 **General Fund, the amount of \$905,071, for the purposes of carrying out sections 3 and 4 of**  
34 **this 2021 Act.**

35 **SECTION 11. This 2021 Act being necessary for the immediate preservation of the public**  
36 **peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect**  
37 **on its passage.**
