

SENATE AMENDMENTS TO RESOLVE CONFLICTS TO HOUSE BILL 3398

1 On page 3 of the printed bill, after line 20, insert:

2 “**SECTION 6a.** Section 6 of this 2021 Act (amending section 63, chapter 700, Oregon Laws
3 2019) is repealed and section 63, chapter 700, Oregon Laws 2019, as amended by section 1,
4 chapter 30, Oregon Laws 2021 (Enrolled House Bill 3178), is amended to read:

5 “**Sec. 63.** (1)(a) ORS 657B.070, 657B.080, 657B.110, 657B.130, 657B.150, 657B.175, 657B.180,
6 657B.190, 657B.210, 657B.220, 657B.230, 657B.240, 657B.250, 657B.260, 657B.280, 657B.290, 657B.300,
7 657B.310, 657B.320, 657B.330, 657B.370, 657B.390, 657B.410, 657B.440, 657B.460, 657B.470, 657B.900,
8 657B.910 and 657B.920 and section 50, chapter 700, Oregon Laws 2019, become operative on
9 [January 1, 2022] **January 1, 2023.**

10 “(b) ORS 657B.015, 657B.020, 657B.025, 657B.030, [657B.040,] 657B.050, 657B.060, 657B.090,
11 657B.100, 657B.120 and 657B.200 [and section 50, chapter 700, Oregon Laws 2019,] become operative
12 on [January 1, 2023] **September 3, 2023.**

13 “[*c*] The amendments to ORS 410.619 by sections 52 and 53, chapter 700, Oregon Laws 2019, be-
14 come operative on January 1, 2022.]

15 “(c) **ORS 657B.040 becomes operative on August 3, 2023.**

16 “(d) **The amendments to ORS 410.619 by sections 52 and 53, chapter 700, Oregon Laws**
17 **2019, and the amendments to ORS 657.471 [and 659A.162] by [sections 55 and 56] section 55,** chapter
18 700, Oregon Laws 2019, become operative on January 1, 2023.

19 “(e) **The amendments to ORS 659A.162 by section 56, chapter 700, Oregon Laws 2019, be-**
20 **come operative on September 3, 2023.**

21 “[*e*] (f) The amendments to ORS 659A.885 by sections 57 and 58, chapter 700, Oregon Laws
22 2019, become operative January 1, 2025.

23 “(2) The Employment Department and the Department of Revenue may take any action before
24 the operative dates specified in subsection (1) of this section that is necessary to enable the de-
25 partments to exercise, on and after the operative dates specified in subsection (1) of this section, the
26 duties, functions and powers conferred on the departments by ORS chapter 657B.”.
