

HOUSE AMENDMENTS TO HOUSE BILL 5007

By JOINT COMMITTEE ON WAYS AND MEANS

1 On page 1 of the printed bill, delete lines 5 through 25 and delete page 2 and insert:

2 **“SECTION 1. There is appropriated to the Employment Department, for the biennium**
3 **beginning July 1, 2021, out of the General Fund, the following amounts, for the family and**
4 **medical leave insurance program:**

5 (1) Shared services..... \$ 13,709,923

6 (2) Family and medical leave
7 insurance program..... \$ 31,485,152

8 (3) Modernization Initiative..... \$ 1,912,374

9 **“SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**
10 **are established for the biennium beginning July 1, 2021, as the maximum limits for payment**
11 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and**
12 **moneys appropriated to the Employment Department by sections 3 and 4 of this 2021 Act,**
13 **but excluding lottery funds and federal funds other than those described in section 3 of this**
14 **2021 Act, collected or received by the Employment Department:**

15 (1) Unemployment insurance,
16 shared services and workforce
17 operations, and workforce
18 and economic research \$181,853,638

19 (2) Office of Administrative
20 Hearings..... \$ 34,882,041

21 (3) Family and medical leave
22 insurance program..... \$ 7,687,291

23 (4) Modernization Initiative..... \$ 54,654,837

24 **“SECTION 3. (1) There is appropriated to the Employment Department, for the biennium**
25 **beginning July 1, 2021, out of the modernization funds made available to the state on June**
26 **4, 2009, and July 16, 2009, under section 903(f) of the Social Security Act (42 U.S.C. 1103(f)),**
27 **as amended, the amount of \$46,599,530 to be used for the purposes of administering unem-**
28 **ployment compensation law and public employment offices and for debt service and capital**
29 **improvements.**

30 **“(2) Expenditures of funds appropriated to the Employment Department under this sec-**
31 **tion are limited by section 2 (1), (3) and (4) of this 2021 Act.**

32 **“SECTION 4. (1) There is appropriated to the Employment Department, for the biennium**
33 **beginning July 1, 2021, out of the Employment Department Special Administrative Fund es-**
34 **tablished in ORS 657.822, the amount of \$45,000,000 to be used for the purposes of adminis-**
35 **tering unemployment compensation law and public employment offices and for debt service**

1 and capital improvements.

2 “(2) Expenditures of funds appropriated to the Employment Department under this sec-
3 tion are limited by section 2 (1), (3) and (4) of this 2021 Act.

4 “SECTION 5. Notwithstanding any other law limiting expenditures, the amount of
5 \$294,964,603 is established for the biennium beginning July 1, 2021, as the maximum limit for
6 payment of expenses from federal funds, other than those described in section 3 of this 2021
7 Act, collected or received by the Employment Department.

8 “SECTION 6. (1) For the biennium beginning July 1, 2021, expenditures by the Employ-
9 ment Department for unemployment insurance claims from the Unemployment Compens-
10 ation Trust Fund are not limited.

11 “(2) For the biennium beginning July 1, 2021, expenditures by the Employment Depart-
12 ment for benefits paid under the federal Trade Act and for unemployment insurance claims
13 from federal funds are not limited.

14 “SECTION 7. This 2021 Act being necessary for the immediate preservation of the public
15 peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect
16 July 1, 2021.”
