

## HOUSE AMENDMENTS TO HOUSE BILL 5012

By JOINT COMMITTEE ON WAYS AND MEANS

1 On page 1 of the printed bill, delete lines 4 through 27 and delete page 2 and insert:

2 “**SECTION 1.** There are appropriated to the Judicial Department, for the biennium be-  
3 ginning July 1, 2021, out of the General Fund, the following amounts, for the following pur-  
4 poses:

- 5 (1) Judicial compensation..... \$ 95,761,823  
6 (2) Operations..... \$390,601,871  
7 (3) Mandated payments ..... \$ 17,819,193  
8 (4) State court technology  
9 systems ..... \$ 8,105,672  
10 (5) Debt service ..... \$ 31,438,952  
11 (6) Third-party debt  
12 collection..... \$ 15,970,809

13 “**SECTION 2.** Notwithstanding any other law limiting expenditures, the following amounts  
14 are established for the biennium beginning July 1, 2021, as the maximum limits for payment  
15 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and in-  
16 cluding reimbursements from federal service agreements, but excluding lottery funds and  
17 federal funds not described in this section, collected or received by the Judicial Department  
18 for the following purposes:

- 19 (1) Operations..... \$ 20,626,120  
20 (2) Mandated payments ..... \$ 711,771  
21 (3) State Court Facilities and  
22 Security Account ..... \$ 8,155,362  
23 (4) State Court Technology Fund... \$ 17,987,058

24 “**SECTION 3.** Notwithstanding any other law limiting expenditures, the amount of  
25 \$1,476,446 is established for the biennium beginning July 1, 2021, as the maximum limit for  
26 payment of expenses from federal funds other than those described in section 2 of this 2021  
27 Act collected or received by the Judicial Department.

28 “**SECTION 4.** In addition to and not in lieu of any other appropriation, there is appro-  
29 priated to the Judicial Department, for the biennium beginning July 1, 2021, out of the Gen-  
30 eral Fund, the amount of \$334,221 for payment of expenses of the Oregon Law Commission.

31 “**SECTION 5.** In addition to and not in lieu of any other appropriation, there is appro-  
32 priated to the Judicial Department, for the biennium beginning July 1, 2021, out of the Gen-  
33 eral Fund, the amount of \$53,934 for payment of expenses of the Council on Court  
34 Procedures.

35 “**SECTION 6.** (1) In addition to and not in lieu of any other appropriation, there is ap-

1   appropriated to the Judicial Department, for the biennium beginning July 1, 2021, out of the  
2   General Fund, the amount of \$7,492,047 for the purpose of providing conciliation and medi-  
3   ation services in circuit courts.

4       “(2) The Chief Justice of the Supreme Court shall distribute the moneys appropriated  
5   under this section to the counties of this state to fund conciliation and mediation services  
6   in circuit courts. The Chief Justice shall consult with the presiding judges of the circuit  
7   courts before making the distributions.

8       “SECTION 7. (1) In addition to and not in lieu of any other appropriation, there is ap-  
9   propriated to the Judicial Department, for the biennium beginning July 1, 2021, out of the  
10   General Fund, the amount of \$7,492,047 for the purpose of operating law libraries or providing  
11   law library services.

12       “(2) The Chief Justice of the Supreme Court shall distribute the moneys appropriated  
13   under this section to the counties of this state based on revenues received from filing fees  
14   collected during the biennium ending June 30, 2021, in civil actions commenced in the circuit  
15   court for the county.

16       “SECTION 8. (1) In addition to and not in lieu of any other appropriation, there is ap-  
17   propriated to the Judicial Department, for the biennium beginning July 1, 2021, out of the  
18   General Fund, the amount of \$12,784,050 for the purpose of funding the Legal Services Pro-  
19   gram described in ORS 9.572.

20       “(2) The Chief Justice of the Supreme Court shall distribute all moneys appropriated  
21   under this section to the Oregon State Bar in eight quarterly installments of equal amount.

22       “SECTION 9. Notwithstanding any other provision of law, the General Fund appropriation  
23   made to the Judicial Department by section 1 (2), chapter 691, Oregon Laws 2019, for the  
24   biennium ending June 30, 2021, for operations, is decreased by \$750,000.

25       “SECTION 10. Notwithstanding any other provision of law, the General Fund appropri-  
26   ation made to the Judicial Department by section 1 (6), chapter 691, Oregon Laws 2019, for  
27   the biennium ending June 30, 2021, for third-party debt collection, is increased by \$750,000.

28       “SECTION 11. This 2021 Act being necessary for the immediate preservation of the public  
29   peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect  
30   July 1, 2021.”.
