**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Bureau of Labor and Industries for biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by bureau.

Limits biennial expenditures by bureau from Wage Security Fund.

Authorizes specified nonlimited expenditures.

Limits biennial expenditures by bureau from federal funds.

**Limits biennial expenditures by bureau of certain lottery funds.**

Declares emergency, effective July 1, 2021.

**A BILL FOR AN ACT**

2 Relating to the financial administration of the Bureau of Labor and Industries; and declaring an  
3 emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There is appropriated to the Bureau of Labor and Industries, for the**  
6 **biennium beginning July 1, 2021, out of the General Fund, the amount of \$17,829,892.**

7 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**  
8 **\$9,067,077 is established for the biennium beginning July 1, 2021, as the maximum limit for**  
9 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**  
10 **but excluding lottery funds and federal funds, collected or received by the Bureau of Labor**  
11 **and Industries.**

12 **SECTION 3. (1) Notwithstanding any other law limiting expenditures, the amount of**  
13 **\$5,913,169 is established for the biennium beginning July 1, 2021, as the maximum limit for**  
14 **payment of administrative expenses by the Bureau of Labor and Industries from the Wage**  
15 **Security Fund.**

16 **(2) For the biennium beginning July 1, 2021, expenditures by the Bureau of Labor and**  
17 **Industries for wage claim payments from the Wage Security Fund are not limited.**

18 **SECTION 4. Notwithstanding any other law limiting expenditures, the amount of**  
19 **\$1,842,766 is established for the biennium beginning July 1, 2021, as the maximum limit for**  
20 **payment of expenses from federal funds collected or received by the Bureau of Labor and**  
21 **Industries.**

22 **SECTION 5. Notwithstanding any other law limiting expenditures, the amount of \$261,416**  
23 **is established for the biennium beginning July 1, 2021, as the maximum limit for payment of**

1 **expenses from lottery moneys allocated from the Veterans' Services Fund established under**  
2 **ORS 406.140 to the Bureau of Labor and Industries for the purpose of implementing the**  
3 **provisions of section 1, chapter 528, Oregon Laws 2019.**

4 **SECTION 6. This 2021 Act being necessary for the immediate preservation of the public**  
5 **peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect**  
6 **July 1, 2021.**
