SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Defines terms related to fitness to proceed. Reorganizes and restructures statutes related to fitness to proceed.

Modifies procedures and criteria for committing defendant charged with felony to state mental hospital or other facility in order to gain or regain fitness to proceed. Requires court to find that defendant requires hospital level of care due to public safety concerns or acuity of symptoms of defendant's mental disorder, and that appropriate community restoration services are not provided.

Modifies procedures and criteria for committing defendant charged with misdemeanor to state mental hospital or other facility in order to gain or regain fitness to proceed. Requires either recommendation from certified evaluator that defendant requires hospital level of care and statement from community mental health program director concerning available community restoration services, or for court to make certain findings concerning *[severity]* **acuity** of defendant's symptoms, public safety concerns and whether appropriate community restoration services are provided.

Modifies procedures when circumstances authorizing commitment of defendant no longer exist. Provides that if defendant is charged with felony, superintendent of state mental hospital or director of facility to which defendant is committed may notify court when hospital level of care is no longer necessary. Requires superintendent or director to notify court when specified circumstances have changed for defendant charged with misdemeanor. Authorizes community mental health program director to notify court if community restoration services become available for committed defendant charged with felony or misdemeanor.

Provides that documents related to involuntary medication of defendant are confidential and may be made available only to specified parties.

Declares emergency, effective on passage.

PRELIMINARY PROVISIONS

8 **SECTION 1. (1) Sections 2 to 5 of this 2021 Act are added to and made a part of ORS**
9 **161.290 to 161.373.**

10 **(2) ORS 161.360, 161.365 and 161.370 are added to and made a part of sections 2 to 5 of this**
11 **2021 Act.**

12 **SECTION 2. As used in sections 2 to 5 of this 2021 Act:**

13 **(1) "Certified evaluator" has the meaning given that term in ORS 161.309.**

14 **(2) "Community restoration services" means services and treatment necessary to safely**
15 **allow a defendant to gain or regain fitness to proceed in the community, which may include**

1 supervision by pretrial services.

2 (3) "Hospital level of care" means that a defendant requires the type of care provided by
3 an inpatient hospital in order to gain or regain fitness to proceed.

4 (4) "Public safety concerns" means that the defendant presents a risk to self or to the
5 public if not hospitalized or in custody.

6 **SECTION 3.** (1) A recommendation provided by a certified evaluator, pursuant to sections
7 2 to 5 of this 2021 Act, that a defendant requires a hospital level of care due to the acuity
8 of the defendant's symptoms must be based upon the defendant's current diagnosis and
9 symptomology, the defendant's current ability to engage in treatment, present safety con-
10 cerns relating to the defendant and any other pertinent information known to the evaluator.
11 If the defendant is in a placement in a facility, the evaluator may defer to the treatment
12 provider's recommendation regarding whether a hospital level of care is needed.

13 (2) A determination by a community mental health program director, or the director's
14 designee, pursuant to sections 2 to 5 of this 2021 Act, that appropriate community restora-
15 tion services are not present and available in the community must include information con-
16 cerning the specific services necessary to safely allow the defendant to gain or regain fitness
17 to proceed in the community and must specify the necessary services that are not present
18 and available in the community.

19 (3)(a) Reports resulting from examinations performed by a certified evaluator, and doc-
20 uments containing the recommendations of or resulting from consultations with a commu-
21 nity mental health program director or the director's designee, prepared under sections 2 to
22 5 of this 2021 Act, and any document submitted to the court by a state mental hospital re-
23 lated to the proceedings under sections 2 to 5 of this 2021 Act, are confidential and may be
24 made available only:

25 (A) To the court, prosecuting attorney, defense attorney, agent of the prosecuting or
26 defense attorney, defendant, community mental health program director or designee, state
27 mental hospital and any facility in which the defendant is housed; or

28 (B) As ordered by a court.

29 (b) Any facility in which a defendant is housed may not use a report or document de-
30 scribed in paragraph (a) of this subsection to support a disciplinary action against the de-
31 fendant.

32 (c) Nothing in this subsection prohibits the prosecuting attorney, defense attorney or
33 agent of the prosecuting or defense attorney from discussing the contents of a report or
34 document described in paragraph (a) of this subsection with witnesses or victims as other-
35 wise permitted by law.

36 (4) The court shall ensure that an order entered under sections 2 to 5 of this 2021 Act
37 is provided, by the end of the next judicial day, to any entity ordered to provide restoration
38 services.

39 (5) Unless the court orders otherwise or either party objects, a defendant committed to
40 a state mental hospital or other facility, or a certified evaluator or other expert witness,
41 may attend hearings held under sections 2 to 5 of this 2021 Act via simultaneous electronic
42 transmission.

44 **FITNESS TO PROCEED GENERALLY**
45

1 ated within 60 days from the defendant's delivery into the superintendent's or director's
2 custody, for the purpose of determining whether there is a substantial probability that, in
3 the foreseeable future, the defendant will have fitness to proceed. In addition, the super-
4 intendent or director shall:

5 (a) Immediately notify the committing court if the defendant, at any time, gains or re-
6 gains fitness to proceed or if there is no substantial probability that, within the foreseeable
7 future, the defendant will gain or regain fitness to proceed.

8 (b) Within 90 days of the defendant's delivery into the superintendent's or director's
9 custody, notify the committing court that:

10 (A) The defendant has present fitness to proceed;

11 (B) There is no substantial probability that, in the foreseeable future, the defendant will
12 gain or regain fitness to proceed; or

13 (C) There is a substantial probability that, in the foreseeable future, the defendant will
14 gain or regain fitness to proceed. If the probability exists, the superintendent or director
15 shall give the court an estimate of the time in which the defendant, with appropriate treat-
16 ment, is expected to gain or regain fitness to proceed.

17 (c) Notify the court if court-ordered involuntary medication is necessary for the defend-
18 ant to gain or regain fitness to proceed and, if appropriate, submit a report to the court
19 under ORS 161.372.

20 (2)(a) If the superintendent of the state mental hospital or director of the facility to
21 which the defendant is committed determines that there is a substantial probability that, in
22 the foreseeable future, the defendant will gain or regain fitness to proceed, unless the court
23 otherwise orders, the defendant shall remain in the superintendent's or director's custody
24 where the defendant shall receive treatment designed for the purpose of enabling the de-
25 fendant to gain or regain fitness to proceed. In keeping with the notice requirement under
26 subsection (1)(b) of this section, the superintendent or director shall, for the duration of the
27 defendant's period of commitment, submit a progress report to the committing court, con-
28 cerning the defendant's fitness to proceed, at least once every 180 days as measured from
29 the date of the defendant's delivery into the superintendent's or director's custody.

30 (b) A progress report described in paragraph (a) of this subsection may consist of an
31 update to:

32 (A) The original examination report conducted under ORS 161.365; or

33 (B) An evaluation conducted under subsection (1) of this section, if the defendant did not
34 receive an examination under ORS 161.365.

35 (3)(a) Notwithstanding subsection (2) of this section, if the most serious offense in the
36 charging instrument is a felony, and the superintendent of the state mental hospital or di-
37 rector of the facility to which the defendant is committed determines that a hospital level
38 of care is no longer necessary due to present public safety concerns and the acuity of
39 symptoms of the defendant's qualifying mental disorder, the superintendent or director may
40 file notice of the determination with the court. Upon receipt of the notice, the court shall
41 order that a community mental health program director or the director's designee, within
42 five judicial days:

43 (A) Consult with the defendant and with any local entity that would be responsible for
44 providing community restoration services, if the defendant were to be released in the com-
45 munity, to determine whether community restoration services are present and available in

1 the community; and

2 (B) Provide the court and the parties with recommendations from the consultation.

3 (b) Notwithstanding subsection (2) of this section, if the most serious offense in the
4 charging instrument is a felony, and the community mental health program director deter-
5 mines that community restoration services that would mitigate any risk posed by the de-
6 fendant are present and available in the community, the community mental health program
7 director may file notice of the determination with the court. Upon receipt of the notice, the
8 court shall order that the superintendent of the state mental hospital or director of the fa-
9 cility to which the defendant is committed, within five judicial days:

10 (A) Evaluate the defendant to determine whether a hospital level of care is no longer
11 necessary due to present public safety concerns, or no longer necessary due to the acuity
12 of symptoms of the defendant's qualifying mental disorder; and

13 (B) Provide the court and the parties with recommendations from the evaluation.

14 (c) Within 10 judicial days of receiving the recommendations described in paragraph (a)
15 or (b) of this subsection, the court shall hold a hearing to determine an appropriate action
16 in accordance with ORS 161.370 (2)(c) as follows:

17 (A) If, after consideration of the factors and possible actions described in ORS 161.370
18 (2)(c) and any recommendations received under paragraph (a) or (b) of this subsection, the
19 court determines that a hospital level of care is necessary due to public safety concerns or
20 the acuity of symptoms of the defendant's qualifying mental disorder, and that based on the
21 consultation or evaluation described in paragraph (a) or (b) of this subsection, any informa-
22 tion provided by community-based mental health providers or any other sources, primary
23 and secondary release criteria as defined in ORS 135.230, and any other information the court
24 finds to be trustworthy and reliable, the appropriate community restoration services are not
25 present and available in the community, the court may continue the commitment of the de-
26 fendant.

27 (B) If the court does not make the determination described in subparagraph (A) of this
28 paragraph, the court shall terminate the commitment and shall set a review hearing seven
29 days from the date of the commitment termination for any defendant remaining in custody.
30 At the review hearing, the court shall consider all relevant information, determine an ap-
31 propriate action in the case as described in ORS 161.370 (2)(c) and enter an order in accord-
32 ance with the defendant's constitutional rights to due process.

33 (4)(a) Notwithstanding subsection (2) of this section, if the most serious offense in the
34 charging instrument is a misdemeanor, and the superintendent of the state mental hospital
35 or director of the facility to which the defendant is committed determines that the defendant
36 no longer needs a hospital level of care due to the acuity of symptoms of the defendant's
37 qualifying mental disorder or there are not present public safety concerns, the superinten-
38 dent or director shall file notice of the determination with the court, along with recommen-
39 dations regarding the necessary community restoration services that would mitigate any risk
40 presented by the defendant. Upon receipt of the notice, the court shall order that a com-
41 munity mental health program director or the director's designee, within five judicial days:

42 (A) Consult with the defendant and with any local entity that would be responsible for
43 providing community restoration services, if the defendant were to be released in the com-
44 munity, to determine whether appropriate community restoration services are present and
45 available in the community; and

1 (B) Provide the court and the parties with recommendations from the consultation.

2 (b) Notwithstanding subsection (2) of this section, if the most serious offense in the
3 charging instrument is a misdemeanor, and the community mental health program director
4 determines that the community restoration services that would mitigate any risk posed by
5 the defendant are present and available in the community, the community mental health
6 program director may file notice of the determination with the court. Upon receipt of the
7 notice, the court shall order that the superintendent of the state mental hospital or director
8 of the facility to which the defendant is committed, within five judicial days:

9 (A) Evaluate the defendant to determine whether a hospital level of care is no longer
10 necessary due to present public safety concerns, or no longer necessary due to the acuity
11 of symptoms of the defendant's qualifying mental disorder; and

12 (B) Provide the court and the parties with recommendations from the evaluation.

13 (c) Within 10 judicial days of receiving the recommendations described in paragraph (a)
14 or (b) of this subsection, the court shall hold a hearing to determine an appropriate action
15 in accordance with ORS 161.370 (2)(c) as follows:

16 (A) After consideration of the factors and possible actions described in ORS 161.370 (2)(c),
17 the consultation or evaluation and any recommendations described in paragraph (a) or (b)
18 of this subsection, and any other information the court finds to be trustworthy and reliable,
19 the court may continue the commitment of the defendant if the court makes written findings
20 that a hospital level of care is necessary due to public safety concerns and the acuity of
21 symptoms of the defendant's qualifying mental disorder, and that appropriate community
22 restoration services are not present and available in the community.

23 (B) If the court does not make the findings described in subparagraph (A) of this para-
24 graph, the court shall terminate the commitment and shall set a review hearing seven days
25 from the date of the commitment termination for any defendant remaining in custody. At
26 the review hearing, the court shall consider all relevant information, determine an appro-
27 priate action in the case as described in ORS 161.370 (2)(c) and enter an order in accordance
28 with the defendant's constitutional rights to due process.

29 (5)(a) If a defendant remains committed under this section, the court shall determine
30 within a reasonable period of time whether there is a substantial probability that, in the
31 foreseeable future, the defendant will gain or regain fitness to proceed. However, regardless
32 of the number of charges with which the defendant is accused, in no event shall the defend-
33 ant be committed for longer than whichever of the following, measured from the defendant's
34 initial custody date, is shorter:

35 (A) Three years; or

36 (B) A period of time equal to the maximum sentence the court could have imposed if the
37 defendant had been convicted.

38 (b) For purposes of calculating the maximum period of commitment described in para-
39 graph (a) of this subsection:

40 (A) The initial custody date is the date on which the defendant is first committed under
41 this section on any charge alleged in the accusatory instrument; and

42 (B) The defendant shall be given credit against each charge alleged in the accusatory
43 instrument:

44 (i) For each day the defendant is committed under this section, whether the days are
45 consecutive or are interrupted by a period of time during which the defendant has gained or

1 regained fitness to proceed; and

2 (ii) Unless the defendant is charged on any charging instrument with aggravated murder
3 or a crime listed in ORS 137.700 (2), for each day the defendant is held in jail before and after
4 the date the defendant is first committed, whether the days are consecutive or are inter-
5 rupted by a period of time during which the defendant lacks fitness to proceed.

6 (c) The superintendent of the state mental hospital or director of the facility to which
7 the defendant is committed shall notify the committing court of the defendant's impending
8 discharge 30 days before the date on which the superintendent or director is required to
9 discharge the defendant under this subsection.

10 (6)(a) All notices required under this section shall be filed with the court and may be filed
11 electronically. The clerk of the court shall cause copies of the notices to be delivered to both
12 the district attorney and the counsel for the defendant.

13 (b) When the committing court receives a notice from the superintendent or director
14 under subsection (1) of this section concerning the defendant's progress or lack thereof, or
15 under subsection (5) of this section concerning the defendant's impending discharge, the
16 committing court shall determine, after a hearing if a hearing is requested, whether the de-
17 fendant presently has fitness to proceed.

18 (7) If at any time the court determines that the defendant lacks fitness to proceed, the
19 court shall further determine whether the defendant is entitled to discharge under sub-
20 section (5) of this section. If the court determines that the defendant is entitled to discharge
21 under subsection (5) of this section, the court shall dismiss, without prejudice, all charges
22 against the defendant and:

23 (a) Order that the defendant be discharged; or

24 (b) Initiate commitment proceedings under ORS 426.070, 426.701 or 427.235 to 427.290.

28 **SECTION 6.** ORS 161.365 is amended to read:

29 161.365. (1)(a) When the court has reason to doubt the defendant's fitness to proceed by reason
30 of incapacity as described in ORS 161.360, the court may call any witness to assist it in reaching
31 its decision and, **except as provided in paragraph (b) of this subsection**, shall order that a com-
32 munity mental health program director, or the director's designee, consult with the defendant and
33 with any local entity that would be responsible for [*supervising*] **providing community restoration**
34 **services to** the defendant if the defendant were to be released in the community, to determine
35 whether [*services and supervision necessary to safely allow the defendant to gain or regain fitness to*
36 *proceed*] **appropriate community restoration services are present and** available in the commu-
37 nity. After the consultation, the program director or the director's designee shall provide to the
38 court a copy of the findings resulting from the consultation.

39 (b) **If the defendant is charged with one or more of the following offenses the court is**
40 **not required to, but may in its discretion, order the consultation described in paragraph (a)**
41 **of this subsection:**

42 (A) **Aggravated murder;**

43 (B) **Murder in any degree;**

44 (C) **Attempted aggravated murder;**

45 (D) **Attempted murder in any degree;**

- 1 **(E) Manslaughter in any degree;**
- 2 **(E) Aggravated vehicular homicide;**
- 3 **(F) Arson in the first degree when classified as crime category 10 of the sentencing**
- 4 **guidelines grid of the Oregon Criminal Justice Commission;**
- 5 **(G) Assault in the first degree;**
- 6 **(H) Assault in the second degree;**
- 7 **(I) Kidnapping in the first degree;**
- 8 **(J) Kidnapping in the second degree;**
- 9 **(K) Rape in the first degree;**
- 10 **(L) Sodomy in the first degree;**
- 11 **(M) Unlawful sexual penetration in the first degree;**
- 12 **(N) Robbery in the first degree; or**
- 13 **(O) Robbery in the second degree.**

14 (c) If the court determines the assistance of a psychiatrist or psychologist would be helpful, the
15 court may:

16 (A) Order that a psychiatric or psychological examination of the defendant be conducted by a
17 certified evaluator and a report of the examination be prepared; or

18 (B) Order the defendant to be committed for the purpose of an examination to a state mental
19 hospital or other facility designated by the Oregon Health Authority if the defendant is at least 18
20 years of age, or to a secure intensive community inpatient facility designated by the authority if the
21 defendant is under 18 years of age. The state mental hospital or other facility may retain custody
22 of a defendant committed under this paragraph for the duration necessary to complete the exam-
23 ination of the defendant, not to exceed 30 days. The examination may include a period of observa-
24 tion.

25 [(b)] (d) The court shall provide a copy of any order entered under this subsection to the com-
26 munity mental health program director or designee and to the state mental hospital or other facility
27 by the end of the next judicial day.

28 (2)(a) A defendant committed under subsection [(1)(a)(B)] (1)(c)(B) of this section shall be
29 transported to the state mental hospital or other facility for the examination.

30 (b) At the conclusion of the examination, the superintendent of the state mental hospital or the
31 superintendent's designee or the director of the facility may:

32 (A) Return the defendant to the facility from which the defendant was transported; or

33 (B) Inform the court and the parties that the defendant requires a hospital level of care due to
34 [the defendant's dangerousness and] the acuity of symptoms of the defendant's qualifying mental
35 disorder and request that the defendant remain at the state mental hospital or other facility pending
36 a hearing or order under ORS 161.370.

37 [(c) If both parties consent, the court may, without holding a hearing, enter any order authorized
38 by ORS 161.370 based on a report resulting from an examination conducted under this section.]

39 (3) The report of an examination described in this section must include, but is not necessarily
40 limited to, the following:

41 (a) A description of the nature of the examination;

42 (b) A statement of the mental condition of the defendant;

43 (c) If the defendant suffers from a qualifying mental disorder, an opinion as to whether the de-
44 fendant is incapacitated within the description set out in ORS 161.360; and

45 (d) If the defendant is incapacitated within the description set out in ORS 161.360, a recom-

1 mendment of treatment and services necessary to allow the defendant to gain or regain capacity,
2 including whether a hospital level of care is required due to *[the defendant's dangerousness and]* the
3 acuity of symptoms of the defendant's qualifying mental disorder.

4 (4) Except when the defendant and the court both request to the contrary, the report may not
5 contain any findings or conclusions as to whether the defendant as a result of a qualifying mental
6 disorder was subject to the provisions of ORS 161.295 or 161.300 at the time of the criminal act
7 charged.

8 (5) If the examination by the certified evaluator cannot be conducted by reason of the unwill-
9 ingness of the defendant to participate in the examination, the report must so state and must in-
10 clude, if possible, an opinion as to whether the unwillingness of the defendant was the result of a
11 qualifying mental disorder affecting *[capacity]* **fitness** to proceed.

12 (6)*[(a)]* The report resulting from the examination of a defendant under this section may be filed
13 electronically and must be filed with the clerk of the court, who shall cause copies to be delivered
14 to the district attorney and to counsel for defendant.

15 *[(b) The entity or evaluator conducting the examination shall provide a copy of the report resulting*
16 *from the examination to the community mental health program director or designee in:]*

17 *[(A) The county in which the defendant is charged; and]*

18 *[(B) The county of the defendant's last known residence.]*

19 *[(c) Reports prepared under this section are confidential and may be made available only:]*

20 *[(A) To the court, prosecuting attorney, defense attorney, agent of the prosecuting or defense attor-*
21 *ney, defendant, community mental health program director or designee and any facility in which the*
22 *defendant is housed; or]*

23 *[(B) As ordered by a court.]*

24 *[(d) Any facility in which a defendant is housed may not use a report prepared under this section*
25 *to support a disciplinary action against the defendant.]*

26 *[(e) Nothing in this subsection prohibits the prosecuting attorney, defense attorney or agent of the*
27 *prosecuting or defense attorney from discussing the contents of a report prepared under this section*
28 *with witnesses or victims as otherwise permitted by law.]*

29 (7)(a) When upon motion of the court or a financially eligible defendant, the court has ordered
30 a psychiatric or psychological examination of the defendant, a county or justice court shall order
31 the county to pay, **a municipal court shall order the city to pay**, and a circuit court shall order
32 the public defense services executive director to pay from funds available for the purpose:

33 (A) A reasonable fee if the examination of the defendant is conducted by a certified evaluator
34 in private practice; and

35 (B) All costs including transportation of the defendant if the examination is conducted by a
36 certified evaluator in the employ of the Oregon Health Authority or a community mental health
37 program established under ORS 430.610 to 430.670.

38 (b) When an examination is ordered at the request or with the acquiescence of a defendant who
39 is determined not to be financially eligible, the examination shall be performed at the defendant's
40 expense. When an examination is ordered at the request of the prosecution, the county shall pay for
41 the expense of the examination.

42 (8) The Oregon Health Authority shall establish by rule standards for the consultation described
43 in subsection (1) of this section.

44 *[(9) As used in this section and ORS 161.370, "certified evaluator" has the meaning given that term*
45 *in ORS 161.309.]*

DISPOSITION UPON FINDING OF LACK OF FITNESS

SECTION 7. ORS 161.370 is amended to read:

161.370. (1)(a) When the defendant's fitness to proceed is drawn in question, the issue shall be determined by the court.

(b) If neither the prosecuting attorney nor counsel for the defendant contests the finding of the report filed under ORS 161.365, the court may make the determination on the basis of the report. If the finding is contested, the court shall hold a hearing on the issue. If the report is received in evidence in the hearing, the party who contests the finding has the right to summon and to cross-examine any certified evaluator who submitted the report and to offer evidence upon the issue. Other evidence regarding the defendant's fitness to proceed may be introduced by either party.

(2)(a) If the court determines that the defendant lacks fitness to proceed, the criminal proceeding against the defendant shall be suspended and the court shall[, *at a hearing,*] proceed in accordance with this subsection.

(b) After making the determination under paragraph (a) of this subsection, the court shall receive a recommendation[, *to be considered at the hearing,*] from a community mental health program director or the director's designee, and from any local entity that would be responsible for [*supervising*] **treating** the defendant if the defendant were to be released in the community, concerning whether [*services and supervision necessary to safely allow the defendant to gain or regain fitness to proceed are available*] **appropriate community restoration services are present and available** in the community.

(c) [*The court and the parties shall at the hearing determine*] **If the parties agree as to the appropriate action under this section, the court may, after making all findings required by law, enter any order authorized by this section. If the parties do not agree as to the appropriate action, the court and the parties shall, at a hearing, consider** an appropriate action in the case, and the court shall **make a determination and** enter an order necessary to implement the action. In determining the appropriate action, the court shall consider the primary and secondary release criteria as defined in ORS 135.230, the least restrictive option appropriate for the defendant, the needs of the defendant and the interests of justice. Actions may include but are not limited to:

(A) Commitment for the defendant to gain or regain fitness to proceed under subsection (3) or [(5)] **(4)** of this section;

(B) **An order to engage in** community restoration **services**, as recommended by the community mental health program director or designee, **under subsection (6) of this section**;

[(C) *Release on supervision;*]

[(D)] **(C)** Commencement of a civil commitment proceeding under ORS 426.070 to 426.170, 426.701 or 427.235 to 427.290;

[(E)] **(D)** Commencement of protective proceedings under ORS chapter 125; or

[(F)] **(E)** Dismissal of the charges pursuant to ORS 135.755.

(d) If the court, while considering or ordering an appropriate action under this subsection, [*determines that the defendant does not require a hospital level of care due to the defendant's dangerousness and the acuity of symptoms of the defendant's qualifying mental disorder, but that services and supervision necessary to safely allow the defendant to gain or regain fitness to proceed are not available*] **does not order the defendant committed to a state mental hospital or other facility, but finds that appropriate community restoration services are not present and available** in the community, for any defendant remaining in custody after such determination, the court

1 shall set a review hearing seven days from the date of the determination under paragraph (a) of this
 2 subsection. At the review hearing, the court shall consider all relevant information and determine
 3 *[an appropriate action in the case as described in paragraph (c) of this subsection. If the defendant*

2 (2) Upon receipt of the information described in this section, the Department of State Police
3 shall access and maintain the information and transmit the information to the federal government

5 (3) The Department of Human Services, the Oregon Health Authority, the Psychiatric Security
6 Review Board and the Judicial Department shall enter into agreements with the Department of State
7 Police describing the access to information provided under this section.

8 (4) The Department of State Police shall adopt rules:

9 (a) After consulting with the Department of Human Services, the Oregon Health Authority, the

11 provided to the Department of State Police under this section; and
