

# Senate Bill 408

Sponsored by Senator PROZANSKI (at the request of Oregon Retailers of Cannabis Association, Oregon Cannabis Association and F.A.R.M.S. Inc.) (Pre-session filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allows marijuana producer to track by batch mature marijuana plants. Defines "batch." Allows marijuana producers owned at least 51 percent by same person to transfer to one another marijuana and usable marijuana. Allows marijuana producer to receive specified marijuana items from marijuana processor. Specifies information required in transfer manifest for transport of marijuana.

## A BILL FOR AN ACT

2 Relating to marijuana.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Sections 2 to 4 of this 2021 Act are added to and made a part of ORS 475B.010**  
5 **to 475B.545.**

6 **SECTION 2. (1) As used in this section, "batch" means mature marijuana plants of the**  
7 **same strain and harvested within eight days of each other.**

8 **(2) A marijuana producer that holds a license issued under ORS 475B.070 may track by**  
9 **the batch:**

10 **(a) The production of mature marijuana plants that are produced in a single or contig-**  
11 **uous area and are segregated from other batches; and**

12 **(b) The transfer of mature marijuana plants described in paragraph (a) of this subsection**  
13 **to another licensee or laboratory licensed under ORS 475B.560.**

14 **SECTION 3. (1) A marijuana producer that holds a license issued under ORS 475B.070**  
15 **may deliver to or receive from a marijuana processor that holds a license issued under ORS**  
16 **475B.090:**

17 **(a) Cannabinoid products, cannabinoid extracts and cannabinoid concentrates processed**  
18 **by the marijuana processor from marijuana produced by the marijuana producer; and**

19 **(b) Marijuana produced by the marijuana producer that the marijuana processor received**  
20 **from the marijuana producer but that was not processed.**

21 **(2) Two or more marijuana producers that hold licenses issued under ORS 475B.070 and**  
22 **are owned at least 51 percent by the same person may deliver to and receive from one an-**  
23 **other marijuana and usable marijuana.**

24 **SECTION 4. In order to transport marijuana items, a licensee shall include in the**  
25 **transfer manifest the following information:**

26 **(1) The name of the driver of the transport vehicle;**

27 **(2) Identifying information for the driver's permit issued under ORS 475B.266;**

28 **(3) The name and location of the licensee from where the marijuana or marijuana items**  
29 **are being transported; and**

30 **(4) A detailed inventory of the marijuana and marijuana items being transported.**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.
