

SENATE AMENDMENTS TO SENATE BILL 5521

By JOINT COMMITTEE ON WAYS AND MEANS

1 On page 1 of the printed bill, delete lines 4 through 28 and delete page 2 and insert:

2 “**SECTION 1.** Notwithstanding any other law limiting expenditures, the amount of
3 \$2,887,511 is established for the biennium beginning July 1, 2021, as the maximum limit for
4 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,
5 but excluding lottery funds and federal funds, collected or received by the State Mortuary
6 and Cemetery Board.

7 “**SECTION 2.** Notwithstanding any other law limiting expenditures, the amount of
8 \$1,092,162 is established for the biennium beginning July 1, 2021, as the maximum limit for
9 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,
10 but excluding lottery funds and federal funds, collected or received by the Oregon Board of
11 Naturopathic Medicine.

12 “**SECTION 3.** Notwithstanding any other law limiting expenditures, the amount of
13 \$711,487 is established for the biennium beginning July 1, 2021, as the maximum limit for
14 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,
15 but excluding lottery funds and federal funds, collected or received by the Occupational
16 Therapy Licensing Board.

17 “**SECTION 4.** Notwithstanding any other law limiting expenditures, the amount of
18 \$1,236,818 is established for the biennium beginning July 1, 2021, as the maximum limit for
19 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,
20 but excluding lottery funds and federal funds, collected or received by the Board of Medical
21 Imaging.

22 “**SECTION 5.** Notwithstanding any other law limiting expenditures, the amount of
23 \$1,071,998 is established for the biennium beginning July 1, 2021, as the maximum limit for
24 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,
25 but excluding lottery funds and federal funds, collected or received by the State Board of
26 Examiners for Speech-Language Pathology and Audiology.

27 “**SECTION 6.** Notwithstanding any other law limiting expenditures, the amount of
28 \$1,369,341 is established for the biennium beginning July 1, 2021, as the maximum limit for
29 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,
30 but excluding lottery funds and federal funds, collected or received by the Oregon State
31 Veterinary Medical Examining Board.

32 “**SECTION 7.** This 2021 Act being necessary for the immediate preservation of the public
33 peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect
34 July 1, 2021.”
