SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Oregon Military Department for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and federal service agreement reimbursements, but excluding lottery funds and other federal funds, collected or received by department for certain purposes.

Limits biennial expenditures by department from federal funds for certain purposes.

Modifies certain General Fund appropriation and expenditure limitation for department for biennium ending June 30, 2021.

Declares emergency, effective July 1, 2021.

A BILL FOR AN ACT

Relating to the financial administration of the Oregon Military Department; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. There are appropriated to the Oregon Military Department, for the biennium beginning July 1, 2021, out of the General Fund, the following amounts, for the following purposes:

8	(1) Administration.....	\$	7,908,986
9	(2) Operations	\$	8,700,661
10	(3) Emergency management	\$	13,007,248
11	(4) Community support	\$	1,223,752
12	(5) Debt service.....	\$	13,189,091

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2021, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and reimbursements from federal service agreements, but excluding lottery funds and federal funds not described in this section, collected or received by the Oregon Military Department, for the following purposes:

2 **SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts**
3 **are established for the biennium beginning July 1, 2021, as the maximum limits for payment**
4 **of expenses from federal funds, other than those described in section 2 of this 2021 Act,**
5 **collected or received by the Oregon Military Department, for the following purposes:**

- 6 **(1) Administration..... \$ 517,673**
- 7 **(2) Operations \$ 105,788,658**
- 8 **(3) Emergency management \$ 1,005,332,920**
- 9 **(4) Community support \$ 17,007,219**
- 10 **(5) Capital improvement \$ 5,354,100**

11 **SECTION 4. Notwithstanding any other provision of law, the General Fund appropriation**
12 **made to the Oregon Military Department by section 1 (4), chapter 534, Oregon Laws 2019, for**
13 **the biennium ending June 30, 2021, for community support, is increased by \$358,378 for state**
14 **active duty expenses.**

15 **SECTION 5. Notwithstanding any other law limiting expenditures, the limitation on**
16 **expenditures established by section 2 (4), chapter 534, Oregon Laws 2019, for the biennium**
17 **ending June 30, 2021, as the maximum limit for payment of expenses from fees, moneys or**
18 **other revenues, including Miscellaneous Receipts and reimbursements from federal service**
19 **agreements, but excluding lottery funds and federal funds not described in section 2, chapter**
20 **534, Oregon Laws 2019, collected or received by the Oregon Military Department, for com-**
21 **munity support, is increased by \$386,797 for state active duty expenses.**

22 **SECTION 6. This 2021 Act being necessary for the immediate preservation of the public**
23 **peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect**
24 **July 1, 2021.**
