4	"(A) A resilient material or combination of materials that is enclosed by a ticking, is used alone
5	or in combination with other products and is intended for or promoted for sleeping upon; or
6	"(B) A foundation.
7	"(b) 'Mattress' does not mean:
8	"(A) An unattached mattress pad or unattached mattress topper, with or without resilient filling
9	or ticking, that is intended to be used with or on top of a mattress;
10	"(B) A sleeping bag;
11	"(C) A pillow;
12	"(D) A car bed, crib mattress or bassinet mattress;
13	"(E) A carriage, basket, dressing table, stroller, playpen, infant carrier, lounge pad, crib bumper
14	or other product manufactured for young children or the pad for a product described in this sub-
15	paragraph;
16	"(F) A water bed, an air mattress or another product that contains liquid- or gas-filled ticking
17	and that does not contain upholstery material between the ticking and the mattress core; or
18	"(G) A foldout sofa bed, futon, futon mattress or upholstered furniture.".
19	On page 3, line 18, delete "or foundation".
20	In line 29, delete "or foun-".
21	In line 30, delete "dations".
22	In line 34, delete "or foundation".
23	In line 37, delete "or founda-".
24	In line 38, delete "tion".
25	In line 42, delete "or foundation".
26	In line 44, delete "or foundation".
27	On page 4, line 2, after "organization" insert "with a plan approved by the Department of En-
28	vironmental Quality under section 6 of this 2021 Act".
29	In line 8, delete "Department of Environmental Quality" and insert "department".
30	In line 33, delete "or pay legal fees associated with legal action taken by the state".
31	On <u>page 5</u> , delete lines 37 through 41 and insert:
32	"(j) Provide a mechanism to mitigate the costs associated with collection and management of
33	discarded mattresses that are illegally dumped. The proposed mechanism must take into account the
34	cost of one or more incentives to encourage collectors to properly dispose of discarded mattresses
35	and discourage illegal dumping, and may include but need not be limited to proposals for funding

1 of cleanup activities, for education and outreach or for studies to evaluate the causes of illegal 2 dumping. The proposed mechanism may not require the stewardship organization or collectors to enter private property without authorization from the property owner or other appropriate author-3 ity.".

On page 6, delete lines 37 through 41 and insert:

6 (b) A plan may provide for methods for providing convenient service that are alternative 7 methods to those provided for in paragraph (a) of this subsection if, based on a geographic infor-8 mation systems analysis or additional information, the alternative methods will result in providing 9 service to residents throughout this state at an equivalent level of convenient service compared with 10 the methods provided for under paragraph (a) of this subsection.".

11 On page 9, delete lines 3 through 6 and insert:

"(4) If the department determines that a change for which notice was given under subsection (3) 1213of this section has a material impact on a previously approved plan, the department may require the stewardship organization to submit an amendment under subsection (1) of this section, regardless 14 15of whether the change has been implemented.".

16 In line 8, delete "four" and insert "five".

In line 11, delete "four" and insert "five". 17

18 Delete lines 33 through 41 and insert:

19 "(b) Information on the number and tonnage of discarded mattresses collected pursuant to the 20mattress stewardship program during the previous calendar year at a sufficient level of disaggre-21gation to determine how the program is performing in different regions of the state;

22"(c) Information on the number and tonnage of program mattresses collected pursuant to the 23mattress stewardship program for recycling during the previous calendar year at a sufficient level of disaggregation to determine how the program is performing in different regions of the state; 24

25"(d) Information on the number and tonnage of program mattresses collected pursuant to the 26mattress stewardship program for renovation during the previous calendar year at a sufficient level of disaggregation to determine how the program is performing in different regions of the state;". 27

On page 10, delete lines 6 through 11 and insert: 28

29"(h) The number of discarded mattresses received through collection that were not program 30 mattresses, the number of discarded mattresses that were illegally dumped as reported to the department, an analysis of how the data required by this paragraph has changed over time and strat-3132egies the stewardship organization will take to address discarded mattresses that are not program 33 mattresses and discarded mattresses that are illegally dumped;".

In line 27, delete "and foundations". 34

On page 11, line 12, delete "four" and insert "five". 35

In line 16, delete "four" and insert "five". 36
