SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Defines "regional health equity coalition" and "regional health equity coalition model." Requires Oregon Health Authority to work with regional health equity coalitions and groups utilizing re-gional health equity coalition model throughout state. Appropriates moneys to fund additional grants for organizations seeking to build regional health equity coalitions and to provide additional staff support.

Declares emergency, effective on passage.

- $\mathbf{5}$ **SECTION 1.** (1) As used in this section:
 - (a) "Communities of color" means members of the following racial or ethnic communi-

- (A) American Indians; 8
- 9 (B) Alaska Natives;
- (C) Individuals of Hispanic or Latino descent; 10
- (D) Individuals of Asian descent; 11
- (E) Native Hawaiians or Pacific Islanders; 12

- 14 (G) Individuals of Middle Eastern descent; or
- (H) Other racial or ethnic minorities. 15

16 (b) "Community-led" means based on a set of core principles that, at a minimum, engages

17 the people living in a geographic community to establish goals and priorities, using local residents as leaders, building on strengths rather than focusing on problems and involving 18 cross-sector collaboration that is intentional and adaptable and works to achieve systemic 19 20

change.

21 (c) "Cross-sector" means involving individuals, public and private institutions and com-22munities working together.

23(d) "Culturally specific" means led by individuals from the community served, using language, structures and settings familiar to the members of the community. 24

(e) "Regional health equity coalition" means an autonomous, community-led, cross-sector 25 26 group that:

(A) Is focused on addressing, at the policy, system and environmental levels, health in-27equities experienced by priority populations, with the leading priority being communities of 28

color; 1 2 (B) Is completely independent of coordinated care organizations and public bodies as defined in ORS 174.109; 3 (C) Is supported by a federally recognized Indian tribe in Oregon or one of the following 4 community-based nonprofit entities: 5 (i) A culturally specific organization; 6 (ii) A social service provider; 7 (iii) An organization that provides health care; 8 9 (iv) An organization that conducts public health research; (v) An organization that provides behavioral health treatment; 10 11 (vi) A private foundation; or 12 (vii) A faith-based organization; and 13 (D) Has a decision-making body that: (i) Is composed 51 percent or more of individuals who identify as members of communi-14 15 ties of color who have experienced health inequities; and 16 (ii) Prioritizes the recruitment of members who identify as members of communities of color or who work in roles that address health inequities and institutional racism. 17 18 (f) "Regional health equity coalition model" means an approach that: 19 (A) Recognizes the impact of structural, institutional and interpersonal racism on the health and well-being of communities of color and other priority populations; 20(B) Meaningfully engages priority populations to lead efforts to address health inequities; 21 22(C) Supports and strengthens leadership development for priority populations; and 23(D) Honors the wisdom of members of priority populations by ensuring that policy solutions and system changes build upon the strengths of the priority populations. 24 (g) "Priority populations" means: 25(A) Communities of color; 2627(B) Oregon's nine federally recognized Indian tribes, including descendants of the members of Oregon's nine federally recognized Indian tribes; 28 (C) Immigrants and refugees; 2930 (D) Migrant and seasonal farmworkers; 31 (E) Low-income individuals and families; (F) Persons with disabilities; and 32(G) Individuals who identify as lesbian, gay, bisexual, transgender or queer or who ques-33 34 tion their sexual or gender identity. (2) The Oregon Health Authority shall work with regional health equity coalitions and 35groups using a regional health equity coalition model, to ensure service to priority popu-36 37 lations throughout this state. 38 (3) The authority shall ensure that it has adequate staffing to support grantees through ongoing technical assistance, contract administration, program planning and daily opera-39 tional support. 40 SECTION 2. In addition to and not in lieu of any other appropriation, there is appropri-41 ated to the Oregon Health Authority, for the biennium beginning July 1, 2021, out of the 42 General Fund, the amount of \$_____, which may be expended for: 43 (1) Restoring funding to grants provided to existing regional health equity coalitions, as 44 defined in section 1 of this 2021 Act; 45

1 (2) Providing grants to four organizations seeking to build capacity to become regional 2 health equity coalitions; and

3 (3) Providing sufficient staff support to regional health equity coalitions in the form of 4 technical assistance, contract administration, daily operational support and long-term plan-5 ning.

6 <u>SECTION 3.</u> This 2021 Act being necessary for the immediate preservation of the public 7 peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect 8 on its passage.
