

SENATE AMENDMENTS TO SENATE BILL 721

- 1 On page 1 of the printed bill, delete lines 14 through 30.
- 2 On page 2, delete lines 1 through 14 and insert:
- 3 “**SECTION 2.** ORS 430.073 is amended to read:
- 4 “430.073. (1) As used in this section and ORS 430.075, ‘consumer’ means a person who has re-
- 5 ceived or is receiving mental health or [*addiction*] **substance use disorder** services.
- 6 “(2) The Director of the Oregon Health Authority shall [*establish a*] **maintain an independent**
- 7 Consumer Advisory Council to:
- 8 “(a) Advise the director on the provision of mental health **and substance use disorder** services
- 9 by the Oregon Health Authority.
- 10 “(b) [*The council may*] Review, evaluate and provide feedback on all site reviews related to
- 11 mental health **and substance use disorder** services provided by the authority.
- 12 “(c) **Review and approve policy proposals developed in accordance with ORS 430.071.**
- 13 “(d) **Make recommendations for policies in accordance with ORS 430.071.**
- 14 “(e) **Provide useful perspectives and experiences.**
- 15 “(f) **Communicate concerns, emergency needs or general conditions related to the deliv-**
- 16 **ery of mental health and substance use disorder services.**
- 17 “(3) [*The director shall appoint 15 to 25 consumers to the council*] **Consistent with the policy**
- 18 **expressed in ORS 430.071 to support and promote self-determination for consumers, 15 to 25**
- 19 **individuals shall be selected as members of the council by:**
- 20 “(a) **Existing consumers on the council; or**
- 21 “(b) **A seven-person subcommittee of the council, appointed by the members of the**
- 22 **council, consisting of individuals who represent consumer-run service agencies or**
- 23 **consumer-run advocacy agencies that are active or headquartered in this state.**
- 24 “(4) In making appointments **to the council**, the [*director*] **council** shall strive to balance the
- 25 representation according to geographic areas of the state, race, ethnicity and age.
- 26 “(5) **The council may convene cooperative work groups and conduct fact-finding.**
- 27 “[*4*] (6) The authority shall provide administrative support to the council.
- 28 “[*5*] (7) A member of the council is entitled to compensation in an amount determined by the
- 29 director and to actual and necessary travel expenses incurred by the member in the performance
- 30 of the member’s official duties. Claims for compensation and expenses shall be paid out of funds
- 31 appropriated to the authority for purposes of the council.”.
