

SENATE AMENDMENTS TO SENATE BILL 732

- 1 On page 1 of the printed bill, delete lines 6 through 31.
- 2 On page 2, delete lines 1 through 15 and insert:
- 3 **“SECTION 2. (1) Nothing in this section shall interfere with the duties, responsibilities**
4 **and rights of duly elected school district boards. There shall be established at each school**
5 **district an educational equity advisory committee.**
- 6 **“(2) The duties of an educational equity advisory committee shall include:**
- 7 **“(a) Advising the school district board about the educational equity impacts of policy**
8 **decisions;**
- 9 **“(b) Advising the school district superintendent about the educational equity impacts of**
10 **policy decisions; and**
- 11 **“(c) Informing the school district board and school district superintendent when a situ-**
12 **ation arises in a school of the school district that negatively impacts underrepresented stu-**
13 **dents and advising the board and superintendent on how best to handle that situation.**
- 14 **“(3) The educational equity advisory committee may prepare an annual report that:**
- 15 **“(a) Contains the following information:**
- 16 **“(A) The successes and challenges the school district has experienced in meeting the**
17 **educational equity needs of students in the school district;**
- 18 **“(B) Recommendations the committee made to the school district board and school dis-**
19 **trict superintendent, and the actions that were taken in response to those recommendations;**
20 **and**
- 21 **“(C) Any other information required by the State Board of Education by rule.**
- 22 **“(b) Is made available by being:**
- 23 **“(A) Distributed to the parents of the students of the school district;**
- 24 **“(B) Posted on the school district’s website;**
- 25 **“(C) Presented to the school district board in an open meeting with adequate opportunity**
26 **for public comment; and**
- 27 **“(D) Sent to the State Board of Education.**
- 28 **“(4)(a) An educational equity advisory committee shall be selected by the school district**
29 **superintendent and must be composed of parents, employees, students and community**
30 **members from the school district.**
- 31 **“(b) For the purpose of selecting members, the school district superintendent:**
- 32 **“(A) Shall solicit names of possible members from the community;**
- 33 **“(B) Must ensure that membership is primarily representative of underserved student**
34 **groups;**
- 35 **“(C) May not exclude members based on immigration status; and**

1 **“(D) Must comply with any other requirements established by the State Board of Edu-**
2 **cation by rule.**

3 **“(5) The State Board of Education shall adopt any rules necessary for the administration**
4 **of this section.”.**

5 On page 3, delete lines 41 through 43 and insert:

6 “(2) In addition to the requirements prescribed by ORS 294.305 to 294.565, a school district must
7 include at least one member of the educational equity advisory committee of the school district on
8 the budget committee.”.

9 After line 43, insert:

10 **“SECTION 6. Notwithstanding ORS 328.542, as amended by section 5 of this 2021 Act, a**
11 **budget committee is not required to include a member of the educational equity advisory**
12 **committee of the school district until a vacancy on the budget committee occurs by a**
13 **member who is not also a member of the school district board.”.**

14 In line 44, delete “6” and insert “7”.
