Sponsored by COMMITTEE ON JUDICIARY AND BALLOT MEASURE 110 IMPLEMENTATION (at the request of Senator Floyd Prozanski)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies and provides for implementation of Ballot Measure 110 (2020).

Renames "Addiction Recovery Center" as "Behavioral Health Resource Network" and modifies services that must be provided by networks. Renames "24/7" triage as "screening" and specifies requirements for screening.

Requires Oversight and Accountability Council to provide funding, in addition to grants to agencies and organizations participating in networks. Modifies requirements for receiving grants and funding.

Modifies quorum requirement for council. Requires members of council to submit statements of economic interest to Oregon Government Ethics Commission.

Requires Oregon Health Authority to post on website information about recipients of grants or funding.

Removes sunset on Behavioral Health Resource Network statewide telephone hotline established by authority. Specifies requirements for hotline.

Directs Division of Audits of office of Secretary of State to conduct performance audits and financial reviews, beginning with real-time audit no later than December 31, 2023. Specifies scope of audits and financial reviews.

Requires authority to quarterly report to Legislative Assembly on expenditures from Drug Treatment and Recovery Services Fund.

Provides that minimum fine for Class E violation is \$45. Directs court to dismiss Class E violation citation upon receiving verification that person completed substance use disorder screening. Requires enforcement officer issuing Class E violation citation to provide person receiving citation with information concerning how person may obtain screening. Directs Legislative Assembly to allocate moneys deposited into Criminal Fine Account as payment of fines on Class E violations to Drug Treatment and Recovery Services Fund. Provides that person may not be charged with crime of failure to appear on Class E violation.

Prohibits juvenile court from waiving Class E violation proceeding to municipal court. Authorizes juvenile court to order youth to undergo assessment and treatment if youth is within jurisdiction of court for committing act that, if committed by adult, would constitute Class E violation. Provides that municipal and justice courts have no jurisdiction over Class E violations.

Makes possession of substantial quantity of Schedule I controlled substance, including heroin, lysergic acid diethylamide, 3,4-methylenedioxymethamphetamine, psilocybin or psilocin, Class B felony punishable by maximum of 10 years' imprisonment, \$250,000 fine, or both. Provides that possession of substantial quantity of Schedule II controlled substance, including cocaine, methamphetamine and fentanyl, constitutes Class C felony punishable by maximum of five years' imprisonment, \$125,000 fine, or both. Reduces penalties for possession of less than 40 pills, tablets, capsules or user units of hydrocodone to Class E violation punishable by maximum of \$100 fine. Establishes substantial quantities of fentanyl for purposes of unlawful delivery, manufacture and possession offenses and mandatory sentences. Authorizes use of presumptive test for controlled substances as prima facie evidence of identity of controlled substance in Class E violation proceeding. Authorizes district attorney to initiate Class E violation proceeding when person is charged with offense that would constitute Class E violation had offense been committed on or after February 1, 2021.

Makes form and style changes to provisions in Ballot Measure 110 (2020).

Declares emergency, effective on passage.

5 **Be It Enacted by the People of the State of Oregon:**

7 **FINDINGS AND POLICY**

8
9 **SECTION 1.** Section 1, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
10 to read:

11 **Sec. 1.** (1)(a) The people of Oregon find that drug addiction and overdoses are a serious problem
12 in Oregon and that Oregon needs to expand access to drug treatment.

13 (b) The people of Oregon further find that a health-based approach to addiction and overdose is
14 more effective, humane and cost-effective than criminal punishments. Making people criminals be-
15 cause they suffer from addiction is expensive, ruins lives and can make access to treatment and
16 recovery more difficult.

17 (2)(a) The purpose of *[this]* **the** Drug Addiction Treatment and Recovery Act of 2020 is to make
18 **screening** health assessment, treatment and recovery services for drug addiction available to all
19 those who need and want access to those services and to adopt a health approach to drug addiction
20 by removing criminal penalties for low-level drug possession.

21 (b) It is the policy of the State of Oregon that **screening** health assessment, treatment and re-
22 covery services for drug addiction are available to all those who need and want access to those
23 services.

24 (3) The provisions of *[this Act]* **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**,
25 shall be interpreted consistently with the findings, purposes and policy objectives stated in this
26 section and shall not be limited by any policy set forth in Oregon law that could conflict with or
27 be interpreted to conflict with the purposes and policy objectives stated in this section.

29 **EXPANDING TREATMENT AND SERVICES**

30
31 **SECTION 2.** Section 2, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
32 to read:

33 **Sec. 2.** [*Grants Program.* (1) *The Oversight and Accountability Council shall oversee and approve*
34 *grants to implement Addiction Recovery Centers and increase access to community care, as set forth*
35 *below.*]

36 [(2) *Addiction Recovery Centers.* *The Oversight and Accountability Council shall provide grants*
37 *to existing agencies or organizations, whether government or community-based, to create Addiction*
38 *Recovery Centers for the purposes of immediately triaging the acute needs of people who use drugs and*
39 *assessing and addressing any on-going needs thorough intensive case management and linkage to care*
40 *and services.*]

41 [(a) *Grants must be disbursed such that at least one center shall be established within each existing*
42 *coordinated care organization service area. Centers within each existing coordinated care organization*
43 *service area shall be established and operational by October 1, 2021.*]

44 [(b) *Grantees must be able to provide or display an ability to provide the following services to any*
45 *Oregon resident who requests it, in order to receive funding as an Addiction Recovery Center:*]

1 *[(i) 24/7 triage: Centers shall assess a client's need for immediate medical or other treatment shortly*
2 *upon the client's arrival to determine what acute care is needed and where it can be best provided.*
3 *Centers shall provide this service twenty-four hours a day, seven days a week, 365 days a year.]*

4 *[(ii) Health assessment: Centers shall conduct a comprehensive behavioral health needs assessment*
5 *for each client, including a substance use disorder screening by a certified alcohol and drug counselor*
6 *or other credentialed addiction treatment professional. The assessment shall prioritize the self-identified*
7 *needs of the client.]*

8 *[(iii) Individual intervention plan, intensive case management and connection to services: If, after*
9 *the completion of the assessment, the client indicates a desire to address some or all of the identified*
10 *needs, a case manager shall work with the client to design an individual intervention plan. The plan*
11 *must address the client's need for substance use disorder treatment, coexisting health problems, hous-*
12 *ing, employment and training, childcare and other services. Intensive case management requires, in the*
13 *least, that case managers have a sufficiently low staff-to-client ratio to provide daily support as needed*
14 *to connect clients to services and care needed to fulfill the individual intervention plan and have the*
15 *capacity to follow-up to ensure clients are accessing care and, if not, to reconnect clients to care as*
16 *necessary and as desired by clients.]*

17 *[(iv) Peer support: Each center shall offer ongoing peer counseling and support from triage and*
18 *assessment through implementation of individual intervention plans as well as provide peer outreach*
19 *workers to engage directly with marginalized community members who could potentially benefit from*
20 *the center's services.]*

21 *[(v) Outreach: Each center shall assess the need for, and provide, mobile or virtual outreach ser-*
22 *vices to reach clients who are unable to access the center.]*

23 *[(A) Notwithstanding subsection (2)(a) of this section, only one center within each coordinated care*
24 *organization service area is required to provide the triage assessments set forth in subsection (2)(b)(i)*
25 *of this section.]*

26 *[(c) All services provided at the centers must be evidence-informed, trauma-informed, culturally re-*
27 *sponsive, patient-centered, non-judgmental, and centered on principles of harm reduction. The goal of*
28 *the individual intervention plan and intensive case management shall be to address effectively the*
29 *client's substance use disorder and any other factors driving problematic behaviors without employing*
30 *coercion or shame or mandating abstinence.]*

31 *[(d) The centers shall be adequately staffed to address the needs of people with substance use dis-*
32 *order within their regions as determined by the Oversight and Accountability Council, but must in-*
33 *clude, at a minimum, at least one person qualified in each of the following categories:]*

34 *[Certified alcohol and drug counselor or other credentialed addiction treatment professional;]*

35 *[Intensive case manager; and,]*

36 *[(C) Peer support specialist.]*

37 *[(e) Each center shall provide timely verification on behalf of any client who has completed a health*
38 *assessment, as set forth in subsection (2)(b)(ii) of this section, if the client requests such verification to*
39 *comply with section 22 or section 23 (2) of this Act.]*

40 *[(3) Increasing Community Access to Care. The Oversight and Accountability Council shall provide*
41 *grants to existing agencies or organizations, whether government or community based, to increase ac-*
42 *cess to one or more of the following:]*

43 *[(a) Low barrier substance use disorder treatment that is evidence-informed, trauma-informed, cul-*
44 *turally responsive, patient-centered, and non-judgmental;]*

45 *[(b) Peer support and recovery services;]*

1 *[(c) Transitional, supportive, and permanent housing for persons with substance use disorder;]*

2 *[(d) Harm reduction interventions including, but not limited to, overdose prevention education, ac-*
3 *cess to naloxone hydrochloride and sterile syringes, and stimulant-specific drug education and*
4 *outreach.]*

5 *[(4) The council shall prioritize providing grants to community-based nonprofit organizations*
6 *within each coordinated care organization service area. However, if within any such service area a*
7 *community-based nonprofit organization does not apply for a grant or grants are not sought within that*
8 *service area for which services are needed, then the council may request and fund grants to any com-*
9 *munity care organization or county within that service area.]*

10 *[(5) Services provided by grantees, including services provided by Addiction Recovery Centers,*
11 *shall be free of charge to the persons receiving the services. To the extent consistent with applicable*
12 *law, grantees and service providers may seek and obtain reimbursement for services provided to any*
13 *person from any insurer or entity providing insurance to that person.]*

14 **(1) The Oversight and Accountability Council shall oversee and approve grants and**
15 **funding to implement Behavioral Health Resource Networks and increase access to commu-**
16 **nity care, as set forth below. A Behavioral Health Resource Network is an entity or col-**
17 **lection of entities that individually or jointly provide some or all of the services described in**
18 **subsection (2)(d) of this section.**

19 **(2)(a) The Oversight and Accountability Council, in consultation with the Oregon Health**
20 **Authority, shall provide grants and funding to agencies or organizations, whether govern-**
21 **ment or community based, to establish Behavioral Health Resource Networks for the pur-**
22 **poses of immediately screening the acute needs of people who use drugs and assessing and**
23 **addressing any ongoing needs through ongoing case management, harm reduction, treat-**
24 **ment, housing and linkage to other care and services. Recipients of grants or funding to**
25 **provide substance use disorder treatment or services must be licensed, certified or creden-**
26 **tialed by the state, including certification under ORS 743A.168 (7), or meet criteria prescribed**
27 **by rule by the Oversight and Accountability Council under section 4, chapter 2, Oregon Laws**
28 **2021 (Ballot Measure 110 (2020)).**

29 **(b) Grants and funding must be disbursed such that at least one network shall be estab-**
30 **lished and operational within each county by October 1, 2021.**

31 **(c) Applicants for grants and funding may apply individually or jointly with other network**
32 **participants.**

33 **(d) A network must have the capacity to provide the following services and any other**
34 **services specified by the council by rule:**

35 **(A) Screening by certified addiction peer support or wellness specialists or other qualified**
36 **persons designated by the council to determine a client's need for immediate medical or**
37 **other treatment to determine what acute care is needed and where it can be best provided,**
38 **identify other needs and link the client to other appropriate local or statewide services, in-**
39 **cluding treatment for substance abuse and coexisting health problems, housing, employment,**
40 **training and child care. Networks shall provide this service 24 hours a day, seven days a**
41 **week, every calendar day of the year. Notwithstanding paragraph (b) of this subsection, only**
42 **one grantee in each network within each county is required to provide the screenings de-**
43 **scribed in this subparagraph.**

44 **(B) Comprehensive behavioral health needs assessment, including a substance use disor-**
45 **der screening by a certified alcohol and drug counselor or other credentialed addiction**

1 treatment professional. The assessment shall prioritize the self-identified needs of a client.

2 (C) Individual intervention planning, case management and connection to services. If,
3 after the completion of a screening, a client indicates a desire to address some or all of the
4 identified needs, a case manager shall work with the client to design an individual inter-
5 vention plan. The plan must address the client's need for substance use disorder treatment,
6 coexisting health problems, housing, employment and training, child care and other services.

7 (D) Ongoing peer counseling and support from screening and assessment through imple-
8 mentation of individual intervention plans as well as peer outreach workers to engage di-
9 rectly with marginalized community members who could potentially benefit from the
10 network's services.

11 (E) Assessment of the need for, and provision of, mobile or virtual outreach services to:

12 (i) Reach clients who are unable to access the network; and

13 (ii) Increase public awareness of network services.

14 (F) Harm reduction services and information and education about harm reduction ser-
15 vices.

16 (G) Low-barrier substance use disorder treatment.

17 (H) Transitional and supportive housing for individuals with substance use disorders.

18 (e) All services provided through the networks must be evidence-informed, trauma-
19 informed, culturally specific, linguistically responsive, patient-centered and nonjudgmental.
20 The goal shall be to address effectively the client's substance use and any other social de-
21 terminants of health.

22 (f) The networks must be adequately staffed to address the needs of people with sub-
23 stance use disorders within their regions as prescribed by the council by rule, including, at
24 a minimum, at least one person qualified by the Oregon Health Authority in each of the
25 following categories:

26 (A) Certified alcohol and drug counselor or other credentialed addiction treatment pro-
27 fessional;

28 (B) Case manager; and

29 (C) Certified addiction peer support or wellness specialist.

30 (g) Each network shall provide prompt verification on behalf of any client who has com-
31 pleted a screening, as set forth in subsection (2)(d)(B) of this section, if the client requests
32 such verification to comply with section 22, chapter 2, Oregon Laws 2021 (Ballot Measure 110
33 (2020)), or section 45 of this 2021 Act to:

34 (A) The client; and

35 (B) The Oregon Health Authority, which shall forward the verification to the court in the
36 manner prescribed by the Chief Justice of the Supreme Court.

37 (3) In addition to grants and funding provided to networks, the council shall provide
38 grants and funding to other agencies or organizations, whether government or community
39 based, and to service providers that are affiliated with the nine federally recognized tribes
40 in this state to increase access to one or more of the following:

41 (a) Low-barrier substance use disorder treatment that is evidence-informed, trauma-
42 informed, culturally specific, linguistically responsive, patient-centered and nonjudgmental;

43 (b) Peer support and recovery services;

44 (c) Transitional, supportive and permanent housing for persons with substance use dis-
45 order; or

1 (d) Harm reduction interventions including, but not limited to, overdose prevention edu-
2 cation, access to naloxone hydrochloride and sterile syringes and stimulant-specific drug
3 education and outreach.

4 (4) In awarding grants within each geographic area, the council shall prioritize
5 community-based organizations serving communities most impacted by laws enacted in the
6 war on drugs initiative.

7 (5) The council shall require any government entity that applies for a grant to specify in
8 the application details regarding subgrantees and how the government entity will fund cul-
9 turally specific organizations and culturally specific services. A government entity receiving
10 a grant must make an explicit commitment not to supplant or decrease any existing funding
11 used to provide services funded by the grant.

12 (6) In determining grants and funding to be awarded, the council may consult the com-
13 prehensive addiction, prevention, treatment and recovery plan established by the Alcohol and
14 Drug Commission under ORS 430.223 and the advice of any other group, agency, organization
15 or individual that desires to provide advice to the council that is consistent with the terms
16 of this section.

17 (7) Services provided by grantees, including services provided by a Behavioral Health
18 Resource Network, shall be free of charge to the clients receiving the services. Grantees in
19 each network shall seek reimbursement from insurance issuers, the medical assistance pro-
20 gram or any other third party responsible for the cost of services provided to a client and
21 grants and funding provided by the council or the authority under subsection (2) of this
22 section may be used for copayments, deductibles or other out-of-pocket costs incurred by the
23 client for the services.

24 (8) Subsection (7) of this section does not require the medical assistance program to re-
25 imburse the cost of services for which another third party is responsible in violation of 42
26 U.S.C. 1396a(25).

27 **SECTION 3.** Section 3, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
28 to read:

29 **Sec. 3. [*Oversight and Accountability Council.*]** (1)(a) The Director of the Oregon Health Au-
30 thority shall establish an Oversight and Accountability Council for the purpose of determining how
31 funds will be distributed to grant applicants and to oversee the implementation of the [*Centers*]
32 **Behavioral Health Resource Networks** pursuant to section 2, **chapter 2, Oregon Laws 2021**
33 **(Ballot Measure 110 (2020))**. The council shall be formed on or before February 1, 2021.

34 [(a)] (b) The council shall [*be comprised*] **consist** of qualified individuals with experience in
35 substance use disorder treatment and other addiction services. The council shall consist of at least
36 one member from each of the following categories only:

37 [(i)] (A) A representative of the Oregon Health Authority, Health Systems Division Behavioral
38 Health Services **as a nonvoting member**;

39 [(ii)] (B) Three members of communities that have been disproportionately impacted by arrests,
40 prosecution or sentencing for conduct that has been classified or reclassified as a Class E violation
41 [*pursuant to section 11 to section 19.*];

42 [(iii)] (C) A physician specializing in addiction medicine;

43 [(iv)] (D) A licensed clinical social worker;

44 [(v)] (E) An evidence-based substance use disorder provider;

45 [(vi)] (F) A harm reduction services provider;

1 [(vii)] **(G)** A person specializing in housing services for people with substance use disorder or
2 a diagnosed mental health condition;

3 [(viii)] **(H)** An academic researcher specializing in drug use or drug policy;

4 [(ix)] **(I)** At least two people who suffered or suffer from substance use disorder;

5 [(x)] **(J)** At least two recovery peers;

6 [(xi)] **(K)** A mental or behavioral health provider;

7 [(xii)] **(L)** A representative of a coordinated care organization; and[,]

8 [(xiii)] **(M)** A person who works for a [*non-profit*] **nonprofit** organization that advocates for
9 persons who experience or have experienced substance use disorder.

10 (2) A quorum consists of [*nine*] **two-thirds of the members of the council, rounded up to the**
11 **next odd number of members.**

12 (3) The term of office for a member of the council [*shall be*] **is** four years. Vacancies shall be
13 appointed for the unexpired term.

14 (4)(a) To the extent permissible by law, a member of the council performing services for the
15 council may receive compensation from [*his or her*] **the member's** employer for time spent per-
16 forming services as a council member.

17 (b) If a member of the council is not compensated by [*their*] **the member's** employer as set forth
18 in [*subsection (4)(a) of this section*] **paragraph (a) of this subsection**, that member shall be entitled
19 to compensation and expenses as provided in ORS 292.495.

20 [(c) *Nothing in this subsection (4) of this section excuses or exempts a member of the council from*
21 *complying with any applicable provision of Oregon's ethics laws and regulations, including the pro-*
22 *visions of ORS chapter 244.*]

23 **(5) Members of the council are subject to and must comply with ORS 244.045 (4), 244.047,**
24 **244.120 and 244.130.**

25 **SECTION 4.** Section 4, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
26 to read:

27 **Sec. 4.** [*Administration.*] (1)(a) On or before June 30, 2021, the Oversight and Accountability
28 Council shall adopt rules that establish general criteria and requirements for the [*Addiction Recov-*
29 *ery Centers*] **Behavioral Health Resource Networks** and the grants **and funding** required by sec-
30 tion 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**, **including rules requiring**
31 **recipients of grants and funding to collect and report information necessary for the Secre-**
32 **tary of State to conduct the financial and performance audits required by section 24, chapter**
33 **2, Oregon Laws 2021 (Ballot Measure 110 (2020))**.

34 (b) The council shall from time to time adopt such rules, and amend and revise rules [*it*] **the**
35 **council** has adopted, as [*it*] **the council** deems proper and necessary for the administration of [*this*
36 *Act*] **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**, and the performance of [*its*] **the**
37 **council's** work.

38 (2) The council shall have and retain the authority to implement and oversee the [*Addiction*
39 *Recovery Centers created by*] **Behavioral Health Resource Networks established under** section
40 **2, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**, and the grants [*program created and*
41 *required by*] **and funding under** section 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110**
42 **(2020))**.

43 (3) The Oregon Health Authority[, *Health Systems Division Behavioral Health Services*] shall
44 administer and provide all necessary support to ensure the implementation of [*this Act*] **chapter 2,**
45 **Oregon Laws 2021 (Ballot Measure 110 (2020))**.

1 (4)(a) The [*Oregon Health Authority, Health Systems Division Behavioral Health Services,*] **au-**
2 **thority**, in consultation with the council, may enter into interagency agreements to ensure proper
3 distribution of funds for the grants [*created and*] required by section 2, **chapter 2, Oregon Laws**
4 **2021 (Ballot Measure 110 (2020))**.

5 (b) The [*Oregon Health Authority, Health Systems Division Behavioral Health Services*] **authority**
6 shall encourage and take all reasonable measures to ensure that grant recipients cooperate, coord-
7 inate and act jointly with one another to offer the services described in section 2, **chapter 2,**
8 **Oregon Laws 2021 (Ballot Measure 110 (2020))**.

9 (c) **The authority shall post to the authority's website, at the time a grant or funding is**
10 **awarded:**

11 (A) **The name of the recipient of the grant or funding;**

12 (B) **The names of any subgrantees or subcontractors of the recipient of the grant or**
13 **funding; and**

14 (C) **The amount of the grant or funding awarded.**

15 (5) The [*Oregon Health Authority, Health Systems Division Behavioral Health Services*] **authority**
16 shall provide requested technical, logistical and other support to the council to assist the council
17 with [*its*] **the council's** duties and obligations.

19 **FUNDING**

20
21 **SECTION 5.** Section 5, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
22 to read:

23 **Sec. 5.** (1) The Drug Treatment and Recovery Services Fund is established in the State Treas-
24 ury, separate and distinct from the General Fund. Interest earned by the **Drug Treatment and**
25 **Recovery Services** Fund shall be credited to the fund.

26 (2) The Drug Treatment and Recovery Services Fund shall consist of:

27 (a) Moneys deposited into the fund pursuant to section 6, **chapter 2, Oregon Laws 2021 (Ballot**
28 **Measure 110 (2020))**;

29 (b) Moneys appropriated or otherwise transferred to the fund by the Legislative Assembly;

30 (c) Moneys allocated from the Oregon Marijuana Account, pursuant to ORS 475B.759 (7); [*and,*]

31 (d) **Moneys allocated from the Criminal Fine Account pursuant to ORS 137.300 (4); and**

32 [*(d)*] (e) All other moneys deposited [*in*] **into** the fund from any source.

33 (3) Moneys in the fund shall be continuously appropriated to the Oregon Health Authority for
34 the purposes set forth in section 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**.

35 [(4) *Unexpended moneys in the fund may not lapse and shall be carried forward and may be used*
36 *without regard to fiscal year or biennium.*]

5 **SECTION 6.** Section 6, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
 6 to read:

7 **Sec. 6.** (1) The Department of Revenue shall credit and transfer or cause to be credited and
 8 transferred to the Drug Treatment and Recovery Services Fund the savings to the State of Oregon
 9 from the implementation of [*this Act*] **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**,

37 to ORS 475B.070 on the last business day of the calendar quarter preceding the date of the transfer
38 for all premises located in each county compared to the total commercially available area of all
39 grow canopies associated with marijuana producer licenses held pursuant to ORS 475B.070 on the
40 last business day of that calendar quarter for all premises located in this state; and

41 (ii) Fifty percent of the 10 percent must be transferred in shares that reflect the number of li-
42 censes held pursuant to ORS 475B.090, 475B.100 and 475B.105 on the last business day of the cal-
43 endar quarter preceding the date of the transfer for premises located in each county compared to
44 the number of licenses held pursuant to ORS 475B.090, 475B.100 and 475B.105 on the last business
45 day of that calendar quarter for all premises in this state.

1 (c) After making the transfer of moneys required by subsection (7) of this section, [eighty] 80
2 percent of the remaining moneys in the Oregon Marijuana Account must be used as follows:

3 (A) Forty percent of the moneys in the account must be used solely for purposes for which
4 moneys in the State School Fund established under ORS 327.008 may be used;

5 (B) Twenty percent of the moneys in the account must be used solely for mental health treat-

39 dividual is:

40 (a) \$2,000 for a Class A violation.

41 (b) \$1,000 for a Class B violation.

44 (e) \$100[*or, in lieu of the fine, a completed health assessment as specified in section 2 (2)(b)(ii)*
45 *or section 23 (2),*] for a Class E violation.

3 (3) If a special corporate fine is specified in the law creating the violation, the sentence to pay
4 a fine shall be governed by the law creating the violation. Except as otherwise provided by law, if
5 a special corporate fine is not specified in the law creating the violation, the maximum fine for a
6 violation committed by a corporation is:

- 7 (a) \$4,000 for a Class A violation.
- 8 (b) \$2,000 for a Class B violation.
- 9 (c) \$1,000 for a Class C violation.
- 10 (d) \$500 for a Class D violation.

11 **SECTION 13.** ORS 153.019 is amended to read:

12 153.019. (1) Except as provided in ORS 153.020 **and sections 22 and 23, chapter 2, Oregon**

 42 respect to the conduct and all intervening circumstances to the specific occupational or professional
 43 standards. There is a rebuttable presumption as to each individual applicant or licensee that an
 44 existing or prior conviction for conduct that has been classified or reclassified as a Class E violation
 45 [*pursuant to section 11 to section 19*] is not related to the fitness and ability of the applicant or

licensee to engage in the activity for which the license is required.

(1) An enforcement officer issuing a citation for a Class E violation shall provide the person receiving the citation with information concerning how the person may complete a screening, as specified in section 2 (2)(d)(B), chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), in lieu of paying a fine.

Upon verification that the person has received a health assessment at an Addiction Recovery Center within 45 days of when the person receives a citation for a violation subject to the penalty set forth in ORS 153.018 (2)(e), the fine shall be waived. Failure to pay the fine shall not be a basis for further penalties or for a term of incarceration.]*

(1) Notwithstanding ORS 153.018, 153.019 and 153.021, and subject to subsection (2) of this section, a person subject to the penalty for a Class E violation may, in lieu of the fine, complete a screening, as set forth in section 2 (2)(d)(B), chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), or any other equivalent or more intensive treatment contact, within 45 days of when the person receives the citation for the Class E violation.

5 *[(3) When an Addiction Recovery Center is established in each coordinated care organization ser-*
6 *vice area, and not later than October 1, 2021, the temporary telephone Addiction Recovery Center shall*
7 *be terminated.]*

8 **(1) Not later than February 1, 2021, the Oregon Health Authority shall establish a Be-**
9 **havioral Health Resource Network statewide telephone hotline to:**

10 **(a) Provide screenings under section 2 (2)(d), chapter 2, Oregon Laws 2021 (Ballot Meas-**
11 **ure 110 (2020)), to any resident in this state by certified addiction peer support or wellness**

REPORT TO LEGISLATIVE ASSEMBLY

1 51.050. (1) Except as otherwise provided in this section, in addition to the criminal jurisdiction
2 of justice courts already conferred upon and exercised by them, justice courts have jurisdiction of
3 all offenses committed or triable in their respective counties. The jurisdiction conveyed by this
4 section is concurrent with any jurisdiction that may be exercised by a circuit court or municipal
5 court.

6 (2) In any justice court that has not become a court of record under ORS 51.025, a defendant
7 charged with a misdemeanor shall be notified immediately after entering a plea of not guilty of the
8 right of the defendant to have the matter transferred to the circuit court for the county where the

10 entered, and the justice shall immediately transfer the case to the appropriate court.

11 (3) A justice court does not have jurisdiction over the trial of any felony or a designated drug-
12 related misdemeanor as defined in ORS 423.478. **A justice court does not have jurisdiction over**
13 **Class E violations.** Except as provided in ORS 51.037, a justice court does not have jurisdiction
14 over offenses created by the charter or ordinance of any city.

15 **SECTION 29.** ORS 221.339 is amended to read:

16 221.339. (1) A municipal court has concurrent jurisdiction with circuit courts and justice courts
17 over all violations committed or triable in the city where the court is located.

18 (2) Except as provided in subsections (3) and (4) of this section, municipal courts have concur-

28 provided in ORS 3.132; and

29 (b) Traffic crimes as defined by ORS 801.545.

30 (5) Subject to the powers and duties of the Attorney General under ORS 180.060, the city at-
31 torney has authority to prosecute a violation of any offense created by statute that is subject to the
32 jurisdiction of a municipal court, including any appeal, if the offense is committed or triable in the
33 city. The prosecution shall be in the name of the state. The city attorney shall have all powers of
34 a district attorney in prosecutions under this subsection.

1 **SECTION 31.** ORS 137.300 is amended to read:

2 137.300. (1) The Criminal Fine Account is established in the General Fund. Except as otherwise
3 provided by law, all amounts collected in state courts as monetary obligations in criminal actions
4 shall be deposited by the courts in the account. All moneys in the account are continuously appro-
5 priated to the Department of Revenue to be distributed by the Department of Revenue as provided
6 in this section. The Department of Revenue shall keep a record of moneys transferred into and out
7 of the account.

8 (2) The Legislative Assembly shall first allocate moneys from the Criminal Fine Account for the
9 following purposes, in the following order of priority:

10 (a) Allocations for public safety standards, training and facilities.

11 (b) Allocations for criminal injuries compensation and assistance to victims of crime and chil-
12 dren reasonably suspected of being victims of crime.

13 (c) Allocations for the forensic services provided by the Oregon State Police, including, but not
14 limited to, services of the Chief Medical Examiner.

15 (d) Allocations for the maintenance and operation of the Law Enforcement Data System.

16 (3) After making allocations under subsection (2) of this section, the Legislative Assembly shall
17 allocate moneys from the Criminal Fine Account for the following purposes:

18 (a) Allocations to the Law Enforcement Medical Liability Account established under ORS
19 414.815.

20 (b) Allocations to the State Court Facilities and Security Account established under ORS 1.178.

21 (c) Allocations to the Department of Corrections for the purpose of planning, operating and
22 maintaining county juvenile and adult corrections programs and facilities and drug and alcohol
23 programs.

24 (d) Allocations to the Oregon Health Authority for the purpose of grants under ORS 430.345 for
25 the establishment, operation and maintenance of alcohol and drug abuse prevention, early inter-
26 vention and treatment services provided through a county.

27 (e) Allocations to the Oregon State Police for the purpose of the enforcement of the laws relat-
28 ing to driving under the influence of intoxicants.

29 (f) Allocations to the Arrest and Return Account established under ORS 133.865.

30 (g) Allocations to the Intoxicated Driver Program Fund established under ORS 813.270.

31 (h) Allocations to the State Court Technology Fund established under ORS 1.012.

32 **(4) Notwithstanding subsections (2) and (3) of this section, the Legislative Assembly shall**
33 **allocate all moneys deposited into the Criminal Fine Account as payment of fines on Class**
34 **E violations to the Drug Treatment and Recovery Services Fund established under section**
35 **5, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)).**

36 [(4)] (5) It is the intent of the Legislative Assembly that allocations from the Criminal Fine
37 Account under subsection (3) of this section be consistent with historical funding of the entities,
38 programs and accounts listed in subsection (3) of this section from monetary obligations imposed in
39 criminal proceedings. Amounts that are allocated under subsection (3)(c) of this section shall be
40 distributed to counties based on the amounts that were transferred to counties by circuit courts

15 containing a detectable amount of ecstasy.

16 (2) 34 months to 72 months, depending on the person's criminal history, if the delivery or man-
17 ufacture involves:

18 (a) 100 grams or more of a mixture or substance containing a detectable amount of cocaine;

19 (b) 100 grams or more of a mixture or substance containing a detectable amount of metham-
20 phetamine, its salts, isomers or salts of its isomers;

21 (c) 50 grams or more of a mixture or substance containing a detectable amount of heroin; [or]

22 **(d) 50 grams or more of a mixture or substance containing a detectable amount of**

28 475.235. (1) It is not necessary for the state to negate any exemption or exception in ORS
29 475.005 to 475.285 and 475.752 to 475.980 in any complaint, information, indictment or other pleading
30 or in any trial, hearing or other proceeding under ORS 475.005 to 475.285 and 475.752 to 475.980.
31 The burden of proof of any exemption or exception is upon the person claiming it.

10 defendant has provided notice of an objection in accordance with subsection (5) of this section.

11 (5) If the defendant intends to object at trial to the admission of a certified copy of an analytical

13 shall file written notice of the objection with the court and serve a copy on the district attorney.

5 135.242. (1) When a defendant is charged with an offense described in subsection (7) of this

7 and shall set a security amount of not less than \$500,000 if the court finds:

8 (a) Except when the defendant is charged by indictment, that there is probable cause to believe
9 that the defendant committed the crime; and

10 (b) By clear and convincing evidence that there is a danger that the defendant will:

45 **SECTION 46.** (1) **Notwithstanding ORS 161.566, a prosecuting attorney may elect to treat**

1 as a Class E violation any offense that would constitute a Class E violation had the offense
2 been committed on or after February 1, 2021, as described in this section.

3 (2) If the prosecuting attorney elects to treat an offense as a Class E violation under this
4 section, with the consent of the defendant and as part of the same hearing, the prosecuting
5 attorney shall move to dismiss the original offense and simultaneously initiate a Class E vi-
6 olation proceeding. In providing consent under this subsection, the defendant waives any
7 challenge to the Class E violation under ORS 131.125.

8 (3) If a Class E violation proceeding is initiated under this section, upon receiving ver-
9 ification that the defendant has obtained a screening or other treatment contact through a
10 Behavioral Health Resource Network, including the telephone hotline described in section 23
