Sponsored by COMMITTEE ON JUDICIARY AND BALLOT MEASURE 110 IMPLEMENTATION (at the request of Senator Floyd Prozanski)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies and provides for implementation of Ballot Measure 110 (2020).

Renames "Addiction Recovery Center" as "Behavioral Health Resource Network" and modifies services that must be provided by networks. Renames "24/7" triage as "screening" and specifies requirements for screening.

Requires Oversight and Accountability Council to provide grants and funding to agencies and organizations to establish Behavioral Health Resource Networks. Modifies requirements for receiving grants and funding. **If money remains available after grants and funding are committed to Behavioral Health Resource Networks, requires counties to provide grants and funding to other agencies or organizations to provide specified services.**

Requires grants and funding to be disbursed to ensure at least one Behavioral Health Network is established within each county by January 1, 2022.

Modifies quorum requirement for council. [*Requires members of council*] **Provides that members of council are subject to provisions of ORS chapter 244, including requirement** to submit statements of economic interest to Oregon Government Ethics Commission.

Requires Oregon Health Authority to post on website information about recipients of grants or funding.

Removes sunset on Behavioral Health Resource Network statewide telephone hotline established by authority. Specifies requirements for hotline.

Directs Division of Audits of office of Secretary of State to conduct performance audits and financial reviews, beginning with real-time audit no later than December 31, 2023. Specifies scope of audits and financial reviews.

Requires authority to quarterly report to Legislative Assembly on expenditures from Drug Treatment and Recovery Services Fund. **Requires authority to report to interim subcommittee of Joint Committee on Ways and Means related to human services specified information about grants and funding awarded.**

Provides that minimum fine for Class E violation is \$45. Directs court to dismiss Class E violation citation upon receiving verification that person completed substance use disorder screening. Requires enforcement officer issuing Class E violation citation to provide person receiving citation with information concerning how person may obtain screening. Directs Legislative Assembly to allocate moneys deposited into Criminal Fine Account as payment of fines on Class E violations to Drug Treatment and Recovery Services Fund. Provides that person may not be charged with crime of failure to appear on Class E violation.

Prohibits juvenile court from waiving Class E violation proceeding to municipal court. Authorizes [*juvenile court to order youth to undergo assessment and treatment if youth is within jurisdiction of court for committing act that, if committed by adult, would constitute*] **youth to enter into formal accountability agreement on** Class E violation. Provides that municipal and justice courts have no jurisdiction over Class E violations.

Makes possession of substantial quantity of Schedule I controlled substance, including heroin, lysergic acid diethylamide, 3,4-methylenedioxymethamphetamine, psilocybin or psilocin, Class B felony punishable by maximum of 10 years' imprisonment, \$250,000 fine, or both. Provides that possession of substantial quantity of Schedule II controlled substance, including cocaine, methamphetamine and fentanyl, constitutes Class C felony punishable by maximum of five years' imprisonment, \$125,000 fine, or both. Reduces penalties for possession of less than 40 pills, tablets, capsules or user units of hydrocodone to Class E violation punishable by maximum of \$100 fine. Establishes substantial quantities of fentanyl for purposes of unlawful delivery, manufacture and possession offenses and mandatory sentences. Authorizes use of presumptive test for controlled substances as prima facie evidence of identity of controlled substance in Class E violation proceeding. Authorizes district attorney to initiate Class E violation proceeding when person is charged with offense that would constitute Class E violation had offense been committed on or after February 1, 2021.

9 **Be It Enacted by the People of the State of Oregon:**

11 **FINDINGS AND POLICY**

12
13 **SECTION 1.** Section 1, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
14 to read:

15 **Sec. 1.** (1)(a) The people of Oregon find that drug addiction and overdoses are a serious problem
16 in Oregon and that Oregon needs to expand access to drug treatment.

17 (b) The people of Oregon further find that a health-based approach to addiction and overdose is
18 more effective, humane and cost-effective than criminal punishments. Making people criminals be-
19 cause they suffer from addiction is expensive, ruins lives and can make access to treatment and
20 recovery more difficult.

21 (2)(a) The purpose of *[this]* **the** Drug Addiction Treatment and Recovery Act of 2020 is to make
22 **screening**, health assessment, treatment and recovery services for drug addiction available to all
23 those who need and want access to those services and to adopt a health approach to drug addiction
24 by removing criminal penalties for low-level drug possession.

25 (b) It is the policy of the State of Oregon that **screening**, health assessment, treatment and re-
26 covery services for drug addiction are available to all those who need and want access to those
27 services.

28 (3) The provisions of *[this Act]* **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**,
29 shall be interpreted consistently with the findings, purposes and policy objectives stated in this
30 section and shall not be limited by any policy set forth in Oregon law that could conflict with or
31 be interpreted to conflict with the purposes and policy objectives stated in this section.

33 **EXPANDING TREATMENT AND SERVICES**

34
35 **SECTION 2.** Section 2, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
36 to read:

37 **Sec. 2.** *[Grants Program. (1) The Oversight and Accountability Council shall oversee and approve*
38 *grants to implement Addiction Recovery Centers and increase access to community care, as set forth*
39 *below.]*

40 *[(2) Addiction Recovery Centers. The Oversight and Accountability Council shall provide grants*
41 *to existing agencies or organizations, whether government or community-based, to create Addiction*
42 *Recovery Centers for the purposes of immediately triaging the acute needs of people who use drugs and*
43 *assessing and addressing any on-going needs thorough intensive case management and linkage to care*
44 *and services.]*

45 *[(a) Grants must be disbursed such that at least one center shall be established within each existing*

1 *coordinated care organization service area. Centers within each existing coordinated care organization*
2 *service area shall be established and operational by October 1, 2021.]*

3 *[(b) Grantees must be able to provide or display an ability to provide the following services to any*
4 *Oregon resident who requests it, in order to receive funding as an Addiction Recovery Center:]*

5 *[(i) 24/7 triage: Centers shall assess a client's need for immediate medical or other treatment shortly*
6 *upon the client's arrival to determine what acute care is needed and where it can be best provided.*
7 *Centers shall provide this service twenty-four hours a day, seven days a week, 365 days a year.]*

8 *[(ii) Health assessment: Centers shall conduct a comprehensive behavioral health needs assessment*
9 *for each client, including a substance use disorder screening by a certified alcohol and drug counselor*
10 *or other credentialed addiction treatment professional. The assessment shall prioritize the self-identified*
11 *needs of the client.]*

12 *[(iii) Individual intervention plan, intensive case management and connection to services: If, after*
13 *the completion of the assessment, the client indicates a desire to address some or all of the identified*
14 *needs, a case manager shall work with the client to design an individual intervention plan. The plan*
15 *must address the client's need for substance use disorder treatment, coexisting health problems, hous-*
16 *ing, employment and training, childcare and other services. Intensive case management requires, in the*
17 *least, that case managers have a sufficiently low staff-to-client ratio to provide daily support as needed*
18 *to connect clients to services and care needed to fulfill the individual intervention plan and have the*
19 *capacity to follow-up to ensure clients are accessing care and, if not, to reconnect clients to care as*
20 *necessary and as desired by clients.]*

21 *[(iv) Peer support: Each center shall offer ongoing peer counseling and support from triage and*
22 *assessment through implementation of individual intervention plans as well as provide peer outreach*
23 *workers to engage directly with marginalized community members who could potentially benefit from*
24 *the center's services.]*

25 *[(v) Outreach: Each center shall assess the need for, and provide, mobile or virtual outreach ser-*
26 *vices to reach clients who are unable to access the center.]*

27 *[(A) Notwithstanding subsection (2)(a) of this section, only one center within each coordinated care*
28 *organization service area is required to provide the triage assessments set forth in subsection (2)(b)(i)*
29 *of this section.]*

30 *[(c) All services provided at the centers must be evidence-informed, trauma-informed, culturally re-*
31 *sponsive, patient-centered, non-judgmental, and centered on principles of harm reduction. The goal of*
32 *the individual intervention plan and intensive case management shall be to address effectively the*
33 *client's substance use disorder and any other factors driving problematic behaviors without employing*
34 *coercion or shame or mandating abstinence.]*

35 *[(d) The centers shall be adequately staffed to address the needs of people with substance use dis-*
36 *order within their regions as determined by the Oversight and Accountability Council, but must in-*
37 *clude, at a minimum, at least one person qualified in each of the following categories:]*

38 *[Certified alcohol and drug counselor or other credentialed addiction treatment professional;]*

39 *[Intensive case manager; and,]*

40 *[(C) Peer support specialist.]*

41 *[(e) Each center shall provide timely verification on behalf of any client who has completed a health*
42 *assessment, as set forth in subsection (2)(b)(ii) of this section, if the client requests such verification to*
43 *comply with section 22 or section 23 (2) of this Act.]*

44 *[(3) Increasing Community Access to Care. The Oversight and Accountability Council shall provide*
45 *grants to existing agencies or organizations, whether government or community based, to increase ac-*

1 *cess to one or more of the following:]*

2 *[(a) Low barrier substance use disorder treatment that is evidence-informed, trauma-informed, cul-*
3 *turally responsive, patient-centered, and non-judgmental;]*

4 *[(b) Peer support and recovery services;]*

5 *[(c) Transitional, supportive, and permanent housing for persons with substance use disorder;]*

6 *[(d) Harm reduction interventions including, but not limited to, overdose prevention education, ac-*
7 *cess to naloxone hydrochloride and sterile syringes, and stimulant-specific drug education and*
8 *outreach.]*

9 *[(4) The council shall prioritize providing grants to community-based nonprofit organizations*
10 *within each coordinated care organization service area. However, if within any such service area a*
11 *community-based nonprofit organization does not apply for a grant or grants are not sought within that*
12 *service area for which services are needed, then the council may request and fund grants to any com-*
13 *munity care organization or county within that service area.]*

14 *[(5) Services provided by grantees, including services provided by Addiction Recovery Centers,*
15 *shall be free of charge to the persons receiving the services. To the extent consistent with applicable*
16 *law, grantees and service providers may seek and obtain reimbursement for services provided to any*
17 *person from any insurer or entity providing insurance to that person.]*

18 **(1) The Oversight and Accountability Council shall oversee and approve grants and**
19 **funding to implement Behavioral Health Resource Networks and increase access to commu-**
20 **nity care, as set forth below. A Behavioral Health Resource Network is an entity or col-**
21 **lection of entities that individually or jointly provide some or all of the services described in**
22 **subsection (2)(d) of this section.**

23 **(2)(a) The Oversight and Accountability Council, in consultation with the Oregon Health**
24 **Authority, shall provide grants and funding to agencies or organizations, whether govern-**
25 **ment or community based, to establish Behavioral Health Resource Networks for the pur-**
26 **poses of immediately screening the acute needs of people who use drugs and assessing and**
27 **addressing any ongoing needs through ongoing case management, harm reduction, treat-**
28 **ment, housing and linkage to other care and services. Recipients of grants or funding to**
29 **provide substance use disorder treatment or services must be licensed, certified or creden-**
30 **tialed by the state, including certification under ORS 743A.168 (7), or meet criteria prescribed**
31 **by rule by the Oversight and Accountability Council under section 4, chapter 2, Oregon Laws**
32 **2021 (Ballot Measure 110 (2020)). A recipient of a grant or funding under this subsection may**
33 **not use the grant or funding to supplant the recipient's existing funding.**

34 **(b) The council and the authority shall ensure that residents of each county have access**
35 **to all of the services described in paragraph (d) of this subsection.**

36 **(c) Applicants for grants and funding may apply individually or jointly with other network**
37 **participants to provide services in one or more counties.**

38 **(d) A network must have the capacity to provide the following services and any other**
39 **services specified by the council by rule:**

40 **(A) Screening by certified addiction peer support or wellness specialists or other qualified**
41 **persons designated by the council to determine a client's need for immediate medical or**
42 **other treatment to determine what acute care is needed and where it can be best provided,**
43 **identify other needs and link the client to other appropriate local or statewide services, in-**
44 **cluding treatment for substance abuse and coexisting health problems, housing, employment,**
45 **training and child care. Networks shall provide this service 24 hours a day, seven days a**

1 week, every calendar day of the year. Notwithstanding paragraph (b) of this subsection, only
2 one grantee in each network within each county is required to provide the screenings de-
3 scribed in this subparagraph.

4 (B) Comprehensive behavioral health needs assessment, including a substance use disorder
5 screening by a certified alcohol and drug counselor or other credentialed addiction
6 treatment professional. The assessment shall prioritize the self-identified needs of a client.

7 (C) Individual intervention planning, case management and connection to services. If,
8 after the completion of a screening, a client indicates a desire to address some or all of the
9 identified needs, a case manager shall work with the client to design an individual inter-
10 vention plan. The plan must address the client's need for substance use disorder treatment,
11 coexisting health problems, housing, employment and training, child care and other services.

12 (D) Ongoing peer counseling and support from screening and assessment through imple-
13 mentation of individual intervention plans as well as peer outreach workers to engage di-
14 rectly with marginalized community members who could potentially benefit from the
15 network's services.

16 (E) Assessment of the need for, and provision of, mobile or virtual outreach services to:

17 (i) Reach clients who are unable to access the network; and

18 (ii) Increase public awareness of network services.

19 (F) Harm reduction services and information and education about harm reduction ser-
20 vices.

21 (G) Low-barrier substance use disorder treatment.

22 (H) Transitional and supportive housing for individuals with substance use disorders.

23 (e) If an applicant for a grant or funding under this subsection is unable to provide all
24 of the services described in paragraph (d) of this subsection, the applicant may identify how
25 the applicant intends to partner with other entities to provide the services, and the Oregon
26 Health Authority and the council may facilitate collaboration among applicants.

27 (f) All services provided through the networks must be evidence-informed, trauma-
28 informed, culturally specific, linguistically responsive, person-centered and nonjudgmental.
29 The goal shall be to address effectively the client's substance use and any other social de-
30 terminants of health.

31 (g) The networks must be adequately staffed to address the needs of people with sub-
32 stance use disorders within their regions as prescribed by the council by rule, including, at
33 a minimum, at least one person qualified by the Oregon Health Authority in each of the
34 following categories:

35 (A) Certified alcohol and drug counselor or other credentialed addiction treatment pro-
36 fessional;

37 (B) Case manager; and

38 (C) Certified addiction peer support or wellness specialist.

39 (h) Verification of a screening by a certified addiction peer support specialist, wellness
40 specialist or other person in accordance with subsection (2)(d)(A) of this section shall
41 promptly be provided to the client by the entity conducting the screening. If the client exe-
42 cutes a valid release of information, the entity shall provide verification of the screening to
43 the Oregon Health Authority or a contractor of the authority and the authority or the
44 authority's contractor shall forward the verification to the court, in the manner prescribed
45 by the Chief Justice of the Supreme Court, to satisfy the conditions for dismissal under

1 section 22, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), or section 46 of this 2021
2 Act.

3 (3)(a) If moneys remain in the Drug Treatment and Recovery Services Fund after the
4 council has committed grants and funding to establish behavioral health resource networks
5 serving every county in this state, the council shall provide grants and funding to other
6 agencies or organizations, whether government or community based, and to the nine feder-
7 ally recognized tribes in this state and service providers that are affiliated with the nine
8 federally recognized tribes in this state to increase access to one or more of the following:

9 (A) Low-barrier substance use disorder treatment that is evidence-informed, trauma-
10 informed, culturally specific, linguistically responsive, person-centered and nonjudgmental;

11 (B) Peer support and recovery services;

12 (C) Transitional, supportive and permanent housing for persons with substance use dis-
13 order;

14 (D) Harm reduction interventions including, but not limited to, overdose prevention ed-
15 ucation, access to naloxone hydrochloride and sterile syringes and stimulant-specific drug
16 education and outreach; or

17 (E) Incentives and supports to expand the behavioral health workforce to support the
18 services delivered by behavioral health resource networks and entities receiving grants or
19 funding under this subsection.

20 (b) A recipient of a grant or funding under this subsection may not use the grant or
21 funding to supplant the recipient's existing funding.

22 (4) In awarding grants and funding under subsections (2) and (3) of this section, the
23 council shall:

24 (a) Distribute grants and funding to ensure access to:

25 (A) Historically underserved populations; and

26 (B) Culturally specific and linguistically responsive services.

27 (b) Consider any inventories or surveys of currently available behavioral health services.

28 (c) Consider available regional data related to the substance use disorder treatment
29 needs and the access to culturally specific and linguistically responsive services in commu-
30 nities in this state.

31 (d) Consider the needs of residents of this state for services, supports and treatment at
32 all ages.

33 (5) The council shall require any government entity that applies for a grant to specify in
34 the application details regarding subgrantees and how the government entity will fund cul-
35 turally specific organizations and culturally specific services. A government entity receiving
36 a grant must make an explicit commitment not to supplant or decrease any existing funding
37 used to provide services funded by the grant.

38 (6) In determining grants and funding to be awarded, the council may consult the com-
39 prehensive addiction, prevention, treatment and recovery plan established by the Alcohol and
40 Drug Policy Commission under ORS 430.223 and the advice of any other group, agency, or-
41 ganization or individual that desires to provide advice to the council that is consistent with
42 the terms of this section.

43 (7) Services provided by grantees, including services provided by a Behavioral Health
44 Resource Network, shall be free of charge to the clients receiving the services. Grantees in
45 each network shall seek reimbursement from insurance issuers, the medical assistance pro-

1 **gram or any other third party responsible for the cost of services provided to a client and**
2 **grants and funding provided by the council or the authority under subsection (2) of this**
3 **section may be used for copayments, deductibles or other out-of-pocket costs incurred by the**
4 **client for the services.**

5 **(8) Subsection (7) of this section does not require the medical assistance program to re-**
6 **imburse the cost of services for which another third party is responsible in violation of 42**
7 **U.S.C. 1396a(25).**

8 **SECTION 2a.** (1) **Grants and funding under section 2 (2), chapter 2, Oregon Laws 2021**
9 **(Ballot Measure 110 (2020)), must be disbursed such that at least one Behavioral Health Re-**
10 **source Network is established and operational within each county by January 1, 2022.**

11 **(2) If the recipients of grants and funding under section 2 (2), chapter 2, Oregon Laws**
12 **2021 (Ballot Measure 110 (2020)), cannot provide all of the services described in section 2**
13 **(2)(d), chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), within a county by January**
14 **1, 2022, the Oversight and Accountability Council and the Oregon Health Authority shall is-**
15 **sue additional requests for proposals to provide the necessary services.**

16 **SECTION 3.** Section 3, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
17 to read:

18 **Sec. 3.** [*Oversight and Accountability Council.*] (1)(a) The Director of the Oregon Health Au-
19 thority shall establish an Oversight and Accountability Council for the purpose of determining how
20 funds will be distributed to grant applicants and to oversee the implementation of the [*Centers*]
21 **Behavioral Health Resource Networks** pursuant to section 2, **chapter 2, Oregon Laws 2021**
22 **(Ballot Measure 110 (2020))**. The council shall be formed on or before February 1, 2021.

23 [(a)] (b) The council shall [*be comprised*] **consist** of qualified individuals with experience in
24 substance use disorder treatment and other addiction services. The council shall consist of at least
25 one member from each of the following categories only:

26 [(i)] (A) A representative of the Oregon Health Authority, Health Systems Division Behavioral
27 Health Services **as a nonvoting member;**

28 [(ii)] (B) Three members of communities that have been disproportionately impacted by arrests,
29 prosecution or sentencing for conduct that has been classified or reclassified as a Class E violation
30 [*pursuant to section 11 to section 19.*];

31 [(iii)] (C) A physician specializing in addiction medicine;

32 [(iv)] (D) A licensed clinical social worker;

33 [(v)] (E) An evidence-based substance use disorder provider;

34 [(vi)] (F) A harm reduction services provider;

35 [(vii)] (G) A person specializing in housing services for people with substance use disorder or
36 a diagnosed mental health condition;

37 [(viii)] (H) An academic researcher specializing in drug use or drug policy;

38 [(ix)] (I) At least two people who suffered or suffer from substance use disorder;

39 [(x)] (J) At least two recovery peers;

40 [(xi)] (K) A mental or behavioral health **care** provider;

41 [(xii)] (L) A representative of a coordinated care organization; [*and,*]

42 [(xiii)] (M) A person who works for a [*non-profit*] **nonprofit** organization that advocates for
43 persons who experience or have experienced substance use disorder[.]; **and**

44 (N) **The Director of the Alcohol and Drug Policy Commission or the director's designated**
45 **staff person, as a nonvoting member.**

1 (2) A quorum consists of *[nine]* **two-thirds of the members of the council, rounded up to the**
2 **next odd number of members.**

3 (3) The term of office for a member of the council *[shall be]* **is** four years. Vacancies shall be
4 appointed for the unexpired term.

5 (4)(a) To the extent permissible by law, a member of the council performing services for the
6 council may receive compensation from *[his or her]* **the member's** employer for time spent per-
7 forming services as a council member.

8 (b) If a member of the council is not compensated by *[their]* **the member's** employer as set forth
9 in *[subsection (4)(a) of this section]* **paragraph (a) of this subsection**, that member shall be entitled
10 to compensation and expenses as provided in ORS 292.495.

11 *[(c) Nothing in this subsection (4) of this section excuses or exempts a member of the council from*
12 *complying with any applicable provision of Oregon's ethics laws and regulations, including the pro-*
13 *visions of ORS chapter 244.]*

14 (5) **Members of the council are subject to and must comply with the provisions of ORS**
15 **chapter 244, including ORS 244.045 (4), 244.047, 244.120 and 244.130.**

16 **SECTION 4.** Section 4, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
17 to read:

18 **Sec. 4.** *[Administration.]* (1)(a) On or before June 30, 2021, the Oversight and Accountability
19 Council shall adopt rules that establish general criteria and requirements for the *[Addiction Recov-*
20 *ery Centers]* **Behavioral Health Resource Networks** and the grants **and funding** required by sec-
21 tion 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**, **including rules requiring**
22 **recipients of grants and funding to collect and report information necessary for the Secre-**
23 **tary of State to conduct the financial and performance audits required by section 24, chapter**
24 **2, Oregon Laws 2021 (Ballot Measure 110 (2020)).**

25 (b) The council shall from time to time adopt such rules, and amend and revise rules *[it]* **the**
26 **council** has adopted, as *[it]* **the council** deems proper and necessary for the administration of *[this*
27 *Act]* **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**, and the performance of *[its]* **the**
28 **council's** work.

29 (2) The council shall have and retain the authority to implement and oversee the *[Addiction*
30 *Recovery Centers created by]* **Behavioral Health Resource Networks established under** section
31 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**, and the grants *[program created and*
32 *required by]* **and funding under** section 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110**
33 **(2020)).**

34 (3) The Oregon Health Authority*[, Health Systems Division Behavioral Health Services]* shall

42 (b) The *[Oregon Health Authority, Health Systems Division Behavioral Health Services]* **authority**
43 shall encourage and take all reasonable measures to ensure that grant recipients cooperate, coor-
44 dinate and act jointly with one another to offer the services described in section 2, **chapter 2,**
45 **Oregon Laws 2021 (Ballot Measure 110 (2020)).**

1 (c) **The authority shall post to the authority’s website, at the time a grant or funding is**
2 **awarded:**

3 (A) **The name of the recipient of the grant or funding;**

4 (B) **The names of any subgrantees or subcontractors of the recipient of the grant or**
5 **funding; and**

6 (C) **The amount of the grant or funding awarded.**

7 (5) The [*Oregon Health Authority, Health Systems Division Behavioral Health Services*] **authority**
8 shall provide requested technical, logistical and other support to the council to assist the council

10 (6) **The Department of Justice shall provide legal services to the council if requested to**

26 [*d*] (e) All other moneys deposited [*in*] **into** the fund from any source.

27 (3) Moneys in the fund shall be continuously appropriated to the Oregon Health Authority for
28 the purposes set forth in section 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**.

29 [*4*] *Unexpended moneys in the fund may not lapse and shall be carried forward and may be used*
30 *without regard to fiscal year or biennium.*]

31 [(5)(a)] (4)(a) Pursuant to subsection (2)(b) of this section, the Legislative Assembly shall ap-
32 propriate or transfer to the fund an amount sufficient to fully fund the grants program required by
33 section 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**.

42 [(ii)] (B) [*An amount not less than the increase*] **The annual increase, if any**, in moneys dis-
43 tributed pursuant to ORS 475B.759 (7).

44 **SECTION 6.** Section 6, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended
45 to read:

1 **Sec. 6.** (1) The Department of Revenue shall credit and transfer or cause to be credited and
 2 transferred to the Drug Treatment and Recovery Services Fund the savings to the State of Oregon
 3 from the implementation of [*this Act*] **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**,

25 to the number of licenses held pursuant to ORS 475B.070, 475B.090, 475B.100 and 475B.105 on the
26 last business day of that calendar quarter for all premises in this state located in cities; and

27 (B) Ten percent of the moneys in the account must be transferred to counties in the following
28 shares:

29 (i) Fifty percent of the 10 percent must be transferred in shares that reflect the total commer-
30 cially available area of all grow canopies associated with marijuana producer licenses held pursuant
31 to ORS 475B.070 on the last business day of the calendar quarter preceding the date of the transfer
32 for all premises located in each county compared to the total commercially available area of all
33 grow canopies associated with marijuana producer licenses held pursuant to ORS 475B.070 on the
34 last business day of that calendar quarter for all premises located in this state; and

35 (ii) Fifty percent of the 10 percent must be transferred in shares that reflect the number of li-
36 censes held pursuant to ORS 475B.090, 475B.100 and 475B.105 on the last business day of the cal-
37 endar quarter preceding the date of the transfer for premises located in each county compared to
38 the number of licenses held pursuant to ORS 475B.090, 475B.100 and 475B.105 on the last business
39 day of that calendar quarter for all premises in this state.

40 (c) After making the transfer of moneys required by subsection (7) of this section, [*eighty*] **80**
41 percent of the remaining moneys in the Oregon Marijuana Account must be used as follows:

42 (A) Forty percent of the moneys in the account must be used solely for purposes for which
43 moneys in the State School Fund established under ORS 327.008 may be used;

44 (B) Twenty percent of the moneys in the account must be used solely for mental health treat-
45 ment or for alcohol and drug abuse prevention, early intervention and treatment;

1 (C) Fifteen percent of the moneys in the account must be used solely for purposes for which
2 moneys in the State Police Account established under ORS 181A.020 may be used; and

3 (D) Five percent of the moneys in the account must be used solely for purposes related to al-
4 cohol and drug abuse prevention, early intervention and treatment services.

5 (4)(a) A city that has an ordinance prohibiting the establishment of a premises for which issu-
6 ance of a license under ORS 475B.070, 475B.090, 475B.100 or 475B.105 is required is not eligible to
7 receive transfers of moneys under subsection (3)(b)(A) of this section.

8 (b) A county that has an ordinance prohibiting the establishment of a premises for which issu-
9 ance of a license under ORS 475B.070 is required is not eligible to receive transfers of moneys under
10 subsection (3)(b)(B)(i) of this section.

11 (c) A county that has an ordinance prohibiting the establishment of a premises for which issu-
12 ance of a license under ORS 475B.090, 475B.100 or 475B.105 is required is not eligible to receive
13 transfers of moneys under subsection (3)(b)(B)(ii) of this section.

14 (5)(a) A city or county that is ineligible under subsection (4) of this section to receive a transfer
15 of moneys from the Oregon Marijuana Account during a given quarter but has received a transfer
16 of moneys for that quarter shall return the amount transferred to the Department of Revenue, with
17 interest as described under paragraph (f) of this subsection. An ineligible city or county may vol-
18 untarily transfer the moneys to the Department of Revenue immediately upon receipt of the ineligi-
19 ble transfer.

20 (b) If the Director of the Oregon Department of Administrative Services determines that a city
21 or county received a transfer of moneys under subsection (3)(b) of this section but was ineligible to
22 receive that transfer under subsection (4) of this section, the director shall provide notice to the

32 (7) Specific fine violations as described in ORS 153.015.

33 **SECTION 12.** ORS 153.018, as amended by section 19, chapter 2, Oregon Laws 2021 (Ballot
34 Measure 110 (2020)), is amended to read:

35 153.018. (1) The penalty for committing a violation is a fine. The law creating a violation may
36 impose other penalties in addition to a fine but may not impose a term of imprisonment.

37 (2) Except as otherwise provided by law, the maximum fine for a violation committed by an in-
38 dividual is:

39 (a) \$2,000 for a Class A violation.

40 (b) \$1,000 for a Class B violation.

41 (c) \$500 for a Class C violation.

42 (d) \$250 for a Class D violation.

43 (e) \$100[*or, in lieu of the fine, a completed health assessment as specified in section 2 (2)(b)(ii)*
44 *or section 23 (2),*] for a Class E violation.

45 (f) \$2,000 for a specific fine violation, or the maximum amount otherwise established by law for

1 the specific fine violation.

2 (3) If a special corporate fine is specified in the law creating the violation, the sentence to pay
3 a fine shall be governed by the law creating the violation. Except as otherwise provided by law, if
4 a special corporate fine is not specified in the law creating the violation, the maximum fine for a
5 violation committed by a corporation is:

- 6 (a) \$4,000 for a Class A violation.
- 7 (b) \$2,000 for a Class B violation.
- 8 (c) \$1,000 for a Class C violation.
- 9 (d) \$500 for a Class D violation.

10 **SECTION 13.** ORS 153.019 is amended to read:

11 153.019. (1) Except as provided in ORS 153.020 **and sections 22 and 23, chapter 2, Oregon**
12 **Laws 2021 (Ballot Measure 110 (2020))**, the presumptive fines for violations are:

38 (4) The Department of Revenue or Secretary of State may audit any court to determine whether
39 the court is complying with the requirements of this section. In addition, the Department of Revenue
40 or Secretary of State may audit any court to determine whether the court is complying with the
41 requirements of ORS 137.145 to 137.159 and 153.640 to 153.680. The Department of Revenue or Sec-
42 retary of State may file an action under ORS 34.105 to 34.240 to enforce the requirements of this
43 section and of ORS 137.145 to 137.159 and 153.640 to 153.680.

32 *to section 11 to section 19*] does not make an applicant for an occupational or professional license
33 or a licensee with an occupational or professional license unfit to receive or hold the license.

41 respect to the conduct and all intervening circumstances to the specific occupational or professional
42 standards. There is a rebuttable presumption as to each individual applicant or licensee that an

44 [*pursuant to section 11 to section 19*] is not related to the fitness and ability of the applicant or
45 licensee to engage in the activity for which the license is required.

18 (b) An offense classified as a violation **other than a Class E violation** under the laws of this state or a political subdivision of this state be waived to municipal court if the municipal court has agreed to accept jurisdiction; and

19 (c) A misdemeanor that entails theft, destruction, tampering with or vandalism of property be waived to municipal court if the municipal court has agreed to accept jurisdiction.

20 (2) Cases waived under subsection (1) of this section are subject to the following:

21 (a) That the criminal or municipal court prior to hearing a case, other than a case involving a parking violation, in which the defendant is or appears to be under 18 years of age notify the juve-

1 nile court of that fact; and

2 (b) That the juvenile court may direct that any such case be waived to the juvenile court for
3 further proceedings.

4 (3)(a) When a person who has been waived under subsection (1)(c) of this section is convicted
5 of a property offense, the municipal court may impose any sanction authorized for the offense except
6 for incarceration. The municipal court shall notify the juvenile court of the disposition of the case.

7 (b) When a person has been waived under subsection (1) of this section and fails to appear as
8 summoned or is placed on probation and is alleged to have violated a condition of the probation, the
9 juvenile court may recall the case to the juvenile court for further proceedings. When a person has
10 been returned to juvenile court under this paragraph, the juvenile court may proceed as though the
11 person had failed to appear as summoned to the juvenile court or had violated a juvenile court
12 probation order under ORS 419C.446.

1 (c) Allocations to the Department of Corrections for the purpose of planning, operating and
2 maintaining county juvenile and adult corrections programs and facilities and drug and alcohol
3 programs.

4 (d) Allocations to the Oregon Health Authority for the purpose of grants under ORS 430.345 for
5 the establishment, operation and maintenance of alcohol and drug abuse prevention, early inter-
6 vention and treatment services provided through a county.

7 (e) Allocations to the Oregon State Police for the purpose of the enforcement of the laws relat-
8 ing to driving under the influence of intoxicants.

9 (f) Allocations to the Arrest and Return Account established under ORS 133.865.

11 (h) Allocations to the State Court Technology Fund established under ORS 1.012.

19 methamphetamine, its salts, isomers or salts of its isomers;

20 [(D)] (E) Two hundred or more user units of a mixture or substance containing a detectable
21 amount of lysergic acid diethylamide;

22 [(E)] (F) Sixty grams or more of a mixture or substance containing a detectable amount of
23 psilocybin or psilocin; or

24 [(F)] (G) Five grams or more or 25 or more pills, tablets or capsules of a mixture or substance
25 containing a detectable amount of:

26 (i) 3,4-methylenedioxyamphetamine;
