**PROPOSED AMENDMENTS TO
HOUSE BILL 2522**

1 On page 1 of the printed bill, delete lines 4 through 31.

2 On page 2, delete lines 1 and 2 and insert:

3 **“SECTION 1. ORS 803.036 is amended to read:**

4 **“803.036. (1) As used in this section:**

5 **“(a) ‘Mobile home park’ has the meaning given that term in ORS 446.003.**

6 **“(b) ‘Park model recreational vehicle’ means a recreational vehicle, as**
7 **defined in ORS 174.101, that:**

8 **“(A) Is designed for use as temporary living quarters;**

9 **“(B) Is built on a single chassis mounted on wheels;**

10 **“(C) Has a gross trailer area that does not exceed 400 square feet;**

11 **“(D) Is more than eight and one-half feet wide;**

12 **“(E) Complies with any manufacturing standards that the Director of**
13 **Transportation recognizes as being in widespread use and applicable to park**
14 **model recreational vehicles; and**

15 **“(F) Meets any other requirements imposed by the director by rule.**

16 **“(2) The Department of Transportation, by rule, may provide for optional**
17 **titling under ORS 803.035 for:**

18 **“(a) Park model recreational vehicles; and**

19 **“(b) Vehicles that no longer meet the definition of park model rec-**
20 **reational vehicle, but that:**

21 **“(A) As originally manufactured, met the definition of park model**

1 **recreational vehicle; and**

2 **“(B) Were first used as living quarters on or before January 1,**
3 **2021.**

4 **“(3) The department may not issue a registration for a park model recre-**
5 **ational vehicle or former park model recreational vehicle.**

6 **“[(3)] (4) The department may require an applicant for optional titling to:**

7 **“(a) Provide a manufacturer certificate or other information the depart-**
8 **ment deems adequate for ensuring that the vehicle was constructed in com-**
9 **pliance with manufacturing standards described in subsection (1)(b)(E) of**
10 **this section; and**

11 **“(b) Attest that the vehicle:**

12 **“(A) Is not permanently affixed to land for use as a permanent dwelling;**
13 **or**

14 **“(B) Is located within a mobile home park.**

15 **“(5) Titles issued under subsection (2)(b) of this section are for the**
16 **purpose of facilitating the documentation of ownership and sales of**
17 **park model recreational vehicles. In issuing a title, the department**
18 **does not make any claims about the suitability, fitness, safety, quality**
19 **or lawfulness of the vehicle’s use as living quarters or for transporta-**
20 **tion and does not assume liability for the vehicle’s use for any pur-**
21 **pose.”.**
