**PROPOSED AMENDMENTS TO  
HOUSE BILL 2264**

1 In line 2 of the printed bill, after “alcohol;” delete the rest of the line and  
2 insert “creating new provisions; and amending ORS 471.130.”.

3 Delete lines 4 through 10 and insert:

4 **“SECTION 1. Sections 2 and 3 of this 2021 Act are added to and**  
5 **made a part of ORS chapter 471.**

6 **“SECTION 2. Notwithstanding ORS 471.175, an Indian tribe that**  
7 **holds a full on-premises sales license may purchase distilled liquor for**  
8 **sale by the drink within Indian country directly from the Oregon Li-**  
9 **quor Control Commission at a price negotiated by the Indian tribe and**  
10 **the commission. As used in this section, ‘Indian country’ has the**  
11 **meaning given that term in 18 U.S.C. 1151.**

12 **“SECTION 3. Notwithstanding ORS 471.175, an airline described in**  
13 **ORS 471.182 that holds a full on-premises sales license may purchase**  
14 **distilled liquor for sale to ticketed passengers aboard a commercial**  
15 **aircraft directly from the Oregon Liquor Control Commission at a**  
16 **price negotiated by the airline and the commission.**

17 **“SECTION 4. ORS 471.130 is amended to read:**

18 **“471.130. (1) [All licensees and permittees of the Oregon Liquor Control**  
19 **Commission,] Before selling or serving an alcoholic [liquor] beverage to any**  
20 **person about whom there is any reasonable doubt of the person’s having**  
21 **reached 21 years of age, a licensee or permittee shall require [such] the**

1 person to produce one of the following pieces of identification:

2 “(a) The person’s passport issued by the United States or a foreign gov-  
3 ernment.

4 “(b) The person’s motor vehicle operator’s license issued by this state or  
5 another state of the United States **or a province or territory of Canada.**

6 “(c) An identification card issued under ORS 807.400.

7 “(d) A United States military identification card.

8 “(e) An identification card issued by a federally recognized Indian tribe.

9 “(f) Any other identification card issued by a state or territory of the  
10 United States **or province or territory of Canada** that bears a picture of  
11 the person, the name of the person, the person’s date of birth and a physical  
12 description of the person.

13 “(g) Proof of the person’s participation in the Secure Electronic Network  
14 for Travelers Rapid Inspection program operated by United States Customs  
15 and Border Protection, the NEXUS program jointly operated by that agency  
16 and the Canada Border Services Agency, or a successor to either of those  
17 programs that is recognized by the **Oregon Liquor Control Commission.**

18 “(h) **Any other form of identification as defined by the commission**  
19 **by rule.**

20 “(2) If a person does not have identification as described in subsection (1)  
21 of this section, the permittee or licensee shall require [*such*] **the** person to  
22 make a written statement of age and furnish evidence of the person’s true  
23 age and identity. The written statement of age shall be on a form furnished  
24 or approved by the commission, including but not limited to the following  
25 information:

10 true age with the intent of obtaining alcohol in violation of ORS chapter 471  
11 may be subject to criminal penalties under ORS 165.805.
