**PROPOSED AMENDMENTS TO
HOUSE BILL 2697**

1 On page 1 of the printed bill, delete lines 4 through 29 and delete page
2 2 and insert:

3 **“SECTION 1. (1) As used in this section:**

4 **“(a)(A) ‘Bias incident’ means a person’s hostile expression of**
5 **animus toward another person, relating to the other person’s per-**
6 **ceived race, color, religion, gender identity, sexual orientation, disa-**
7 **bility or national origin, of which criminal investigation or**
8 **prosecution is impossible or inappropriate.**

9 **“(B) ‘Bias incident’ may include derogatory language or behavior.**

10 **“(b) ‘Education program’ means any program, service, school or**
11 **activity sponsored by an education provider.**

12 **“(c) ‘Education provider’ means:**

13 **“(A) A school district;**

14 **“(B) A public charter school;**

15 **“(C) The Oregon School for the Deaf;**

16 **“(D) An education service district;**

17 **“(E) An educational program under the Youth Corrections Educa-**
18 **tion Program or the Juvenile Detention Education Program, as those**
19 **terms are defined in ORS 326.695; or**

20 **“(F) A program that receives moneys pursuant to ORS 343.243.**

21 **“(d) ‘School property’ means any property under the control of an**

1 education provider.

2 “(e) ‘Symbol of hate’ means nooses, symbols of neo-Nazi ideology
3 or the battle flag of the Confederacy.

4 “(2)(a) To comply with the prohibition on discrimination required
5 by ORS 659.850, an education provider must prohibit the display of
6 symbols of hate on school property or in an education program.

7 “(b) The prohibition required by this subsection does not apply to
8 displays that align with and are used in conjunction with state stan-
9 dards of education for public schools.

10 “(3) To comply with the prohibition on discrimination required by
11 ORS 659.850, each education provider must adopt a policy to address
12 bias incidents and displays of symbols of hate. The policy must:

13 “(a) Affirm that all students are entitled to a high quality educa-
14 tional experience free from discrimination or harassment based on
15 perceived race, color, religion, gender identity, sexual orientation,
16 disability or national origin.

17 “(b) Affirm that all employees of education providers are entitled
18 to work in an environment that is free from discrimination or
19 harassment based on perceived race, color, religion, gender identity,
20 sexual orientation, disability or national origin.

21 “(c) Affirm that all visitors of an education provider are entitled to
22 participate in a school or educational environment that is free from
23 discrimination or harassment based on perceived race, color, religion,
24 gender identity, sexual orientation, disability or national origin.

25 “(d) Prohibit the display of symbols of hate on school property or
26 in an education program.

27 “(e) Establish procedures for addressing bias incidents and displays
28 of symbols of hate. The procedures must:

29 “(A) Apply broadly to include persons directly targeted by an act,
30 as well as the community of students as a whole who are likely to be

1 impacted by the act.

2 “(B) Require the education provider to prioritize the safety and
3 well-being of all persons impacted by the act.

4 “(C) Require the education provider to recognize the experience of
5 all persons impacted by the act, acknowledge the impact, commit to
6 taking immediate action and commit to preventing further harm
7 against those persons impacted.

8 “(D) Include educational components that:

9 “(i) Address the history and impact of bias and hate;

10 “(ii) Advance the safety and healing of those impacted by bias and
11 hate; and

12 “(iii) Promote accountability and transformation for people who
13 cause harm as well as transformation of the conditions that perpet-
14 uated the harm.

15 “(E) Include communication protocols that provide all persons im-
16 pacted by the act with information relating to the investigation and
17 outcome of the investigation, including:

18 “(i) Notice that an investigation has been initiated;

19 “(ii) Notice when an investigation has been completed;

20 “(iii) The findings of the investigation and the final determination
21 based on those findings;

22 “(iv) Actions taken to remedy a person’s behavior and prevent re-
23 occurrence; and

24 “(v) When applicable, the legal citation of any law prohibiting the
25 disclosure of any of the information described in this subparagraph
26 and an explanation of how that law applies to the current situation.

27 “(F) Direct the education provider to consider whether the act im-
28 plicates other civil rights laws and, if so, to respond accordingly. The
29 nature of the act must determine:

30 “(i) The process used to respond to the act;

1 “(ii) The rights and protections available to the person impacted by
2 the act; and

3 “(iii) The right to appeal to the Department of Education or to the
4 United States Department of Education.

5 “(G) Require the education provider to develop and implement in-
6 structional materials to make this policy and related practices, in-
7 cluding reporting procedures, educational processes and possible
8 consequences, known to all employees and students of the education
9 provider.

10 “(4) Any education provider that violates this section or a policy
11 adopted under this section shall be:

12 “(a) Considered to be in noncompliance with the provisions of ORS
13 659.850;

14 “(b) Subject to the sanctions for noncompliance of ORS 659.850 un-
15 der ORS 659.855; and

16 “(c) Subject to the enforcement provisions of ORS 659.850 by ORS
17 659.860.”.
