As used in ORS 475B.010 to 475B.545: 10 "(1) 'Cannabinoid' means any of the chemical compounds that are the 11 active constituents derived from marijuana. 12 "(2) 'Cannabinoid concentrate' means a substance obtained by separating 13 cannabinoids from marijuana by: 14 "(a) A mechanical extraction process; 15 "(b) A chemical extraction process using a nonhydrocarbon-based solvent, 16 such as water, vegetable glycerin, vegetable oils, animal fats, isopropyl al-17 cohol or ethanol; 18 "(c) A chemical extraction process using carbon dioxide, provided that the 19 process does not involve the use of high heat or pressure; or 20

"(12) 'Housing unit' means a house, an apartment or a mobile home, or a group of rooms or a single room that is occupied as separate living quarters, in which the occupants live and eat separately from any other persons in the building and that has direct access from the outside of the building or through a common hall.

16 "(13) 'Immature marijuana plant' means a marijuana plant that is not 17 flowering.

"(14) 'Licensee' means a person that holds a license issued under ORS
475B.070, 475B.090, 475B.100 or 475B.105.

"(15) 'Licensee representative' means an owner, director, officer, manager,
employee, agent or other representative of a licensee, to the extent that the

"(29) 'Noncommercial' means not dependent or conditioned upon the provision or receipt of financial consideration.

"(A) All public and private enclosed areas at the location that are used in the business operated at the location, including offices, kitchens, rest rooms and storerooms;
