4 383.014, 383.015, 383.017, 383.035, 383.045, 383.075 and 383.150; repealing ORS
5 383.006, 383.013, 383.023, 383.065 and 383.155; and prescribing an effective
6 date”.

9 **“TRANSPORTATION PROJECTS**
10

11 **“SECTION 1. ORS 367.095 is amended to read:**

12 “367.095. (1) The following amounts shall be distributed in the manner
13 prescribed in this section:

14 “(a) The amount attributable to the increase in tax rates by section 45,
15 chapter 750, Oregon Laws 2017, and the amendments to ORS 319.020 and
16 319.530 by sections 40 to 43, chapter 750, Oregon Laws 2017.

17 “(b) The amount attributable to the vehicle registration and title fees
18 imposed under ORS 803.091 and 803.422.

19 “(c) The amount attributable to the increase in taxes and fees by the
20 amendments to ORS 803.420, 803.645, 818.225, 818.270, 825.476, 825.480 and
21 826.023 by sections 34, 35, 48, 49, 51, 52, 54, 63, 64, 66, 67 and 70, chapter 750,

1 Oregon Laws 2017.

2 “(2) The amounts described in subsection (1) of this section shall be dis-
3 tributed in the following order and for the following purposes:

4 “(a)(A) For calendar years beginning on or after January 1, 2022, \$30
5 million per year shall be used **to pay** for [*the Interstate 5 Rose Quarter*
6 *Project*]:

7 “(i) **Interstate highway projects that are partially funded with toll**
8 **revenues, are located on interstate highways within the region where**
9 **toll revenues are generated and are of statewide significance;**

10 “(ii) **The implementation of the toll program established under ORS**
11 **383.150; and**

12 “(iii) **The department’s costs related to the jurisdictional transfer**
13 **of 82nd Avenue from the Department of Transportation to the City of**
14 **Portland not to exceed the amounts described under ORS 366.483**
15 **(1)(c).**

16 “(B) [*This*] **The amount described in subparagraph (A) of this para-**
17 **graph shall be used to pay for [*the Interstate 5 Rose Quarter Project,*] costs,**
18 **including project costs on a current basis and paying for debt service on**
19 **bonds issued to finance the [*project*] projects, jurisdictional transfer or**
20 **toll program, only until the later of the date on which the [*project*] projects**
21 **or jurisdictional transfer is completed or on which all bonds issued to fund**
22 **the [*project*] projects, jurisdictional transfer or toll program have been**
23 **repaid. Any remaining moneys shall be distributed as described in subsection**
24 **(3) of this section.**

25 “(b) \$10 million per year shall be deposited into the Safe Routes to
26 Schools Fund for the purpose of providing Safe Routes to Schools matching
27 grants under ORS 184.742. The remainder of the moneys shall be distributed
28 as described in subsection (3) of this section.

29 “(3) The moneys described in subsection (1) of this section that remain
30 after the allocation of moneys described in subsection (2) of this section shall

1 be allocated as follows:

2 “(a) 50 percent to the Department of Transportation.

3 “(b) 30 percent to counties for distribution as provided in ORS 366.762.

4 “(c) 20 percent to cities for distribution as provided in ORS 366.800.

5 “(4) The moneys described in subsection (3)(a) of this section or equiv-
6 alent amounts that become available to the Department of Transportation
7 shall be allocated as follows:

8 “(a) \$10 million for safety.

9 “(b) Of the remaining balance:

10 “(A) Forty percent for bridges.

11 “(B) Thirty percent for seismic improvements related to highways and
12 bridges.

13 “(C) Twenty-four percent for state highway pavement preservation and
14 culverts.

15 “(D) Six percent for state highway maintenance and safety improvements.

16 “(5) For the purposes of this section, the regions are as follows:

17 “(a) **Region one consists of Clackamas, Hood River, Multnomah and
18 Washington Counties.**

19 “(b) **Region two consists of Benton, Clatsop, Columbia, Lane,
20 Lincoln, Linn, Marion, Polk, Tillamook and Yamhill Counties.**

21 “(c) **Region three consists of Coos, Curry, Douglas, Jackson and
22 Josephine Counties.**

23 “(d) **Region four consists of Crook, Deschutes, Gilliam, Jefferson,
24 Klamath, Lake, Sherman, Wasco and Wheeler Counties.**

25 “(e) **Region five consists of Baker, Grant, Harney, Malheur,
26 Morrow, Umatilla, Union and Wallowa Counties.**

27 “**SECTION 2.** ORS 367.095, as amended by section 47, chapter 491, Oregon
28 Laws 2019, is amended to read:

29 “367.095. (1) The following amounts shall be distributed in the manner
30 prescribed in this section:

1 “(a) The amount attributable to the increase in tax rates by section 45,
2 chapter 750, Oregon Laws 2017, and the amendments to ORS 319.020 and
3 319.530 by sections 40 to 43, chapter 750, Oregon Laws 2017.

4 “(b) The amount attributable to the vehicle registration and title fees
5 imposed under ORS 803.091 and 803.422.

6 “(c) The amount attributable to the increase in taxes and fees by the
7 amendments to ORS 803.420, 803.645, 818.225, 825.476, 825.480 and 826.023 by
8 sections 34, 35, 48, 49, 51, 52, 63, 64, 66, 67 and 70, chapter 750, Oregon Laws
9 2017.

10 “(2) The amounts described in subsection (1) of this section shall be dis-
11 tributed in the following order and for the following purposes:

12 “(a)(A) \$30 million per year shall be used **to pay** for [*the Interstate 5 Rose*
13 *Quarter Project*]:

14 “(i) **Interstate highway projects that are partially funded with toll**
15 **revenues, are located on interstate highways within the region where**
16 **toll revenues are generated and are of statewide significance;**

17 “(ii) **The implementation of the toll program established under ORS**
18 **383.150; and**

19 “(iii) **The department’s costs related to the jurisdictional transfer**
20 **of 82nd Avenue from the Department of Transportation to the City of**
21 **Portland not to exceed the amounts described under ORS 366.483**
22 **(1)(c).**

23 “(B) [*This*] **The amount described in subparagraph (A) of this para-**
24 **graph** shall be used to pay for [*the Interstate 5 Rose Quarter Project*] **costs,**
25 including project costs on a current basis and paying for debt service on
26 bonds issued to finance the [*project*] **projects, jurisdictional transfer or**
27 **toll program,** only until the later of the date on which the [*project*]
28 **projects, jurisdictional transfer or toll program** is completed or on which
29 all bonds issued to fund the [*project*] **projects, jurisdictional transfer or**
30 **toll program** have been repaid. Any remaining moneys shall be distributed

2 “(b) \$15 million per year shall be deposited into the Safe Routes to
3 Schools Fund for the purpose of providing Safe Routes to Schools matching
4 grants under ORS 184.742. The remainder of the moneys shall be distributed
5 as described in subsection (3) of this section.

6 “(3) The moneys described in subsection (1) of this section that remain
7 after the allocation of moneys described in subsection (2) of this section shall
8 be allocated as follows:

9 “(a) 50 percent to the Department of Transportation.

10 “(b) 30 percent to counties for distribution as provided in ORS 366.762.

11 “(c) 20 percent to cities for distribution as provided in ORS 366.800.

12 “(4) The moneys described in subsection (3)(a) of this section or equiv-
13 alent amounts that become available to the Department of Transportation

5 **“SHORT-TERM BORROWING**

6
7 **“SECTION 3.** ORS 367.105 is amended to read:

8 “367.105. (1) In addition to the authority for short-term borrowing granted
9 in ORS 286A.025 (2)(d) and 286A.045, the Department of Transportation, act-
10 ing through the State Treasurer, may borrow money by entering into a credit
11 agreement, a line of credit or a revolving line of credit, or by issuing a note,
12 a warrant, a short-term promissory note, commercial paper or another simi-
13 lar obligation, for the following purposes:

14 “(a) Providing matching funds as set forth in ORS 366.564.

15 “(b) Providing funds with which to pay when due the principal or interest
16 of bonded indebtedness created for highway purposes, the payment of which
17 is necessary to preserve the financial credit of the state.

18 “(c) Meeting emergencies.

19 “(d) Providing funds for use by the department during times when ex-
20 penditures exceed revenues, whether or not the department anticipated that
21 expenditures would exceed revenues.

22 “(e) Providing funds for the payment of current expenses in anticipation
23 of revenue, grants or other moneys intended for payment of the current ex-
24 penses.

25 “(f) Providing funds for interim financing of a capital asset or project to
26 be undertaken by the department.

27 “(g) Refunding an outstanding obligation.

28 “(2) Short-term borrowing under this section may be in such denomi-
29 nations or for such sums as the department fixes and may draw interest at
30 a negotiated rate.

1 population and growing transportation needs, and all available alternative
2 sources of funding should be utilized to supplement available public sources
3 of revenues.

4 “(3) Because public funding sources are not providing the state with suf-
5 ficient funds to meet all of its transportation needs, private funding should
6 be encouraged as an additional source of funding for transportation projects
7 and facilities.

8 “(4) Various alternatives for utilizing the funds of private entities in the
9 acquisition, design, construction, reconstruction, operation and maintenance
10 of transportation facilities exist, including arrangements whereby private
11 entities obtain exclusive agreements to design, build, own, lease or operate
12 with private funds all or a portion of transportation projects and facilities
13 in exchange for the right to receive certain revenues generated from the
14 operation and utilization of such transportation projects and facilities.

15 “(5) Another important alternative for the funding of transportation fa-
16 cilities is the use of federal funds pursuant to 23 U.S.C. 129(a), as amended
17 by section 112 of the Intermodal Surface Transportation Efficiency Act of
18 1991, which established a program authorizing federal participation in con-
19 struction of publicly or privately owned toll highways, bridges and tunnels.

20 “(6) The federal legislation allows for a mix of federal funding and private
21 funding of transportation facilities, allowing the states to leverage available
22 federal funds as a means for attracting private capital.

23 “(7) Legislation for the utilization of private funding of transportation
24 facilities should be flexible enough to permit the Department of Transporta-
25 tion to obtain the advantages of any available alternative under which the
26 acquisition, design, construction, reconstruction, operation, maintenance and
27 repair of transportation facilities can be financed in whole or in part or in
28 combination by any available sources of private or public funding.

29 “(8) The funding of transportation facilities through the imposition of
30 tolls on those who use such facilities is a fair and impartial means of as-

1 assessing the costs of improvements against those who most benefit from such
2 improvements, and is consistent with public policy.

3 “(9) Joint endeavors of public and private entities do the following:

4 “(a) Take advantage of private sector efficiencies in designing, con-
5 structing and operating transportation projects.

6 “(b) Allow for the rapid formation of capital necessary for funding
7 transportation projects.

8 “(c) Require continued compliance with environmental requirements and
9 applicable state and federal laws that all publicly financed projects must
10 address.

11 **“(10) Significant traffic congestion adversely impacts Oregon’s**
12 **economy and the quality of life of Oregon’s communities. Where ap-**
13 **propriate, the selective use of tolling may help reduce traffic con-**
14 **gestion and support the state’s greenhouse gas emissions reduction**
15 **goals.**

16 **“SECTION 4b.** ORS 383.003 is amended to read:

17 “383.003. As used in ORS 383.003 to 383.075:

18 “(1) ‘Department’ means the Department of Transportation.

19 “[2) ‘*Electronic toll collection system*’ means a system that records use of
20 a tollway by electronic transmissions to or from the vehicle using the tollway
21 and that collects tolls, or that is capable of charging an account established
22 by a person for use of the tollway.]

23 “[3) ‘*Photo enforcement system*’ means a system of sensors installed to work
24 in conjunction with an electronic toll collection system and other traffic control
25 devices and that automatically produces videotape or one or more photographs,
26 microphotographs or other recorded images of a vehicle in connection with the
27 collection or enforcement of tolls.]

28 **“(2) ‘Electronic toll collection system’ means a system for collecting**
29 **tolls that:**

30 **“(a) Does not require a vehicle to stop at a toll booth to pay the toll;**

1 **and**

2 **“(b) Uses transponder readers and license plate capture cameras to**
3 **aid in collecting tolls.**

4 “[4] (3) ‘Private entity’ means any nongovernmental entity, including a
5 corporation, partnership, company or other legal entity, or any natural per-
6 son.

7 “[5] (4) ‘Related facility’ means any real or personal property that:

8 “(a) Will be used to operate, maintain, renovate or facilitate the use of
9 the tollway;

10 “(b) Will provide goods or services to the users of the tollway; or

11 “(c) [*Can be developed efficiently when tollways are developed and*] Will
12 generate revenue that may be used to reduce tolls or will be deposited in the
13 [*State Tollway Account*] **Toll Program Fund.**

14 “[6] (5) ‘Toll’ means any fee or charge for the use of a tollway.

15 “[7] ‘Toll booth collections’ means the manual or mechanical collection of
16 cash or charging of an account at a toll plaza, toll booth or similar fixed toll
17 collection facility.]

18 “[8] (6) ‘Tollway’ means any roadway, path, highway, bridge, tunnel,
19 railroad track, bicycle path or other paved surface or structure specifically
20 designed as a land vehicle transportation route **for the use of which tolls**
21 **are assessed**[, *the construction, operation or maintenance of which is wholly*
22 *or partially funded with toll revenues resulting from an agreement under ORS*
23 *383.005*].

24 “[9] (7) ‘Tollway operator’ means the unit of government or the private
25 entity that is responsible for **all or any portion of** the construction, recon-
26 struction, [*installation,*] improvement, financing, maintenance, repair and
27 operation of a tollway or a related facility.

28 “[10] (8) ‘Tollway project’ means any capital project involving the [*ac-*
29 *quisition of land for, or the construction, reconstruction, improvement, instal-*
30 *lation,*] development, **operation** or equipping of[,] a tollway, related facilities

1 or any portion thereof.

2 “(9) ‘Tollway project revenue bonds’ means revenue bonds desig-
3 nated as tollway project revenue bonds under section 17 of this 2021
4 Act.

5 “[11] (10) ‘Unit of government’ means any department or agency of the
6 federal government, any state, any department or agency of a state, any
7 bistate entity created by agreement under ORS 190.420 or other law for the
8 purposes of the Interstate 5 bridge replacement project, and any city, county,
9 district, port or other public corporation organized and existing under stat-
10 utory law or under a voter-approved charter.

11 “**SECTION 5.** ORS 383.004 is amended to read:

12 “383.004. (1) Except as provided in subsection (2) of this section, a toll
13 may not be established unless the Oregon Transportation Commission has
14 reviewed and approved the toll. The commission shall adopt rules specifying
15 the process under which proposals to establish tolls will be reviewed. When
16 reviewing a proposal to establish tolls, the commission shall take into con-
17 sideration:

18 “(a) The amount and classification of the traffic using, or anticipated to
19 use, the tollway;

20 “(b) The amount of the toll proposed to be established for each class or
21 category of tollway user and, if applicable, the different amounts of the toll
22 depending on time and day of use;

23 “(c) The extent of the tollway, including improvements necessary for
24 tollway operation and improvements necessary to support the flow of traffic
25 onto or off of the tollway;

26 “(d) The location of [*toll plazas or toll collection devices*] **toll booths or**
27 **electronic toll collection systems** to collect the toll for the tollway;

28 “(e) The cost of constructing, reconstructing, improving, installing,
29 maintaining, repairing and operating the tollway;

30 “(f) The amount of indebtedness incurred for the construction of the

1 tollway and **all expenses and obligations related to the indebtedness**
2 **including, without limitation, financial covenants,** debt service require-
3 ments, **reserve requirements and any other funding requirements es-**
4 **tablished under the terms of any indenture prepared under section 20**
5 **of this 2021 Act and any other contracts establishing the terms of the**
6 **indebtedness, if any;**

7 “(g) The value of assets, equipment and services required for the opera-
8 tion of the tollway;

9 “(h) The period of time during which the toll will be in effect;

10 “(i) The process for altering the amount of the toll during the period of
11 operation of the tollway;

12 “(j) The method of collecting the toll; and

13 “(k) The rate of return that would be fair and reasonable for a private
14 equity holder, if any, in the tollway.

15 “(2)(a) Nothing in ORS 383.003 to 383.075 prohibits a city or county from
16 establishing a toll on any highway, as defined in ORS 801.305, that the city
17 or county has jurisdiction over as a road authority pursuant to ORS 810.010.

18 “(b) Nothing in ORS 383.003 to 383.075 prohibits Multnomah County from
19 establishing a toll on the bridges across the Willamette River that are within
20 the boundaries of the City of Portland and that are operated and maintained
21 by Multnomah County as required under ORS 382.305 and 382.310.

22 “**SECTION 6.** ORS 383.009 is amended to read:

23 “383.009. (1) There is hereby established the [*State Tollway Account*] **Toll**
24 **Program Fund** as a separate [*account*] **and distinct fund** [*within*] **from** the
25 [*State Highway Fund*] **General Fund**. The [*State Tollway Account*] **Toll**
26 **Program Fund** shall consist of:

27 “(a) All moneys and revenues received by the Department of Transporta-
28 tion from or made available by the federal government to the department for
29 any tollway project or for the operation or maintenance of any tollway;

30 “(b) Any moneys received by the department from any other unit of gov-

1 ernment or any private entity for a tollway project or from the operation or
2 maintenance of any tollway;

3 “(c) All moneys and revenues received by the department from any
4 **agreement entered into or** loan made by the department for a tollway
5 project pursuant to ORS 383.005, and from any lease, agreement, franchise
6 or license for the right to the possession and use, operation or management
7 of a tollway project;

8 “(d) All tolls and other revenues received by the department **or tollway**
9 **operator** from the users of any tollway project;

10 “(e) The proceeds of any bonds authorized to be issued for tollway
11 projects;

12 “(f) Any moneys that the department has legally transferred from the
13 State Highway Fund to the [*State Tollway Account*] **Toll Program Fund** for
14 tollway projects;

15 “(g) All moneys and revenues received by the department from all other
16 sources that by **gift, bequest, donation, grant, contract or law from any**
17 **public or private source are for deposit in the fund** [*are allocated or*
18 *dedicated for tollway projects*];

19 “(h) All interest earnings on investments made from any of the moneys
20 held in the [*State Tollway Account*] **Toll Program Fund**; [*and*]

21 “(i) All civil penalties and administrative fees paid to the department
22 from the enforcement of tolls[.];

23 “(j) **Fees paid to the department for information provided under**
24 **ORS 383.075;**

25 “(k) **Moneys appropriated for deposit in or otherwise transferred to**
26 **the Toll Program Fund by the Legislative Assembly; and**

27 “(L) **Moneys received from federal sources or other state or local**
28 **sources, excluding proceeds of Highway User Tax Bonds issued under**
29 **ORS 367.615 that finance projects other than toll projects.**

30 “(2) Moneys in the [*State Tollway Account*] **Toll Program Fund** may be

1 used by the department for the following purposes:

2 “(a) To finance preliminary studies and reports for any tollway project;

3 “(b) To acquire land to be owned by the state for tollways and any related
4 facilities therefor;

5 “(c) To finance the construction, renovation, operation, improvement,
6 maintenance or repair of any tollway project;

7 “(d) To make grants or loans to a unit of government for tollway projects;

8 “(e) To make loans to private entities for tollway projects;

9 “(f) To pay the principal, interest and premium due with respect to, and
10 to pay the costs connected with the issuance or ongoing administration of,
11 any bonds or other financial obligations authorized to be issued by, or the
12 proceeds of which are received by, the department for any tollway project,
13 **including capitalized interest and any rebates or penalties due to the**
14 **United States in connection with the bonds;**

15 “(g) To provide a guaranty or other security for any bonds or other fi-
16 nancial obligations, including but not limited to financial obligations with
17 respect to any bond insurance, surety or credit enhancement device issued
18 or incurred by the department, a unit of government or a private entity, for
19 the purpose of financing a single tollway project or any related group or
20 system of [tollways] **tollway projects** or related facilities; [and]

21 “(h) To pay the costs incurred by the department in connection with its
22 oversight, operation and administration of the [State Tollway Account] **Toll**
23 **Program Fund**, the proposals and projects submitted under ORS 383.015 and
24 the tollway projects financed under ORS 383.005[.]; **and**

25 “(i) **To develop, implement and administer the toll program estab-**
26 **lished under ORS 383.150, including the cost of consultants, advisors,**
27 **attorneys or other professional service providers appointed, retained**
28 **or approved by the department.**

29 “(3) For purposes of paying or securing bonds or providing a guaranty,
30 surety or other security authorized by [subsection (2)(g) of] this section, the

1 department may:

2 “(a) Irrevocably pledge all or any portion of the amounts that are credited
3 to, or are required to be credited to, the [*State Tollway Account*] **Toll Pro-**
4 **gram Fund**;

5 “(b) Establish subaccounts in the [*State Tollway Account*] **Toll Program**
6 **Fund**, and make covenants regarding the credit to and use of amounts in
7 those [*accounts and*] subaccounts; and

8 “(c) Establish separate trust funds or accounts and make covenants to
9 transfer to those separate trust funds or accounts all or any portion of the
10 amounts that are required to be deposited in the [*State Tollway Account*]
11 **Toll Program Fund**.

12 “(4) Notwithstanding any other provision of ORS 383.001 to 383.075, the
13 department shall not pledge any funds or amounts at any time held in the
14 [*State Tollway Account*] **Toll Program Fund** as security for the obligations
15 of a **unit of government or a** private entity unless the department has en-
16 tered into a binding and enforceable agreement that provides the department
17 reasonable assurance that the department will be repaid, with appropriate
18 interest, any amounts that the department is required to advance pursuant
19 to that pledge.

20 “(5) Moneys in the [*State Tollway Account*] **Toll Program Fund** are
21 continuously appropriated to the department for purposes authorized by this
22 section.

23 “(6) **Moneys in the Toll Program Fund that are transferred from the**
24 **State Highway Fund or are derived from any revenues under Article**
25 **IX, section 3a, of the Oregon Constitution, may be used only for pur-**
26 **poses authorized by Article IX, section 3a, of the Oregon Constitution.**

27 “**SECTION 7. The Toll Program Fund is a continuation of the State**
28 **Tollway Account. Moneys contained in the State Tollway Account on**
29 **the effective date of this 2021 Act are considered to be moneys in the**
30 **Toll Program Fund.**

1 **“SECTION 8. ORS 383.155 is repealed.**

2 **“SECTION 9. (1) The Congestion Relief Fund, established under**
3 **ORS 383.155, is abolished.**

4 **“(2) Any moneys remaining in the Congestion Relief Fund on the**
5 **effective date of this 2021 Act that are unexpended, unobligated and**
6 **not subject to any conditions shall be transferred to the Toll Program**
7 **Fund established under ORS 383.009.**

8 **“SECTION 10. ORS 383.014 is amended to read:**

9 **“383.014. [The Oregon Transportation Commission shall set standards by**
10 **rule for electronic toll collection systems and photo enforcement systems used**
11 **on tollways in this state to ensure that systems used in Oregon and systems**
12 **used in the State of Washington are compatible to the extent technology per-**
13 **mits.] The Oregon Transportation Commission shall establish criteria**
14 **when selecting electronic toll collection systems used in this state to**
15 **ensure interoperability with tolling systems used in other states, to**

3 **“SECTION 18. Sources of funds to secure revenue bonds for tollway**

9 “(g) Provide for other matters affecting the issuance of bonds.

10 “(h) Provide for a debt service reserve pursuant to ORS 286A.025 (6).

11 “(i) Provide for certain covenants pursuant to ORS 286A.025 (4)(c)
12 and ORS 286A.102 (10).

13 “SECTION 21. Reserve account. (1) The Department of Transporta-
14 tion may establish one or more separate reserve accounts within, or
15 separate and distinct from, the Toll Program Fund in connection with
16 the issuance of tollway project revenue bonds issued under section 17
17 of this 2021 Act.

18 “(2) The moneys held in any account established under this section
19 may be subject to the provisions of any revenue declaration or
20 indenture prepared under section 20 of this 2021 Act.

21 “SECTION 22. Bond form, issuance and maturity; provisions subject
22 to determination of State Treasurer. (1) A tollway project revenue
23 bond issued under section 17 of this 2021 Act:

24 “(a) Must contain on its face a statement that the ad valorem tax-
25 ing power of this state is not pledged to the payment of the principal
26 or the interest on the bond.

27 “(b) Shall be issued as provided in ORS chapter 286A.

28 “(c) Must mature on or before a date determined by calculation of
29 the expected economic life of the improvements, assets and projects
30 financed with the proceeds of the bond.

1 “(2) The State Treasurer shall determine, after consultation with
2 the Department of Transportation, all aspects relating to the sale of
3 bonds under section 17 of this 2021 Act that are not otherwise specif-
4 ically provided in sections 17 to 22 of this 2021 Act.

9 “SECTION 24. ORS 367.010 is amended to read:

10 “367.010. As used in this chapter:

11 “(1) ‘Agency’ means any department, agency or commission of the State
12 of Oregon.

13 “(2) ‘Bond’ means [*an evidence of indebtedness*] **a contractual under-**
14 **taking or an instrument to borrow money** including, but not limited to,
15 a bond, a note, an obligation, a loan agreement, a financing lease, a financ-
16 ing agreement or other similar instrument or agreement.

17 “(3) ‘Bond debt service’ means payment of:

18 “(a) Principal, interest, premium, if any, or purchase price of a bond;

19 “(b) Amounts due to a credit enhancement provider, trustee, paying
20 agent, **commercial paper dealer** or remarketing agent authorized by this
21 chapter;

22 “(c) Amounts necessary to fund bond debt service reserves; and

23 “(d) Amounts due under an agreement for exchange of interest rates if
24 designated by the State Treasurer or the Department of Transportation.

25 “(4) ‘Credit enhancement’ means a credit enhancement device, as defined
26 in ORS 286A.001.

27 “(5) ‘Financial institution’ means a banking institution, a financial insti-
28 tution or a non-Oregon institution, as those terms are defined in ORS
29 706.008, and any other institution defined by rule of the Oregon Transporta-
30 tion Commission as a financial institution for purposes of ORS 367.010 to

1 367.067.

2 “(6) ‘Infrastructure assistance’ means any use of moneys in the Oregon
3 Transportation Infrastructure Fund, other than an infrastructure loan, to
4 provide financial assistance for transportation projects. The term includes,
5 but is not limited to, use of moneys in the infrastructure fund to finance
6 leases, fund reserves, make grants, pay issuance costs or provide credit en-
7 hancement or other security for bonds issued by a public entity to finance
8 transportation projects.

9 “(7) ‘Infrastructure bonds’ means bonds authorized by ORS 367.030, 367.555
10 to 367.600 or 367.605 to 367.665 that are issued to fund infrastructure loans
11 and the proceeds of which are deposited in the infrastructure fund.

12 “(8) ‘Infrastructure fund’ means the Oregon Transportation Infrastructure
13 Fund.

14 “(9) ‘Infrastructure loan’ means a loan of moneys in the infrastructure
15 fund to finance a transportation project.

19 “(11) ‘Transportation project’ means any project or undertaking that fa-
20 cilitates any mode of transportation within this state. The term includes, but
21 is not limited to, a project for highway, transit, rail and aviation capital
22 infrastructure, bicycle and pedestrian paths, bridges and ways, and other
23 projects that facilitate the transportation of materials, animals or people.

24 “**SECTION 25.** ORS 367.555 is amended to read:

25 “367.555. (1) The Department of Transportation may request the State
26 Treasurer to issue general obligation bonds of the State of Oregon used to
27 provide funds to defray the costs of building and maintaining permanent
28 roads, including the costs of location, relocation, improvement, construction
29 and reconstruction of state highways and bridges[, *in an outstanding princi-*
30 *pal amount that is subject to the provisions of ORS 286A.035.*] **and those**

1 portions of a tollway project, as defined in ORS 383.003, that constitute
2 building or maintaining permanent roads.

3 “(2) The principal amount of any bonds issued under this section is
4 subject to the provisions of ORS 286A.035.

5 “SECTION 26. ORS 367.560 is amended to read:

6 “367.560. All moneys obtained from the sale of general obligation bonds
7 under ORS 367.555 to 367.600 must be paid over to the State Treasurer and
8 credited by the State Treasurer to **either** the State Highway Fund **or the**
9 **Toll Program Fund**. Such moneys may be used only for the purposes [*stated*
10 *in ORS 367.555 to 367.600 and, pending the use of such moneys for highway*
11 *purposes*] **for which the bonds were authorized to be sold and, pending**
12 **the use of the moneys**, may be invested as provided by law.

13 “SECTION 27. ORS 367.615 is amended to read:

14 “367.615. (1) The Department of Transportation may request the State
15 Treasurer to issue and sell revenue bonds known as Highway User Tax
16 Bonds as provided in this section.

17 “(2) Bonds issued under this section do not constitute a debt or general
18 obligation of this state or any political subdivision of this state but are se-
19 cured and payable from moneys described under ORS 367.605. A holder of
20 bonds issued under this section may not compel the exercise of the ad
21 valorem taxing power of the state to pay the bond debt service on the bonds.

22 “(3) This state shall provide for the continued assessment, levy, collection
23 and deposit into the highway fund of moneys described under ORS 367.605
24 in amounts sufficient to pay, when due, the annual bond debt service and
25 other amounts necessary to meet requirements established by indenture un-
26 der ORS 367.640.

27 “(4) This state may not in any way impair obligations of any agreement
28 between this state and the holders of bonds issued under this section.

29 “(5) The authority granted by this section is continuing and the depart-
30 ment reserves the right to request the State Treasurer to issue additional

2 “(a) Additional bonds must be secured equally and ratably by the pledge
3 and appropriation of moneys described under ORS 367.605 unless the State
4 Treasurer, as permitted by law and the contracts with owners of outstanding
5 Highway User Tax Bonds, issues additional bonds in different series and se-
6 cures each series by a lien on and pledge of moneys described under ORS
7 367.605 that is superior to or subordinate to the lien of the pledge securing
8 any other series of Highway User Tax Bonds.

9 “(b) The State Treasurer may only issue additional bonds **under this**
10 **section** if sufficient moneys described under ORS 367.605 may be pledged to
11 pay the annual bond debt service for all outstanding bonds issued under this
12 section as well as for the additional bonds.

13 “(6) Proceeds from the sale of bonds under this section are declared to
14 be for the purpose of building and maintaining permanent public roads and
15 may be used:

16 “(a) To finance the cost of state highway, county road and city street
17 projects in this state.

18 “(b) To pay the cost of issuing the bonds.

19 “(c) For loans to cities and counties as provided under ORS 367.035 or
20 367.655.

21 “(d) To pay the bond debt service of the bonds.

22 “(e) To pay the costs of the State Treasurer and the department to ad-
23 minister and maintain the bonds and the Highway User Tax Bond program,
24 including the cost of consultants, advisors, attorneys or other professional
25 service providers appointed, retained or approved by the treasurer or the
26 department.

27 “(f) To pay capitalized interest, principal or premium, if any, of the bonds.

28 “(g) For rebates or penalties due to the United States in connection with
29 the bonds.

30 “(7) The State Treasurer, at the request of the department, may issue

1 Highway User Tax Bonds as capital appreciation bonds, auction rate bonds,
2 variable rate bonds, deep discount bonds or deferred interest bonds.

3 “(8) The State Treasurer or the Director of Transportation, if so directed
4 by the treasurer, may obtain credit enhancement or an agreement for ex-
5 change of interest rates to provide additional security or liquidity for the
6 bonds or to provide funding, in lieu of cash, for all or a portion of a bond
7 debt service reserve account established with respect to the bonds.

9 **“CONFORMING AMENDMENTS RELATED TO TOLLING**

10

11 **“SECTION 28.** ORS 366.505 is amended to read:

12 “366.505. (1) **Except as provided in ORS 383.009**, the State Highway
13 Fund shall consist of:

14 “(a) All moneys and revenues derived under and by virtue of the sale of
15 bonds, the sale of which is authorized by law and the proceeds thereof to be
16 dedicated to highway purposes.

17 “(b) All moneys and revenues accruing from the licensing of motor vehi-
18 cles, operators and chauffeurs.

19 “(c) Moneys and revenues derived from any tax levied upon gasoline,
20 distillate, liberty fuel or other volatile and inflammable liquid fuels, except
21 moneys and revenues described in ORS 184.642 (2)(a) that become part of the
22 Department of Transportation Operating Fund.

23 “(d) Moneys and revenues derived from the road usage charges imposed
24 under ORS 319.885.

25 “(e) Moneys and revenues derived from the use tax imposed under ORS
26 320.410.

27 “(f) Moneys and revenues derived from or made available by the federal
28 government for road construction, maintenance or betterment purposes.

29 “(g) All moneys and revenues received from all other sources which by
30 law are allocated or dedicated for highway purposes.

1 “(2) The State Highway Fund shall be deemed and held as a trust fund,
2 separate and distinct from the General Fund, and may be used only for the
3 purposes authorized by law and is continually appropriated for such pur-
4 poses.

5 “(3) Moneys in the State Highway Fund may be invested as provided in
6 ORS 293.701 to 293.857. All interest earnings on any of the funds designated
7 in subsection (1) of this section shall be placed to the credit of the highway
8 fund.

9 **“SECTION 29.** ORS 367.806 is amended to read:

10 “367.806. (1) As part of the Oregon Innovative Partnerships Program es-
11 tablished under ORS 367.804, the Department of Transportation may:

12 “(a) Enter into any agreement or any configuration of agreements relating
13 to transportation projects with any private entity or unit of government or
14 any configuration of private entities and units of government. The subject
15 of agreements entered into under this section may include, but need not be
16 limited to, planning, acquisition, financing, development, design, con-
17 struction, reconstruction, replacement, improvement, maintenance, manage-
18 ment, repair, leasing and operation of transportation projects.

19 “(b) Include in any agreement entered into under this section any fi-
20 nancing mechanisms, including but not limited to the imposition and col-
21 lection of franchise fees or user fees and the development or use of other
22 revenue sources.

23 “(2) As part of the Oregon Innovative Partnerships Program established
24 under ORS 367.804, the department shall enter into agreements to undertake
25 transportation projects the subjects of which include the application of
26 technology standards to determine whether to certify technology, the col-
27 lection of metered use data, tax processing and account management, as
28 these subjects relate to the operation of a road usage charge system pursuant
29 to ORS 319.883 to 319.946.

30 “(3) The agreements among the public and private sector partners entered

1 into under this section must specify at least the following:

2 “(a) At what point in the transportation project public and private sector
3 partners will enter the project and which partners will assume responsibility
4 for specific project elements;

5 “(b) How the partners will share management of the risks of the project;

6 “(c) How the partners will share the costs of development of the project;

7 “(d) How the partners will allocate financial responsibility for cost over-
8 runs;

9 “(e) The penalties for nonperformance;

10 “(f) The incentives for performance;

11 “(g) The accounting and auditing standards to be used to evaluate work
12 on the project; and

13 “(h) Whether the project is consistent with the plan developed by the
14 Oregon Transportation Commission under ORS 184.617 and any applicable
15 regional transportation plans or local transportation system programs and,
16 if not consistent, how and when the project will become consistent with ap-
17 plicable plans and programs.

18 “(4) The department may, either separately or in combination with any
19 other unit of government, enter into working agreements, coordination
20 agreements or similar implementation agreements to carry out the joint im-
21 plementation of any transportation project selected under ORS 367.804.

22 “(5) Except for ORS 383.015[, 383.017 (1), (2), (3) and (5)] and 383.019, the
23 provisions of ORS 383.003 to 383.075 apply to any tollway project entered into
24 under ORS 367.800 to 367.824.

25 “(6) The provisions of ORS 279.835 to 279.855 and ORS chapters 279A,
26 279B and 279C do not apply to concepts or proposals submitted under ORS
27 367.804, or to agreements entered into under this section, except that if
28 public moneys are used to pay any costs of construction of public works that
29 is part of a project, the provisions of ORS 279C.800 to 279C.870 apply to the
30 public works. In addition, if public moneys are used to pay any costs of

1 construction of public works that is part of a project, the construction con-
2 tract for the public works must contain provisions that require the payment
3 of workers under the contract in accordance with ORS 279C.540 and 279C.800
4 to 279C.870.

5 “(7)(a) The department may not enter into an agreement under this sec-
6 tion until the agreement is reviewed and approved by the Oregon Transpor-
7 tation Commission.

8 “(b) The department may not enter into, and the commission may not
9 approve, an agreement under this section for the construction of a public
10 improvement as part of a transportation project unless the agreement pro-
11 vides for bonding, financial guarantees, deposits or the posting of other se-
12 curity to secure the payment of laborers, subcontractors and suppliers who
13 perform work or provide materials as part of the project.

14 “(c) Before presenting an agreement to the commission for approval under
15 this subsection, the department must consider whether to implement proce-
16 dures to promote competition among subcontractors for any subcontracts to
17 be let in connection with the transportation project. As part of its request
18 for approval of the agreement, the department shall report in writing to the
19 commission its conclusions regarding the appropriateness of implementing
20 such procedures.

22 communications and information developed, exchanged or compiled in the
23 course of negotiating an agreement with a private entity under this section
24 are exempt from disclosure under ORS 192.311 to 192.478.

26 graph (a) of this subsection are subject to disclosure under ORS 192.311 to
27 192.478 when the documents, communications or information are submitted
28 to the commission in connection with its review and approval of a trans-
29 portation project under subsection (7) of this section.

30 “(9) The terms of a final agreement entered into under this section and

1 the terms of a proposed agreement presented to the commission for review
2 and approval under subsection (7) of this section are subject to disclosure
3 under ORS 192.311 to 192.478.

4 “(10) As used in this section:

5 “(a) ‘Public improvement’ has the meaning given that term in ORS
6 279A.010.

7 “(b) ‘Public works’ has the meaning given that term in ORS 279C.800.

8 **“SECTION 30.** ORS 367.816 is amended to read:

9 “367.816. (1) Notwithstanding ORS 367.020, the Department of Transpor-
10 tation may use moneys in the Oregon Transportation Infrastructure Fund
11 established by ORS 367.015 to ensure the repayment of loan guarantees or
12 extensions of credit made to or on behalf of private entities engaged in the
13 planning, acquisition, financing, development, design, construction, recon-
14 struction, replacement, improvement, maintenance, management, repair,
15 leasing or operation of any transportation project that is part of the program
16 established under ORS 367.804.

17 “(2) The lien of a pledge made under this section is subordinate to the lien
18 of a pledge securing bonds payable from moneys in the State Highway Fund
19 described in ORS 366.505, the [*State Tollway Account*] **Toll Program Fund**
20 established by ORS 383.009 or the State Transportation Enterprise Fund es-
21 tablished by ORS 367.810.

22 **“SECTION 31.** ORS 381.312 is amended to read:

23 “381.312. (1) The Port of Hood River, or any private entity or unit of
24 government that the port designates to operate a bridge in an agreement the
25 port enters into under ORS 381.205 to 381.314, may establish, collect or alter
26 a reasonable toll, administrative fee or civil penalty in connection with the
27 bridge.

28 “(2) The port or the private entity or unit of government that the port
29 designates shall deposit any proceeds from a toll, administrative fee or civil
30 penalty into an account established under an agreement described in ORS

1 381.310. The port or unit of government shall deposit the share of proceeds
2 that the port or unit of government receives with a depository that meets the
3 requirements set forth in ORS chapter 295. A private entity shall deposit the
4 share of proceeds that the private entity receives with an insured institution,

22 Transportation, by a unit of government having an interest in the installa-
23 tion of a tollway, or by a private entity interested in constructing or oper-
24 ating a tollway project. The department shall charge an administrative fee
25 for reviewing and considering any tollway project proposed by a private en-
26 tity, which the department shall establish by rule. All such administrative

5 ronmental, aesthetic and economic conditions and on the economy of the
6 state in general;

7 “(c) The extent to which funding other than state funding is available for
8 the proposed tollway project;

9 “(d) The likelihood that the estimated use of the tollway project will
10 provide sufficient revenues to independently finance the costs related to the
11 construction and future maintenance, repair and reconstruction of the
12 tollway project, including the repayment of any loans to be made from
13 moneys in the [*State Tollway Account*] **Toll Program Fund**;

14 “(e) With respect to tollway projects, any portion of which will be fi-
15 nanced with state funds or department loans or grants:

16 “(A) The relative importance of the proposed tollway project compared to
17 other proposed tollways; and

18 “(B) Traffic congestion and economic conditions in the communities that
19 will be affected by competing tollway projects; and

20 “(f) The effects of tollway implementation on community and local street
21 traffic.

22 “(3) Notwithstanding any other provision of ORS 383.001 to 383.075, no
23 tollway project shall be authorized unless the department finds that either:

24 “(a) Based on the department’s estimate of present and future traffic
25 patterns, the revenues generated by the tollway project will be sufficient,
26 after payment of all obligations incurred in connection with the acquisition,
27 construction and operation of such tollway project, to ensure the continued
28 maintenance, repair and reconstruction of the tollway project without the
29 contribution of additional public funds; or

30 “(b) The revenues generated by the tollway project will be at least suffi-

1 cient to pay its operational expenses and a portion of the costs of its con-
2 struction, maintenance, repair and reconstruction, and the importance of the
3 tollway project to the welfare or economy of the state is great enough to
4 justify the use of public funding for a portion of its construction, mainte-
5 nance, repair and reconstruction.

6 “(4) If the department finds that a proposed tollway project qualifies for
7 authorization under this section, the department may conduct or cause to
8 be conducted any environmental, geological or other studies required by law
9 as a condition of construction of the tollway project. The costs of completing
10 the studies for any proposed tollway project may be paid from moneys in the
11 [*State Tollway Account*] **Toll Program Fund** that are reimbursed from the
12 permanent financing for the project.

14 **“REPORT ON EQUITABLE INCOME-BASED TOLL RATES**

16 **“SECTION 33. (1) As used in this section, ‘toll’ and ‘tollway’ have**
17 **the meanings given those terms in ORS 383.003.**

19 **department shall implement a method for establishing equitable**
20 **income-based toll rates to be paid by users of tollways.**

21 **“(3) At least 90 days before the date the Oregon Transportation**
22 **Commission seeks approval from the Federal Highway Administration**
23 **to use the income-based toll rates developed under subsection (1) of**
24 **this section, the department shall prepare and submit a report on the**
25 **method developed to the Joint Committee on Transportation and the**
26 **Oregon Transportation Commission. The department may also submit**
27 **to the Joint Committee on Transportation any recommended legisla-**
28 **tive changes. The report shall be provided to the Joint Committee on**
29 **Transportation, in the manner provided under ORS 192.245, on or be-**
30 **fore September 15, 2022.**

1 **“SECTION 34. Section 33 of this 2021 Act is repealed on January 2,**
2 **2023.**

4 **“JURISDICTIONAL TRANSFER**

5
6 **“SECTION 35. ORS 366.483 is amended to read:**

7 **“366.483. (1) In accordance with ORS 374.329, the Department of Trans-**
8 **portation shall transfer jurisdiction of the following state highways to the**
9 **following cities:**

10 **“(a) Pacific Highway West, State Highway 99, from the department to the**
11 **City of Eugene. The department shall transfer the following two portions:**

12 **“(A) The portion beginning where the highway intersects with the**
13 **Beltline Highway and ending where the highway intersects with Washington**
14 **Street, but excluding the bridge at milepost 121.42.**

15 **“(B) The portion beginning where the highway intersects with Walnut**
16 **Street and ending where the highway intersects with Interstate 5, but ex-**
17 **cluding the bridge at milepost 126.02.**

18 **“(b) Springfield Highway, State Highway 228 to the City of Springfield.**

19 **“(c) To the City of Portland, the portion of 82nd Avenue beginning**
20 **where it intersects with Northeast Killingsworth Street and ending**
21 **where the highway intersects with Southeast Clatsop Street. Before**
22 **the transfer:**

23 **“(A) The department shall determine the total costs to improve the**
24 **portion of 82nd Avenue described in this paragraph to a state of good**
25 **repair;**

26 **“(B) The department shall provide the city 25 percent of the costs;**
27 **and**

28 **“(C) The city shall cover the remaining 75 percent of the costs.**

29 **“(2) Notwithstanding section 71d (4), chapter 750, Oregon Laws 2017, the**
30 **department shall use the funds described in section 71d, chapter 750, Oregon**

1 Laws 2017, for the transfer of Powell Boulevard to upgrade the portion of
2 Southeast Powell Boulevard beginning where the highway intersects with
3 Interstate 205 and ending where the highway intersects with the city limits.
4 After the upgrades are completed, in accordance with ORS 374.329, the de-
5 partment shall transfer jurisdiction of the upgraded portion to the City of
6 Portland. The department may upgrade and transfer portions of the highway
7 in phases.

8 “(3) In accordance with ORS 366.290:

9 “(a) The department shall transfer jurisdiction of the portion of Territo-
10 rial Highway, State Highway 200, that is located within Lane County from
11 the department to the county. The department may transfer portions of the
12 highway in phases. The department shall retain jurisdiction of bridges on
13 Territorial Highway located at milepoints 4.59, 7.07, 17.92, 18.72, 18.98, 19.28
14 and 25.49. The department shall transfer the jurisdiction of the bridges after
15 the bridges are replaced.

16 “(b) The department shall transfer jurisdiction of the portion of the
17 Springfield-Creswell Highway, State Highway 222, beginning where it inter-
18 sects with Jasper-Lowell Road and ending where it intersects with Emerald
19 Parkway to Lane County. The department shall retain jurisdiction of bridges
20 on Springfield-Creswell Highway located at mileposts 5.20, 5.41, 5.64 and
21 13.36. The department shall transfer the jurisdiction of a bridge after the
22 bridge is replaced.

23 “(c) Lane County shall transfer jurisdiction of the portion of Delta
24 Highway beginning where the highway intersects with Interstate 105 and
25 ending where the highway intersects with the Randy Pape Beltline from the
26 county to the department.

27 “(d) Multnomah County and Washington County shall transfer jurisdic-
28 tion of the portion of Cornelius Pass Road beginning where the highway
29 intersects with U.S. Highway 30 and ending where the highway intersects
30 with U.S. Highway 26 from the counties to the department. The counties may

1 transfer portions of the highway in phases.

2 “(4) The amounts described in this section for jurisdiction transfers
3 authorized under this section may not be allocated until after the
4 transfer for which the allocation is dedicated occurs.

5

6 **“PROJECT LABOR AGREEMENTS**

7

8 **“SECTION 36. (1) As used in this section:**

9 **“(a) ‘Apprentice’ has the meaning given that term in ORS 660.010.**

10 **“(b) ‘Apprenticeable occupation’ has the meaning given that term
11 in ORS 660.010.**

12 **“(c) ‘General contractor’ has the meaning given that term in ORS
13 701.005.**

14 **“(d) ‘Project labor agreement’ means a collective bargaining agree-
15 ment with one or more labor organizations that establishes the terms
16 and conditions of employment for a specific construction project.**

17 **“(e) ‘Training agent’ has the meaning given that term in ORS
18 660.010.**

19 **“(2) The Director of Transportation shall apply the considerations
20 specified in subsection (3) of this section to objectively and specifically
21 determine whether a project labor agreement is appropriate for each
22 of the interstate highway projects described in ORS 367.095 (2)(a)(A)(i).**

23 **“(3) In making the determination described in subsection (2) of this
24 section, the director shall consider:**

25 **“(a) Whether a project labor agreement will secure a skilled and
26 diverse workforce for the project;**

27 **“(b) Whether a single project labor agreement for all of the projects
28 described in subsection (2) of this section is feasible and beneficial and
29 whether the project subject to the director’s determination could be
30 included within or adapted to the terms and conditions of a project**

1 labor agreement for all of the projects described in subsection (2) of
2 this section;

3 “(c) Whether the project labor agreement includes provisions for
4 employing a sufficient percentage of apprentices in apprenticeable oc-
5 cupations and whether the employer is or will agree to become a
6 training agent;

7 “(d) The numbers and categories of the trades and crafts that the
8 project will likely require;

9 “(e) The potential for labor disruptions in connection with the
10 project;

11 “(f) Whether anticipated benefits for the public, including efficien-
12 cies from using skilled labor, a higher quality of construction, im-
13 proved safety for workers and the public and timely completion of the
14 project, outweigh anticipated costs associated with a project labor
15 agreement;

16 “(g) The urgency of the project and the harm to the public interest
17 if delays occur in the project schedule; and

18 “(h) The size and complexity of the project and the time necessary
19 to complete the project.

20 “(4)(a) The director shall ensure that, at a minimum, any project
21 labor agreement the director determines is appropriate for any of the
22 projects described in subsection (2) of this section:

23 “(A) Designates a general contractor or project manager for the
24 project with experience in negotiating and administering project labor
25 agreements to manage the construction of the project and to develop
26 and implement an effective labor relations policy for the project;

27 “(B) Allows all contractors and subcontractors to compete for con-
28 tracts and subcontracts to perform work on or supply materials for the
29 project without regard to whether the contractor or subcontractor is
30 a party to any other collective bargaining agreement;

1 “(C) Has guarantees against strikes, lockouts or otherwise slowing
2 or stopping work on the project;

3 “(D) Sets forth prompt, effective and mutually binding procedures
4 for resolving labor disputes that arise during the term of the agree-
5 ment; and

6 “(E) Binds all contractors and all subcontractors at any tier that
7 perform work on the construction project to the provisions set forth
8 in this paragraph by means of:

9 “(i) Appropriate specifications in solicitation documents for the
10 project and in contractors’ solicitations for subcontracts for the
11 project; and

12 “(ii) Appropriate terms and conditions in each public contract and
13 all subcontracts for the project.

14

17 “SECTION 37. The unit and section captions used in this 2021 Act
18 are provided only for the convenience of the reader and do not become
19 part of the statutory law of this state or express any legislative intent
20 in the enactment of this 2021 Act.
