HOUSE BILL 5042**

1 Delete lines 4 through 15 of the printed bill and insert:

2 **“SECTION 1. Notwithstanding any other provision of law, the**  
3 **General Fund appropriation made to the Department of Human Ser-**  
4 **vices by section 1 (4), chapter 668, Oregon Laws 2019, for the biennium**  
5 **ending June 30, 2021, for aging and people with disabilities and**  
6 **intellectual/developmental disabilities programs, is decreased by**  
7 **\$68,448,535.**

8 **“SECTION 2. Notwithstanding any other provision of law, the**  
9 **General Fund appropriation made to the Department of Human Ser-**  
10 **vices by section 1 (3), chapter 668, Oregon Laws 2019, for the biennium**  
11 **ending June 30, 2021, for child welfare, is decreased by \$1,855,725.**

12 **“SECTION 3. Notwithstanding any other provision of law, the**  
13 **General Fund appropriation made to the Department of Human Ser-**  
14 **vices by section 1 (1), chapter 668, Oregon Laws 2019, for the biennium**  
15 **ending June 30, 2021, for central services and state assessments and**  
16 **enterprise-wide costs, is increased by \$70,304,260 for food and shelter**  
17 **services related to wildfire recovery.**

18 **“SECTION 4. Notwithstanding any other law limiting expenditures,**  
19 **the limitation on expenditures established by section 2 (1), chapter 668,**  
20 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**  
21 **imum limit for payment of expenses from fees, moneys or other reve-**

1 nues, including Miscellaneous Receipts and Medicare receipts and  
2 including federal funds for indirect cost recovery, Social Security  
3 Supplemental Security Income recoveries and the Child Care and De-  
4 velopment Fund, but excluding lottery funds and federal funds not  
5 described in section 2, chapter 668, Oregon Laws 2019, collected or re-  
6 ceived by the Department of Human Services, for central services and  
7 state assessments and enterprise-wide costs, is increased by \$68,687,837  
8 to allow the agency to use federal reimbursement funds for wildfire-  
9 related food and shelter costs.

10 **“SECTION 5.** Notwithstanding any other law limiting expenditures,  
11 the limitation on expenditures established by section 3 (3), chapter 668,  
12 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-  
13 imum limit for payment of expenses from federal funds, excluding  
14 federal funds described in section 2, chapter 668, Oregon Laws 2019,  
15 collected or received by the Department of Human Services, for child  
16 welfare, is increased by \$1,855,725.

17 **“SECTION 6.** Notwithstanding any other law limiting expenditures,  
18 the limitation on expenditures established by section 3 (4), chapter 668,  
19 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-  
20 imum limit for payment of expenses from federal funds, excluding  
21 federal funds described in section 2, chapter 668, Oregon Laws 2019,  
22 collected or received by the Department of Human Services, for aging  
23 and people with disabilities and intellectual/developmental disabilities  
24 programs, is increased by \$74,162,847.

25 **“SECTION 7.** Notwithstanding any other provision of law, the  
26 General Fund appropriation made to the Oregon Health Authority by  
27 section 1 (1), chapter 695, Oregon Laws 2019, for the biennium ending  
28 June 30, 2021, for Health Systems, Health Policy and Analytics, and  
29 Public Health, is increased by \$4,058,368 to rebalance the agency’s  
30 budget, repay federal Medicaid matching funds owed to the federal

1 government, begin implementation of the Oregon Psilocybin Services  
2 Act and fund behavioral health investments related to ORS 161.370.

3 **“NOTE:** Section 8 was deleted. Subsequent sections were not renumbered.

4 **“SECTION 9.** Notwithstanding any other provision of law, the  
5 General Fund appropriation made to the Oregon Health Authority by  
6 section 1 (3), chapter 695, Oregon Laws 2019, for the biennium ending  
7 June 30, 2021, for central services, state assessments and enterprise-  
8 wide costs, is increased by \$1,844,075 to rebalance the agency’s budget.

9 **“SECTION 10.** Notwithstanding any other provision of law, the  
10 General Fund appropriation made to the Oregon Health Authority by  
11 section 7, chapter 560, Oregon Laws 2019, for the biennium ending June  
12 30, 2021, is decreased by \$84,473 as part of a net-zero technical adjust-  
13 ment with the General Fund appropriation made to the Oregon Health  
14 Authority by section 1 (1), chapter 695, Oregon Laws 2019, for Health  
15 Systems, Health Policy and Analytics, and Public Health.

16 **“SECTION 11.** Notwithstanding any other provision of law, the  
17 General Fund appropriation made to the Oregon Health Authority by  
18 section 11, chapter 629, Oregon Laws 2019, for the biennium ending  
19 June 30, 2021, is decreased by \$591,974 as part of a net-zero technical  
20 adjustment with the General Fund appropriation made to the Oregon  
21 Health Authority by section 1 (1), chapter 695, Oregon Laws 2019, for  
22 Health Systems, Health Policy and Analytics, and Public Health.

23 **“SECTION 12.** Notwithstanding any other law limiting expenditures,  
24 the limitation on expenditures established by section 2 (1), chapter 695,  
25 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-  
26 imum limit for payment of expenses from fees, moneys or other reve-  
27 nues, including Miscellaneous Receipts, tobacco tax receipts,  
28 recreational marijuana tax receipts, provider taxes, Medicare receipts  
29 and federal funds for indirect cost recovery, Supplemental Security  
30 Income recoveries, Women, Infants and Children Program food re-

1 bates, the Coordinated School Health Program, the Edward Byrne  
2 Memorial State and Local Law Enforcement Assistance Grant Pro-  
3 gram and emergency preparedness and response services, but exclud-  
4 ing lottery funds and federal funds not described in section 2, chapter  
5 695, Oregon Laws 2019, collected or received by the Oregon Health  
6 Authority, for Health Systems, Health Policy and Analytics, and Pub-  
7 lic Health, is increased by \$615,420,291 to rebalance the agency's budget  
8 and begin implementation of the Drug Addiction Treatment and Re-  
9 covery Act.

13 the limitation on expenditures established by section 2 (3), chapter 695,

15 imum limit for payment of expenses from fees, moneys or other reve-  
16 nues, including Miscellaneous Receipts, tobacco tax receipts,  
17 recreational marijuana tax receipts, provider taxes, Medicare receipts  
18 and federal funds for indirect cost recovery, Supplemental Security  
19 Income recoveries, Women, Infants and Children Program food re-  
20 bates, the Coordinated School Health Program, the Edward Byrne  
21 Memorial State and Local Law Enforcement Assistance Grant Pro-  
22 gram and emergency preparedness and response services, but exclud-  
23 ing lottery funds and federal funds not described in section 2, chapter  
24 695, Oregon Laws 2019, collected or received by the Oregon Health  
25 Authority, for central services, state assessments and enterprise-wide  
26 costs, is increased by \$29,293 to rebalance the agency's budget.

27 **SECTION 15.** Notwithstanding any other law limiting expenditures,  
28 the limitation on expenditures established by section 4 (1), chapter 695,  
29 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-  
30 imum limit for payment of expenses from federal funds, excluding

1 federal funds described in section 2, chapter 695, Oregon Laws 2019,  
2 collected or received by the Oregon Health Authority, for Health Sys-  
3 tems, Health Policy and Analytics, and Public Health, is decreased by  
4 \$129,961,710 as a result of net adjustments to rebalance the agency’s  
5 budget and fund behavioral health investments related to ORS 161.370.

8 **“SECTION 17.** Notwithstanding any other law limiting expenditures,  
9 the limitation on expenditures established by section 4 (3), chapter 695,  
10 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-  
11 imum limit for payment of expenses from federal funds, excluding  
12 federal funds described in section 2, chapter 695, Oregon Laws 2019,  
13 collected or received by the Oregon Health Authority, for central ser-  
14 vices, state assessments and enterprise-wide costs, is increased by  
15 \$5,306,299 to rebalance the agency’s budget.

16 **“SECTION 18.** Notwithstanding any other provision of law, the  
17 General Fund appropriation made to the Department of Justice by  
18 section 1, chapter 608, Oregon Laws 2019, for the biennium ending June  
19 30, 2021, for the payment of expenses of district attorneys, is increased  
20 by \$575,000 for reconciliation of personal services expenses.

21 **“SECTION 19.** Notwithstanding any other provision of law, the  
22 General Fund appropriation made to the Public Defense Services  
23 Commission by section 1 (2), chapter 303, Oregon Laws 2019, for the  
24 biennium ending June 30, 2021, for professional services, is decreased  
25 by \$133,715 for a technical adjustment.

26 **“SECTION 20.** Notwithstanding any other provision of law, the  
27 General Fund appropriation made to the Public Defense Services  
28 Commission by section 1 (3), chapter 303, Oregon Laws 2019, for the  
29 biennium ending June 30, 2021, for the Contract and Business Services  
30 Division, is increased by \$133,715 for a technical adjustment.

1       **“SECTION 21. Notwithstanding any other law limiting expenditures,**  
2 **the limitation on expenditures established by section 4, chapter 269,**  
3 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**  
4 **imum limit for payment of expenses from federal funds other than**  
5 **those described in section 2, chapter 269, Oregon Laws 2019, collected**  
6 **or received by the Employment Department, is decreased by**  
7 **\$30,000,000.**

8       **“SECTION 22. Notwithstanding any other law limiting expenditures,**  
9 **the limitation on expenditures established by section 1 (1), chapter 269,**  
10 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**  
11 **imum limit for payment of expenses from fees, moneys or other reve-**  
12  **nues, including Miscellaneous Receipts and moneys appropriated to**  
13 **the Employment Department by sections 2 and 3, chapter 269, Oregon**  
14 **Laws 2019, but excluding lottery funds and federal funds other than**  
15 **those described in section 2, chapter 269, Oregon Laws 2019, collected**  
16 **or received by the Employment Department, for unemployment in-**  
17 **surance, shared services and workforce operations, and workforce and**  
18 **economic research, is increased by \$30,000,000 for payment of admin-**  
19 **istrative expenses related to unemployment insurance.**

20       **“SECTION 23. Notwithstanding any other law limiting expenditures,**  
21 **the limitation on expenditures established by section 4, chapter 642,**  
22 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**  
23 **imum limit for payment of expenses from federal funds other than**  
24 **those described in sections 2 and 6, chapter 642, Oregon Laws 2019,**  
25 **collected or received by the Housing and Community Services Depart-**  
26 **ment, is increased by \$526,951 to administer federal funding for rental**  
27 **assistance, energy assistance, homeless assistance and coronavirus**  
28 **relief programs.**

29       **“SECTION 24. Notwithstanding any other law limiting expenditures,**  
30 **the limitation on expenditures established by section 1 (1), chapter 694,**

1 Oregon Laws 2019, for the biennium ending June 30, 2021, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Oregon Liquor Control Commission, for administrative expenses, is increased by \$1,531,400 for payment of bank card fees.

7 **“SECTION 25.** Notwithstanding any other law limiting expenditures, the limitation on expenditures established by section 1 (4), chapter 694, Oregon Laws 2019, for the biennium ending June 30, 2021, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Oregon Liquor Control Commission, for agents’ compensation - all other, is increased by \$2,255,296 for retail store liquor agent compensation.

15 **“SECTION 26.** Notwithstanding any other law limiting expenditures, the limitation on expenditures established by section 1 (5), chapter 694, Oregon Laws 2019, for the biennium ending June 30, 2021, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Oregon Liquor Control Commission, for agents’ compensation - distillery agents, is increased by \$659,000 for distillery agents’ compensation.

23 **“SECTION 27.** Notwithstanding any other law limiting expenditures, the amount of \$629,574 is established for the biennium ending June 30, 2021, as the maximum limit for payment of expenses from fees, moneys, or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Real Estate Agency for increased testing costs.

29 **“SECTION 28.** Notwithstanding any other law limiting expenditures, the limitation on expenditures established by section 4 (1), chapter 452,

1 Oregon Laws 2019, for the biennium ending June 30, 2021, as the maximum limit for payment of expenses from federal funds other than  
2 those described in section 2, chapter 452, Oregon Laws 2019, collected  
3 or received by the State Department of Agriculture, for administrative  
4 and support services, is increased by \$32,630 to shift limitation between  
5 program areas.  
6

7 **“SECTION 29.** Notwithstanding any other law limiting expenditures,  
8 the limitation on expenditures established by section 4 (4), chapter 452,  
9 Oregon Laws 2019, for the biennium ending June 30, 2021, as the maximum limit for payment of expenses from federal funds other than  
10 those described in section 2, chapter 452, Oregon Laws 2019, collected  
11 or received by the State Department of Agriculture, for market access,  
12 is decreased by \$32,630 to shift limitation between program areas.  
13

14 **“SECTION 30.** Notwithstanding any other provision of law, the  
15 General Fund appropriation made to the State Department of Energy  
16 by section 1, chapter 698, Oregon Laws 2019, for the biennium ending  
17 June 30, 2021, for debt service for the small scale local energy loan  
18 program, is decreased by \$4,334,048.

19 **“SECTION 31.** Notwithstanding any other provision of law, the  
20 General Fund appropriation made to the Legislative Assembly by section  
21 6, chapter 693, Oregon Laws 2019, for the biennium ending June  
22 30, 2021, for payment of the expenses of certain offices, is decreased  
23 by \$1,500,000.

24 **“SECTION 32.** Notwithstanding any other provision of law, the  
25 General Fund appropriation made to the Legislative Assembly by section  
26 7 (1), chapter 693, Oregon Laws 2019, for the biennium ending June  
27 30, 2021, for payment of the expenses of members of the Eightieth  
28 Legislative Assembly of the State of Oregon, is increased by \$100,000.

29 **“SECTION 33.** Notwithstanding any other provision of law, the  
30 General Fund appropriation made to the Legislative Assembly by section



1 tion 7 (2), chapter 693, Oregon Laws 2019, for the biennium ending June  
2 30, 2021, for payment of the expenses of members of the Eighty-first  
3 Legislative Assembly of the State of Oregon, is increased by \$1,400,000.

4 **“SECTION 34.** Notwithstanding any other provision of law, the  
5 General Fund appropriation made to the Department of Corrections  
6 by section 1 (1), chapter 688, Oregon Laws 2019, for the biennium end-  
7 ing June 30, 2021, for operations and health services, is decreased by  
8 \$5,747,811.

9 **“SECTION 35.** Notwithstanding any other provision of law, the  
10 General Fund appropriation made to the Department of Corrections  
11 by section 1 (2), chapter 688, Oregon Laws 2019, for the biennium end-  
12 ing June 30, 2021, for central administration and administrative ser-  
13 vices, is increased by \$10,593,586.

14 **“SECTION 36.** Notwithstanding any other provision of law, the  
15 General Fund appropriation made to the Department of Corrections  
16 by section 1 (3), chapter 688, Oregon Laws 2019, for the biennium end-  
17 ing June 30, 2021, for offender management and rehabilitation, is de-  
18 creased by \$2,218,948.

19 **“SECTION 37.** Notwithstanding any other provision of law, the  
20 General Fund appropriation made to the Department of Corrections  
21 by section 1 (6), chapter 688, Oregon Laws 2019, for the biennium end-  
22 ing June 30, 2021, for capital improvements, is decreased by \$2,626,827.

23 **“SECTION 38.** Notwithstanding any other law limiting expenditures,  
24 the limitation on expenditures established by section 2 (1), chapter 688,  
25 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-  
26 imum limit for payment of expenses from fees, moneys or other reve-  
27 nues, including Miscellaneous Receipts, but excluding lottery funds  
28 and federal funds, collected or received by the Department of Cor-  
29 rections, for operations and health services, is increased by \$19,500,000  
30 for federal reimbursement of COVID-19 expenses.

1       **“SECTION 39. Notwithstanding any other law limiting expenditures,**  
2 **the limitation on expenditures established by section 2 (1), chapter 688,**  
3 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**  
4 **imum limit for payment of expenses from fees, moneys or other reve-**  
5  **nues, including Miscellaneous Receipts, but excluding lottery funds**  
6 **and federal funds, collected or received by the Department of Cor-**  
7 **rections, for operations and health services, is increased by \$1,500,000**  
8 **for federal reimbursement of expenses incurred during the 2020**  
9 **wildfire season.**

10       **“SECTION 40. Notwithstanding any other provision of law, the**  
11 **General Fund appropriation made to the Department of Justice by**  
12 **section 1 (5), chapter 692, Oregon Laws 2019, for the biennium ending**  
13 **June 30, 2021, for the defense of criminal convictions, is increased by**  
14 **\$550,000 for forecasted caseload expenses.**

15       **“SECTION 41. Notwithstanding any other provision of law, the**  
16 **General Fund appropriation made to the Oregon Military Department**  
17 **by section 1 (4), chapter 534, Oregon Laws 2019, for the biennium end-**  
18 **ing June 30, 2021, for community support, is increased by \$229,608 for**  
19 **state active duty expenses and to provide matching funds for**  
20 **reimbursable wildfire expenses.**

21       **“SECTION 42. Notwithstanding any other provision of law, the**  
22 **General Fund appropriation made to the Oregon Military Department**  
23 **by section 1 (1), chapter 534, Oregon Laws 2019, for the biennium end-**  
24 **ing June 30, 2021, for administration, is increased by \$25,000 for inter-**  
25 **est expenses.**

26       **“SECTION 43. Notwithstanding any other law limiting expenditures,**  
27 **the limitation on expenditures established by section 2 (4), chapter 534,**  
28 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**  
29 **imum limit for payment of expenses from fees, moneys or other reve-**  
30  **nues, including Miscellaneous Receipts and reimbursements from**

1 federal service agreements, but excluding lottery funds and federal  
2 funds not described in section 2, chapter 534, Oregon Laws 2019, col-  
3 lected or received by the Oregon Military Department, for community  
4 support, is increased by \$3,376,526 for federal reimbursement of ex-  
5 penses incurred during the 2020 wildfire season.

6 **SECTION 44.** Notwithstanding any other provision of law, the  
7 General Fund appropriation made to the Oregon Military Department  
8 by section 1 (3), chapter 534, Oregon Laws 2019, for the biennium end-  
9 ing June 30, 2021, for emergency management, is increased by \$584,456  
10 to provide state matching funds for the Federal Emergency Manage-  
11 ment Agency’s Other Needs Assistance program.

12 **SECTION 45.** Notwithstanding any other law limiting expenditures,  
13 the limitation on expenditures established by section 2 (1), chapter 479,  
14 Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-  
15 imum limit for payment of expenses from fees, moneys or other reve-  
16 nues, including Miscellaneous Receipts, but excluding lottery funds  
17 and federal funds, collected or received by the Department of Public  
18 Safety Standards and Training, for operations, is increased by  
19 \$1,503,520 to add three classes to the 2019-2021 training calendar.

20 **SECTION 46.** Notwithstanding any other provision of law, the  
21 General Fund appropriation made to the Public Defense Services  
22 Commission by section 1 (1), chapter 303, Oregon Laws 2019, for the  
23 biennium ending June 30, 2021, for the Appellate Division, is increased  
24 by \$1,000,000 for the payment of transcription and discovery services.

25 **SECTION 47.** Notwithstanding any other provision of law, the  
26 General Fund appropriation made to the Public Defense Services  
27 Commission by section 1 (2), chapter 303, Oregon Laws 2019, for the  
28 biennium ending June 30, 2021, for professional services, is increased  
29 by \$6,185,368 for increases in contracting costs and the Parent Child  
30 Representation Program.

1       **“SECTION 48. Notwithstanding any other provision of law, the**  
2 **General Fund appropriation made to the Public Defense Services**  
3 **Commission by section 1 (3), chapter 303, Oregon Laws 2019, for the**  
4 **biennium ending June 30, 2021, for the Contract and Business Services**  
5 **Division, is increased by \$353,854 for office equipment for the**  
6 **Multnomah County Courthouse.**

7       **“SECTION 49. Notwithstanding any other provision of law, the**  
8 **limitation on expenditures established by section 71, chapter 9, Oregon**  
9 **Laws 2020 (second special session), for the biennium ending June 30,**  
10 **2021, as the maximum limit for payment of expenses from federal**  
11 **funds collected or received by the Department of Veterans’ Affairs, is**  
12 **increased by \$849,918 for CARES Act Provider Relief Fund payments**  
13 **to the Oregon Veterans’ Homes.**

14       **“SECTION 50. Notwithstanding any other provision of law, the**  
15 **limitation on expenditures established by section 4, chapter 570,**  
16 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**  
17 **imum limit for payment of expenses from federal funds collected or**  
18 **received by the Department of Veterans’ Affairs, is increased by**  
19 **\$110,164 for the State Approving Agency program.**

20       **“SECTION 51. Notwithstanding any other law limiting expenditures,**  
21 **the limitation on expenditures established by section 2, chapter 669,**  
22 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**  
23 **imum limit for payment of expenses from fees, moneys or other reve-**  
24  **nues, including Miscellaneous Receipts, but excluding lottery funds**  
25 **and federal funds, collected or received by the Department of Land**  
26 **Conservation and Development, is increased by \$150,901 for**  
27 **collaborative projects funding.**

28       **“SECTION 52. Notwithstanding any other law limiting expenditures,**  
29 **the limitation on expenditures established by the Emergency Board**  
30 **at its November 9, 2020, meeting (Item No. 3), for the biennium ending**

1 **June 30, 2021, as the maximum limit for payment of expenses from**  
2 **moneys received by the Oregon Department of Administrative Services**  
3 **from the Federal Emergency Management Agency to pay for COVID-19**  
4 **emergency response activities, is increased by \$54,465,305 for FEMA**  
5 **reimbursement of protective equipment purchases and 2020 fire season**  
6 **costs.**

7 **“SECTION 53. Notwithstanding any other law limiting expenditures,**  
8 **the limitation on expenditures established by the Emergency Board**  
9 **at its January 8, 2021, meeting (Item No. 16), for the biennium ending**  
10 **June 30, 2021, as the maximum limit for payment of expenses for re-**  
11 **imbursement of costs incurred in responding to the COVID-19**  
12 **pandemic from revenues received from the Coronavirus Relief Fund**  
13 **by the Oregon Department of Administrative Services, is increased by**  
14 **\$8,923,765 for agency-related COVID-19 expenses.**

15 **“SECTION 54. Notwithstanding any other provision of law, the**  
16 **General Fund appropriation made to the Department of Revenue by**  
17 **section 1 (5), chapter 612, Oregon Laws 2019, for the biennium ending**  
18 **June 30, 2021, for the Corporate Division, is decreased by \$108,398 for**  
19 **a technical adjustment.**

20 **“SECTION 55. Notwithstanding any other law limiting expenditures,**  
21 **the limitation on expenditures established by section 2 (6), chapter 612,**  
22 **Oregon Laws 2019, for the biennium ending June 30, 2021, as the max-**
