**PROPOSED AMENDMENTS TO  
HOUSE BILL 2316**

1 On page 1 of the printed bill, line 2, after the semicolon delete the rest  
2 of the line and insert “creating new provisions; amending ORS 458.380 and  
3 458.385; repealing ORS 458.380; and declaring an emergency.”.

4 Delete lines 4 through 11 and insert:

5 **“SECTION 1. (1) The Behavioral Health Housing Incentive Fund is**  
6 **established in the State Treasury, separate and distinct from the**  
7 **General Fund. The Behavioral Health Housing Incentive Fund consists**  
8 **of moneys deposited or transferred to the fund by the Legislative As-**  
9 **sembly and moneys appropriated to the fund by the Legislative As-**  
10 **sembly. Interest earned on the fund shall be credited to the fund.**

11 **“(2) Moneys in the Behavioral Health Housing Incentive Fund are**  
12 **continuously appropriated to the Oregon Health Authority to carry out**  
13 **the provisions of ORS 458.385.**

14 **“SECTION 2. On the effective date of this 2021 Act, interest earned**  
15 **on the Housing for Mental Health Fund established in ORS 458.380**  
16 **shall be transferred to the Behavioral Health Housing Incentive Fund**  
17 **established in section 1 of this 2021 Act.**

18 **“SECTION 3. Any unobligated funds remaining in the Housing for**  
19 **Mental Health Fund established in ORS 458.380 on June 30, 2022, shall**  
20 **be transferred to and deposited in the Behavioral Health Housing In-**  
21 **centive Fund established in section 1 of this 2021 Act.**

1       **“SECTION 4.** ORS 458.380 is amended to read:

2       “458.380. [(1)] The Housing for Mental Health Fund is established in the  
3 State Treasury, separate and distinct from the General Fund. The Housing  
4 for Mental Health Fund consists of moneys deposited in the fund under sec-  
5 tion 8, chapter 812, Oregon Laws 2015, and may include moneys appropriated,  
6 allocated, deposited or transferred to the fund by the Legislative Assembly  
7 or otherwise and interest earned on moneys in the fund.

8       “[(2) *Moneys in the fund are continuously appropriated to the Housing and*  
9 *Community Services Department for disbursement for the purposes set forth in*  
10 *ORS 458.385.*”

11       In line 12, delete “2” and insert “5”.

12       In line 14, delete “Housing for Mental Health Fund” and insert “Behav-  
13 ioral Health Housing Incentive Fund established in section 1 of this 2021  
14 Act”.

15       On page 2, after line 20, insert:

16       **“SECTION 6. ORS 458.380 is repealed on June 30, 2022.**

17       **“SECTION 7. This 2021 Act being necessary for the immediate**  
18 **preservation of the public peace, health and safety, an emergency is**  
19 **declared to exist, and this 2021 Act takes effect on its passage.”.**
