**PROPOSED AMENDMENTS TO  
SENATE BILL 795**

1 On page 1 of the printed bill, delete lines 4 through 31 and delete page  
2 2 and insert:

3 **“SECTION 1.** ORS 390.124 is amended to read:

4 “390.124. (1) In accordance with any applicable provision of ORS chapter  
5 183, the State Parks and Recreation Commission may adopt rules necessary  
6 to carry out the duties, functions and powers imposed by law upon the  
7 commission and the State Parks and Recreation Department. Rules adopted  
8 pursuant to this section shall be duly entered in the minutes and records of  
9 the commission.

10 “(2)(a) The commission may adopt by rule a schedule setting forth the  
11 range of reasonable charges that may be assessed for the use of areas es-  
12 tablished and maintained by the department. **The range of user fees in the**  
13 **schedule for nonresidents must be greater than the range for residents**  
14 **of this state. The fee differential for nonresidents may not exceed the**  
15 **fee charged to residents of this state by more than 30 percent.**

16 “(b) With the approval of the commission, the State Parks and Recreation  
17 Director may set, adjust and assess fees for the use of areas established and  
18 maintained by the department. Fees assessed under this paragraph must be  
19 within the range of reasonable charges adopted by the commission under  
20 paragraph (a) of this subsection. The director may adjust a fee under this  
21 paragraph no more than four times per calendar year. The director may also

1 adopt rules establishing reductions in waivers of or exemption from the  
2 charges.

3 “(c) Notwithstanding paragraphs (a) and (b) of this subsection, the com-  
4 mission shall authorize the use of any state park, individual campsite or day  
5 use fee area without charge:

6 “(A) Upon the showing of proper identification, by a person maintaining  
7 a foster home, as defined by ORS 418.625, and the person’s children, when  
8 accompanied by a foster child residing in the home.

9 “(B) Upon the showing of proper identification, by a person maintaining  
10 a developmental disability child foster home, as defined by ORS 443.830, and  
11 the person’s children, when accompanied by a foster child residing in the  
12 home.

13 “(C) If a deed to, lease of or contract to use the property used as a state  
14 park, campsite or day use fee area prohibits the charging of fees for use of  
15 the property.

16 “(D) Upon the showing of proper identification, by either a disabled vet-  
17 eran or a person on leave from military active duty status on Memorial Day,  
18 Independence Day or Veterans Day.

19 “(3) The commission shall adopt any rules pursuant to ORS chapter 183  
20 that the commission considers necessary to carry out ORS 273.563 to  
21 273.591.”.

22 **“SECTION 2. This 2021 Act takes effect on the 91st day after the**  
23 **date on which the 2021 regular session of the Eighty-first Legislative**  
24 **Assembly adjourns sine die.”.**
