**PROPOSED AMENDMENTS TO  
HOUSE BILL 3145**

1 On page 1 of the printed bill, line 2, after “provisions;” delete the rest  
2 of the line and line 3 and insert “and amending section 3, chapter 7, Oregon  
3 Laws 2020 (first special session).”.

4 Delete lines 5 through 26 and delete pages 2 through 19 and insert:

5 **“SECTION 1. Section 2 of this 2021 Act is added to and made a part  
6 of ORS 181A.355 to 181A.670.**

7 **“SECTION 2. Within 10 days after an economic sanction as part of  
8 discipline imposed on a police officer has become final and the arbi-  
9 tration process is complete, the law enforcement unit that imposed the  
10 discipline shall report on the discipline to the Department of Public  
11 Safety Standards and Training. The report must include:**

12 **“(1) The name and rank of the officer disciplined;**

13 **“(2) The name of the law enforcement unit at which the officer is  
14 or was employed; and**

15 **“(3) A description of the facts underlying the discipline imposed,  
16 including a copy of any final decision.**

17 **“SECTION 3. Section 3, chapter 7, Oregon Laws 2020 (first special ses-  
18 sion), is amended to read:**

19 **“Sec. 3. (1) The Department of Public Safety Standards and Training  
20 shall establish a statewide online database of suspensions and revocations  
21 of the certifications of police officers and discipline of police officers in-**

1 **volving economic sanctions** that is accessible by the public.

2 “(2) The department shall publish information on the database when the  
3 department suspends or revokes the certification of a police officer under  
4 ORS 181A.630, 181A.640 and 181A.650, **and when the department receives**  
5 **notice of discipline of a police officer under section 2 of this 2021 Act,**  
6 including but not limited to:

7 “(a) The name of the officer;

8 “(b) The law enforcement unit at which the officer was employed; and

9 “(c) A description of the facts underlying the suspension [*or*], revocation  
10 **or discipline.**

11 “(3)(a) The department shall publish the information **related to a sus-**  
12 **pension or revocation of certification** required under subsection (2) of this  
13 section within 10 days after:

14 “[*a*] (A) The time for filing an appeal of the department’s decision under  
15 ORS 181A.650 has passed and no appeal has been filed; or

16 “[*b*] (B) The decision of the department is appealed under ORS 181A.650  
17 and the department’s decision has been sustained by the Court of Appeals  
18 or the appeal has been dropped.

19 “(b) **The department shall publish the information related to disci-**  
20 **pline of an officer required under subsection (2) of this section within**  
21 **10 days after receiving notice of the discipline under section 2 of this**  
22 **2021 Act.**

23 “(4) The department shall submit an annual report to an appropriate  
24 committee of the Legislative Assembly summarizing and analyzing the data  
25 in the database.”.
