PROPOSED AMENDMENTS TO HOUSE BILL 2883

1 On page 1 of the printed bill, delete lines 4 through 30 and delete pages 2 2 and 3 and insert:

<u>SECTION 1.</u> Sections 2 to 4 of this 2021 Act are added to and made
a part of ORS chapter 401.

<u>SECTION 2.</u> (1) The Oregon Public Places Are Safe Places Investment Fund is established in the State Treasury, separate and distinct
from the General Fund.

8 "(2) Amounts in the Oregon Public Places Are Safe Places Invest-9 ment Fund may be invested as provided in ORS 293.701 to 293.857, and 10 interest earned on moneys in the fund must be credited to the fund.

"(3) Amounts credited to the fund are continuously appropriated to the Office of Emergency Management for the implementation of strategies for identifying and developing staging areas for emergency response.

15 **"(4) The fund consists of:**

"(a) Amounts appropriated, or otherwise provided, by the Legisla tive Assembly for deposit in the fund; and

"(b) Gifts, grants or contributions received by the office from any
 source for deposit in the fund.

20 "<u>SECTION 3.</u> (1) There is created within the Office of Emergency 21 Management an advisory committee to provide recommendations and advice to the office regarding expenditures from the Oregon Public
 Places Are Safe Places Investment Fund established under section 2
 of this 2021 Act.

4 "(2) The advisory committee initially consists of 43 members as
5 follows:

6 "(a) Each individual designated as an agency liaison under ORS
7 401.054 shall serve as a member of the advisory committee.

8 "(b) The Governor shall appoint 10 members as follows:

9 "(A) One member representing local governments in this state;

10 "(B) One member representing special districts in this state;

11 "(C) One member representing a park and recreation district 12 formed under ORS chapter 266;

13 **"(D) One member representing the Port of Portland;**

"(E) One member representing the interests of Oregonians who are
 Black, Indigenous or other people of color;

16 "(F) One member representing Indian tribal interests;

17 "(G) One member representing the Portland metropolitan area;

18 "(H) One member representing coastal areas in Oregon;

¹⁹ "(I) One member representing the Willamette Valley; and

20 "(J) One member of the public who has experience or interest in 21 disaster response and recovery.

"(3) Appointments under subsection (2)(b) of this section shall be made for a term of four years in a manner to preserve as much as possible the representation of the advisory committee described in this section. Vacancies shall be filled for any unexpired term as soon as the appointing authority can make such appointments.

"(4) The chairperson of the advisory committee may appoint additional members to the advisory committee. Members added under this subsection serve for a term of four years. If a member appointed under this subsection leaves service on the advisory committee for any reason, the chairperson may appoint another person for the unexpired
term.

"(5) The advisory committee shall choose its own chairperson and shall meet at the call of the chairperson or the Director of the Office of Emergency Management. The advisory committee shall adopt rules to govern its proceedings and may select officers it considers necessary.

"(6) The Office of Emergency Management shall provide office space
and personnel to assist the advisory committee as requested by the
chairperson, within the limits of available funds.

"(7) Members of the advisory committee shall receive no compen-11 sation for their services. Members of the advisory committee other 12 than members employed in full-time public service shall be reimbursed 13 by the office for their actual and necessary expenses incurred in the 14 performance of their duties. Such reimbursements shall be subject to 15the provisions of ORS 292.210 to 292.288. Members of the advisory 16 committee who are employed in full-time public service may be reim-17 bursed by their employing agency for their actual and necessary ex-18 penses incurred in the performance of their duties. 19

"<u>SECTION 4.</u> Sections 2 to 4 of this 2021 Act shall be known and
 may be cited as the Oregon Public Places Resiliency Investment
 Act.".
