**PROPOSED AMENDMENTS TO
HOUSE BILL 2145**

1 On page 1 of the printed bill, delete lines 3 and 4 and insert “536.750,
2 536.900, 537.545, 537.747, 537.753, 537.762, 537.763, 537.765, 537.780, 537.789 and
3 537.791 and sections 2 and 7, chapter 496, Oregon Laws 2001.”.

4 Delete lines 6 through 23 and delete pages 2 through 14 and insert:

5 **“SECTION 1. Sections 2 and 3 of this 2021 Act are added to and
6 made a part of ORS 537.747 to 537.795.**

7 **“SECTION 2. The Water Well Abandonment, Repair and Replace-
8 ment Fund is established in the State Treasury, separate and distinct
9 from the General Fund. Interest earned by the Water Well Abandon-
10 ment, Repair and Replacement Fund shall be credited to the fund.
11 Moneys in the fund are continuously appropriated to the Water Re-
12 sources Department for the purpose of carrying out the program pur-
13 poses described in section 3 of this 2021 Act. The fund shall consist of
14 any moneys designated for deposit in the fund or for carrying out the
15 program purposes, including but not limited to appropriations or other
16 provisions of moneys by the Legislative Assembly and public or private
17 moneys from gifts, grants or donations.**

18 **“SECTION 3. (1) As used in this section, ‘repair’ may include, but
19 is not limited to, a well deepening.**

20 **“(2) Moneys in the Water Well Abandonment, Repair and Replace-
21 ment Fund may be disbursed under authority of the Water Resources**

1 Director for the purposes described in this section. The Water Re-
2 sources Department may disburse moneys from the fund to provide
3 financial assistance:

4 “(a) To a person, as defined in ORS 536.007, or member of a federally
5 recognized Indian tribe in Oregon to permanently abandon a water
6 well or to repair or replace a water well that is used for household
7 purposes;

8 “(b) To nonprofit, governmental or other institutions that meet
9 qualifications established by Water Resources Commission rules, for
10 programs to permanently abandon water wells and to repair or replace
11 water wells used for household purposes;

12 “(c) As cost-sharing with other programs to permanently abandon
13 water wells and to repair or replace water wells used for household
14 purposes; or

15 “(d) To pay the cost of direct services of a water well constructor
16 licensed under ORS 537.747 to purchase necessary materials and per-
17 form the work needed for abandoning, repairing or replacing water
18 wells that are eligible under this section.

19 “(3) Except as provided in subsection (4) of this section, financial
20 assistance provided under subsection (2) of this section may not ex-
21 ceed:

22 “(a) 75 percent of the cost to permanently abandon a water well;

23 “(b) 75 percent of the cost to repair or to replace a water well used
24 for household purposes; or

25 “(c) 50 percent of the cost of developing a program to permanently
26 abandon, repair or replace water wells, when paid to an institution
27 described in subsection (2)(b) of this section.

28 “(4) Notwithstanding subsection (3) of this section, financial assist-
29 ance provided under subsection (2) of this section to an individual with
30 lower income, as defined by the department, may cover the full cost

1 of the materials or work described in subsection (2) of this section.

2 “(5) An expenditure from the fund is subject to at least one of the
3 following purposes:

4 “(a) The permanent abandonment, repair or replacement of water
5 wells in which deficiencies in the well construction might:

6 “(A) Result in waste, loss of artesian pressure or ground water de-
7 clines;

8 “(B) Serve as a conduit for contamination; or

9 “(C) Otherwise be a detriment to public health or safety.

10 “(b) The repair or replacement of water wells used for household
11 purposes by persons of lower or moderate income.

12 “(c) The replacement of water wells used for household purposes in
13 areas of declining ground water levels where other sources of water
14 for household purposes are not feasible.

15 “(d) The abandonment, repair or replacement of water wells con-
16 sistent with water resources management purposes specified by rule
17 by the commission.

18 “(e) The abandonment, repair or replacement of water wells dam-
19 aged due to natural disasters.

20 “(6) If the department provides funding to an institution under
21 subsection (2)(b) of this section, the department shall require that the
22 institution:

23 “(a) Use accounting, auditing and fiscal procedures that conform
24 with generally accepted government accounting standards;

25 “(b) Give preference to persons of lower or moderate income and
26 to small businesses that do not qualify for other financing;

27 “(c) Demonstrate past success in offering, underwriting, servicing
28 and managing loans or grants to:

29 “(A) Persons of lower or moderate income; or

30 “(B) Persons representing a wide range of qualifications for credit;

1 **and**

2 **“(d) Have a plan for engaging other stakeholders in outreach and**
3 **marketing efforts for a loan or grant program.**

4 **“(7) The department may enter into contracts, intergovernmental**
5 **agreements or other arrangements with public or private entities for**
6 **any purposes consistent with this section.**

7 **“(8) The commission may adopt rules to implement this section,**
8 **including rules that:**

9 **“(a) Prioritize the issuance of the funding for a purpose described**
10 **in subsection (5) of this section.**

11 **“(b) Establish a preference for providing the funding to individuals**
12 **of moderate or lower income.**

13 **“(c) Establish that the funding may only be provided to individuals**
14 **of moderate or lower income.**

15 **“SECTION 4. ORS 536.090 is amended to read:**

16 **“536.090. (1) In carrying out the duties, functions and powers prescribed**
17 **by law, the Water Resources Commission shall appoint a ground water ad-**
18 **visory committee to:**

19 **“(a) Advise the commission on all matters relating to:**

20 **“(A) Rules for the development, securing, use and protection of ground**
21 **water; and**

22 **“(B) Licensing of well constructors, including the examination of such**
23 **persons for license.**

24 **“(b) Review the proposed expenditure of all revenues generated under**
25 **ORS 537.762 [(5)]. At least once each year, and before the expenditure of such**
26 **funds on new program activities, the Water Resources Department and the**
27 **ground water advisory committee shall develop jointly a proposed expendi-**
28 **ture plan for concurrence by the Water Resources Commission. The plan may**
29 **be modified, if necessary, upon the joint recommendation of the department**
30 **and the ground water advisory committee with concurrence by the commis-**

1 sion.

2 “(2) The committee shall consist of nine members who represent a range
3 of interests or expertise. At least three of the members shall be individuals
4 actively engaged in some aspect of the water supply or monitoring well
5 drilling industry. Members shall serve for such terms as the commission may
6 specify. The committee shall meet at least once every three months and at
7 other times and places as the commission may specify.

8 “(3) A member of the committee shall not receive compensation, but at
9 the discretion of the commission may be reimbursed for travel expenses in-
10 curred, subject to ORS 292.495.

11 “**SECTION 5.** ORS 536.750 is amended to read:

12 “536.750. (1) Notwithstanding any provision of ORS chapters 536 to 543A,
13 after a declaration that a severe, continuing drought exists, the Water Re-
14 sources Commission may:

15 “(a) Issue without first conducting a hearing under ORS 537.170, a tem-
16 porary permit for an emergency use of water;

17 “(b) Allow a temporary change in use, place of use or point of diversion
18 of water without complying with the notice and waiting requirements under
19 ORS 540.520;

20 “(c) Notwithstanding the priority of water rights, grant preference of use
21 to rights for human consumption or stock watering use;

22 “(d) Waive the notice requirements under ORS 537.753 and the [*report*]
23 **start card** required under ORS 537.762;

24 “(e) Allow a temporary exchange of water without giving notice as re-
25 quired under ORS 540.535; and

26 “(f) Utilize an expedited notice and waiting requirement established by
27 rule for the substitution of a supplemental ground water right for a primary
28 water right under drought conditions in place of the notice and waiting re-
29 quirement provided in ORS 540.524.

30 “(2) The commission by rule may establish procedures for carrying out the

1 provisions of this section and a schedule of fees that must accompany a re-
2 quest under subsection (1) of this section.

3 **“SECTION 6.** ORS 537.747 is amended to read:

4 “537.747. (1) No person shall advertise services to construct, alter, aban-
5 don or convert wells, offer to enter or enter into a contract with another
6 person or public agency to construct, alter, abandon or convert a well for
7 such other person, cause any well construction, alteration, abandonment or
8 conversion to be performed under such a contract or operate well drilling
9 machinery without possessing a water well constructor’s license therefor in
10 good standing issued by the Water Resources Department. The department
11 shall adopt a single water well constructor’s license that may specify the
12 type of well, type of well alteration or construction or type of well drilling
13 machine operation for which the water well constructor is qualified.

14 “(2) Notwithstanding subsection (1) of this section, a person may operate
15 a well drilling machine without a water well constructor’s license if super-
16 vised by one who possesses such a license.

17 “(3) A person shall be qualified to receive a water well constructor’s li-
18 cense if the person:

19 “(a) Is at least 18 years of age.

20 “(b) Has passed a written examination conducted by the department to
21 determine fitness to operate as a water well constructor.

22 “(c) Has paid a license fee and an examination fee according to the fee
23 schedule set forth under subsection (6) of this section.

24 “(d) Has one year or more experience in the operation of well drilling
25 machinery.

26 **“(e) Provides evidence that the person has completed an arc welding**
27 **training course from a community college, received a professional**
28 **welding certification, passed a welding proficiency test or otherwise**
29 **completed professional welding training.**

30 “(4) Upon fulfillment of all the requirements set out in subsection (3) of

1 this section, the department shall issue the applicant a water well
2 constructor's license in a form prescribed by the department. The license may
3 be issued for a period of two years.

4 “(5) A water well constructor's license shall expire on June 30 or on such
5 date as may be specified by department rule. A person may renew a license
6 by submitting an application and the appropriate fees any time before the
7 license expires but not later than one year after the license expires. A person
8 who renews a license within the 12 months after the license expires may ei-
9 ther pay a penalty fee set forth under subsection (6)(d) of this section or
10 requalify for a water well constructor's license in accordance with subsection
11 (3) of this section. If a person fails to renew a license within 12 months after
12 expiration, the person must comply with the requirements of subsection (3)
13 of this section for a new water well constructor's license.

14 “(6) The department shall collect in advance the following fees:

15 “(a) An examination fee of \$20.

16 “(b) A license fee of \$150.

17 “(c) A renewal fee of \$150, **if the license is renewed on or before the**
18 **expiration date.**

19 “(d) Unless a person requalifies for a water well constructor's license in
20 accordance with subsection (3) of this section, a water well constructor shall
21 pay a renewal fee of \$250 if [*the*] **an expired** license is renewed [*within*] **on**
22 **or before** 12 months after **the** expiration **date.**

23 “(e) If a person requalifies for a water well constructor's license under
24 subsection (3) of this section, the person shall pay the renewal fee estab-
25 lished under paragraph (c) of this subsection.

26 “(7) The department may revoke, suspend or refuse to renew any water
27 well constructor's license when it appears to the satisfaction of the depart-
28 ment, after notice and opportunity to be heard by the licensee, that the
29 licensee has failed to comply with the provisions of ORS 537.505 to 537.795
30 and 537.992 applicable to such licensee or any order or rule adopted there-

1 under applicable to such licensee, or has made a **material misrepresen-**
2 **tation or** material misstatement of fact on an application for a license or
3 well log or established a pattern of conduct that willfully or negligently vi-
4 olates any provision of ORS 537.505 to 537.795 and 537.992, or any rule
5 adopted pursuant thereto, applicable to such licensee.

6 “(8) The [*provisions of*] **requirement in** subsection (3)(d) of this section
7 [*requiring one year or more experience in the operation of well drilling ma-*
8 *chinery do*] **does** not apply to any person who, on July 1, 1981, holds the li-
9 cense required by this section and who continues thereafter to maintain the
10 license in good standing.

11 “(9) **The requirement in subsection (3)(e) of this section does not**
12 **apply to any person who, on July 1, 2023, holds the license required**
13 **by this section and who continues thereafter to maintain the license**
14 **in good standing.**

15 “(10) **If the department observes a welding deficiency on a well, the**
16 **department may order the licensee who welded the well to, within a**
17 **reasonable time, complete an arc welding training course from a**
18 **community college, acquire a professional welding certification, pass**
19 **a welding proficiency test or otherwise complete professional welding**
20 **training.**

21 “[9] (11) The fees collected under subsection (6) of this section shall be
22 paid into the Water Resources Department Water Right Operating Fund.
23 Such moneys are continuously appropriated to the Water Resources Depart-
24 ment to pay the department’s expenses in administering and enforcing the
25 water well constructor’s licensing program.

26 “**SECTION 7.** ORS 537.753 is amended to read:

27 “537.753. (1) Any person who contracts or offers services to contract to
28 construct, alter, abandon or convert wells shall have in effect a surety bond
29 or an irrevocable letter of credit issued by an insured institution, as defined
30 in ORS 706.008, running to the State of Oregon in the sum of \$20,000, en-

1 suring that in the construction, alteration, abandonment or conversion of
2 wells, the principal shall comply with all the provisions of ORS 537.505 to
3 537.795 and 537.992 that are applicable to such construction, alteration,
4 abandonment or conversion and to the rules and standards of well con-
5 struction, alteration, abandonment and conversion that have been prescribed
6 by the Water Resources Commission. The bond or letter of credit shall be
7 filed with the Water Resources Commission.

8 “(2) The Water Resources Commission or any person injured by failure
9 of a water well constructor to comply with the provisions of the bond or
10 letter of credit has a right of action on the bond or letter of credit in the
11 name of the injured person. However, the aggregate liability of the surety
12 or letter of credit issuer to all such persons may not exceed the sum of the
13 bond or letter of credit.

14 “(3) A proceeding against the bond or letter of credit under subsection (2)
15 of this section may not be commenced unless the commission notifies the
16 water well constructor of the alleged violation within three years after the
17 date the water well report is filed with the commission.

18 “(4) If a well is to be constructed, altered, abandoned or converted by a
19 person that is not licensed under ORS 537.747 on property owned by that
20 person, the person shall obtain a permit from the commission before begin-
21 ning work. Application for the permit shall be in the form prescribed by the
22 commission and must be accompanied by a fee of \$500. At the time [*the per-*
23 *mit is obtained,*] **of filing the permit**, the applicant also shall [*file with*]
24 **submit to** the commission a bond or an irrevocable letter of credit issued
25 by an insured institution as defined in ORS 706.008 running to the State of
26 Oregon in the sum of \$10,000, ensuring that in the construction, alteration,
27 abandonment or conversion of the well the landowner shall comply with all
28 the provisions of ORS 537.505 to 537.795 and 537.992 that are applicable to
29 the construction, alteration, abandonment or conversion of wells and to the
30 rules and standards of well construction, alteration, abandonment and con-

1 version that have been prescribed by the commission. Before the person who
2 constructs, alters, abandons or converts a well referred to in this subsection
3 seals the well, the person must give 10 days' written notice [*of the con-*
4 *struction, alteration, abandonment or conversion to the commission*] **to the**
5 **Water Resources Department so department personnel can be present**
6 **to observe the work.** After expiration of the notice period, the well may
7 be sealed even if the [*commission*] **department** has not caused the well to
8 be inspected.

9 **“SECTION 8.** ORS 537.762 is amended to read:

10 “537.762. (1) Each person required to possess a license under ORS 537.747
11 who has entered into a contract to construct, alter, abandon or convert a
12 well or cause a well to be constructed, altered, abandoned or converted shall,
13 before beginning work on the well, make a report to the Water Resources
14 Commission containing:

15 “(a) The name and post-office address of the owner of the well.

16 “(b) The approximate location of the well.

17 “(c) The proposed depth and diameter of the well.

18 “(d) The proposed purpose or use of the ground water from the well.

19 “(2) The commission shall furnish a convenient means for submitting the
20 reports referred to in subsection (1) of this section to each person who pos-
21 sesses a license under ORS 537.747.

22 “(3) A separate report shall be furnished under subsection (1) of this sec-
23 tion for each well that is constructed, altered, abandoned or converted.

24 “(4) The report furnished under subsection (1) of this section shall be
25 confidential and maintained as such for one year or until the well log re-
26 quired under ORS 537.765 is received by the commission, whichever is earlier.
27 Nothing in this subsection prohibits the commission from using the report
28 for enforcement actions during the period the report is considered confiden-
29 tial.

30 “(5) Each report form submitted under subsection (1) of this section for

1 the construction of a new well, deepening of an existing well, or conversion
2 of a well shall be accompanied by a fee of [~~\$225~~] **\$350**. Notwithstanding the
3 fee established pursuant to this subsection, the commission may adopt by
4 rule a reduced fee for persons submitting materials to the Water Resources
5 Department in a digital format approved by the department.

6 “(6) The moneys paid to the commission under subsection (5) of this sec-
7 tion shall be paid into the Water Resources Department Operating Fund. All
8 interest, if any, from moneys received under subsection (5) of this section
9 shall inure to the benefit of the Water Resources Department. Such moneys
10 and interest earned on such moneys are continuously appropriated to the
11 department to be used to pay the costs of the department to employ personnel
12 to inspect wells and well construction.

13 **“SECTION 9.** ORS 537.762, as amended by section 8 of this 2021 Act, is
14 amended to read:

15 **“537.762. (1) As used in this section:**

16 **“(a) ‘Licensed or permitted person’ means a person licensed under**
17 **ORS 537.747 or permitted under ORS 537.753 (4).**

18 **“(b) ‘Start card’ means a form containing all information required**
19 **by the Water Resources Department as a notification that a licensed**
20 **or permitted person will commence work on a well.**

21 **“[(1)] (2) Each [person required to possess a license under ORS 537.747]**
22 **licensed or permitted person** who has entered into a contract to construct,
23 alter, abandon or convert a well or cause a well to be constructed, altered,
24 abandoned or converted shall, **not earlier than 60 days and not later than**
25 **72 hours** before beginning work on the well, [*make a report*] **submit a start**
26 **card** to the [*Water Resources Commission*] **department** containing:

27 **“(a) The name, telephone number, electronic mail address** and post-
28 office address of the owner of the well.

29 **“(b) The approximate location of the well by county tax lot number,**
30 **township, range, section and nearest quarter-quarter section.**

1 “(c) **The street address nearest to the proposed well.**

2 “(d) **The latitude and longitude of the well as established by a global**

3 **positioning system.**

4 “[(c)] (e) **The proposed depth and diameter of the well.**

5 “[(d)] (f) **The proposed purpose or use of the ground water from the pro-**

6 **posed well.**

7 “(g) **The time frame proposed for beginning and completing the**

8 **construction, alteration, abandonment or conversion.**

9 “(h) **The time frame proposed for annular seal placement.**

10 “(i) **The well identification label number, if assigned.**

11 “(j) **The water right application, permit or certificate number, if**

12 **applicable.**

13 “(k) **The original well log number, if applicable.**

14 “(L) **The type of work proposed.**

15 “(m) **Notification of any need for special standards.**

16 “(n) **The signature and license number, if applicable, of the bonded**

17 **and licensed or permitted person who would undertake the work.**

18 “(o) **For an existing well, the current purpose or use of the well and**

19 **the existing depth and diameter of the well.**

20 “[(2) *The commission shall furnish a convenient means for submitting the*

21 *reports referred to in subsection (1) of this section to each person who possesses*

22 *a license under ORS 537.747.]*

23 “(3) **The department shall furnish a convenient means for licensed**

24 **or permitted persons to submit start card information under this sec-**

25 **tion.**

26 “[(3)] (4) *A separate [report shall be furnished under subsection (1) of this*

27 *section]* **start card is required** for each well that is constructed, altered,

28 abandoned or converted.

29 “[(4)] (5) *[The report furnished under subsection (1) of]* **A start card**

30 **submitted under** this section shall be confidential and maintained as such

1 for one year or until the well log required under ORS 537.765 is received by
2 the [commission] **department**, whichever is earlier. Nothing in this sub-
3 section prohibits the [commission] **department** from using [the report] a
4 **start card** for enforcement actions during the period the [report] **start card**
5 is [considered] confidential.

6 “(6) On the date that work on the well commences, the licensed or
7 permitted person shall, before commencing work, notify the depart-
8 ment that the work is about to commence. If the proposed date of seal
9 placement is not the date proposed on the start card required by this
10 section, the licensed or permitted person shall notify the department
11 of the change at least four hours before placing the seal.

12 “(7) The Water Resources Commission may adopt rules establishing
13 precision requirements and standards for global positioning system
14 equipment used to obtain information submitted under subsection (2)
15 of this section.

16 “(8) Unless the licensed or permitted person submitting a start card
17 under this section has requested and received an extension, a start
18 card expires if construction, alteration, abandonment or conversion
19 of a well does not begin on or before 60 days after submission of the
20 start card. If a start card expires, a new start card and fee must be
21 submitted in compliance with this section before construction, alter-
22 ation, abandonment or conversion of the well may occur. If a start
23 card is withdrawn before expiring, the licensed or permitted person
24 that submitted the start card may request that the fee paid for the
25 withdrawn start card be transferred to a new start card.

26 “(9) The commission may establish by rule an exception to any time
27 frame established in this section for areas requiring special standards
28 and for any other purpose identified by the commission.

29 “(10) The requirement in subsection (2) of this section that a li-
30 censed or permitted person must submit a start card not later than

1 **72 hours before beginning work on a well does not apply:**

2 **“(a) To a second or additional water well drilled on the same or a**
3 **contiguous tax lot for the same landowner and for which a valid un-**
4 **expired start card has been submitted pursuant to this section, if a**
5 **start card for the second or additional water well is filed not later than**
6 **the day the work on the water well begins.**

7 **“(b) During water emergencies or casing height adjustments, if a**
8 **start card is submitted before work begins.**

9 **“(11) The Water Resources Director may, for good cause in exigent**
10 **circumstances, waive any time frame established by this section.**

11 **“[(5)] (12) Each [report form] start card** submitted under *[subsection (1)*
12 *of]* this section for the construction of a new well, deepening of an existing
13 well or conversion of a well shall be accompanied by a fee of \$350. *[Not-*
14 *withstanding the fee established pursuant to this subsection, the commission*
15 *may adopt by rule a reduced fee for persons submitting materials to the Water*
16 *Resources Department in a digital format approved by the department.]*

17 **“[(6)] (13) The moneys paid to the [commission] department** under sub-
18 section **[(5)] (12)** of this section shall be paid into the Water Resources De-
19 partment Operating Fund. All interest, if any, from moneys received under
20 subsection **[(5)] (12)** of this section shall inure to the benefit of the *[Water*
21 *Resources]* department. Such moneys and interest earned on such moneys
22 are continuously appropriated to the department to be used to pay the costs
23 of the department to employ personnel to inspect wells and well con-
24 struction.

25 **“SECTION 10.** ORS 537.762, as amended by sections 8 and 9 of this 2021
26 Act, is amended to read:

27 **“537.762. (1) As used in this section:**

28 **“(a) ‘Licensed or permitted person’ means a person licensed under ORS**
29 **537.747 or permitted under ORS 537.753 (4).**

30 **“(b) ‘Start card’ means a form containing all information required by the**

1 Water Resources Department as a notification that a licensed or permitted
2 person will commence work on a well.

3 “(2) Each licensed or permitted person who has entered into a contract
4 to construct, alter, abandon or convert a well or cause a well to be con-
5 structed, altered, abandoned or converted shall, not earlier than 60 days and
6 not later than 72 hours before beginning work on the well, submit a start
7 card to the department containing:

8 “(a) The name, telephone number, electronic mail address and post-office
9 address of the owner of the well.

10 “(b) The approximate location of the well by county tax lot number,
11 township, range, section and nearest quarter-quarter section.

12 “(c) The street address nearest to the proposed well.

13 “(d) The latitude and longitude of the well as established by a global po-
14 sitioning system.

15 “(e) The proposed depth and diameter of the well.

16 “(f) The proposed purpose or use of the ground water from the proposed
17 well.

18 “(g) The time frame proposed for beginning and completing the con-
19 struction, alteration, abandonment or conversion.

20 “(h) The time frame proposed for annular seal placement.

21 “(i) The well identification label number, if assigned.

22 “(j) The water right application, permit or certificate number, if applica-
23 ble.

24 “(k) The original well log number, if applicable.

25 “(L) The type of work proposed.

26 “(m) Notification of any need for special standards.

27 “(n) The signature and license number, if applicable, of the bonded and
28 licensed or permitted person who would undertake the work.

29 “(o) For an existing well, the current purpose or use of the well and the
30 existing depth and diameter of the well.

1 “(3) The department shall furnish a convenient means for licensed or
2 permitted persons to submit start card information under this section.

3 “(4) A separate start card is required for each well that is constructed,
4 altered, abandoned or converted.

5 “(5) A start card submitted under this section shall be confidential and
6 maintained as such for one year or until the well log required under ORS
7 537.765 is received by the department, whichever is earlier. Nothing in this
8 subsection prohibits the department from using a start card for enforcement
9 actions during the period the start card is confidential.

27 **“(a)** Violation of any of the terms or conditions of a permit, certificate
28 or license issued under ORS chapters 536 to 543A.

29 **“(b)** Violation of ORS 537.130 or 537.535.

30 **“(c)** Violation of ORS 537.545 (5) [or (6)] or of a rule described in ORS

1 537.545 [(8)] (7).

2 “(d) Violation of any rule or order of the Water Resources Commission
3 that pertains to well maintenance.

4 “(e) Violation of ORS 540.045, 540.145, 540.210, 540.310, 540.320, 540.330,
5 540.340, 540.435, 540.440, 540.570 (5), 540.710, 540.720 and 540.730 or rules
6 adopted under ORS 540.145.

7 “(2) A civil penalty may be imposed under this section for each day of
8 violation of ORS 537.130, 537.535, 540.045, 540.310, 540.330, 540.570 (5), 540.710,
9 540.720 or 540.730.

10 “(3) In the event the petitioner knowingly misrepresents the map and pe-
11 tition required in ORS 541.329, the commission may assess a penalty of up
12 to \$1,000 based upon guidelines to be established by the commission. In ad-
13 dition, the petition and map shall be amended to correct the error at the
14 petitioner’s cost. Affected users shall be given notice as provided in ORS
15 541.329 (5).

16 “(4) A civil penalty may not be imposed until the commission prescribes
17 a reasonable time to eliminate the violation. The commission shall notify the
18 violator of the time allowed to correct a violation within five days after the
19 commission first becomes aware of the violation.

20 “(5) Notwithstanding any term or condition of a permit, certificate or li-
21 cense, the rotation of the use of water under ORS 540.150 may not be con-
22 sidered a violation under subsection (1) of this section.

23 **“SECTION 21.** ORS 537.763 is amended to read:

24 “537.763. (1) There is established in the State Treasury the Water Re-
25 sources Department Operating Fund to provide for the payment of the ad-
26 ministrative expenses of the Water Resources Commission in carrying out
27 the provisions of ORS 537.762.

28 “(2) The Water Resources Department Operating Fund shall consist of:

29 “(a) Fees received pursuant to ORS 537.762.

30 “(b) All moneys received on behalf of the fund by gift, grant or appro-

1 priation, from whatever source.

2 “(3) The Water Resources Department Operating Fund shall be separate
3 and distinct from the General Fund. All interest **earned by the Water Re-**
4 **sources Department Operating Fund**, if any, shall inure to the benefit of
5 the [*Water Resources Department Operating Fund*] **fund**.

6 “(4) In expending moneys in the [*Water Resources Department Operating*
7 *Fund*] **fund** received from fees pursuant to ORS 537.762, the biennial limi-
8 tations on expenditures of the Water Resources Department shall be:

9 “(a) No more than five percent for well inspection administrative support;

10 “(b) No more than 20 percent for well inspection technical and informa-
11 tion services; and

12 “(c) No less than 75 percent for well inspection field investigation, [*and*]
13 enforcement **and review of well logs**.

14 **“SECTION 22. On or before January 31, 2023, and on or before Jan-**
15 **uary 31, 2025, the Water Resources Department shall report to a com-**
16 **mittee or interim committee of the Legislative Assembly related to**
17 **water, in the manner prescribed in ORS 192.245, on the department’s**
18 **review of well logs and inspection of wells. The reports shall describe,**
19 **but need not be limited to:**

20 “(1) **The number of well logs the department has identified as hav-**
21 **ing deficiencies and the nature of the deficiencies.**

22 “(2) **The number of inspected wells that had deficiencies and**
23 **whether the nature of the deficiencies was observed on the well logs**
24 **for the wells.**

25 “(3) **The department’s workload associated with reviewing well logs**
26 **and inspecting wells.**

27 **“SECTION 23. Sections 2 and 3 of this 2021 Act become operative**
28 **on January 1, 2022.**

29 **“SECTION 24. The amendments to ORS 537.765 by section 11 of this**
30 **2021 Act:**

1 **“(1) Become operative on July 1, 2022.**

2 **“(2) Apply to wells logs submitted on or after July 1, 2022.**

3 **“SECTION 25. The amendments to ORS 537.747 by section 6 of this**
4 **2021 Act apply to license issuance, requalification or renewal for which**
5 **an application is received by the Water Resources Department on or**
6 **after July 1, 2023.**

7 **“SECTION 26. The amendments to ORS 537.762 by section 9 of this**
8 **2021 Act apply to information submitted to the Water Resources De-**
9 **partment on or after July 1, 2023, relating to the proposed con-**
10 **struction, alteration, abandonment or conversion of a well.**

11 **“SECTION 27. Section 19 of this 2021 Act and the amendments to**
12 **ORS 536.090, 536.750, 537.747, 537.753, 537.762, 537.765, 537.780, 537.789 and**
13 **537.791 by sections 4 to 7, 9, 12 and 14 to 16 of this 2021 Act become**
14 **operative on July 1, 2023.**

15 **“SECTION 28. The amendments to ORS 537.762 and 537.765 by**
16 **sections 10 and 13 of this 2021 Act become operative on July 1, 2024.**

17 **“SECTION 29. The amendments to section 2, chapter 496, Oregon**
18 **Laws 2001, by section 17 of this 2021 Act do not alter the term of office**
19 **of a member serving on the Well Constructors Continuing Education**
20 **Committee immediately prior to the effective date of this 2021 Act.”.**
